Israeli citizens have demonstrated great mistrust towards the immunization campaign against corona virus, scheduled to kick off this weekend, a just-released poll shows, with only a fourth prepared to get vaccinated immediately. Some 25 percent of Israelis have expressed their readiness to receive a corona virus jab off the bat, the poll, released by Ynet News, has found. The level of mistrust towards the vaccination campaign turned out to be particularly high among younger Israelis. At the same time, some 50 percent of people over the age of 65 expressed their readiness to get a Covid-19 shot without delay. Moreover, some 82 percent of elder Israelis said they would like to get vaccinated sooner or later. All in all, only some 63 percent of Israelis plan to get vaccinated, the poll results suggest. "There appears to be a striking lack of trust in a large part of the whole Israeli population, and particularly among Arabs and women, in a Covid-19 vaccine," director of University of Haifa's international master's program in public health, Prof. Manfred Green, said, as cited by local media. In a statement released on December 14, 2020 the World Health Organization finally owned up to what 100,000's of doctors and medical professionals have been saying for months: the PCR test used to diagnose COVID-19 is a hit and miss process with way too many false positives. Mullis said was never designed to diagnose diseases. Among thousands of angry doctors arguing PCR tests should not be used is Dr. Pascal Sacré. He wrote that: "This misuse of RT-PCR technique is used as a relentless and intentional strategy by some governments, supported by scientific safety councils and by the dominant media, to justify excessive measures such as the violation of a large number of constitutional rights, the destruction of the economy with the bankruptcy of entire active sectors of society, the degradation of living conditions for a large number of ordinary citizens, under the pretext of a pandemic based on a number of positive RT-PCR tests, and

not on a real number of patients." Clear and conclusive scientific evidence proves that these tests are not accurate, and create a statistically significant percentage of false positives. Positive results more likely indicate "ordinary respiratory diseases like the common cold." Professor Mullis was awarded the Nobel Prize in Chemistry in 1993. 'Coincidentally', Mullis died just before the pandemic started. So, there you have the proof factcheckers, one of your own people again admitting the flawed nature of tests to roll out this vaccine scamdemic.

GOP Sen. Ron Johnson (Wis.) blocked a proposal to provide another round of stimulus checks for the second time on Friday - this time when it was offered by Sen. Bernie Sanders (I-Vt.). Sanders, speaking from the Senate floor late Friday afternoon, tried to pass his bill that would provide a second \$1,200 stimulus check for Americans making up to \$75,000, the same language passed during a March CARES Act. "This is not a radical idea, this is an idea that is supported by President Donald Trump, it is an idea that is supported by President-elect Joe Biden," Sanders said. "The American people cannot wait any longer; they need economic relief right now versus they need help and they need it now." Sanders is the second senator to try to pass a bill Friday to provide a second round of \$1,200 checks. Sen. Josh Hawley (R-Mo.) also tried earlier Friday and was similarly blocked by Johnson, who argued that additional corona virus relief needs to be targeted and voiced concerns about the country's debt. Senate Minority Leader Charles Schumer (D-N.Y.) aligned himself with Sanders on Friday. "The quickest way to get money into the pockets of the American people is, to send some of their tax dollars right back where they came from. So let's step up the plate. Oh my politician remembering the tax dollars came from the people, well I never. Just when you thought this bill would be completed for the American people, in steps the counter arguments against it.

US President Trump has urged Congress to amend a bumper corona virus stimulus bill to increase stimulus payments to \$2,000 per American. In a video message posted on Twitter, he asked lawmakers to "remove wasteful and unnecessary items", adding that the package "really is a disgrace". "It's called the Covid relief bill, but it has almost nothing to do with Covid," he said. But in Tuesday night's message from the White House, he balked at spending in the bill on other countries, arguing that the money should go to struggling Americans. He said: "I am asking Congress to amend this bill and increase the ridiculously low \$600 to \$2,000 or \$4,000 for a couple. "I'm also asking Congress to immediately get rid of the wasteful and unnecessary items from this legislation and to send me a suitable bill, or

else the next administration will have to deliver a Covid relief package." This is pleasing rhetoric from Trump although one just wonders how much it is genuine care for the American people, or another delay tactic that has been prevalent since July.

But he went one step further in another pleasing move this week, US President Donald Trump has vetoed a \$740bn defence spending bill that passed Congress this month. Mr Trump is objecting to provisions that limit troop withdrawals from Afghanistan and Europe and remove Confederate leaders' names from military bases. He also wanted it to repeal a liability shield for social media companies. Good stuff, personally I wouldn't send the Military a penny and make Rothschild's pay, seen as they believe they own and run them, or make the Fed pay if the Black Sun thinks they own them as well. California saw record-low population growth in 2020, as the state lost more residents than it gained for the second consecutive year. About 135,600 more people left the state than moved in, according to data from the state's finance department released this week, marking the third largest migration loss in the state's history. In total, just 21,200 people were added between July 2019 and July 2020. The 2020 growth rate was 0.05 percent, down from 0.23 percent the year prior – marking the slowest growth rate on record. The state saw a similar outflow of residents when compared with last year, but the inflow was notably smaller. The total population currently sits at about 39.78 million people. As previously reported by FOX Business, cities like San Francisco – where the cost of living is notoriously high – have seen an exodus of residents who have more flexibility to work remotely during the pandemic and beyond. Further, stay-at-home orders that have been implemented intermittently since March may have led to a lower influx of residents to California this year. Just as warned as far back as 2015, the ongoing rush out of the big, expensive and over crowded cities is carrying on unabated. California was a deliberate plan, but the other big cities is an example of people having enough of the extortionate practices ongoing in those cities. The over the top housing, rents, business rents and shops will all take a hit, buildings will and have emptied, what will big business do then? The big question

is what happens next?

The grandstanding Governor of New York has prohibited the sale or display of the Dixie flag and other so-called “hate symbols” on public property, an act he admits violates the Constitution, does anyone think he’ll stop at flags? Signed into law on Tuesday, the new bill bars anyone from selling or displaying “symbols of hate” on New York state property unless the symbol appears in a book, “digital medium,” or within an educational context. The definition of “symbols of hate” is left deliberately open-ended, with the legislation noting that it “shall include, but not be limited to, symbols of white supremacy, neo-Nazi ideology or the battle flag of the Confederacy.” Cuomo praised the legislation, declaring the US was facing a “pervasive, growing attitude of intolerance and hate,” and hailed the effort to “help safeguard New Yorkers from the fear-instilling effects of these abhorrent symbols.” If he knows the history of New York, then the best things to do is to ban the whole of it, because New York was built upon hate, division, death, cults and crime, and that was only the Hebrew white collar brigade.

Multimillionaire televangelist Joel Osteen’s Lakewood Church in Texas netted \$4.4 million in bailouts through the federal COVID-19 relief program, records show. The loan was the third-highest in the Houston area during all of July and August, the outlet noted, citing federal data. Osteen — whose sermons are seen around the world — is worth an estimated \$100 million. He took the helm of Lakewood Church following the death of his dad, founding pastor John Osteen, in 1999. The NY Times has been caught out this week and has finally retracted its award-winning podcast about a Canadian-born Islamic State executioner, months after Ottawa discovered he'd made it all up, admitting their fact-checking was "not sufficiently rigorous." A bit like the Facebook and BBC factcheckers then oops. The 'paper of record' has come clean about the festering hoax at the center of its 2018 hit podcast 'Caliphate,' officially retracting the series on Friday, and reassigning lead reporter Rukmini Callimachi off the terrorism beat. The podcast's central narrative thread, purporting to be an "eye-opening account" of one man's journey from Canada into the ranks of Islamic State (IS, formerly ISIS/ISIL) in Syria, was largely fabricated, the New York Times admitted, acknowledging the central character had probably never been to Syria at all, let alone committed the grisly atrocities he described in detail on the podcast. The paper's statement explained that Shehroze Chaudhry – the Canadian 25-year-old who presented himself as a fearsome IS executioner named Abu Huzayfah – was not only not a terrorist, but during the years he claimed to have spent slaughtering Syrians, he was actually working at his family's kebab shop in Toronto or living with his grandparents in Pakistan. Canadian authorities charged him in September with perpetrating a terrorist hoax, a crime that carries a maximum sentence of five years' imprisonment, after a four-year investigation. Ottawa claims it had knowledge Chaudhry was making the whole thing up even as Caliphate launched in 2018, but could not share the information at the time because the investigation was ongoing. Among the more obvious pieces of evidence for the "terrorists tall tales were the photos he posted, supposedly featuring his partners in crime, that were actually shot by news photographers and activist groups. So, news photographers and activist groups are fabricating stuff to look real, brings into question a whole heap of events surrounding alleged cop shootings doesn't it? Mubin Shaikh stated that Huzaifi could be "rehabilitated" and that Canada needs to "have an eye" on him. Mubin Shaikh is a former security intelligence and counter terrorism operative. He has testified as an expert for the United Nations Security Council, the United States Senate Committee on Homeland Security and Governmental Affairs with NATO, the National Counterterrorism Center, and Special Operations Command Central and he is an external expert with the Joint Staff SMA for CENTCOM Command Staff. The World Health Organization's head should be probed over genocide, a claim filed with the ICC by a US Nobel Peace Prize nominee says, adding that the Ethiopian may be involved in many crimes at home. The current World Health Organization (WHO) Director-General Tedros Adhanom Ghebreyesus "was a crucial decision maker in relation to security service actions that included killing, arbitrarily detaining and torturing Ethiopians," a complaint filed with the International Criminal Court (ICC) says. Its author, an American economist and activist, David Steinman, who was nominated for the 2019 Nobel Peace Prize, alleges that the Ethiopian biologist and health researcher had a role in atrocities committed by various Ethiopian security forces during his tenure as a high-ranking government official.

Kansas Mayor Joyce Warshaw said Tuesday in her resignation letter, her resignation was effective immediately. Warshaw said she had been receiving threatening emails and telephone calls since being quoted, in a December 11 USA Today article about Dodge City's delays in imposing a Covid-19 mask mandate, which was finally passed by the City Commission on November 16. Even a well-paid expatriate moving to the United States can be caught in the conundrum of not getting a credit card for lack of credit record, and not having a credit record for lack of credit cards. Fintech resolves the dilemma by tapping various nonfinancial data: the type of browser and hardware used to access the internet, the history of online searches and purchases. Recent research documents that, once powered by artificial intelligence and machine learning, these alternative data sources are often superior than traditional credit assessment methods, and can advance financial inclusion, by, for example, enabling more credit to informal workers and households and firms in rural areas. More credit for rural areas yeah right, that is the seducement they always offer, but ultimately it is about more control by the weak ones.

In a December 4, 2020 interview with the New York Times, she supported both fast lockdowns - rather dubiously claiming African countries have had strict and effective lockdowns - and compulsory wearing of face masks, none of which would affect her personal lifestyle: "We can look at how this disease traveled around the world and see that the countries who locked down first, they're doing better. Many African countries saw it coming and locked it down early, their replication rate just never got as high as many other countries, and that is a good thing." "It is insane that we're at this point in this pandemic, in the United States, and we're still debating whether people should wear a mask when they go in a store to buy their groceries." The whole interview was worded in such a way that it was never clear how much she herself had contributed to these policies, but she admitted: "What did surprise us is we hadn't really thought through the economic impacts." In 2016, Pfizer was expected to merge with Allergan to create the Ireland-based "Pfizer plc" in a deal that would have been worth US\$160 billion. The merger was called off in April 2016, however, because

of new rules from the US Department of the Treasury against tax inversions, a method of avoiding taxes by merging with a foreign company. The company has made the second-largest pharmaceutical settlement with the United States Department of Justice. On 19 December 2018, Pfizer announced a joint merger of their consumer healthcare division with UK pharma giant GlaxoSmithKline which maintains a controlling 68% of shares. Cartel Pricing Pfizer has been at the center of controversies over price fixing for more than 50 years. In 1958 it was one of six drug companies accused by the Federal Trade Commission of fixing prices on antibiotics. The company was also charged with making false statements to the U.S. Patent Office to obtain a patent on tetracycline. Withholding Safety Problems The US Food and Drug Administration expressed great concern about reports of dozens of fatalities linked to heart valves made by Pfizer's Shiley division. In 1986, as the death toll reached 125, Pfizer ended production of all models of the valves, yet by that point they were implanted in tens of thousands of people, who worried that the devices could fracture and fail at any moment. In 1991 an FDA task force charged that Shiley had withheld information about safety problems from regulators in order to get initial approval for its valves and that the company continued to keep the FDA in the dark. A November 7, 1991 investigation in the Wall Street Journal asserted that Shiley had been deliberately falsifying manufacturing records relating to valve fractures. Withholding Trial Results In 2004, in the wake of revelations about dangerous side effects of Merck's painkiller Vioxx, Pfizer agreed to suspend television advertising for a related medication called Celebrex. The following year, Pfizer admitted that a 1999 clinical trial found that elderly patients taking Celebrex had a greatly elevated risk of heart problems. Testing Dangerous Drugs in Africa In 2000 Pfizer was accused of testing a dangerous new antibiotic called Trovan on children in Nigeria without receiving proper consent from their parents. The experiment occurred during a 1996 meningitis epidemic in the country. In 2001 Pfizer was sued in U.S. federal court by thirty Nigerian families, who accused the company of using their children as human guinea pigs. In 2006 a panel of Nigerian medical experts concluded that Pfizer had violated international law. In 2009 the company agreed to pay \$75 million to settle some of the lawsuits that had been brought in Nigerian courts. BBC reported on WikiLeaks cables that showed that Pfizer "used dirty tricks to avoid clinical trial payout", the company hired investigators to find evidence of corruption on Nigerian attorney general to persuade him to drop legal action. The U.S. case was settled in 2011 for an undisclosed amount. Lying and Digging Dirt on Opponents Classified U.S. State Department cables made public in 2010 by Wikileaks indicated that Pfizer had hired investigators to dig up dirt on Nigeria's former attorney general as a way to get leverage in one of the remaining cases. Pfizer had to apologize over the revelation in the cables that it had falsely claimed that the group Doctors Without Borders was also dispensing Trovan during the Nigerian meningitis epidemic. Bribery In 1976 Pfizer was one of the many companies that disclosed that it had made questionable payments to foreign government officials. The company said that about \$265,000 had been paid to officials in three countries but did not identify them. In August 2012 the U.S. Securities and Exchange Commission announced that it had reached a \$45 million settlement with Pfizer to resolve charges that its subsidiaries, especially Wyeth, had bribed overseas doctors and other healthcare professionals to increase foreign sales. Firing

Employees for Raising Safety Concerns In 2010 a US federal jury awarded \$1.37 million to a former Pfizer scientist who claimed she was sickened by a genetically engineered virus at a company lab and was then fired for raising safety concerns. Last month Nigeria is suing Pfizer again for \$7B for the killing and maiming of many children by Pfizer in Nigeria. Yet the bots line up for this companies vaccine with that record of malfeasance on their docket? Some senior Defense Department officials are pressing to formally separate the leadership of the National Security Agency from U.S. Cyber Command, in a move that would shift the nation's top electronic spy agency from military to civilian control, according to people familiar with the matter. The proposal under consideration was circulated among Pentagon officials in recent days, according to a U.S. official and another person familiar with the matter. It is supported by acting Defense Secretary Christopher Miller, who was installed at the Pentagon in early November. The proposal would split control of the two giant agencies in the final weeks of the Trump administration, and comes amid revelations of a suspected Russian hack of U.S. agencies. There was no Russian hack at all, it was a restructure ongoing. It appears to be a dusted-off version of one that was previously floated inside the Pentagon



by then-Defense Secretary Jim Mattis, according to another U.S. official. "This is very preliminary," the official said, adding that a meeting was scheduled for this coming week to discuss the proposal. Many current and former officials say the partnership between the two spy entities is vital to sharing intelligence and resources, but critics have said the arrangement can lead to bureaucratic headaches. Some officials also believe the two agencies have dueling missions that are in conflict with one another, because Cyber Command focuses on offensive operations while the NSA's chief goal is intelligence collection. Some supporters of separation believe that the two agencies are simply too critical and vast for one leader to manage.

We may see a lot more information shortly due to a major shift in the security clearance levels as of the past 2-3 weeks.

OP-ED In a recent report to shareholders on advancements in “gene therapy” Goldman Sachs analysts asked the awkward and revealing question: “Is curing patients a sustainable business model?” “The potential to deliver ‘one shot cures’ is one of the most attractive aspects of gene therapy, genetically-engineered cell therapy and gene editing,” analyst Salveen Richter wrote in an April 10 note to clients titled “The Genome Revolution.” “However, such treatments offer a very different outlook with regard to recurring revenue versus chronic therapies,” While advancements in the biotech industry add “tremendous value for patients and society, it could represent a challenge for genome medicine developers looking for sustained cash flow,” he adds. Richter cited the development of high-tech hepatitis C treatments, which achieved cure rates of more than 90 percent, as an example. The company’s sales for those treatments peaked at \$12.5 billion in 2015, but are predicted to be less than \$4 billion this year. Curing hepatitis C “has gradually exhausted the available pool of treatable patients,” he wrote. “In the case of infectious diseases such as hepatitis C, curing existing patients also decreases the number of carriers able to transmit the virus to new patients, thus the incident pool also declines,” he adds. The report suggested three potential solutions for biotech firms: Solution 1: Address large markets: Hemophilia is a \$9-10bn worldwide market, growing at 6-7% annually. Solution 2: Address disorders with high incidence: Spinal muscular atrophy affects the cells (neurons) in the spinal cord, impacting the ability to walk, eat, or breathe. Solution 3: Constant innovation and portfolio expansion: There are hundreds of inherited retinal diseases (genetics forms of blindness) ... Pace of innovation will also play a role as future programs can offset the declining revenue trajectory of prior assets. The sheer coldness, heartlessness of these people who seek money at any cost, staggers my mind. We can't cure people as it affects our income, is sickening levels of service to self and pure greed. Lynn Forester de Rothschild, the Coalition's founder, contends that the alliance isn't another caucus for big corporations. Any enterprise who believes in the need to reform the prevailing capitalist agenda can sign up to be part of the movement. "It's available to the corner pharmacy who wants to make a commitment to hiring one person of color, or being carbon neutral," she explains. "They don't have to do what Johnson & Johnson or Merck does, they'll do what's comfortable to

There were members and local chapters in many countries, at around that time, a split appears to have occurred within A Brighter Dawn. An extreme faction in ABD felt that direct action was needed to achieve the "reset" or "paradigm shift", that would be required to fundamentally alter the balance. This splinter group consisted of no more than 30 individuals. A charismatic leader assumed leadership, and he worked closely with about 25 other ABD members in the group who had bioscience training, including virologists. Following the schism, the splinter group established a laboratory near Zurich, Switzerland, and masqueraded as a small biotech start-up firm. They set up a sophisticated life science laboratory with commercially available equipment, and focused on developing a biological weapon that would have a global impact. ABD's leadership also seems to have been attracted to the concept of a biblical plague as the corrective to humanity's excesses. The splinter group's funding came from members, like-minded private donors, and involvement in illicit activities. A Brighter Dawn did not register as a threat for law enforcement and intelligence agencies, because they were in on it is why. ABD's spin-off and subsequent weapons development efforts went unnoticed, until they claimed credit on social media for the Clade X attacks. Their purchase of supplies and equipment was not unusual for a biotech company. ABD's R&D team consisted primarily of ideologically aligned scientists, some of whom held advanced degrees. Several PhD-level scientists were responsible for various aspects of the bioweapons program, which included molecular and classical microbiology, aerobiology, and testing and evaluation, or in our terms jackasses. They say it expands your consciousness, but have you considered it is not your consciousness that has expanded? it is you and the entity that has expanded. 3. mushrooms, they call it magic mushrooms for a reason, and all magic comes with a price
4. Ayahuasca and other derivatives described as hallucinogenic or is it hallucino - genie, again it calls in the spirits, all done by so called shamans, which really means shar man, shar means time or era, so they are time men, just not our time but theirs. The South Americans and many other tribal

people were tricked into these ceremonies by the rogue ET groups here to engage a covenant or contract, they had with the demons or djinns here. Golems are artificial beings that are used as a slave force, is an animated anthro-pom-orphic being that is created entirely from inanimate matter (usually clay or mud), just like the Gingerbread man, whose earliest origins of that cookie, appeared to have started in Egypt. Which is the Hebrew and Quran version of how man started, taken from one description of it . This is how Adam was created: from the earth – i.e. from its dust – which was then mixed with water to form mud, which then became black, stinking mud. And this dust was created from the earth which is partly sand and when it is mixed it becomes sounding clay like the clay of pottery. Anthro-pom-orphism is the attribution of human traits, emotions, or intentions to non-human entities. In religion and mythology, anthropomorphism is the perception of a divine being or beings in human form, or the recognition of human qualities in these beings. In science fiction, an artificially-intelligent computer or robot, even though it has not been programmed with human emotions, often spontaneously experiences those emotions anyway: for example, Agent Smith in The Matrix was influenced by a "disgust" toward humanity. This is an example of anthropomorphism: in reality, while an artificial intelligence could perhaps be deliberately programmed with human emotions, or could develop something similar to an emotion as a means to an ultimate goal if it is useful to do so, it would not spontaneously develop human emotions for no purpose whatsoever, as portrayed in fiction. In Modern Hebrew, golem is used to mean "dumb" or "helpless". "Golem" passed into Yiddish as goylem to mean someone who is lethargic or beneath a stupor. The oldest stories of golems date to early Judaism, in the Talmud (Tractate Sanhedrin 38b), Adam was initially created as a golem (גולם) when his dust was "kneaded into a shapeless husk." Like Adam, all golems are created from mud by those close to divinity, but no anthropogenic golem is fully human. Goylem became Goyim and the elite Jewish belief that we are not real humans and only dumb animals was adopted as their mantra.

Abracadabra magical formula, 1690s, from Latin (Q. Serenus Sammonicus, 2c.), from Late Greek Abraxas, cabalistic or gnostic name for the supreme god, and thus a word of power. It was written out in a triangle shape and worn around the neck to ward off sickness. A few things from that, the mention of the Abraxas, who are a humanoid group worse than the Draco, as covered in Jupiter Ascending movie. But that word is a spell cast and yet curiously many who believe in the divinity of the gnostics, they think a spell cast is a name for a supreme god, really?

Abraxas Cabalistic word associated with the followers of Basilides the Gnostic, by 1680s, of uncertain origin and with many elaborate explanations. Also used in reference to a type of Gnostic amulet featuring a carved gem depicting a monstrous figure and obscure words, or

words connected to Hebrew or Egyptian religion. Ah, the Abraxas connected to the Egyptian and Hebrew religion they say, well I never!! yep they are the religion with their Annunaki sidekicks is why.

The Ciakar species are rarely covered in alt media and they are considered the royal caste amongst the reptilian races. They supposedly have a powerful military and control many other races throughout the galaxy, such as the Zeta Grey Reticulans, who do much of the dirty work for the Ciakars, such as human abductions throughout galactic history, Ciakars and the Lyrans (and other human races) have been mortal enemies. As with most Reptilians, Ciakars allegedly continue to this day to seek the
