WASHINGTON—The Office of the Comptroller of the Currency (OCC) today published a letter clarifying national banks' and federal savings associations' authority, to participate in independent node verification networks (INVN) and use stablecoins to conduct payment activities and other bank-permissible functions. "While governments in other countries have built real-time payments systems, the United States has relied on our innovation sector to deliver real-time payments technologies. Some of those technologies are built and managed by bank consortia and some are based on independent node verification networks such as blockchains," said Acting Comptroller of the Currency Brian P. Brooks. "The President's Working Group on Financial Markets recently articulated a strong framework for ushering in an era of stablecoin-based financial infrastructure, identifying important risks while allowing those risks to be managed in a technology-agnostic way. Our letter removes any legal uncertainty about the authority of banks to connect to blockchains as validator nodes, and thereby transact stablecoin payments on behalf of customers who are increasingly demanding the speed, efficiency, interoperability, and low cost associated with these products." The OCC just told US banks that they must treat permissionless, open source blockchains like Bitcoin and Ethereum the same way they treat SWIFT, ACH and FedWire. Oh and also, there is FinCen putting up kyc walls for crypto effectively de-platforming it as US currency asset. Square's Letter to FinCen For example, under this Proposal — if a Square customer's mother gifts her daughter \$4,000 in physical cash and the daughter deposits those funds in a bank, the bank would have no obligation to collect information on the customer's mother. Under the Proposal, if this same transaction were completed in cryptocurrency, the bank would have to reach beyond its customer relationship and intrude upon the mother's private information in order for the daughter to successfully deposit and freely access her gift. US President-elect Joe Biden has accused the US defence department of "irresponsibility" for failing to give his team the information it needs for the transition of power. He said his team had encountered "obstruction from the political leadership". Mr Biden also claimed that agencies critical to US security had suffered "enormous damage" under Donald Trump. A Pentagon spokesman said it had been "completely transparent". Mr Biden takes office on 20 January but President Trump has refused to concede. For weeks after the 3 November election, Mr Biden was blocked from receiving key intelligence briefings, an essential and normally routine part of a presidential transition. After Mr. Trump finally agreed to allow the formal transition process last month, Mr Biden praised the White House for its help in the process. But his tone had changed on Monday, Mr Biden spoke after a briefing by national security and foreign policy aides. In a speech which he posted on Twitter, Mr Biden said his team was facing "roadblocks" in the defence department and the Office of Management and Budget. "Right now, we just aren't getting all the information that we need from the outgoing administration in key national security areas," he said. "It's nothing short, in my view, of irresponsibility." The president-elect added that his team needed a "clear picture of our force posture around the world" and that US adversaries could exploit any confusion that resulted. Classic example of faction fighting in my opinion, if not, actions would have been taken.

North Korea's leader Kim Jong-un has admitted his five-year economic plan for the isolated country failed to meet its targets in "almost every sector". He was speaking at the opening of a rare congress of his ruling Workers' Party - only the eighth in its history. North Korea closed its borders last January to prevent the spread of Covid-19, despite claiming to have no cases of the virus. That has left it cut off from its neighbour and ally, China. Trade between the two has plummeted by about 80%. Typhoons and floods have devastated homes and crops in North Korea, which remains under strict international sanctions, including over its nuclear programme. It is not unusual for Mr Kim to admit mistakes - in fact, it is quickly becoming one of his trademarks, the BBC's Laura Bicker

Congress handed Donald Trump a major, bipartisan defeat in the waning days of his presidency, as the Republican-led Senate voted to override his veto of a \$740.5 billion defense policy bill. The final tally was 81 to 13, easily exceeding the two-thirds threshold needed to override a veto, with support coming from both Republicans and Democrats as it did earlier in the House. The massive annual defense authorization measure now will become law. Trump had sought to intimidate GOP senators into voting to sustain his veto, unleashing a bitter attack on fellow Republicans as the chamber prepared to begin the override process. "Weak and tired Republican 'leadership' will allow the bad Defense Bill to pass," Trump tweeted Dec. 29. "Negotiate a better Bill, or get better leaders, NOW!" he added. You see how they fought to get a war bill passed but not to pass the stimulus bill, at which point will Americans see the clowns are not there for their benefit. Does anyone ask who or what are we fighting to spend \$3/4T on defense, that is riddled with corruption and fraud as they have previously admitted? As President Donald Trump scrambles to fuel claims of a stolen election in the final days of his administration, the nation's 10 living secretaries of Defense warned Sunday that the U.S. military should have no role in determining the outcome of a U.S. election. We did not swear it to an individual or a party," penned Defense secretaries Mark Esper, James Mattis, Ash Carter, Chuck Hagel, Leon Panetta, Dick Cheney, William Cohen, Robert Gates, William Perry and Donald Rumsfeld. "Efforts to involve the U.S. armed forces in resolving election disputes would take us into dangerous, unlawful and unconstitutional territory," wrote the former Defense secretaries. "Civilian and military officials who direct or carry out such measures would be accountable, including potentially facing criminal penalties, for the grave consequences of their



actions on our republic," they added. Typical one sided reporting again, and typical globalist names crop up again. China will overtake the US to become the world's largest economy by 2028, five years earlier than previously forecast, a report says. The UK-based Centre for Economics and Business Research (CEBR) said China's "skilful" management of Covid-19 would boost its relative growth compared to the US and Europe in coming years. Meanwhile India is tipped to become the third largest economy by 2030. The CEBR releases its economic league table every year on 26 December. Although China was the first country hit by Covid-19, it controlled the disease through swift and extremely strict action, meaning it did not need to repeat economically paralysing lockdowns as European countries have done. As a result, unlike other major economies, it has avoided an economic recession in 2020 and is in fact estimated to see growth of 2% this year. Despite tears and pleas, the anxious couple were sent home by officials who said more tests were needed, they were told to call the hospital for updates. Then, doctors asked him to sign a document authorising the cremation of their child, as required by law in Sri Lanka. Mr Fahim refused: the cremation of bodies is forbidden in Islam, considered a form of mutilation, forbidden by Allah. A host of new billionaires who have emerged in 2020, their fortunes propelled by a stock market surge as investors flocked to companies involved in the development of vaccines, treatments, medical devices and everything in between. Altogether, Forbes found 50 new billionaires in the healthcare sector in 2020. The most notable newcomers of the year are the scientists behind the two most successful vaccines for the corona virus — one developed by Pfizer and German biotech firm BioNTech, the other by Massachusettsbased Moderna — who have seen their net worths skyrocket since January: Uğur Sahin and Stéphane Bancel, virtually unknown at the outset of 2020, both men are now billionaires several times over. BioNTech CEO Sahin, who cofounded the firm with Özlem Türeci, his wife and the firm's chief medical officer — she owns no shares in the company — is now worth \$4.2 billion; his French counterpart at Moderna, Stéphane Bancel, has a \$4.1 billion fortune. Moderna's meteoric rise also produced two more billionaires among its earliest investors, Harvard professor Timothy Springer and MIT scientist Robert Langer. Those vaccines will require billions of glass vials to safely transport them — enter Italy's Sergio Stevanato, a new billionaire and the majority shareholder in the privately-owned Stevanato Group, which is making glass vials for several dozen vaccine efforts around the world. It's not just vaccines: companies developing antibody treatments and drugs to help doctors fight the virus have also benefited from the market frenzy. Carl Hansen, the CEO of Canadian biotech outfit AbCellera, is now worth \$2.9 billion after his company went public on December 11, fueled by the Food and Drug Administration's approval last month of its antibody treatment developed with pharma giant Eli Lilly. Even the firms working behind the scenes to help larger companies test new drugs and devices have seen their stock prices reach new highs. August Troendle, the founder and CEO of Cincinnati-based contract research firm Medpace, is now worth \$1.3 billion thanks to a nearly 70% jump in the company's shares since the beginning of the year. The new moguls hail from 11 different countries, but the majority live in China, the early epicenter of Covid-19, which is now home to nearly three dozen new healthcare billionaires — chief among them is Hu Kun, the chairman of medical device manufacturer Contec Medical Systems, which went public on the Shenzhen stock exchange in August. Contec's shares have risen nearly 150% since the IPO on the back of strong overseas sales of products ranging from pulse oximeters to pulmonary devices used for checking lung conditions, all of which have become more necessary with the spread of Covid-19 throughout the globe. Anyone making money to that level on the health of others is sick and twisted, and a complete waste of a human vessel.

A recently elected US lawmaker has died from Covid-19 - the first member of the US Congress to die from the disease. On December 18, 2020, during the COVID-19



pandemic, Rep-Luke Letlow announced that he had tested positive for the virus. He was hospitalized in Monroe, after his condition deteriorated, he was transferred to the intensive care unit of Ochsner LSU Health Shreveport on December 23. On December 29, Letlow died of complications of COVID-19 at the age of 41, five days before he was scheduled to be sworn into office. The hospital reported that he had no underlying conditions when admitted but died in the ICU of a heart attack after a procedure. 6 of 7 condolences all said the words heartbroken or broken hearts. Pennsylvania State Representative Mike Reese died on Saturday from an apparent brain aneurysm. Rep. Mike Reese died at Excela Health Westmoreland Hospital with his family by his side. With the COVID-19 vaccinations being rolled out, some are concerned they may be mandated in the future. On Friday, a group rallied outside the Liberty Pole. In a thinly-veiled swipe at the UK, the US firm warned that any 'alternative' dosing regimens should be closely monitored by health authorities. 'Data from the phase three study demonstrated that, although partial protection from the vaccine appears to begin as early as 12 days after the first dose, two doses of the vaccine are required to provide the maximum protection against the disease, a vaccine efficacy of 95 per cent,' Pfizer said in a statement. 'There are no data to demonstrate that protection after the first dose is sustained after 21 days.' Well, fall has arrived, bringing a surge of corona virus cases in the US and Europe. After weeks of steady increases, America reached the third peak of its COVID-19 epidemic on Friday, its highest yet with over 80,000 cases. But the flu epidemic isn't where experts expected it to be, Doctors in the US and UK have noted a drop in flu deaths so far this season. now doctors just have to put two and two together outside of John Hopkins maths. hello mcfly. the explanation is tragic: COVID-19 may have already killed the people who would have been most at risk of dying due to flu complications. The interpretation comes from The New York Post, which says the flu deaths are down two-thirds from the five-year average. Federal estimates show no flu deaths for the week ending October 17th, compared to the average of 17 fatalities for the period. The state and the city recorded no flu deaths, matching the five-year average for each. The flu season is just a few weeks old, and that could partly explain the problem. The UK registered 1,132 flu and pneumonia deaths last month, 28% lower than the five-year monthly average of around 1,500. The UK's Office for National Statistics thinks that the drop is because the people who would have been vulnerable to the flu have already died this spring from COVID-19. Or maybe in the real world those that died of Covid have already died of the flu? is that too sensible a statement for their world? The report notes that pneumonia deaths have dropped in the US for the week of October 17th by 60%. The five-year average is at 3,106 deaths for the week, but only 1,251 people died of pneumonia during the period. Statistics for the southern hemisphere, which experienced its flu season during the summer, further indicates that the protective measures that various nations imposed this year can explain the unexpected drop in flu cases. The flu epidemic was almost absent south of the Equator, surprising health experts.

Just 388 people aged under 60 with no underlying health conditions have died of Covid-19 in England's hospitals since the start of the pandemic, NHS data has showed. The figures show that 1,979 previously healthy people died in hospitals in England after testing positive for Covid-19 between April 2 and December 23. Just 338 of these people were aged 40 to 59, with another 44 aged between 20 and 39, and just six under the age of 19, according to the data. UK death rates: In 1978 the death rate per 1000 people was 11.920, which was 0.012%, by 2013 it was down to 9.044 in 2018 it was 9.382, 2019 it was 9.398 and in 2020 it is 9.413 which is 0.009%

If you believe the fake media and factcheckers many bots are lining up for the vaccines, this story says different. Many employees at Howard University Hospital in Washington, D.C., have reservations about taking the COVID-19 vaccine, and CEO Anita Jenkins is trying to get workers to follow her lead by getting vaccinated, according to CNN. The hospital, a major healthcare provider for the Black community, received 725 doses of the Pfizer vaccine Dec. 15 and expects to receive a second shipment this week. As of Dec. 18, only about 600 of the hospital's 1,900 employees had signed up for the shots, according to Kaiser Health News. "There is a high level of mistrust and I get it," Ms. Jenkins told Kaiser Health News. "People are genuinely afraid of the vaccine." The vaccination numbers, though low, still exceeded expectations, Ms. Jenkins told CNN. An internal hospital survey of about 350 employees in early November showed that 70 percent were not willing to take the COVID-19 vaccine or would not take it immediately after it became available. Ms. Jenkins received the shot Dec. 15 in hopes of inspiring staff



to get vaccinated. So, if Ms. Jenkins advocates it, add her name to an indemnity form for the vaccine, she then becomes personally responsible for adverse effects, should you have to take it. Why is Howard University Hospital critical? Because the hospital is located in a predominantly Black community. And we all know that Black people make great guinea pigs, as stated by Black activist Kevin Jackson. About 35 percent of Black Americans said they probably or definitely would not get the vaccine if it was determined to be safe by scientists and widely available for free, according to a Kaiser Family Foundation study cited by CNN. Howard University Hospital isn't the only healthcare provider with workers who turned down the vaccine. At Doctors Hospital at Renaissance in Edinburg, Texas, so many workers declined the COVID-19 vaccine that the hospital offered doses to other medical workers in the region. The hospital received 5,850 doses of the vaccine, and it quickly became clear that not enough people eligible for the vaccine, like staff who work directly with COVID-19 patients, were opting to get it, DHR Health CMO Robert Martinez, MD. "You start to see similar numbers across the country, all this mistrust and misinformation," Dr. Martinez said. After the first day of distribution, DHR reached out to other hospitals and healthcare facilities in the region to offer doses of the vaccine. ProPublica reported that the vaccine ended up going to non-medical personnel as well, including state Sen. Eddie Lucio Jr. He told ProPublica he was invited to take the vaccine by DHR after officials explained to him that all eligible workers who wanted the vaccine received it.

The suit alleges the FBI has contracted with companies like GrayShift, which makes a passcode-cracking tool that works on some iPhones, and CheckPoint Technologies, which "permits detailed microscopic views of electronics hardware in a way that could assist investigators with determining secret encryption keys stored on hardware." A job posting for the EDAU even admitted the division extracts data from locked iPhones, according to the filing - yet the FBI refuses to admit as much to the public. Indeed, its response to the ACLU's FOIA requests consisted entirely of "can neither confirm nor deny" non-responses. The suit merely asks the FBI to cough up the requested records, allowing iPhone users to at least understand the extent to which the agency can hack into their phones. The notion that the agency can 'neither confirm nor deny' the existence of any records about a publicly-known unit within itself is ludicrous, the filing states. While the FBI was publicly rebuffed in 2016 when it demanded the password to a mass shooter's iPhone, the agency has since purchased tools from multiple companies that have allowed it to gain access to encrypted devices. Even as Apple plugs the vulnerabilities, law enforcement has allegedly contracted with multiple companies to continue to gain



access to the supposedly privacy-prioritizing devices. In 2001, Matser wrote for NATO Review on "NATO-Russia relations in the wake of 11 September and the prospects for improved cooperation". On 3rd February 2003, Willem Matser, then aged 50, was arrested in his office at NATO HQ in Brussels on suspicion of laundering around USD 200 million for a Colombian drug cartel. Police seized a \$200,000 transaction document issued by Bank Santander in Bogota, Colombia in favour of Tender SA, together with a CD detailing a \$200,000,000 transfer to the company. Matser was arrested with Pietro Fedino, aged 64, an Italian crime boss connected to the Columbian Cali cartel. The judge expressed sympathy with Matser, saying that as there were no previous convictions against him and since his actions were not solely for personal gain, a shorter sentence was more suitable. Matser was sentenced to 14 months in prison, but was ordered released because he has already served two-thirds of the sentence in pretrial detention, he was given three years' probation. His co-accused, Pietro Fedino and Willem van Voorthuizen of Nijmegen, were respectively sentenced to jail



terms of 15 and 18 months of which three months was suspended. The unusual surname "matser" facilitates exploration of reporting on the case. Commercially-controlled media reporting of the case has been very low. No US newspapers or TV channels are known to have reported on the arrest, trial or sentencing of Willem Matser. The Washington Post has made no mention of "Matser" since 2005 (earlier references are paywalled). In the middle of January 2004, the Times of London had a short, 48 words article about the matter as an agency news item from AFP. "This is why (...) even though the FBI routinely monitored the communications of the diplomatic arms of all countries, only four countries were exempt from this protocol – the UK, Turkey, Azerbaijan, and Belgium – the seat of NATO. No other country – not even allies like Israel or Saudi Arabia, were exempt. This is because these four countries were integral to the Pentagon's so-called Gladio B operations."

The Royal Institute for International Affairs - also known as Chatham House - is an organ of the UK Deep state. It was founded in 1920 and is a lynchpin of the British Foreign Policy establishment. The Chatham House Rule requires confidentiality of all meeting participants and prohibits attribution of comments. The current (2010) chairman of the council of Chatham House is the former CIA operative Dr DeAnne Julius and the Director (until the end of 2006) was Victor Bulmer-Thomas. The Royal Institute of International Affairs was founded in 1920 as the Institute of International Affairs following a meeting at the previous year's Paris Peace Conference. This group was the precursor to the United Nations. The first chairman was Robert Cecil, 1st Viscount Cecil of Chelwood, while Lionel Curtis served as honorary secretary. Arnold J. Toynbee later became director. The Council on Foreign Relations, its American sister institute, was established the following year. Chatham House, The RIIA's well-known headquarters at 10 St James's Square, London, was gifted to the institute in 1923, having previously been the home of three British Prime Ministers: Pitt the Elder, Edward Stanley and William Gladstone. The name of the building grew to be so synonymous with the Institute that it was officially rebranded as "Chatham House" in September 2004. However, "Royal Institute of International Affairs" continues to be used interchangeably with "Chatham House". The Chatham House building is located just a few metres from the former Libyan embassy building, and many long term staff members witnessed the 1984 Libyan Embassy Siege. On July 18, 2005, Chatham House released a paper on Security, Terrorism and the UK which stated that "[a] key problem for the UK in preventing terrorism in Britain is, the government's position as 'pillion passenger' to the United States' war on terror." Chatham House conducts original research into a variety of regional and global issues, and describes itself as follows. We provide an independent forum in which academia, business, diplomats, the media, NGOs, politicians, policy makers and researchers can interact in an open and impartial environment. The widespread recognition of the Chatham House Rule, as a byword for free and frank debate is a reflection of our unique and non-aligned perspective, free and frank debate oh my they just, pro pagan da and frankish debate is the real terminology. Chatham House is routinely used as a source of information for media organizations, seeking background or experts upon matters involving major international issues. This means they are scripted narrative of lies writers to formulate an opinion for the gullible public. Chatham House reflects a pro-establishment view of the world (due to donations from large corporations, governments and other organisations), but is nevertheless membership-based and anyone may join. Sponsors: Bill & Melinda Gates Foundation, Norway Ministry of Foreign Affairs, Open Society Foundation(Soros) and Rockefeller Foundation.

After serving his 30 years sentence, Pollard was released November 20, 2015, and placed on parole in accordance with federal guidelines in place at the time of his sentencing. On November 20, 2020, the parole expired and all restrictions were removed, and Pollard was a free man. On 29 December 2020, Pollard and his wife left the United States and arrived in Israel on a private plane provided by American casino magnate Sheldon Adelson, a major funder and board member of the Republican Jewish Coalition, a pro-Israel lobbying group, and a billionaire supporter of the GOP, and both Netanyahu and President Trump. Over nine years, the Soviet spy handed over information that led to the betrayal of at least 40 MI6 agents in Eastern Europe. He was jailed in London in 1960, but escaped in 1966 and fled to Russia. The Russian Foreign Intelligence Service said Blake "had a genuine love for our country". Blake himself worked for the Dutch resistance during World War Two, before fleeing to British-controlled Gibraltar. He was later, due to his background, asked to join the intelligence service. In an interview with the BBC in 1990, Blake said he estimated that he betrayed more than 500 Western agents but he denied suggestions that 42 of them had lost their lives as a result of his actions. His downfall came when a Polish secret service officer, Michael Goleniewski, defected to the West, bringing his mistress and details of a Soviet mole in British intelligence. Blake was recalled to London and arrested. At a subsequent trial he pleaded guilty to five counts of passing information to the Soviet Union. George Blake did enormous damage to British intelligence operations during the Cold War, betraying agents and secret operations and showing that the KGB could run agents within the heart of the British state. Oh I forgot to mention that George Blake was not Russian at all, but was Jewish working for the KGB, and the truth bell rings again for the FRWL series.

The title of the book is "2020" and it was published in 1994 by an Israeli editorial house called Keter Press, which literally translates to "Crown" or "Corona" Press. bought Macmillian, which then owned Keter. The publishing house was passed on to an Israeli investment concern called Arledan after Maxwell's death in 1991, which owned it until 2016. Arledan has companies in America, Germany and Canada, all are vulture capitalists, ran by Elliot Shiff, born to, from a shell company based in fake Jerusalem. Robert Maxwell's links to Israeli intelligence has been well documented, by Whitney Webb for MintPress News in her series on Jeffrey Epstein, who ran a sex-trafficking blackmail operation with his daughter, Ghislaine. Just two weeks after it was announced China was developing biologically enhanced super soldiers, France has joined the fray in creating terminator troops that can be "bred to kill" according to a new report. Last week, France gave the go-ahead for augmented soldiers, and some fear the super troopers could be the new norm in the recent future. The French seek to improve "physical, cognitive, perceptive and psychological capacities," and could allow for location tracking or connectivity with weapons systems and other soldiers. Among the ministry's research were drugs to keep troops awake for long periods of time and combat stress, and even surgery to improve hearing. The new species of augmented soldiers, dubbed "homo robocopus" could also have altered DNA to give them enhanced speed and strength as well as robotics. Michael Clarke, visiting professor in war studies at Kings College London (KCL), told the Sun participating could be "using DNA as a farmer would in a herd of cattle." "We've reached the point now where we could potentially manipulate people's DNA to breed into them extra strength, endurance and other things just as we do with animals," Clarke said. "Just as we've done with standard cattle to give them more back, we can do that now very precisely with humans." Clarke added that the bio-race is being fueled internationally due to fears of China's program. "What they're all thinking about is what might come up in 30 years' time, given another 10 years development and experimentation," Clarke told the paper. "The Chinese in 30 years' time might have a cohort of people who are 20 years old who've got particular characteristics they might have tried to breed into them by manipulating DNA." Due to DNA manipulation, future soldiers could also be immune to disease and feelings. A recent report by the International Society for Military Ethics in Europe obtained by the Sun, reveals a dystopic arena full of bionic men capable of fighting "all the time." "Enhanced soldiers would be reduced to bionic men, who run fast, do not need sleep, eat and drink very little, and can fight all the time," the report states. "A new species is born: Homo robocopus." Sir Lawrence Freedman, Professor of war studies at KCL, told the Sun robotics are of more importance: "There are people going back into combat in ways they wouldn't have been able to before because prosthetics have been improved. You can



use Google glasses, there's lots of things you can now do with a modern soldier that makes them much more effective than they were in the past. If you want people to act just according to orders going in to great danger, the other trend you can see that is pretty active at the moment is drones, autonomous vehicles and so on." While France claims it will abide by humanitarian law, French armed forces minister Florence Parly warned, "we have to be clear, not everyone has the same scruples as us and we have to prepare ourselves for such a future," she said. Here is some of the tech in progress to create "homo robocopus," according to the Sun. Brain microchips — France has been given the all-clear to develop microchips to enhance soldier brain power. Bionic eyes — Being developed in Hong Kong, this gives users infrared and night vision. Super hearing — The US's Tactical Communication and Protective System are smart earbuds which boost soldiers' hearing to be near superhuman. Health implant — DARPA, the Pentagon's research arm, is developing cyborg implants to monitor combat efficiency. Develop or developing in their world is the same as the use of Dystopian being the future when it is past or now, the correct term is we have developed. Enhanced limbs — A Devcom report revealed plans to equip US soldiers with enhanced limbs for increased strength. Exoskeleton legs — The US Army has tested an exoskeleton which can be attached to soldier's legs and can increase their productivity by up to 27 times. Synthetic blood — Respirocyte is a theoretical red blood cell that could help soldiers not get out of breath and stay underwater for hours. Pain immunity — DARPA's Persistence in Combat initiative would allow soldiers to have their pain suppressed for 30 days.
