A Kenyan man has pleaded not guilty in a US court to trafficking illegal ivory and rhino horn. Mansur Mohamed Surur was part of an "international conspiracy" responsible for the slaughter of more than 100 elephants and dozens of rhinos, federal prosecutors in New York say. It allegedly amounts to an estimated \$7.4m (£5.4m) amassed over seven years. Some exports were hidden inside "pieces of art such as African masks and statues", court documents allege. Money was paid to and from foreign customers by "international wire transfers, some which were sent through US financial institutions", prosecutors say. Mr Surur was arrested last year in the Kenyan city of Mombasa and extradited to the US to face trial in New York. He also faces charges of money laundering and drug dealing. He and three others - Amara Cherif from Guinea, Moazu Kromah of Liberia, and Abdi Hussein Ahmed of Kenya are accused of agreeing illegal ivory sales with buyers in Manhattan, as well as others in south-east Asia. Whilst I applaud the arrest of these people who cause animals to suffer or die, I fail to see why the purchasers are not arrested as well? If there was no market for these items, there would be less of these people doing this stuff, in my opinion the buyers are equally responsible. We have to generate more business opportunities for the Africans to stop people doing this, slavery, trafficking and drugs as their only avenue to generate income.

The billionaires' wealth grew so much that they could cut "every man, woman and child in the country" a \$3,000 stimulus check and "still be richer than they were nine months ago, "ATF executive director Frank Clemente said in a Tuesday press release. The report tracked the fat-cats' profits from March 18, the approximate start date of the economic shutdowns, through December 7. The vast majority accelerated their accumulation of wealth, even as ordinary Americans saw their life savings slip through their fingers, losing jobs, businesses, and loved ones to the one-two punch of the corona virus and the political response. After nine months of raking in the cash, the billionaires' total wealth had soared 36 percent to over \$4 trillion, nearly twice the \$2.1 trillion in wealth held by the poorest 50 percent of Americans. The monstrous cash-pile amounts to double the two-year budget gap of all state and local governments, a figure estimated to reach \$500 billion thanks to the devastating effects of the economic shutdowns on tax revenues. It even approaches the massive sum the federal government spends on Medicare and Medicaid, \$644 billion and \$389 billion in 2019, respectively, the report claims. While most working and middle class Americans received a single stimulus payment of \$1,200 as part of March's CARES Act pandemic bailout, the promised second stimulus check has failed to materialize from July onwards, until after the election and then it became a political grandstanding item. The expanded unemployment program that doled out \$600 per week to newly-jobless Americans came to an end in July, and while President Donald Trump issued an executive order to bridge the gap with a less generous \$300 weekly payment. One of the chief beneficiaries of the fiscal explosion has been Amazon founder Jeff Bezos, whose personal fortune increased 63 percent since March, as locked-down Americans turned to online shopping to meet their needs. We warned of this several times last year, nice to see others focusing on the shit show these greed based harvesters, have deliberately engineered for themselves.

Leon Black, who founded Apollo Global Management Inc. three decades ago in the aftermath of one scandal, is retiring as chief executive in the aftermath of another, this one involving the notorious sex offender Jeffrey Epstein. Just months after Apollo announced an internal investigation into Black's long association with the late financier, the investment firm said in a statement Monday, that he would retire as CEO no later than July 31 and would remain chairman. Marc Rowan, one of Black's top lieutenants, will succeed him as CEO. In a statement, Apollo said an outside law firm hired to conduct the review found that, Apollo never retained Epstein for any services, and that Epstein never invested in any Apollo-managed funds. The law firm, Dechert, also found no evidence that Black, 69, was involved in any way with Epstein's criminal activities at any time. So. because Dechert who no one knows who they are, said that was the case, we all have to believe them? One of Dechert's lead people are Henry Nassau which has links back to the

House of Orange. This tells me this Management group are connected to Mossad and Isis, which is Israeli Secret Intelligence Service, just like Epstein was. Australia has approved at least 14 permits for the export of military goods to Saudi Arabia and United Arab Emirates over the last year and a half, despite their involvement in the Yemen conflict which has created a humanitarian crisis. Department of Defence has also revealed it has approved permits for \$580,000 of military goods to Turkey since late 2019, even though the defence minister, Linda Reynolds, announced a "pause" of such exports at that time because of, concerns the country's incursion into north-east Syria was "causing great civilian suffering". The latest figures have prompted calls for the Australian government to show more transparency, in the way it discloses exports of weapons and other military goods, which are shrouded in secrecy. You can thank ASIO and Pine Gap for that secrecy. "It is deeply disturbing that our government could allow weapons to be sold to Saudi Arabia and the United Arab Emirates, who the UN has said are responsible for breaches of international humanitarian law, including the killing of children, in Yemen," the chief executive of Save the Children Australia, Paul Ronalds, said. The government has not released information about the particular equipment that has been exported, arguing such details were "commercial in confidence". But it said such goods can include weapons and munitions but also armour, radios, simulators and training equipment "which are not necessarily for a military purpose". You know why they did this? to help the Israelis again, that is where all these arms deals leads back to. With Israel already having Saudi Arabia in it's puppet pack, and recently the UAE did a deal formalizing relations with Israel, well now you know why that treaty went ahead.

Google has threatened to remove its search engine from Australia over the nation's attempt to make the tech giant share royalties with news publishers. Australia is introducing a world-first law to make Google, Facebook and potentially other tech companies pay media outlets for their news content. But the US firms have fought back, warning the law would make them withdraw some of their services. Australian PM Scott Morrison said lawmakers would not yield to "threats". Australia is far from Google's largest market, but the proposed news code is seen as a possible global test case for how governments could seek to regulate big tech firms. Tech firms have faced increasing pressure to pay for news content in other countries, including France, where Google struck a landmark deal with media outlets on Thursday. In Australia, the proposed news

code would tie Google and Facebook to mediated negotiations with publishers over the value of news content, if no agreement could be reached first. Google Australia managing director Mel Silva told a Senate hearing on Friday that the laws were "unworkable". "If this version of the code were to become law, it would give us no real choice but to stop making Google Search available in Australia," she said. Australia's news industry is struggling. Of every A\$100 (£56; \$77) spent on digital advertising, A\$81 goes to Google and Facebook. And Covid-19 has only made this worse. With companies reducing their digital advertising spend, a number of outlets in Australia have been forced to close. Google, by contrast, has been performing well. Last year the social media giant made almost \$4bn from Australia, while paying \$45m in tax. Meanwhile, Australia's competition watchdog has accused both Facebook and Google of misleading Australian consumers about how their data is used, launching inquiries into digital advertising and the app stores market. Just ban Go ogle in every country, we don't need their input into our internet experience, riddled with data mining, harvesting, spying and adverts, which consumer actually wants any of those experiences?

President Biden is seeking a five-year extension with Russia on the only remaining treaty limiting the world's two largest nuclear arsenals just days before it expires, said two senior U.S. officials. At the same time, his administration is preparing to impose new costs on Russia pending a newly requested intelligence assessment of its recent activities. The officials said Biden is ruling out a "reset" in bilateral relations with Moscow, as many U.S. presidents have done since the end of the Cold War. "As we work with Russia, so, too, will we work to hold Russia accountable for their reckless and aggressive actions that we've seen in recent months and years," said a senior U.S. official, who like others spoke on the condition of anonymity to discuss a sensitive security matter. You didn't complain about their reckless attempt to save your nation and it's people twice in the 1800's, did you? Aggressive actions? haha, America has invaded 81 countries since WW2, not one of those countries has attacked America, aggressive actions indeed, pot calling the kettle springs to mind. The decision to seek a five-year treaty extension, which Russia supports but the Biden administration hadn't settled on until now, reflects the rapidly approaching deadline for Washington to renew the New START pact Feb. 5, the officials said. President Donald Trump tried to conclude a shorter extension with Moscow in the final months of his presidency, but he failed to reach an agreement after his nuclear envoy spent months, trying to persuade China to join the accord before dropping that demand. Letting the treaty expire would allow Moscow and Washington to deploy an unlimited number of nuclear-armed submarines, bombers and missiles in what many experts fear could spark a nuclear arms race and further exacerbate U.S.-Russia relations. They deploy unlimited anyway, and these deals and treaties are rarely what they are stated for, and largely used to generate more income for global warmongerers like Lockheed Martin, Boeing and Northrup Grumman amongst others.

Here is the latest appointees of Biden, Sec. of the Treasury is Janet Yellen, Sec. of State is Anthony Blinken, Dep. At least a thousand National Guard members brought in to secure the Capitol ahead of President Biden's inauguration, are taking rest breaks outside and in nearby parking garages, photos showed. Guard members were forced to vacate congressional grounds on Thursday, after spending two weeks protecting the city following a deadly riot at the Capitol on Jan. 6. "Yesterday, dozens of senators and congressmen walked down our lines taking photos, shaking our hands, and thanking us for our service," a guard member told Politico. "Within 24 hours, they had no further use for us and banished us to the corner of a parking garage. We feel incredibly betrayed." One unit, which had been resting in the Dirksen Senate Office building, was told to leave the facility and later forced to rest in a nearby parking garage with no internet reception, one electrical outlet, and one bathroom with two stalls for 5,000 troops, Politico reported, citing the guard member. "There really may be an important reason for us to vacate, and it just hasn't been well communicated yet," another guard member said. Guard spokesman Maj. Matt Murphy said while U.S. Capitol Police were asked to move their rest area, the troops are ready to provide additional security if needed. "As Congress is in session and increased foot traffic and business is being conducted, Capitol Police asked the troops to move their rest area," Murphy said. "They were temporarily relocated to the Thurgood Marshall Judicial Center garage with heat and restroom facilities. We remain an agile and flexible force to provide for the safety and security of the Capitol and its surrounding areas." Upon hearing the news, Sen. Kyrsten Sinema offered her office for the troops. "This is outrageous, shameful, and incredibly disrespectful to the men and women keeping the U.S. Capitol safe and secure. We need it fixed and we need answers on how it happened," Sinema said in a tweet. After being in tight quarters with limited bathroom access, at least 100 guard members tested positive for COVID-19. Some are quarantining in hotels. Following that event the Florida Governor Ron DeSantis ordered more than 600 National Guard troops to return home from Washington, DC. DeSantis questioned the reason for troops being in DC at all, calling it a "half-cocked mission at this point". "They are soldiers," the governor said. "They are not Nancy Pelosi's servants." Over 20,000 soldiers were brought to DC following the US Capitol riot on January 6, and many remained in place for Joe Biden's recent inauguration. Just 24 hours after Donald Trump formally left the White House and the presidency behind, it's increasingly clear that his money problems are getting worse, not better. According to financial disclosure documents released in the hours after Trump left the White House to fly to his new home in Florida, the ex-President's eponymous company took a major revenue hit over the last year. Overall, Trump's businesses produced almost 40% less revenue in 2020 versus 2019, he made \$30 million less at his Doral property in Miami than he did in 2019. Revenue at the Trump International Hotel in Washington and the former President's Turnberry property in Scotland, were down more than 60% year over year. Those downturns came even before a series of companies cut ties, following Trump's role in the incitement of rioters who stormed the US Capitol on January 6. While some maybe much of the downturn in Trump's financial fortunes, can be laid at the feet of the ongoing corona virus pandemic and the societal restrictions, it has forced on all of the travel and hospitality industry, the "why" of Trump's falling fortune matters far less than the "what now." They have been proposed to provide an effective means of genetically modifying specific populations and entire species. The technique can employ adding, deleting, disrupting, or modifying genes. Proposed applications include exterminating insects that carry pathogens (notably mosquitoes that transmit malaria, dengue, and zika pathogens), controlling invasive species, or eliminating herbicide or pesticide resistance. As with any potentially powerful technique, gene drives can be misused in a variety of ways or induce unintended consequences. For example, a gene drive intended to affect only a local population might spread across an entire species. Gene drives used to eradicate populations of invasive species in their non-native habitats, may have consequences for the population of the species as a whole, even in its native habitat. Any accidental return of individuals of the species to its original habitats, through natural migration, environmental disruption (storms, floods, etc.), accidental human transportation, or purposeful relocation, could unintentionally drive the species to extinction if the relocated individuals carried harmful gene drives. "It is very much easier to kill or sterilise a plant using gene editing than it is to make it herbicide or insect-resistant." Guy Reeves, expert in GM insects at the Max Planck Institute for Evolutionary Biology. Gene drives can be built from many naturally occurring selfish genetic elements that use a variety of molecular mechanisms. These naturally occurring mechanisms induce similar segregation distortion in the wild, arising when alleles evolve molecular mechanisms that give them a transmission chance greater than the normal 50%. Most gene drives have been developed in insects, notably mosquitoes, as a way to control insect-borne pathogens. Recent developments designed gene drives directly in viruses, notably herpes viruses. These viral gene drives can propagate a modification into the population of viruses, and aim to reduce the infectivity of the virus. In December 2017, documents released under the US Freedom of Information Act showed that the military research agency DARPA had invested \$100 million in gene drive research, making them likely the largest single funder of gene drive research on the planet. The documents also reveal that DARPA either funds or co-ordinates with almost all major players working on gene drive development, as well as the key holders of patents on CRISPR gene editing technology. "Given that Darpa is a military agency, we find it surprising that the obvious and concerning dual-use aspects of this research have received so little attention," Felix Beck - lawyer at the University of Freiburg The secretive top-level JASON group of military advisors produced a classified study on gene drive in 2017, reflecting an extremely high level of interest and activity by other sections of the U.S. military and Intelligence community. Emails show that the JASON study was initiated with a two day meeting of a select group of invited gene drive researchers in June 2017. At the meeting, the VP of Global Biotechnology for Monsanto gave a presentation on crop science and gene drives. The Intelligence Advanced Research Projects Agency (IARPA), an organization within the Office of the Director of National Intelligence, has also expressed interest in funding gene drive work. A scientist involved

describes IARPA as "basically the intelligence agencies version of DARPA, which may be more frightening" The Bill and Melinda Gates Foundation paid a PR firm \$1.6 million to secretly stack key UN advisory processes with gene drive-friendly scientists, and recruited ostensibly independent academics and public officials into a private collaboration to counteract proposed regulations, and to resist calls by scientists and conservationists for an international moratorium. Target Malaria, a project funded by the Bill and Melinda Gates Foundation, invested \$75 million in gene drive technology. The foundation originally estimated the technology to be ready for field use by 2029 somewhere in Africa. However, in 2016 Gates changed this estimate to some time within the following two years. So, this gene editing was ready in 2018 then, connecting the dots now? Because Target Malaria hopes to deploy their gene drives in African countries, they have been at pains to emphasize independence from military agendas. However, Target Malaria's Andrea Crisanti (working at Imperial College) is also a lead grantee or subcontractor for DARPA's Safe Genes project, having confirmed he has been hired by DARPA on a \$2.5m contract. Imperial College London has been a pioneer in gene drive research, with DARPA funding. In trials 2016-2018, scientists succeeded in destroying a population of mosquitoes in a lab, by introducing a genetic mutation that spread through the population and eventually sterilized all of the mosquitoes. In previous experiments, mosquitoes had small random mutations that immunized them against the gene drive. The Imperial College scientists created a gene drive that did not fall prey to this type of resistance. Since it can never more than double in frequency with each generation, a gene drive introduced in a single individual typically requires dozens of generations to affect a substantial fraction of a population. Alternatively, releasing drive-containing organisms in sufficient numbers can affect the rest within a few generations; for instance, by introducing it in every thousandth individual, it takes only 12-15 generations to be present in all individuals. Whether a gene drive will ultimately become fixed in a population and at which speed, depends on its effect on individuals fitness, on the rate of allele conversion, and on the population structure. In a well mixed population and with realistic allele conversion frequencies ($\approx 90\%$), population genetics predicts that gene drives get fixed for selection coefficient smaller than 0.3; in other words, gene drives can be used to spread modifications as long as reproductive success is not reduced by more than 30%. This is in contrast with normal genes, which can only spread across large populations if they increase fitness. Because the strategy usually relies on the simultaneous presence of an unmodified and a gene drive allele in the same cell nucleus, it had generally been assumed that a gene drive could only be engineered in sexually reproducing organisms, excluding bacteria and viruses. However, technological breakthroughs have enabled the design of a gene drive strategy that doesn't involve sexual reproduction, but relies on co-infection of a given cell by a naturally occurring and an engineered virus. "co-infection of a given cell by a naturally occurring and an engineered virus" line screams out right there, does it not? This virus is to test large quantities of people and insert gene altering technology, but who decides the parameters of this program, and as it is being run by military top brass personnel who have almost zero empathy, one has to question where this is all going. Upon co-infection, the unmodified genome is cut and repaired by homologous recombination, producing new gene drive viruses that can progressively replace the naturally occurring population. In cell culture experiments, it was shown that a viral gene drive can spread into the viral population and strongly reduce the infectivity of the virus, which opens novel therapeutic strategies against herpes viruses. Because gene drives propagate by replacing other alleles that contain a cutting site and the corresponding homologies, their application has been mostly limited to sexually reproducing species (because they are diploid or polyploid and alleles are mixed at each generation). As a side effect, inbreeding could in principle be an escape mechanism, but the extent to which this can happen in practice is difficult to evaluate. So, the escape mechanism is to be like all the royalty and elite circles, following their bible cousins and the Egyptian hierarchy, of lets all keep it in the family then. No wonder incest is mentioned 54 times in the bible. Due to the number of generations required for a gene drive to affect an entire population, the time to universality varies according to the reproductive cycle of each species: it may require under a year for some invertebrates, but centuries for organisms with years-long intervals between birth and sexual maturity, such as humans. Hence this technology is of most use in fastreproducing species. Other problematic issues highlighted by researchers include: Mutations: A mutation could happen mid-drive, which has the potential to allow unwanted traits to "ride along". Escape: Cross-breeding or gene flow potentially allow a drive to move beyond its target population. Ecological impacts: Even when new traits' direct impact on a target is understood, the drive may have side effects on the surroundings.' The Broad Institute of MIT and Harvard added gene drives to a list of uses of gene-editing technology it doesn't think companies should pursue. Gene drives affect all future generations, and represent the possibility of a larger change in a living species than has been possible before. In December 2015, scientists of major world academies called for a moratorium on inheritable human genome edits that would affect the germline, including those related to CRISPR-Cas9 technologies, but supported continued basic research and gene editing that would not affect future generations. In February 2016, British scientists were given permission by regulators to genetically modify human embryos by using CRISPR-Cas9 and related techniques on condition that the embryos were destroyed in seven days. In June 2016, the US National Academies of Sciences, Engineering, and Medicine released a report on their "Recommendations for Responsible Conduct" of gene drives. Models suggest that extinction-oriented gene drives will wipe out target species, and that drives could reach populations beyond the target given minimal connectivity between them. Kevin M. Esvelt stated that an open conversation was needed around the safety of gene drives: "In our view, it is wise to assume that invasive and self-propagating gene drive systems, are likely to spread to every population of the target species throughout the world. Accordingly, they should only be built to combat true plagues such as malaria, for which we have few adequate countermeasures

and that offer a realistic path towards an international agreement to deploy among all affected nations.". He moved to an open model for his own research on using gene drive to eradicate Lyme disease (itself a biological weapon released by accident) in Nantucket and Martha's Vineyard. Esvelt and colleagues suggested that CRISPR could be used to save endangered wildlife from extinction. Esvelt later retracted his support for the idea, except for extremely hazardous populations such as malaria-carrying mosquitoes and isolated islands that would prevent the drive from spreading beyond the target area. Austin Burt, an evolutionary geneticist at Imperial College London, introduced the possibility of conducting gene drives based on natural homing endonuclease selfish genetic elements in 2003. Researchers had already shown that such genes could act selfishly to spread rapidly over successive generations. Burt suggested that gene drives might be used to prevent a mosquito population from transmitting the malaria parasite or to crash a mosquito population. Gene drives based on homing endonucleases have been demonstrated in the laboratory in transgenic populations of mosquitoes and fruit flies. However, homing endonucleases are sequence-specific. Altering their specificity to target other sequences of interest remains a major challenge. The possible applications of gene drive remained limited until the discovery of CRISPR and associated RNA-guided endonucleases such as Cas9 and Cpf1. In June 2014, the World Health Organization (WHO) Special Programme for Research and Training in Tropical Diseases issued guidelines for evaluating genetically modified mosquitoes. In 2013 the European Food Safety Authority issued a protocol for environmental assessments of all genetically modified organisms. In sexually-reproducing species, most genes are present in two copies (which can be the same or different alleles), either one of which has a 50% chance of passing to a descendant. By biasing the inheritance of particular altered genes, synthetic gene drives could spread alterations through a population. At the molecular level, an endonuclease gene drive works by cutting a chromosome at a specific site that does not encode the drive, inducing the cell to repair the damage by copying the drive sequence onto the damaged chromosome. The cell then has two copies of the drive sequence. The method derives from genome editing techniques. As a result, the gene drive insertion in the genome will re-occur in each organism that inherits one copy of the modification and one copy of the wild-type gene. If the gene drive is already present in the egg cell (e.g. when received from one parent), all the gametes of the individual will carry the gene drive (instead of 50% in the case of a normal gene). Scientists have designed multiple strategies to maintain control over gene drives. The drosophila drive requires at least thousands of insects for the drive to begin. A few individuals escaping the target region would be unlikely to spread the drive. In 2020 researchers reported the development of two active guide RNA-only elements that, according to their study, may enable halting or deleting gene drives introduced into populations in the wild with CRISPR-Cas9 gene editing. The paper's senior author cautions that the two neutralizing systems they demonstrated in cage trials "should not be used with a false sense of security for field-implemented gene drives". CRISPR is a DNA editing method that

makes genetic engineering faster, easier, and more efficient. The approach involves expressing an RNA-guided endonuclease such as Cas9 along with guide RNAs directing it to a particular sequence to be edited. When the endonuclease cuts the target sequence, the cell repairs the damage by replacing the original sequence with homologous DNA. By introducing an additional template with appropriate homologues, an endonuclease can be used to delete, add or modify genes in an unprecedentedly simple manner. As of 2014, it had been tested in cells of 20 species, including humans. In many of these species, the edits modified the organism's germline, allowing them to be inherited. In 2014 Esvelt and coworkers first suggested that CRISPR/Cas9 might be used to build endonuclease gene drives. In 2015 researchers published successful engineering of CRISPR-based gene drives in Saccharomyces, Drosophila, and mosquitoes. All four studies demonstrated efficient inheritance distortion over successive generations, with one study demonstrating the spread of a gene drive into laboratory populations. Drive-resistant alleles were expected to arise for each of the described gene drives, however this could be delayed or prevented by targeting highly conserved sites at which resistance is expected to have a severe fitness cost. Because of CRISPR's targeting flexibility, gene drives could theoretically be used to engineer almost any trait. Unlike previous designs, they could be tailored to block the evolution of drive resistance in the target population by targeting multiple sequences within appropriate genes. CRISPR could permit a variety of gene drive architectures intended to control rather than crash populations. Gene drives have two main classes of application, which have implications of different significance: Introduce a genetic modification in laboratory populations; once a strain or a line carrying the gene drive has been produced, the drive can be passed to any other line by mating. Here the gene drive is used to achieve much more easily a task that could be accomplished with other techniques. Introduce a genetic modification in wild populations. Gene drives constitute a major development that makes possible previously unattainable changes. Because of their unprecedented potential risk, safeguard mechanisms have been proposed and tested. One possible application is to genetically modify mosquitoes and other disease vectors so that they cannot transmit diseases such as malaria and dengue fever. Researchers have claimed that by applying the technique to 1% of the wild population of mosquitoes, that they could eradicate malaria within a year. A gene drive could be used to eliminate invasive species and has, for example, been proposed as a way to eliminate invasive species in New Zealand. Gene drives for biodiversity conservation purposes are being explored as part of The Genetic Biocontrol of Invasive Rodents (GBIRd) program because they offer the potential for reduced risk to non-target species and reduced costs when compared to traditional invasive species removal techniques. Given the risks of such an approach described below, the GBIRd partnership is committed to a deliberate, step-wise process that will only proceed with public alignment, as recommended by the world's leading gene drive researchers from the Australian and US National Academy of Sciences and many others. A wider Outreach Network for Gene Drive Research exists to raise awareness of the value of gene drive

research for the public good. Some scientists are concerned about the technique, fearing it could spread and wipe out species in native habitats. The gene could mutate, potentially causing unforeseen problems (as could any gene). Many non-native species can hybridize with native species, such that a gene drive afflicting a non-native plant or animal that hybridizes with a native species could doom the native species. Many non-native species have naturalized into their new environment so well that crops and/or native species have adapted to depend on them. The Predator Free 2050 project is a New Zealand government program to completely eliminate eight invasive mammalian predator species (including rats, short-tailed weasels, and possums) from the country by 2050. The projects was first announced in 2016 by New Zealand's prime minister John Key and in January 2017 it was announced that gene drives would be used in the effort. In 2017 one group in Australia and another in Texas released preliminary research into creating 'daughterless mice', using gene drives in mammals. In 2017 scientists at the University of California, Riverside developed a gene drive to attack the invasive spotted-wing drosophila, a type of fruit fly native to Asia that is costing California's cherry farms \$700 million per year because of its tail's razor-edged "ovipositor" that destroys unblemished fruit. The primary alternative control strategy involves the use of insecticides called pyrethroids that kills almost all insects that it contacts. The transhumanist philosopher David Pearce has advocated for using CRISPR-based gene drives to reduce the suffering of wild animals. Kevin M. Esvelt, an American biologist who has helped develop gene drive technology, has argued that there is a moral case for the elimination of the New World screwworm through such technologies because of the immense suffering that infested wild animals experience when they are eaten alive. Around 1,000 Swedes have received Moderna Covid-19 shots that were kept too cold while being transported, the company in charge of deliveries, Apoteket AB, said on Friday. A total of 2,100 doses of the US-made vaccine that were kept too cold in transit have been delivered to the regions of Gävleborg, Halland, Värmland, Dalarna, and Östergötland, a government spokesperson said. The Swedish Public Health Agency has said there is no risk to those given the Moderna vaccine, but it has halted the rollout and is investigating whether keeping doses too cold may affect the vaccine's efficacy. "We apologize for what happened and consider it an accident," said the deputy health chief of the Gävleborg region, Tina Mansson Söderlund, who also pledged to investigate the incident. "The worst that can happen is that the vaccine is ineffective, and then we will offer new vaccinations," she added. The government's top epidemiologist, Anders Tegnell, told newspaper Dagens Nyheter that an initial assessment of the situation was that those who received the affected doses are in no danger, they said that before the vaccine and yet many have died or suffered, so we take their advice with the salt lake in Utah. Unfortunately, the supplier has made a mistake and delivered the vaccine far too cold, ie at the same level as it would have done with Pfizer's vaccine," he explained. "The moderna vaccine is not made to be moved so cold." In some regions, all the delivered Moderna vaccine doses were administered, while some regions have not yet used up all their doses and are now storing their shots, pending the investigation. A new lawsuit has accused Twitter of turning a blind eye to child pornography on its platform, claiming that it snubbed repeat requests from an underage sex trafficking victim, to remove explicit images obtained through blackmail. The suit, filed by the teenage victim and his mother in the Northern District of California on Wednesday, argues that Twitter refused to pull the sexually graphic videos, on the grounds that they did not violate its policies, allowing them to rack up well over 150,000 views. The plaintiff in the case identified only as "John Doe" in court records, says he was just 13 when he was manipulated, into sharing nude images of himself with a Snapchat user he believed to be a 16-year-old classmate. After he did so, "the correspondence changed to blackmail," the lawsuit claims, adding that the perpetrators threatened to share the photos with the victim's "parents, coach, pastor, and others in his community" if he did not send additional material. He complied with the traffickers' demands, sending sexually explicit videos of himself, some of which included another minor. At some point in 2019, a "compilation video" featuring the footage extorted from John Doe surfaced on Twitter through at least two accounts, eventually making their way to the victim in January 2020 after "he learned from his classmates that [the] videos of him and another minor were on Twitter, and that many students in the school had viewed them." Immediately, the victim who by this time was 16-years-old informed his parents of the situation, prompting his mother, named as "Jane Doe" in the suit, to take up the issue with school officials, local police and with Twitter directly. That followed at least one previous complaint from a concerned Twitter user in late 2019, who reported one of the accounts that shared footage of the victim. The company took no action and the videos remained live. By January 21, the plaintiff filed his own complaint with Twitter, telling the platform "These videos were taken from harassment and being threatened. It is now spreading around school and we need them taken down as we are both minors, and we have a police report for the situation." At the request of Twitter, he provided a photo of his driver's license to confirm his identity. Jane Doe also filed two additional complaints with the company one day later, to which Twitter replied with identical automated messages promising to review the content in question. After a full week without a response from the company, despite repeat attempts by the victim's mother beyond her initial complaints, Twitter finally replied on January 28, stating that it found no problems with the sexually explicit videos and would do nothing to have them removed. "Thanks for reaching out. We've reviewed the content, and didn't find a violation of our policies, so no action will be taken at this time," Twitter said, while insisting without a hint of irony that "your safety is the most important thing." Sextexting a big problem in this country and whilst it is seen as a lot of harmless fun for the children, it can and often does, lead to serious implications for those in the pictures, generally following some sort of falling out. But it also leads to sexual predators and social miscreants who will use any situation to gain leverage over another person, due to them being weak. Twitter and the blackmailers should both be dealt with in court, for a gross negligence from Twitter, that apparently blackmailing, sexualization of minors and harassment are all acceptable by their standards. Again, like Amazon, the public has a choice, #boycott-twitter is the simple solution to end their enterprise, because they breach our community standards, and their policies are not an acceptable standard for the public either.

Microsoft files a patent to bring back dead loved ones as AI "chatbots" from their digital harvested data, another seemingly episode taken from the series Black Mirror. Patent No: 10853717B2 on December 1st 2020 having first filed it in April 2017. Examples of the present disclosure describe systems and methods of creating a conversational chat bot of a specific person, In aspects (social data, images, voice data, social media posts, electronic messages, written letters) about the specific person may be accessed. The social data may be used to create or modify a special index in the theme of the specific persons personality. The special index may be used to train a chat bot to converse in the personality of the specific person. During such conversations, one or more conversational data stores and or API's, may be used to reply to user dialogue and or questions for which the social data does not provide data. In some aspects, a 2 or 3D model of a specific person may be generated using images, depth information, and/or video data associated with the specific person. In aspects a personalized chat index may be used to train a chat bot or language understanding model, to converse and/or interact in the personality of the specific person. A model, as used herein, may refer to a predictive or statistical language model that may be used to determine a probability distribution over one or more word, character sequence or events, and/or to predict a response value from one or more predictors. In example, a model may be a rule based model, a machine learning regressor, a machine learning classifier, a neural network, or the like. In some aspects, conversing in the personality of a specific person, may include determining and/or using conversational attributes of the specific person, such as style, diction, tone, voice, intent, sentence/dialogue length and complexity, topic and consistency. Conversing in the personality of a specific person may additionally include determining and/or using behavioral attributes (user interests, opinions, and demographic information (age, gender, education, profession, income level, relationship status) of the specific person and/or persons determine to be similar to the specific person. Another example of those in the technological field are complete psychopaths, the seducement will be it is to speak to lost loved ones again, the reality is it gets out to public awareness they have been doing this for years. Fake names, personalities called bots on social media is the most obvious, but also renders the question, with this technology is anyone who appears on Television or videos real anymore?

The Achnacarry Agreement, also known as the As-Is-Agreement, was a top secret agreement from 1928 to form an oil cartel of all the major oil producers of the time, to limit "excessive competition". The governments at the time ratified this agreement, but the public did not find out about this cartel until 1952. The agreement was made on August 18, 1928 at a meeting of representatives of oil production companies in Achnacarry Castle, owned by Deterding. Achnacarry Castle which is in Scotland, tells me the Scottish Rite Masons where involved in this shenanigan, as they have done in a lot of American history, and also Russian history. Masonry was brought to Russia in the 1700's from Scotland also. Participants included: John Cadman of the Anglo-Persian Oil Company, Henri Deterding from the Royal Dutch Shell, Walter Teagle from Standard Oil of New Jersey. The so-called "Seven Sisters" belonged to the cartel: Standard Oil of New Jersey, Mobil (Standard Oil of New York), Gulf Oil, Texaco, Standard Oil of California, Royal Dutch Shell and Anglo-Persian Oil Company. Price wars among major oil companies in the 1920s, most significantly one in India, between Standard Oil of New York and a subsidiary of Royal Dutch Shell, threatened major oil company profits, especially those from relatively high-cost production in the United States. The As-Is Agreement, consisted of seven "principles" to limit "excessive competition" that had led to enormous overproduction, by dividing markets, fixing prices, and limiting the expansion of production capacity. The agreement affected the development of oil production capacity in the Middle East by limiting price competition in product markets and, as a result, supporting the prices of products made from high-cost, primarily American, crude oil. This strategy was implemented as a "basing-point" system under which all sellers calculated delivered prices as. For the crude oil of the Middle East, which could be extracted with little effort, this system meant that the development of production capacities was delayed by the exploitation of existing concessions, until the Second World War and reserves were exploited in the USA and Canada. The resulting division of production shares between Middle Eastern countries and others, increased anticolonial and anti-Western feelings among the populations of many Middle Eastern states, most notably Iraq and Iran. It also established a pattern for ensuring oil profits by exercising market control, that the members of the Organization of Petroleum Exporting Countries (OPEC) later tried to emulate. This as-is agreement was revealed in 1952 in a report entitled The International Petroleum Cartel by the Federal Trade Commission to the subcommittee of the US Senate. A letter from J. Edgar Hoover indicates that the publication of this matter would be favorable to Soviet propaganda; President Harry S. Truman then calls for the end of the criminal investigation.

Black Cube is a private intelligence agency, which is based in London, Paris and Tel Aviv. It has been noted that "Black Cube's political work frequently intersects with Israel's foreign policy priorities." Black Cube told the BBC that it "applies high moral standards to its work, and operates in full compliance with the law of any jurisdiction in

which it operates." Black Cube's Human intelligence capabilities have proved to be an effective way of exposing fraud, bribery, money laundering and corruption. The company uncovered high-level corruption in the judicial systems of Italy and Panama. The company was founded in 2010 by former Israeli intelligence officers Dan Zorella and Avi Yanus. Its employees include former members of Israeli intelligence units, including Aman, Mossad and Shin Bet, as well as legal and financial experts. Former Mossad director Meir Dagan led Black Cube's board until his death in 2016. Black Cube is known to have two separate divisions for corporations and governments. The firm was caught attempting to undermine the Iran nuclear deal — then also a top political objective of Israeli Prime Minister Benjamin Netanyahu — by attempting to obtain information on the "financial or sexual impropriety" (i.e., blackmail) of top U.S. officials involved in drafting the accord. Black Cube gathered information about women accusing Harvey Weinstein of sexual harassment to try to help him escape conviction. Summit News reported that "tried to intimidate journalist Ronan Farrow in order to "bury the truth" about Weinstein's activity." Weinstein used the private spy firm to "target,' or collect information on, dozens of individuals, and compile psychological profiles that sometimes focused on their personal or sexual histories." It was the Israeli deep politician and intelligence chief Ehud Barak who put Weinstein in contact with Black Cube. Asher Tishler, a member of Black Cube's advisory board, remarked "In retrospect, it's a shame we took the job." (presumably for getting caught).
