

## THI-SHOW TRANSCRIPT 2021-02-25

Welcome to the THI Love train, a diet buster and a sleep apnea cure show. Israel's biggest news outlet Ynet reported this week that the country is voluntarily making itself Pfizer's testing ground, "75.4% of those diagnosed yesterday were under 39, only 5.5% were over 60. "The number of critical patients dropped to 858 - the lowest since January 4. However, this number is more than double that in mid-December, just before Israel started its 'pioneering' experiment in mass vaccination. Ynet reports today that "In Israel 59.9% of critical patients are over 60 years old, 18.2% are aged 50 to 59. In addition, 10.8% are aged 40 to 49 and 7.5% are in their 30s. As of today, more than a third of critical patients are between 30 to 59 years old." The meaning of the above can hardly be denied or at least demands immediate attention. The country that leads the mass vaccination contest, reports a radical shift in the nature of the pandemic. It doesn't take a genius to suspect that there may be a correlation between the mass vaccination campaign, and the growing vulnerability of younger age groups including new-born and pregnant women. The biology here is also far from being too complicated. The virus that initially preyed on the elderly and vulnerable has morphed by means of mutation, and is now fit enough to attack other segments of society and particularly younger age groups. Up to the 20th of December, the day Israel launched its mass vaccination campaign the country had logged 3,074 deaths. In less than two months of 'successful' mass vaccination that number almost doubled, as of writing this article, it stands on 5,526. This spectacular rise in deaths (80% in less than two months) occurred when the country was in lockdown, hence it wasn't exactly 'social gathering' that helped the virus spread. The only thing that was spreading in Israel in these two months was the Pfizer vaccines and the so-called

British mutant, that is apparently more popular in Bnei Brak than in Kent. The inevitable question here is whether there is a connection between vaccination and mutants, but this is the one question no one is allowed to ask in Israel. In November 2020 Israeli Health Ministry data revealed that Israel detected 400 cases corona virus under the age of two, by February 2021, that number grew to 5,800. We are dealing with a clear rise of about 1300%, impressive indeed. Israeli Ynet reports that this kind of rise in numbers of new-born Covid-19 morbidity are reported around the world, I investigated it but didn't manage to find any confirmation that this is indeed the case. In Britain, for instance, all I find is reports on a 'Covid-19 baby boom' and some concerns regarding a rise in child obesity. In fact, nobody reports on a rise of 1300% in new-born Covid-19 except Israel. I am not in a position to determine, what led Israelis to make themselves into guinea pigs for a pharma giant, with a dubious safety and ethical record. The possibility must be considered that in Israel, the success of a mass vaccination campaign could be Netanyahu and his party's primary ploy ahead of the coming election. Netanyahu faces a serious legal battle, and winning the election extends far beyond politics for him, it is an existential survival battle. I believe Bibi had to choose between war with Iran and a Pfizer vaccine, he had good reason to assume that Pfizer is by far a better and more peaceful option. Netanyahu probably gathered that a successful mass vaccination campaign would secure his victory. This was indeed a reasonable consideration on his part, and it may prove to be correct. It is worth mentioning that not one of Netanyahu's political opponents, on the evaporating Israeli Left or centre dare challenge Netanyahu's vaccine policy. More so, not one Left-wing institution in Israel has stood up for the many Israelis reluctant to be vaccinated (currently more than 50%), not one politician took their side and stood for their elementary rights. Meanwhile, the government is desperate to make sure that the entire nation is vaccinated, the government won't hesitate to introduce totalitarian measures. The Jerusalem post reported today that "a green passport will be required, to enter certain places and to participate in certain activities. Only people who have been vaccinated or have recovered from corona virus will be eligible for one. As part of the program, registered gyms, theatres, hotels, concerts and synagogues will be able to operate starting next week." Israel already signed agreements with countries that will open their gates solely to the Israelis who carry green passport. One may wonder why the Israeli Government is so obsessed with vaccinating the entire population, including the youth, army and other segments that aren't necessarily high-risk. One possibility is that the Israeli government knows by now the real implications of the vaccine. Israel can't turn a blind eye to the 1300% rise of Covid-19 cases in new-borns. They also can't ignore that the number of Covid-19 deaths since the vaccination campaign started, equals that of IDF fatalities in the 1973 Yom Kippur War, a war the country is still traumatized by. It is possible that Israeli leadership now acknowledge the fatal mistake it has made distributing the vaccine widely. It may be plausible that the only solution they could come up with is vaccinating the entire population, hoping that this may provide at least temporary protection, which may last until the March election date.

The UK government is set to review when social distancing measures could be scrapped as part of lockdown easing. Under the roadmap limited social mixing indoors will be allowed from May 17 and ministers will review whether people can hug their loved ones at that time. Indoor gatherings of six people will not be permitted until Step 3 - not before May 17 - when 30-strong outdoor gatherings will be allowed. Also part of the new directives was the decision to send the children back to school on March 8th, so on the one hand this is a deadly disease and everyone must curtail their lifestyle, and the next they are using children as test guinea pigs to see if it is ok to fully re-open society? What message is that sending to the people?

Earlier this month, New York Democratic attorney general Letitia James issued a report which reprimanded the Cuomo administration, for minimizing the death toll at nursing homes by excluding certain fatalities from the count. Cuomo's administration then revealed at least 15,000 people living in long-term care facilities have died of COVID-19, nearly double the number Cuomo had initially disclosed. 15K elderly died in Cuomo's constituency is a dereliction of duty by those who are designated to provide care. Yes, Cuomo told them to accept Covid patients, but that doesn't mean they are obligated to do such stupidity either. Cuomo and the Health Authority needs to be arrested and investigated, as why so many vulnerable elderly people died unnecessarily under their watch.

Republicans ramped up their criticisms of Gov. Cuomo Thursday, calling for his impeachment over the state's mismanagement of nursing homes during the COVID crisis. Assembly Minority Leader Will Barclay (R-Oswego) called on Democrats to back a GOP plan to create an impeachment commission, that would "gather facts and evidence" about the administration's withholding of data, related to the deaths of thousands of seniors and other actions. "The Cuomo Administration's nursing home cover-up is one of the most alarming scandals we've seen in state government," Barclay said. "Intentionally withholding critical information from the public, underreporting fatality numbers by 50%, and the recent revelation they hid the truth to avoid a federal Department of Justice investigation, are among the factors that raise the serious possibility of criminality." The governor and top officials have been bombarded by criticisms in recent weeks, as state lawmakers prepare to strip him of his pandemic powers, and federal authorities probe the administration's handling of nursing home data. Last week, a top Cuomo aide conceded the administration withheld the total nursing home death toll from state lawmakers, out of fear it would be used against the state by the Trump administration. The governor has since sought to clarify those remarks, saying that a federal Department of Justice inquiry was prioritized. Critics have long targeted Cuomo over a March 25 guidance from the state Department of Health, requiring facilities to accept COVID-positive patients as long as they had the ability to care for them. The current uproar was sparked when Attorney General Letitia James issued a

scathing report last month accusing state officials of underreporting the number of nursing home deaths by 50%. In the wake of that report, and a court ruling ordering the state release additional data, officials admitted the number of nursing home and long-term care facility residents who died during the pandemic is more than 15,000, not the 8,500 previously reported by the state. The Albany Times Union first reported news of a probe being conducted by federal prosecutors in Brooklyn. It's unclear how or if the inquiry is connected to the Department of Justice request for information about nursing home deaths made last year. "As we publicly said, DOJ has been looking into this for months. We have been cooperating with them and we will continue to," senior Cuomo adviser Rich Azzopardi said Wednesday night. Democrats in both the Senate and Assembly are preparing to vote on measures, scaling back Cuomo's executive authority during the emergency, but Republicans, who have repeatedly called on their counterparts across the aisle to issue subpoenas and hold hearings, say more should be done to hold the administration accountable. Barclay said conservatives in both chambers are introducing a resolution establishing the "Temporary Joint Legislative Committee on Investigating the State's Response to the COVID-19 Pandemic in Nursing Homes." The committee would be tasked with "examining the state's method of administration and conduct in all matters relating to nursing homes and long-term care facilities during the COVID-19 pandemic." Will Cuomo like Comey and others just get a slap on the wrist, or will he be held accountable like we the people are? I personally won't be holding my breath on that outcome.

The US is considering introducing a monthly child benefit for the first time, a seismic shift for the country that has some of the highest rates of child poverty in the developed

world. Democrats are hoping to include the measure - which could pay up to \$300 (£217.50) per month per child - as part of a larger corona virus spending package. President Joe Biden's spokeswoman this week repeated that the current plans are focused on "emergency funding" rather than a more permanent shift. But anti-poverty advocates, who have pushed for a monthly benefit for years, hope inserting such a programme temporarily will lay the groundwork for more lasting change. "It is an emergency and not a temporary one," says Michelle Dallafior, senior vice president for budget and tax at First Focus on Children, a children's advocacy group in Washington. "Child poverty in this country has been persistently high and once we get a programme into place and iron out those wrinkles, then we're going to keep pushing to make sure that it is permanent." Under the Democratic plan, the tax credit would increase to allow families to receive up to \$3,600 (£2,610.40) per child under the age of six, and up to \$3,000 for children under the age of 18. The benefits, intended to be accessed monthly, would be available to those with no and low incomes and phase out for single-parent families earning more than \$75,000 or \$150,000 for a couple. Supporters on the left say expanding the benefit and making it available monthly could cut the child poverty rate - which was roughly 15% before the pandemic - by more than 40%, lifting four million children out of poverty. The harsh truth is 1 in 6 American children live below the poverty line. I said this recently and it still applies "A society who neglects it's children and the elderly is destined to fail".

WhatsApp is pushing ahead with controversial changes to its terms of service, but altering the way it notifies users following a backlash. After its first announcement in January, millions of users downloaded apps from WhatsApp's competitors. The Facebook-owned platform previously said it had been the victim of "misinformation" around the change. But WhatsApp now says it has "reflected" on how it could have explained the changes better. The phrasing of the warning in the initial push led to widespread fears that it was going to share large amounts of WhatsApp data with Facebook. WhatsApp already shares information with Facebook, such as your IP address and information about your phone, as well as purchases made via the platform. However this does not apply in Europe and the UK, where different privacy laws exist. But privacy experts say the saga highlights how unaware users are of how their data is being used. "In its efforts to clarify that isn't doing anything wrong, Whatsapp has in fact inadvertently highlighted that it was already harvesting huge amounts of data for Facebook," said Ray Walsh, a digital privacy expert at ProPrivacy. Another reason to monitor your friends list, mine is low due to backdoors from bot profiles. But here is something to consider given they map everything and everyone together. US scientists have successfully cloned a highly-endangered black-footed ferret, using DNA from an identical animal that has been frozen since 1988. The birth of the ferret, named Elizabeth Ann, was announced by the US Fish and Wildlife Service. The cloning is a first for a US endangered species. Once thought to be extinct, all black-footed ferrets are descended from seven ancestors that were found in 1981. Scientists say the clone will help increase the population's gene pool. Elizabeth Ann's birth on 10 December was announced as a "bold step forward" by the US Fish and Wildlife Service (USFWS) on Thursday. She was cloned from the DNA of an animal named Willa. Anna Toumazoff chose a powerful hashtag to highlight sexual abuse at France's top political science college. Sciences Po - the training ground for the country's presidents, politicians and administrators - became #SciencesPorcs (Science Pigs). "This story is very French," Anna told me. "Because it's about great schools; it's about rape culture; it's about the elegance of being silent - that's very French." Since then, the social media activist has received more than 400 messages from current and former students of Sciences Po. They describe sexual assaults and rapes, mostly by fellow students, that they say were not taken seriously by the college. "Some were told that 'it's not the worst thing in the world', that life goes on," Anna said. "Others were accused of defamation. Some were considered liars, I haven't received any testimonies of people being well treated." Stories like this are not new and not unique to Sciences Po. But she believes they are attracting wider attention now because the college is already under the spotlight for something else. France has been shaken by a series of incest allegations involving public figures over the past few weeks, beginning last month with the publication of a book by Camille Kouchner, in which she accused her stepfather, Olivier Duhamel, of abusing her twin brother as a child. Olivier Duhamel, a political commentator, was the head of Sciences Po's Foundation. He resigned, along with the school's director who, it turned out, had also known about the allegations. A government investigation into the college found no systematic cover-up, but noted that none of those who knew about the accusations had reported them, and said that the college should reinforce awareness of gender-based and sexual violence. Sciences Po said in a statement that it "support[ed] the victims of gender-based and sexual violence" and that a specialist monitoring and listening unit, set up in 2015 as part of an action plan on gender equality, was now being extended with a new project involving students. Alexandre Kouchner, Camille's half-brother, teaches at Sciences Po. It's probably true, he says, that the book has refocused attention on other forms of sexual assault. "But it would be untrue and unwise to think this started with a debate about incest," he told me. "This started with the MeToo movement." The French actor Gerard Depardieu is also now under investigation for allegations of rape. The levels of predatory sexual behaviors continues to be disclosed

now on a global and wide scale. No things have not got worse, this has always been the case, all hushed up and the greatest hush up is the levels of incest in each family.

Facing court cases and its own promises of transparency, the Biden administration is about to release a long-sought U.S. intelligence report, concluding that Saudi Crown Prince Mohammed bin Salman ordered the 2018 killing of journalist Jamal Khashoggi. The report, an unclassified summary of findings across the intelligence community produced by the Office of the Director of National Intelligence (ODNI), will be made public as early as next week, according to people familiar with the matter. Plans for the release come as U.S.-Saudi relations have tumbled to a new low in recent weeks, with the administration canceling arms sales, criticizing human rights abuses and the harassment of dissidents, and pledging to “recalibrate” ties with the kingdom. The administration has said it will continue to supply Saudi Arabia — the world’s biggest customer for U.S. weaponry — with the means to defend itself against regional adversaries, including Iran and the Iranian-backed Houthi rebels in neighboring Yemen, and has indicated it wants to continue a robust counterterrorism partnership. But it has also made clear that it will, in contrast to its predecessor, press the Saudis toward a diplomatic end to their war in Yemen and to moderate their own extremism, and it will not allow Riyadh to interfere with its plans to rejoin the Obama-era nuclear deal with Iran. In what was widely seen as a snub, White House press secretary Jen Psaki said Tuesday that President Biden, who has not yet communicated directly with Saudi rulers, would not be speaking with the crown prince, known as MBS, the country’s de facto leader. “The president’s counterpart is King Salman,” the crown prince’s aging father, she said, “and I expect that, in appropriate time, [Biden] would have a conversation with him.” The release of the Khashoggi report may make that a fraught exchange. “I think it’s going to put Biden on the spot,” said David Ottaway, a longtime Saudi expert at the Wilson Center. “He’s going to have to define what his relationship is going to be with the leadership, and what steps he’s going to take in response.” Despite Saudi government claims that he was not involved, the CIA concluded, in an assessment leaked later that year, that Mohammed had ordered the assassination. But Trump persisted in discounting the conclusions of his own intelligence service, calling the killing a “rogue operation,” and continued to shield the crown prince. Speaking of Mohammed, he boasted in an interview with Bob Woodward that he had “saved his ass” from congressional attempts to hold the crown prince responsible. The Saudi relationship is all built on weapons sales and the House of Saud's connections to Israel, and it is high time the American peoples monies were diverted onto our own soil, instead of appeasing psychotic nations with a penchant for war, death and destruction.

While Israel prepares to welcome only vaccine recipients into gyms, hotels, and other venues, thousands have been making their own 'Green Pass,' the easily-counterfeited credential the country is using to prove vaccination. The Green Pass looks complex



enough, with the secure-looking QR code on the lower-right side, but the code is just made up of the same details printed on the pass in normal letters and numbers, cybersecurity expert Ran Bar-Zik revealed in a Facebook post earlier this week. The pass can thus be easily forged by anyone with a graphics program and a printer. But having over 100,000 Israelis buying and selling fake passes on social media, a market the Times of Israel reported on Thursday is already moving at a healthy pace, defeats the purpose of having a vaccine pass. The purpose of having such a pass to begin with, is lost on these weak control based freaks. The passes are going for about 750 shekels (\$230), according to Haaretz, and even before the businesses reopen their doors, can exempt the holder from quarantine. The Health Ministry has attempted to minimize the issue, telling Channel 12 it is "looking into implementing a secure barcode that will be internationally accepted" and that the current situation is just an "initial quick response." Internationally accepted, suggests that Israel are the starting point of a global fascist pass. Meanwhile, Health Minister Yuli Edelstein warned that a 5,000-shekel fine (\$1,500) awaited anyone who tried to get away with using a fake pass. Edelstein has tried to warn vaccine refusers that their lives will be lonely ones if they do not line up for the jab, declaring last week that "whoever doesn't vaccinate will only go out to supermarkets or pharmacies, while the vaccinated will go to stadiums and gyms." "Similar outbreaks and death clusters following vaccination have been reported across the globe, including: 29 elderly people died in Norway shortly after receiving Pfizer's vaccination. 13 deaths

among 40 residents following vaccination at one nursing home in Germany were dismissed as “tragic coincidence.” 10 deaths in a German palliative care patients within hours to four days of COVID-19 vaccination were deemed a “coincidence.” 22 of 72 residents of a nursing home in Basingstoke, England have died following vaccination. 24 seniors at a nursing home in Syracuse, NY were reported to have died from COVID-19 as of January 9, 2021 despite having been vaccinated beginning December 22, 2020. 10 cases of COVID-19 were reported on January 28 among seniors who had received both doses of Pfizer’s vaccine at one care home in Stockholm Sweden. The residents were vaccinated on December 27 and again on January 19. The COVID-19 death toll in the small British enclave of Gibraltar numbered 16 before it launched its Pfizer vaccination campaign on January 10, 2021 and then shot up to 53 deaths 10 days later and to 70 seven days after that. According to a Reuters report, the Gibraltar Health Authority declared there was “no evidence at all of any causal link” between 6 of the deaths that were investigated and the Pfizer’s vaccine, despite the individuals having tested negative for Covid-19 before vaccination, but positive “in the days immediately after.” 4,500 COVID-19 cases in Israel occurred in patients after they had received one dose of Pfizer’s vaccine and 375 of those vaccinated patients required hospitalization, Israeli news media reported on January 12. Seven adults living in a care home in Saskatoon tested positive for corona virus a week after residents were vaccinated at the Sherbrooke Community Centre, the CBC reported. There were no positive cases at the time of vaccination. Seven residents at a Montreal long-term care facility tested positive for Covid-19 within 28 days of being vaccinated with Pfizer’s vaccine, prompting the province of Quebec to delay the second Pfizer dose. Abercorn Care Home in Scotland, which began COVID-19 vaccinations on December 14, 2020 was home to an outbreak of the virus by January 10 and the National Health Service for the region refused to comment on whether vaccinated residents were ill. A care home staff group founder told the Scottish Daily Record : “We have had members of our group whose parents have had the vaccine and then two weeks later have tested positive for corona virus.” All of the residents at a home in Inverness, Scotland were vaccinated against COVID-19 early in January, but 17 became infected with the virus after the first dose." I warned in a show on May 28th in Expose 1, of the global systematic attack on the elderly, with this and other reports coming out, I rest my case.

WASHINGTON — By the thousands, U.S. service members are refusing or putting off the Covid-19 vaccine, as frustrated commanders scramble to knock down internet rumors and find the right pitch, that will persuade troops to get the shot. To the commanders of death, if you have to find the right pitch to convince people, perhaps your pitch is wrong to begin with? There is a Universal Law that says all people have the right to free will, that is real law, not common, natural or Hebrew Annunaki law. Some Army units are seeing as few as one-third agree to the vaccine. Military leaders searching for answers believe they have identified one potential convincer: an imminent deployment. Navy sailors on ships heading out to sea last week, for example, were choosing to take the shot at rates exceeding 80 percent to 90 percent. Air Force Maj. Gen. Jeff Taliaferro, vice director of operations for the Joint Staff, told Congress on Wednesday that "very early data" suggests that just up to two-thirds of the service members offered the vaccine have accepted. That's higher than the rate for the general population, which a recent survey by the Kaiser Family Foundation put at roughly 50 percent. The Kaiser Family Foundation previously funded professorial chairs at UC Berkeley, Stanford University, Harvard University, and Johns Hopkins University, so now you know where they get their fake figures from. John no hope kins. But the significant number of forces declining the vaccine is especially worrisome because troops often live, work and fight closely

together in environments where social distancing and wearing masks, at times, are difficult. The military's resistance also comes as troops are deploying to administer shots at vaccination centers around the country, and as leaders look to American forces to set an example for the nation. Invading 81 countries few of which had the means to defend themselves, none of which actually attacked us, is not an example of leadership, it is an example of being a bully and knuckledragger. "We're still struggling with what is the messaging and how do we influence people to opt in for the vaccine," said Brig. Gen. Edward Bailey, the surgeon for Army Forces Command. He said that in some units just 30 percent have agreed to take the vaccine, while others are between 50 percent and 70 percent. Forces Command oversees major Army units, encompassing about 750,000 Army, Reserve and National Guard soldiers at 15 bases. At Fort Bragg, North Carolina, where several thousand troops are preparing for future deployments, the vaccine acceptance rate is about 60 percent, Bailey said, that's "not as high as we would hope for front-line personnel," he said. Bailey has heard all the excuses. "I think the most amusing one I heard was, 'The Army always tells me what to do, they gave me a choice, so I said no'," he said. Service leaders have vigorously campaigned for the vaccine. They have held town halls, written messages to the force, distributed scientific data, posted videos, and even put out photos of leaders getting vaccinated. For weeks, the Pentagon insisted it did not know how many troops were declining the vaccine, on Wednesday they provided few details on their early data. Officials from individual military services, however, said in interviews with The Associated Press that refusal rates vary widely, depending on a service member's age, unit, location, deployment status and other intangibles. The variations make it harder for leaders to identify which arguments for the vaccine are most persuasive. The Food and Drug Administration has allowed emergency use of the vaccine, so it's voluntary. And here is your much vaunted and celebrated military response to the vaccine being voluntary, But Defense Department officials say they hope that soon may change. Imperial nobility enjoyed a more elevated status than the nobilities of the German successor states and indeed, of the Italian states. The descendants of Italian Holy Roman Empire titles have formed an

Association, to which all male line descendants of someone ennobled by Imperial Patent is entitled to belong. The Principality of Liechtenstein has also claimed the ability to confirm a succession to Imperial titles, and has confirmed the right of a Spanish noble man to heir such a title for purposes of the Spanish law, requiring the successor state to confirm that the claimant to a particular title is in fact the heir. Thus there is a remaining jurisdiction, even though no Imperial titles have been conferred since 1806. In 1963, the Holy Roman Empire Association (Associzioni dei Nobili del Sacro Romano Impero) was established to unite male descendants in its membership, who are invested with nobility of the Holy Roman Empire. It also includes a number of honorary members. The Black Nobility belong to the "Committee of 300" that controls the United Nations. Prince Bernhard of the Netherlands has the power to veto the Vatican's choice of any pope it selects. This may explain the untimely end to Pope John Paul I's 33-day pontificate, ah the number 33 again. The Prince has veto power because his family, the Habsburgs, are descended directly from the last Roman emperor. (The Habsburg Frederick III was the last emperor to be crowned in Rome; his great-grandson Charles V was the last to be crowned by a pope). The question remains from the excerpt is, is Anna Von Reitz who is a Hapsburg all part of this faction based war? Was she a double agent for the Hapsburg's and her family line Prince Bernhard, when she worked for the Vatican? This is the civil equivalent of the Pope's claimed "apostolic succession" from Saint Peter. Prince Bernhard is leader of the Black Families and he also claims descent from the House of David through the Merovingian dynasty, a claim that was acknowledged to be valid by the Carolingian dynasty that supplanted them, by other monarchs and by the Roman Church of that time. Thus he can truly say that he is "related to Jesus". What if the entity known as Jesus, was also Black Nobility? What if the entity known as Jesus is related to Lucifer? Prince Bernhard's House of Orange's origins are in fact in France. The Habsburgs are related through marriage with the Merovingian Dynasty, who are said to have descended from the Tribe of Benjamin. The Tribe of Benjamin went into exile following war with the other eleven Tribes -- see Judges chapter 21. Just because they were at war with the other tribes, does not make them the good guys, think faction wars and ultimate power. Exile lead them to Arcadia in the central Peloponnesian part of Greece. From this introductory point, they aligned with the Arcadian royal line and towards the advent of the Christian era, migrated up the Danube and Rhine, through marriage engendering the Sicambrian Franks -- the immediate forebears of the Merovingians, who were ultimately of Semitic origin, and descendants of King Saul. They are identified with the Spartans, and both of the books of Maccabees, in the Catholic Bible, link the Spartans with the Jews. In Maccabees 12 tells of Jonathan sending a letter to the Lacedemonians (Spartan Greeks) asking for their help, since they were brothers. The Spartans replied, "It is found in writing, that the Lacedemonians and Jews are brethren and that they are of the stock of Abraham" (verse 21), Abraham being the reverse of the now Indian book called Maharba - with rata on the end. We linked the modern day Jews with India in FRWL 1 & 2. It is assumed by some writers that this means the Spartans were Israelites, but the Spartans

were not Israelites they were Edomites, descended from Bela son of Beor and brother of Baalim, and king of Edom (Genesis 36:32; I Chronicles 1:43). Edom was the son of Isaac and grandson of Abraham who sold his birthright, and bred his posterity off the Book of Life. Early in the 5th century the Merovingians established themselves in what is now Belgium and northern France. There they adopted the Cabalistic pseudo-Christianity of the Cathars, a dualistic religion that holds there are two eternal gods, the god of Good and the god of Evil. It is revealing that this Luciferian belief is held by Masons of high degree and those who would be Masters of this world today, and who claim that Lucifer will ultimately be victorious. Under Clovis I, who reigned from 481-511, the Franks converted to Roman Catholicism. Through him, Rome began to establish undisputed supremacy in Western Europe. The Franks were Jewish, and that is why the name France is called today, for the Franks. In return for being the sword of Rome through which the church would manifest her power and impose a spiritual dominion, Clovis was granted the title of "New Constantine" and to preside over a unified "Holy Roman Empire" based on the church, and administered on the secular level in perpetuity by the Merovingian bloodline. Like "the sure mercies of David", this was a pact that could be modified, but not revoked, broken or betrayed. They believe Jesus survived the cross and married Mary Magdalene who bore His son then lived in seclusion in the south of France. During the 5th century, this bloodline is said to have married within the royal line of the Franks uniting with the Merovingian dynasty. In 496 the church aligned itself in perpetuity to the Merovingian bloodline. The church was presumably in full knowledge of their claimed identity. This would explain why Clovis was offered the status of Holy Roman Emperor, and why he was not created but only "crowned" king. In 754 the church clandestinely betrayed its pact. The Priore de Sion is the name of the secret order which created the Knight Templars as its military and administrative arm. (It should be remembered that the Knight Templars were the forerunners of Freemasonry). The Priore de Sion continues to function through the centuries, acting in the shadows, and has orchestrated certain critical events in Western history. It exists today and is still operative. Its declared objective is the restoration of the Merovingian dynasty and bloodline -- to the throne not only of France, but of other European nations as well -- a restoration that is sanctioned and justifiable, both legally and morally. There is strong evidence to suggest that this order was the author of Freemasonry, and "The Protocols of the Learned Elders of Sion", as well as the Rosicrucians. The group formerly known as the Kingdom of Manna, were all heavily into Rosicrucianism, not a cohen-cidence. There is abundant evidence to suggest that Nostradamus was one of their own, and there is no question that numerous quatrains which refer to the advent of "le Grand Monarch" indicate that this sovereign will ultimately derive from the Merovingian dynasty. Implying a double hegemony of the Papacy and the Empire, of the Vatican and of the Habsburgs. He frequently referred quite explicitly to the Knights Templars and to the house of Lorraine which is now synonymous with the Habsburgs. Although deposed in the eighth century, the Merovingian bloodline did not become extinct. On the contrary it perpetuated itself in

a direct line from Dagobert II and his son Sigisbert IV. By dint of dynastic alliances and intermarriages, this line came to include Godfroi de Bouillon, who captured Jerusalem in 1099, and various other noble and royal families, past and present -- Blanchefort, Gisors, Saint-Clair (Sinclair in England), Montesquieu, Montpezat, Poher, Luisignan, Plantard and Habsburg-Lorraine. At present, the Merovingian bloodline enjoys a legitimate claim to its heritage. The crown of Charlemagne -- a replica of which is now part of the imperial Habsburg regalia -- is said to have borne the inscription "Rex Salomon" (Encyclopaedia Britannica, 14th Ed., 1972, Crown and Regalia, Fig. 2). Rex Salomon means King Solomon, he who brought in the demons and also child sacrifice. And the "Spear of Destiny", which is said to have pierced Christ, reside today in the Treasure House, Vienna, awaiting another Holy Roman Emperor (The Rigby Joy of Knowledge Library). History and Culture I, 1977:160; The Holy Roman Empire, Friedrich Heer, p. 284). It is clear why the "Protocols of the Elders of Zion" speak of a new king "of the Holy seed of David", (Holy Blood and the Holy Grail, Baigent, Leigh and Lincoln). Otto von Habsburg is today the titular Duke of Lorraine and King of Jerusalem. The Priore de Sion claim to hold the lost treasure of the Temple of Jerusalem plundered by Titus in AD70 which would be returned to Israel "when the time was right". Yes, when their caliphate is complete, they remove all peoples from the area, including Jews, and build their third temple behind a wall, that could potentially go from Egypt to India. From there you will have One World Government, One World religion under the hospice of Lucifer and One World Currency of the dead, called crypto. Throw in all the crypto and RV people all work for and by the establishment, all of them All of them making this claim and that claim, outing this group and that group, revealing all kinds of differing information, yet none of them went near the elephant in the room, of the Jewish elites problem, now why is that? Charlie Ward reported that once the Quantum Financial System is turned on lots of things will change. Which one? Immediately that happens it takes the power away from the deep state and the cabal, which then means we've got access to the Med Beds. When is NESARA happening? We're nearly there. I was speaking to the Quantum Financial System people only 10-minutes ago. The #2 on the Quantum Financial System. Either not the same QS or Kim has been replaced.
