NEWS: Microsoft will reportedly use a US Congressional committee hearing, to champion Australian-style regulation targeting tech giant and major rival Google, which it claims has a stranglehold on the digital ad market. Axios reports Microsoft president Brad Smith will appear before a House Judiciary antitrust subcommittee on Friday, where he will argue in favour of legislation, which echoes Australia's contentious news media bargaining code. The bipartisan committee this week introduced a bill, which would allow small publishers the ability to collectively bargain with internet juggernauts including Google and Facebook, over compensation for the news content displayed on those sites, something which is currently blocked by US antitrust law. If that sounds familiar, that's because it is. The collective bargaining aspect mirrors legislation passed in Australia last month, which enshrined the ability of media companies to band together while seeking payment from those internet juggernauts. The Australian legislation also includes a provision compelling Google and Facebook to enter mandatory arbitration with publishers if they fail to broker a deal, an aspect not included in the proposed US bill. Tech giants fighting each other now, all part of the faction war we warned of. Micro chips, Micro bots, Micro manage and Micro soft in the head, whilst believing they are the Macro.

House Speaker Nancy Pelosi just placed the first domino in her 2021 anti-gun agenda, Universal Gun Registration. H.R. 8 -- her Universal Gun Registration bill -- bans nearly all private firearms sales, preventing you from exercising your constitutional right to keep and bear arms. This Universal Gun Registration bill funnels nearly all firearms transactions through the federal government, and makes it illegal to sell firearms to lifelong friends and neighbors unless Big Brother knows about it. And without your grassroots action, I'm afraid Universal Gun Registration will rapidly advance in Congress. The ongoing gun confiscation is trying to be achieved by stealth, remember the piece on it we did a month ago, with them requiring you to have \$800 Insurance and to take yearly tests? Once the guns are gone this country is doomed, I am not in favor of them per se, but they are a modicum of protection against the current tyranny being imposed on the people.

Israeli Prime Minister Benjamin Netanyahu has brokered an electoral alliance, that is almost certain to bring Israel's version of the Ku Klux Klan into the Israeli parliament when elections are held later this month. Netanyahu's primary aim is to make sure he wins a decisive majority by shoring up the far-right bloc, so that he can pass an immunity law to neutralize his current corruption trial. Enter Otzma Yehudit, or the Jewish Power party. Otzma Yehudit is strongly influenced by the late Rabbi Meir Kahane, who we referenced in a show in February as having racist and apartheid attitudes, whose virulently anti-Palestinian Kach party was barred from Israeli elections more than 30 years ago. Since being proscribed, Kach has been declared a terrorist organization in most western countries, including the United States, Canada and the European Union. Funny how the same countries will declare just a party a terrorist organization, but not their whole apartheid based country? Most of the leadership of Jewish Power had previously been involved with Kach, including its current leader, Itamar Ben Gvir, who held a position in Kahane's movement in his student days. Jewish Power's former leader and current chair, Michael Ben Ari, has been banned from entering the US because of his links to Jewish terrorism. Nonetheless, Netanyahu is widely reported to have offered sweeteners to get Jewish Power, and two other extreme right parties to establish a new alliance called Religious Zionism. Religious Zionism oh my, what a name selection that is, let me break the meaning of that down for you, it means the law of the Hebrew Annunaki, that is religious Zionism. And despite claims by Netanyahu that Ben Gvir will not be given a ministerial post in his government after the 23 March election, Netanyahu may have to capitulate if his far-right and religious coalition, needs Jewish Power to secure a majority of seats. The election is set up over there so no one can get into power except the incumbent. The parties are fractured and structured in a way that it allows no one else to have power.

During his speech, Biden announced he is ordering all states, territories and tribes to make all adults eligible to receive their vaccines by May 1, a date he said is much sooner

than anticipated. While most states are rolling out the vaccines in phases and priority going to health care workers and seniors, Alaska became the first state to open up eligibility to all adults this week. He noted that the order does not mean all Americans will immediately receive a vaccine after May 1, but that "you'll be able to get in line beginning May 1." A July 4 with your loved ones, that's the goal. I wouldn't count on either date as more and more Americans are refusing it, despite the portal media promoting it. I could foresee a raft of lawsuits against all the media giants for promoting something as good, despite overwhelming evidence to the contrary. Because that is coercion and essentially the news media outlets are portraying themselves under false pretences as, medical experts. What should not be overlooked is the dates he used, May 1st is a sacrifice day, July 4th is when they sacrificed America for Crown interests.

Fox News's Jeanine Pirro slammed Vice President Kamala Harris as a "mealy mouthed politician" for not speaking up about the seven women who have accused Gov. Andrew Cuomo of sexual misconduct. Proclaiming she is a fraud, a phony, a woman without a moral core, a regular two-faced, mealy mouthed politician who swings with the wind," Pirro said during the "closing statement" portion of her show Saturday evening. A reporter asked Harris about Cuomo's scandal late last week, but the vice president walked away without answering the question. The truth never feared investigation Mrs. Harris, more on her later.

Jared Kushner left taxpayers with a hotel bill for more than \$24,000 on his way out of the White House, according to a new federal filing. The expense filing, first reported by The Daily Beast, shows a State Department expenditure labeled "KUSHNER VISIT DEC 2020" for \$24,335 stemming from Kushner's trip to Israel, to tout the administration's accomplishments four weeks before Trump left office. Kushner met with Israeli Prime Minister Benjamin Netanyahu, who last month pleaded not guilty to three corruption charges, and visited the U.S. embassy that Trump had relocated from Tel Aviv to Jerusalem. Shortly after the trip, Kushner Companies sought to raise more than \$100 million in Israel. During the visit, Kushner touted Trump's controversial embassy relocation for leading to an "explosion of peace" in the Middle East, even though the decision has been widely condemned by Arab countries, as was Kushner's failed attempt at a peace deal between Israel and the Palestinians. Explosion of peace yes we all saw your explosion of peace in Beirut last year, you can stick your versions of peace, as it is not in your vocabulary. Israel and peace is a sham and oxymoron. The trip came after Kushner and his wife, Ivanka Trump, racked up big taxpayer bills with vacations

to Charlottesville, Aspen, the Dominican Republic and Canada, while forcing Secret Service to pay thousands per month to rent an apartment near their Washington home for the use of a bathroom after agents were instructed not to use theirs. Jared Kushner was there to cement his 5th peace deal for Israel in 4 months. Therein lies the problem, he was working for Israel whilst being paid by Americans, why can't Israel pay the bill given it was for their benefit? Why can't Israel broker their own deals at their own cost? Why is it always Americans paying for them?

Key economic data in China surged dramatically in the first two months of 2021, pointing to a continued recovery for the world's second largest economy. China's industrial output grew 35.1% in January and February compared to the same months last year. The strong numbers are distorted because they are compared to 2020, when most of China's factories were in pandemic lockdown. But Monday's slew of economic data still beat analysts' expectations. Looking back to 2019 before the pandemic hit may give a more accurate picture of what is happening to economic activity in China. Industrial output was up 16.9% compared with the first two months of 2019, highlighting the stronger output. A rebound in foreign demand has helped push export growth higher for China, often called the world's factory. The Chinese government has set a modest annual economic growth target for 2021, at above 6%, even though analysts are tipping growth of around 8%. China was the only major economy last year to report positive growth, with an expansion of 2.3%. Yes because it was another attempt to collapse the West and shift everything to the East, and jackass politicians appear oblivious to it, or complicit in it. Which is why the people in all countries have to start to make their governments accountable for their decisions.

To take a single step beyond the boundaries thus specially drawn around the powers of Congress, is to take possession of a boundless field of power not longer susceptible of any definition. I am opposed to any form of tyranny over the mind of man. The opinion which gives to the judges the right to decide what laws are constitutional and what not, not only for themselves, in their own sphere of action, but for the Legislature and Executive also in their spheres, would make the Judiciary a despotic branch. All very valid statements and often repeated, yet behind the shadows of those words, lies a mass of contradictions the people have not addressed. The Americans cite all kinds of code, statutes, Constitutions for varying rights, yet how do you explain or get around the Insurrection Act? Insurrection an act or instance of rising in revolt, rebellion, or resistance against civil authority or an established government. 18 U.S. Code § 2383 - Rebellion or insurrection Whoever incites, sets on foot, assists, or engages in any rebellion or insurrection against the authority of the United States or the laws thereof, or gives aid or comfort thereto, shall be fined under this title or imprisoned not more than ten years, or both; and shall be incapable of holding any office under the United States. I often accuse common law type groups of chasing down the wrong paths, like the Magna Carta and Birth Certificates, that contradiction I have just brought to your attention is an actionable item to challenge. Californian Judge Craig Griffin rejected and dismissed the lawsuit, as well as the attempt

to apply Israeli laws in his Orange County Superior Court. In his ruling, the judge also granted Palestinian Suhair Nafal's anti-SLAPP motion, and said that Rumshiskaya must pay the defendant's legal costs. The anti-SLAPP laws are designed to deter people from using the US courts, and potential threats of a lawsuit, to intimidate people who are exercising their First Amendment rights to free speech. A "strategic lawsuit against public participation" (SLAPP) is one intended to deter freedom of speech, and which the plaintiff usually doesn't really expect to win. The outcome of this particular lawsuit is a major blow to Israel's ongoing efforts around the world to silence the boycott, divestment, and sanctions (BDS) movement, especially on social networks. It is also a major victory for Nafal and her supporters. She insisted, however, that this was a victory for all pro-Palestinian activists, both on social media and on the ground. "We have a lot of work ahead of us, but we are tireless and will not give up until we see justice served." Finally a judge applying common sense, these Israeli based people seem to think they have a right over everybody else, and yet too few challenge it.

Finally the loop news people ran an all too predictable story this week, delivered to them by the oxymoron named groups called Intelligence Agencies. To them it is 2016-2017 again of running the same story over and over, except the clever or stupid people there added an extra word in this time, that word is Iran. Here is their fake news report: Russia and Iran both carried out operations to try to interfere in the 2020 presidential election between Joe Biden and Donald Trump, according to a U.S. intelligence report. But intelligence experts also found that China, which was previously thought to be expanding its U.S. influence efforts, ultimately did not deploy operations to affect the outcome of the Trump-Biden election. That report was brought to you by the Rothschild's group. The report also said there are no indications that foreign actors attempted to alter U.S. ballots or vote tabulation. That report was brought to you by the Israelis, the Soros Foundation and Rothschild's groups.

INTERESTING NEWS: In 1972, a worker at a nuclear fuel processing plant noticed something suspicious, in a routine analysis of uranium obtained from a normal mineral source from Africa. As is the case with all natural uranium, the material under study contained three isotopes — i.e. three forms with different atomic masses: uranium 238, the most abundant variety; uranium 234, the rarest; and uranium 235, the isotope that is coveted because it can sustain a nuclear chain reaction. For weeks, specialists at the French Atomic Energy Commission (CEA) remained perplexed. Elsewhere in the earth's crust, on the moon and even in meteorites, we can find uranium 235 atoms that make up only 0.720 percent of the total. But in the samples that were analyzed, which came from the Oklo deposit in Gabon, a former French colony in West Africa, the uranium 235 constituted only 0.717 percent. That small difference was enough to alert French scientists that there was something very strange going on with the minerals. These small

details led to further investigations which showed that least a part of the mine, was well below the normal amount of uranium 235: some 200 kilograms appeared to have been extracted in the distant past. In today's terms, that amount is enough to make half a dozen nuclear bombs. Funny how they always reference it in terms of weaponry is it not? Soon, researchers and scientists from all over the world gathered in Gabon, to explore what was going on with the Uranium from Oklo. What was found in Oklo surprised everyone gathered there, the site where the uranium originated from is actually an advanced subterranean nuclear reactor, that goes well beyond the capabilities of our present scientific knowledge. Researchers believe that this ancient nuclear reactor is around 1.8 billion years old and operated for at least 500,000 years in the distant past. Oops there goes the biblical based bs of the Vatican that life started here 6K years ago, yet curiously have references to Noah and the flood of 12-13K years ago in their books. Neither do they try to explain how with only a boat load of people and some animals, Noah's ark, they built Gobekli Tepi within a thousand years of the flood. Or how with primitive life here that started 6K years ago, they built the pyramids within 500 years, what a load of conspiracy theories the biblical books and scriptures delivers. Scientists performed several other investigations at the uranium mine and the results were made public at a conference of the International Atomic Energy Agency. According to News agencies from Africa, researchers had found traces of fission products and fuel wastes at various locations within the mine's area. Incredibly, our modern-day nuclear reactors are really not comparable, both in design and functionality with this huge mega reactor. According to studies, this ancient nuclear reactor was several kilometers long. Interestingly, for a large nuclear reactor like this, the thermal impact on the environment was limited to just 40 meters on all sides. Incredibly clever people them primitive beings it seems, with their grass skirts and animal skin suits, spears and mud huts, yet can build nuclear reactors and pyramids, yet can't build themselves a decent home, does that make any sense? What researchers found even more astonishing, are the radioactive wastes that have still not moved outside the limits of the site as they have still held in place thanks to the geology of the area. What is surprising is that a nuclear reaction had occurred in a way that the plutonium, the by-product, was created and the nuclear reaction itself had been moderated, which is considered as a "holy grail" for atomic science. Some of the researchers that participated in the testing of the Nuclear reactor concluded, that the minerals had been enriched in the distant past, around 1.8 billion years ago, to spontaneously produce a chain reaction. They also concluded that water had been used to moderate the reaction in the same way that the modern nuclear reactors cool down, using graphite-cadium shafts preventing the reactor from going into critical state and exploding. However, Dr. Glenn T. Seaborg, former head of the United States Atomic Energy Commission and Nobel Prize winner for his work in the synthesis of heavy elements, pointed out that for uranium to "burn" in a reaction, conditions must be exactly right. For example, the water involved in the nuclear reaction must be extremely pure. Even a few parts per million of contaminant will "poison" the reaction, bringing it to a halt. The

problem is that no water that pure exists naturally anywhere in the world. Clearly it did back then Mr. Seaborg, the question is why it has taken near 50 years for this to become more publically available knowledge? The answer is all down to the church and their books timelines fitting the narrative they spit out, and also the cover up of man, along with the cover up that not all advance species on this planet in the past, were human. Like I have said several times in our shows, technology is not the future it is the distant past, and is introduced here at regular intervals to be largely used as a weapon against the people.

Scientists want to build an "ark" on the moon, filled with 6.7 million sperm samples. I wonder if the jizz woman and Texas senator Jessica Farrar who wanted to fine men \$100 for jacking off will approve of that? This "Lunar ark" could be a global insurance policy for mankind against natural disasters and other catastrophes. The idea is similar to the Svalbard "Doomsday" seed vault in Norway, that stores over a million seed samples from around the world. Scientists have suggested that humans could buy into a "modern global insurance policy" by building an "ark" filled with 6.7 million sperm samples - on the moon. What if the moon is a hollowed out space rock and filled with other non human beings? The ark would involve shooting the sperm and ova samples of 6.7 million species up to the moon via multiple payloads. So, they are going to ejaculate the samples then. The samples would then be stored in a vault beneath the surface of the moon, in a "lunar pit," where they could be kept secure. Kept secure by whom, may I ask? Who is building the lunar pit? Who is paying for it? The American peoples again? According to a New York Post report, this would be similar, conceptually, to the "Doomsday" seed vault in Svalbard, Norway, which currently holds more than a million crop samples originating from almost every country in the world. The team of six researchers from the University of Arizona presented their idea at the Institute of Electrical and Electronics Engineers (IEEE) Aerospace Conference, where they said their proposal would protect mankind from extinction. This lunar ark, the researchers said, could help the earth repopulate if a catastrophic disaster - such as a deadly epidemic, a super volcanic eruption, a large-scale nuclear war, widespread drought, or an asteroid - were to occur. Or they could build an ark like they did in the past as a preventative measure for disasters, it was called Noah's Ark. It wasn't Noah's and it wasn't a ship on the oceans either, it was a space ship in the sky. These types of decisions need to be made by the people, not scientists, governments or agencies, all of which have been found out within the last 12 months of being corrupt or just plain stupid. Which is why I keep saying we need to build a peoples movement to be at some point involved in this type of decision making, that is what The Peoples Club is all about. These are decisions we should be making, not preselected politicians working for the el-ites. EXPOSE: Kamala Devi Harris (born 20 October 1964) is a US politician and lawyer serving as the Vice President of the United States from 20 January 2021. A member of the Democratic Party, Kamala Harris served as a United States Senator from California from 2017 to 2021, and as the Attorney General of California from 2011 to 2017. **Early Career tied to Willy Brown:** Harris started her career as a lawyer in 1990, after graduating from Howard University and the University of California's Hastings College of the Law, at the Alameda County district attorney's office in Oakland. From there, she was recruited to the San Francisco district attorney's office to run the department's career criminal unit. In the mid-1990s, Kamala Harris started dating Willie Brown, the mayor of San Francisco and one of California's most powerful politicians. Brown was investigated by the FBI when he was speaker of the California Assembly and as mayor was dogged by conflict of interest, as he used his political machine to steer government contracts and jobs to allies. In 2003, Harris' critics used the relationship with Brown to contend that she was not independently qualified to hold office and that, if elected, she would hesitate to investigate corruption at City Hall. Eric Jaye, a political strategist in the city, said Harris' emergence from San Francisco politics reminds him of Andy Dufresne, the Tim Robbins character from *The Shawshank Redemption*. "Andy Dufresne," he said, quoting a line from the movie, "who crawled through a river of shit and came out clean on the other side." The Brown family are one of the unholy 4 in Californian crime families, Brown, Pelosi, Feinstein and Newsome. Newsome is related to Pelosi but also has family connections to Brown. The connections date back at least 80 years, to when Jerry Brown's father, Pat Brown, ran for San Francisco district attorney, losing in 1939 but winning in 1943, with the help of his close friend and Gavin Newsom's grandfather, businessman William Newsom. **Mid-Career:** In 2003, she was elected district attorney of San Francisco. She was elected Attorney General of California in 2010 and re-elected in 2014. Harris served as the junior United States senator from California from 2017 to 2021. **Views on Israel:** In July 2019, Kamala Harris was interviewed on the Kyle Kulinski show, and was asked whether she considered Israel was meeting international standards of human rights. Harris seemed determined to say nothing that could be remotely construed as critical. It means she sees no problem with Israel’s military detention and torture of Palestinian children. It means Harris sees no problem with dozens of Israeli laws, that discriminate against Palestinian citizens of Israel solely for not being Jewish. These include laws and policies that promote the kind of housing discrimination and official segregation, that is banned in the US thanks to the civil rights laws she claims to uphold. It means she sees no problem with Israel’s recent Nation-State Law, explicitly affirming superior rights for Jews over Palestinians. Kyle Kulinski, an influential left-wing commentator and a founder of the progressive political action committee Justice Democrats, offers a scathing response. He says that Harris brushing aside Israel’s horrific record shows that her “moral” and “ethical concerns” are “nonexistent”: “She’s playing the political game that people play in the United States of America to try to get ahead.” “It shows you that she’s unlikely to change anything,” he adds. “That’s why this is important.” Harris is a puppet of the unholy 4, who are all puppets to the Israeli junta and AIPAC lobbyists. during the 2019 summit the media leaders rued "the first threat to press freedom is the demonization of journalists. From a rhetorical and digital environment where they are framed as enemies of the state, the demonization of journalists crosses over to a physical environment which fuels the rise in attacks on journalists." This is coming from corporate media outlets that have done their utmost to demonize and deplatform independent media. Trust in Authorities and the Establishment: As an example of the issues the Colloquium sees as self-evidently needing to be "solved", Marina Weisband, a speaker at the 2020 Colloquium, discussed the question of trust in authorities. "Weisband explained that this is caused by a lack of control and overview in a complex world. In this context, media would need to stop magnifying irrelevant but loud groups, as well as regarding the view of authoritarians and populists as equally valuable, but rather shape a common ground for discussion. Weisband hopes that with improved transparency and improved education the fundamental distrust in media and the establishment could be minimized. Weisband who is born to, yet another Jewish person in a lead position to decide what is best for the establishment. The point is there are no journalists anymore, just a bunch of yes people who lie through their teeth. M100 Young European Journalists Workshop: The M100 Young European Journalists Workshop (M100YEJ) was initiated in 2005 as part of the Colloquium. Every year, the workshop is addressed to 25 young journalists between the ages of 18 and 26 from Europe, the countries of the Eastern Partnership and Russia. In addition to the cultivation of practical and theoretical knowledge relating to journalistic work, the workshop also seeks to generate professional contacts and long-term ties among participants. In plain speak, that means they are trying to acquire Eastern European and Russia journalists as spies. Some of the M100 alumni now work for successful independent funded European media" (several of these are aligned and openly or covertly funded by Western governments), "such as De Correspondent in the Netherlands or Hromadske.TV in Ukraine. Others have founded their own media organizations, such as the investigative network Correctiv or the international reporting platform Outriders." Sponsors: Sponsors include the German Foreign Ministry and the US Govt funded National Endowment for Democracy, Friedrich Naumann Stiftung, whose founder was a part of the Nazi Party and wrote journalistic pieces for Joseph Goebbels paper Das Reich, the PR agency Agentur Medienlabor.

In 1947, PROJECT SIGN was created to acquire as much information as possible about UFO's, their performance characteristics and their purposes. In order to preserve security, liaison between Project Sign and MJ-12 was limited to two individuals within the intelligence division of the Air Material Command, whose roll was to pass along certain types of information through channels. Project Sign evolved Project Grudge in December of 1948. Project Grudge had an overt civilian counterpart named PROJECT BLUE BOOK, with which we are all familiar. Admiral Hillenkoetter, director of the CIA from May 1, 1947 until September 1950, decided to activate the "Robertson Panel," which was designed to monitor civilian UFO study groups that were appearing all over the country. He also joined NICAP in 1956 and was chosen as a member of its board of directors. It was from this position that he was able to act as the MJ-12 "Mole", along with his team of other covert experts. They were able to steer NICAP in any direction they wanted to go. With the "Flying Saucer Program" under complete control of MJ-12 and with the physical evidence hidden away, General Marshall felt more at ease with this very bizarre situation. The main thrust behind the original "Security Lid", and the very reason for its construction, was the analysis and attempted duplication of the technologies of the discs. The activity was headed up by the following groups. 1. The Research and Development Board (R&DB) 2. Air Force Research and Development (AFRD) 3. The Office of Naval Research (ONR) 4. CIA Office of Scientific Intelligence (CIA-OSI) 5. NSA Office of Scientific Intelligence (NSA-OSI) No single one of these groups knew the whole story. Each group was to know only the parts that MJ-12 allowed them to know. MJ-12 also operates through the various civilian intelligence and investigative groups. The CIA and FBI are manipulated by MJ-12 to carry out their purposes. The NSA was created in the first place to protect the secret of the recovered flying discs, and eventually got complete control over all communication intelligence. This control allows the NSA to monitor any individual through mail, telephone, telexes, telegrams, and now through on-line computers, monitoring private and personal communications as they may desire. The name "JASON" is sometimes explained as an acronym, standing either for "July-August-September-October-November", the months in which the group would typically meet; or, tongue-in-cheek, for "Junior Achiever, Somewhat Older Now". But neither explanation is right and in fact, the name is not an acronym at all. It's simply a reference to the Greek myth, Jason. The wife of one of the founders (Mildred Goldberger -born to again) thought the name given by the defense department, Project Sunrise, was unimaginative and suggested the group be named for a hero and his search. Mildred (Ginsberg) Goldberger was an American mathematician and economist. She was a research assistant and computer at the Metallurgical Laboratory at the University of Chicago during the Manhattan Project. She was one of ten women to sign the Szilard Petition, a document written by physicist Leo Szilard petitioning against the use of the atomic bomb on Japan. She was married to Marvin "Murph" Goldberger, a physicist who taught at Princeton

during J. Robert Oppenheimer's tenure as Director of the Institute for Advanced Study. The Goldbergers would eventually become President and First Lady of CalTech.

Data released today by the Centers for Disease Control and Prevention (CDC) on the number of injuries and deaths reported to the Vaccine Adverse Event Reporting System (VAERS) following COVID vaccines remain consistent with previous weeks, with the exception of a 31% spike in reports of Bell's Palsy. Every Friday, VAERS makes public all vaccine injury reports received by the system as of Friday of the previous week. Today's data show that between Dec. 14, 2020, and March 5, a total of 31,079 total adverse events were reported to VAERS, including 1,524 deaths, an increase of 259 over the previous 7 days, and 5,507 serious injuries, up 1,083 over the same time period. The deaths are a 17% increase in one week, imagine if the virus went up 17% in one week the outcry and bs'ery would be merciless, yet curiously ignored by portal people and fiction checkers. Of the 1,524 deaths reported as of March 6, 30% occurred within 48 hours of vaccination, and 46% occurred in people who became ill within 48 hours of being vaccinated. According to CNN, the level of precautions taken are determined by the characteristics of unvaccinated people. Fully vaccinated people can visit with other vaccinated people indoors without masks or social distancing, and can visit indoors with unvaccinated people from a single household without masks or physical distancing, if the

unvaccinated people are at low risk for severe disease. But they fail to answer the basic questions, if vaccines worked why would you need to social distance? why would you need a mask? why should they be concerned of whether other people are vaccinated or not? In the U.S., 85.01 million COVID vaccine doses had been administered as of March 5. That means that at a minimum 42.5M to 60M people have been given the techno jab, 42.5 if people have had 2 doses, and the 60M as it varies between people who have had 1 or 2 doses. I appreciate some were forced into taking it, but 40-60M people taking a vaccine with no personal research done on it, if they had they would not have taken it, is classic bots and Milgram experiment people.

There is a dashing of glorious irony for this next piece, the Australian Health Minister Greg Hunt was hospitalized two days after taking AstraZeneca's COVID-19 vaccine. Pfizer wanted Argentina and Brazil to guarantee the company would be compensated for any expenses resulting from injury lawsuits against it. Pfizer demanded Brazil waive sovereignty of its assets abroad in favor of Pfizer, to not apply its domestic laws to the country, not penalize Pfizer for vaccine delivery delays, and exempt Pfizer from all civil liability for COVID vaccine side effects. Brazil rejected Pfizer's demands, calling them "abusive." Nine other South American countries have reportedly negotiated deals with Pfizer. It's unclear whether they actually ended up giving up national assets in return. That piece alone should stop anyone else from ever taking another vaccine, the company themselves know there is severe risks of taking these poisons.

US Dep. of Health said we believe countries should work together to save lives. Efforts to undermine the vaccines are unethical and are costing lives. Yet they speak from two separate orifices it seems, or perhaps it's the same waste content is coming out of both orifices? American diplomats actively persuaded the Brazilian government not to approve a Russian-made corona virus vaccine, as part of a campaign to counter the country's "malign influence," Washington has revealed in a bombshell admission. On Monday, Russia's Direct Investment Fund (RDIF), which financed the development of the Sputnik V jab, published an excerpt that recently came to light from the annual report of the US Department of Health and Human Services (HHS), which is responsible for healthcare and access to medicines. As part of the self-appraisal of the department's successes in 2020, it confirmed that its international team, the Office of Global Affairs (OGA), "used

diplomatic relations in the Americas region to mitigate efforts by states, including Cuba, Venezuela, and Russia, who are working to increase their influence in the region to the detriment of US safety and security.” How the use of the jab, which has already been approved by 51 countries across the world, would have been to the detriment of Americans’ safety and security is not detailed. US Dep. of Health publicly confirmed that it pressured Brazil against Sputnik V.

Nursing home staff in France are hesitant to take a Covid-19 jab, according to local media, with a trade union official telling RT that the problem is the lack of communication and trust in authorities. France has one of the highest vaccine skepticism rates in the world, the country's media reported earlier this month. Four in ten people there say they are unlikely to get vaccinated against the novel corona virus anytime soon. The sentiment seems to be even more widespread among the French medical caregivers, since around half of them are in no rush to take the jab even if they have an opportunity to do so. According to government statistics, 25,000 people died from Covid-19 in French nursing homes. That is more than a quarter of the total national death toll linked to Covid-19, which amounts to over 87,000. We have lost confidence in the government over the vaccine process, people are concerned about side effects, some want to wait and get more information. 25K elderly patients died in nursing homes in France alone, just as we had warned of back in May of last year, that is not a side effect, that is mass murder.

Of the nearly 35,000 people living in New York’s group homes for disabled individuals, 552 have died from Covid-19 since last year and over 6,000 residents and workers have been infected with the virus, according to the New York State Office for People With Developmental Disabilities (OPWDD). Many are now pointing to an April 10 directive from the Cuomo administration, which is similar in tone to a controversial and now-reversed order for nursing homes, which forced such facilities to accept Covid-positive patients, which critics say led to thousands of unnecessary deaths. “No individual shall be denied re-admission or admission to a Certified Residential Facility based solely on a confirmed or suspected diagnosis of COVID-19,” the directive states.

An analysis done by Dr. Hervé Seligmann and Haim Yativ had them conclude that, Pfizer's shot causes "mortality hundreds of times greater in young people compared to mortality from corona virus, and dozens of times more in the elderly." In other words, the cure is worse than the disease - by a long shot. The authors referred to this as "a new Holocaust". And Israel isn't the only country with data like this coming to light. On Monday, the prosecutor of Biella, a town in the northern Italian region of Piedmont, ordered the preventive seizure of the country's entire 'ABV5811' batch of Oxford/AstraZeneca vaccines. Prosecutor Teresa Angela Camelio's order affects nearly 400,000 doses of the Anglo-Swedish jab. Camelio said the decision to seize the batch was made pending the outcome of an investigation by the Judicial Authority and the Medicines Supervision Commission into the death of Sandro Tognatti, a music teacher who died on Saturday night a few hours after the administration of the Covid-19 vaccine produced by AstraZeneca.

In our lifetime we saw the rise of feminism, and yet this practice of demeaning young girls persists, all because of parents seeking fame and money for their child, whilst they live off of the glory of it should it be attained, but at what cost? You are teaching your child wrong values in life in doing so, fame and fortune is not the be all and end all of life, overly sexualizing young girls, teaching young girls to be bitchy and competitive, stimulating and enticing pedophiles, teaching your children to use their bodies to get on in life, are not good parenting skills. I know it is the culture here, but your culture is wrong on many levels.

The killing of George Floyd last year triggered a national debate about racial injustice not just in the US, but in the UK, too. Naga Munchetty travelled across the UK to understand what race and racism means today. I have experienced racism, you never forget the first time you hear that painful and distressing word. I was seven, when someone I thought was a friend at school, told me we could no longer hang out. They used the P-word, making clear the reason was because of the colour of my skin. The P word is Paki, short for Pakistani. The sense of shame was overwhelming, I was told I didn't belong when up until then I assumed I did. From that moment I knew I was seen as different, that first hurt never goes away. I grew up in south London, my dad was from Mauritius and my mum was from India. Both were nurses, they too received racial insults at work, including the P-word. News events last year catapulted the subject of race into many conversations people were having. Yes because it is a program being ran on the people, and also because far too many people are a victim of something and everything these days, the offended by everything crew and woe is me, that is the real epidemic. Like I have said, this world is racist, every color and every culture, but this labeling of one

group only, is a program. Miss Munchetty would be better served focusing on the rampant racism within her own culture in India, as it is all too easy to point fingers at others, yet rarely is it pointed at your own. Whites are racist, and so is every other color due to geneticism not racism. India is largely all the same color and yet they have caste systems, incidentally the same as the Jews, same people, same program is why. Caste systems are racism, and yet we have these sanctimonious reporters and media peoples all focusing on one group, if Miss Munchetty wants to erase racism, then it starts at home and your own culture. Indians object to being called a Paki, because they are racist to their neighboring country, who are also the same color. Don't believe me? try this next piece then.

A controversial new anti-conversion law that criminalizes interfaith love has put Hindu-Muslim couples on edge. Now, they face the wrath of not just their families, but also the Indian state. The iron door opened just enough for the girl to peep out, she looked scared. Ayesha and her boyfriend, Santosh (both their names have been changed) are on the run. "My parents have come to look for me and they are outside somewhere," Ayesha said. "We are scared. We have been asked to stay inside." The couple, both 29, fled their home town in the western state of Gujarat. For now, they are living in a safe house - a nondescript two-story building - in Delhi. Also hiding with them is another couple from Uttar Pradesh state in India's north. In November 2020, Uttar Pradesh became the first state to pass a law - Prohibition of Unlawful Religious Conversion Ordinance - banning "unlawful conversion" by force, fraudulent means or marriage. It was in response to what right-wing Hindu groups call "love jihad", an Islamophobic term denoting an alleged plot, that accuses Muslim men of seeking to make Hindu women fall in love with them, with the sole purpose of converting them to Islam. Banning people being together because they are a different religion is another form of racism, in their terms. What happened to the so called morals of the church and how all people need to be righteous, yet curiously all that goes out of the window, when it is a different god or religion. Like I have said with 2/3 of humans following religion on this planet, that states it is all so holy and righteous, why aren't 2/3 of this planets people in a better state of mind? Which tells thinking people not emotionally attached that religion doesn't work, it doesn't do what it says on the tin, and is a failed program.

When people speak without thinking we end up with stories like this. Under the banner of trying to combat racism allegedly, THI listeners know of the wider agenda, the mayor of London said this.
