Facebook data from over 533 million users was leaked, Insider reported last week. Now the company won't notify impacted users, a representative said on Wednesday. Facebook isn't notifying impacted users because the company isn't sure whose data was leaked. Moreover, since users are unable to fix the issue and the data is already public, Facebook is choosing not to identify and inform users. The data leak included phone numbers, full names, locations, email addresses, and biographical information of over 533 million Facebook users from 106 countries. US users made up the majority with over 32 million users impacted, with users in the UK and India representing the second- and third-most impacted regions. These events are rarely random acts, largely done by 5 eyes groups to obtain data streams on more people, or used for financial gains to sell to marketing advertisers. China must "fully liberalize" its birth-control policy to increase its labor force in the upcoming decades and compete with such countries as the US economically, a paper published by the People's Bank of China says. Beijing should pay close attention to the fact that the country's birth rate is declining, while its population is aging fast, the researchers argued. The research, which was published this week by China's central bank as part of its working paper series, suggests that the country's main economic rival, the US, is undergoing "favorable changes" in working population rates, largely through mass immigration. Based on statistics and forecasts by the United Nations — which might even overestimate China's reproduction rate, according to the researchers — the report suggests



that in the next three decades, China's population will decrease by some 32 million people. At the same time, US may add 50 million people to its population by 2050. The US police officer who died after January's Capitol riot had two strokes and died from natural causes, the chief medical examiner for Washington DC has ruled. Two men are accused of using a type of pepper spray on Officer Brian Sicknick. However, the ruling means they are now unlikely to be charged with homicide. The autopsy found no evidence of an allergic reaction to chemicals, nor of internal or external injuries, Dr Francisco Diaz said. Officer Sicknick, 42, was defending the Capitol building from supporters of then President Donald Trump who stormed it on 6 January. He collapsed after returning to his office during the siege, and died the next day in hospital. In his ruling, Dr Diaz found Officer Sicknick died of a medical condition which was not brought on by an injury. West Virginia is about to lose another congressional seat because of steady population decline, Republican lawmakers are convinced a massive income tax cut is the key to reversing the trend. But figuring out how to do that without harming the state's most vulnerable, or punching a massive hole in the budget has proven complicated. Although the United States doubled its population over the past seven decades, West Virginia headed in the other direction. Tracking closely with the long-term decline of the coal industry, it is the only state in the nation with fewer residents than in 1950. Figures from the 2020 U.S. census, expected to be released later this month, are projected to reduce West Virginia's seats in the U.S. House from three to two. Fathers in Utah are now legally obliged to pay half the cost of a mother's medical care related to pregnancy and delivery. Supporters of the law - which is thought to be the first of its kind in the US - say it will help alleviate the financial burden of motherhood for American women. The legislation passed with bipartisan support - but it raises questions about the cost of parenting in the US, as well as the state's growing roster of anti-abortion legislation. Utah's Shared Medical Costs law requires biological fathers to pay half of a mother's insurance premiums - her monthly health insurance costs - during pregnancy as well as all other related medical fees, including the birth of the child. For US women with insurance, giving birth costs an average of \$4,500 (£3,254) out of pocket, according to a study in the Health Affairs journal that tracked costs from 2008 - 2015. For those without coverage, this figure could more than double: the not-for-profit Fair Health organisation reported the average as closer to \$10,000. If paternity of the child is in question, fathers are able to delay payments until paternity is proven. The payment process is not automatic. Similar to child support, if a woman does not seek assistance, the father will not be notified. The same financial obligation does not apply if a woman wants to terminate the pregnancy. Biological fathers will not be required to contribute to the cost of an abortion if it is sought without their consent, except in the case of rape or if the mother's life is in danger. The cost of an abortion, without insurance, is roughly \$1,000 according to Planned Parenthood. The law, which will take effect on 5 May, passed unanimously with bipartisan support in the state's Senate but faced Democratic opposition in the House of Representatives. An Oath Keepers militia leader said members of the anti-government extremist group are being trained by "active-duty" police officers, during a 60 Minutes interview. During the Sunday evening interview, Jim Arroyo, vice president of the Oath Keepers Arizona chapter, said serving officers were members of the extremist group and were helping with training. Speaking with 60 Minutes' Sharyn Alfonsi, Arroyo said: "Our guys are very experienced, we have active-duty law enforcement in our organization that are helping to train us. We can blend in with our law enforcement, in fact, in a lot of cases, our training is much more advanced because of our military backgrounds." The CBS program also explored the origins of the militia and profiled member Stewart Rhodes who founded the Oath Keepers in March 2009. Members of the far-right militia group have since been present at key standoffs, the most notable being in 2014 when they stood with Clive Bundy, a Nevada rancher, who was in dispute with the Bureau of Land Management over his use of federally owned land. Oath Keepers arrived armed to the standoff with federal officers. Members of the militia were also present during the January 6 storming of the



U.S. Capitol. Ireland: Inciting hatred on social media could carry prison sentence of up to six months For the first time in the history of the State it will become a specific criminal offence, with longer prison terms, to commit a hate crime based on the color of a person's skin, sexual orientation or their gender, including gender expression or identity. Other new "protected characteristics" from which a hate-based conviction can result include a victim's race, nationality, religion, ethnic and national origin, and any disability. The new offences, set to be provided for under the Criminal Justice (Hate Crime) Bill 2021, are the first of their kind in the Republic. Minister for Justice Helen McEntee is due to publish the general scheme of the Bill on Friday morning. "These crimes are motivated by prejudice, they make victims feel afraid for their future, their friends and their families. They lead to a divided society, where whole communities can feel unsafe and angry," she said, adding, "perpetrators will know that we are determined to stamp out prejudice and hate." Displaying content intended to incite hatred in a public place, including on social media, will carry a prison sentence of up to six months on conviction. However, very specific "intent or recklessness" criteria must be met before such charges can be brought. Under the criteria, which are designed to ensure "giving offence" is not criminalized, a conviction could only be arrived at if it was found a suspect deliberately acted to incite hatred, or at least felt it was likely they would incite hatred and decided to persist with their actions anyway. All very vague and discriminatory to me, which is deliberate because these bills encouraging the targeting of individuals the system doesn't approve of. Thousands of motorists and passengers were stuck in traffic for hours after police blocked major roads in Kenya's capital, Nairobi, to enforce a Covid curfew to battle infections. Last month President Uhuru Kenyatta introduced a 20:00-04:00 curfew to deal with a third Covid-19 wave. "Whereas the foregoing measures will have a negative impact on the economy, these measures are temporary... the cost of not acting now will be much greater," Mr Kenyatta said. The doctors union said at the time that there were no free intensive-care beds because of an increase in hospitalised Covid-19 patients. Kenya has confirmed more than 151,000 cases of the virus and just over 2,400 deaths. The UK and US have issued travel bans to the country because of Covid-19 and other security concerns. Like the ST. In response to Trump's statement for example, the Director of National Intelligence's office firmly refuted the idea Covid-19 was "manmade or genetically modified." Of course, the virus could be neither and still have escaped from a lab. French teachers in the city of Nice have overwhelmingly rejected AstraZeneca's Covid jab after just 58 out of a possible 3,000 signed up to be vaccinated. The jabs were being offered at a mass vaccination centre in Nice's Palais des Expositions this weekend, with 4,000 available to those aged over 55 in high-risk occupations, meaning 3,000 teachers eligible to take part. But the centre was forced to close after just four hours on Saturday due to lack of demand with just 58 appointments registered, and did not reopen today despite being scheduled to do so. That means the take-up rate among eligible teachers was just 2 per cent, with one local official blaming vaccine hesitancy caused by scaremongering around the British-made jab. Anne Frackowiak-Jacobs, sub-prefect of nearby Grasse, said people had 'turned around' when they learned they would be given AstraZeneca. The AstraZeneca jabs will instead be sent to a nearby fire station to be used by government employees on the priority list, Nice Martin reported. TOPICS FOR PONDERING: Here is more examples of people blindly following the techno route. Researchers from the University of Georgia have conducted a study which confirms what many already suspected; humans now tend to trust algorithms more than each other, especially when it comes to tedious tasks. The premise of the study was simple: some 1,500 participants were shown photos and asked to count the number of people in them. The participants were able to take suggestions from a computer algorithm, or the averages of guesses from their fellow humans in order to complete the task, which involved images of 15 to 5,000 people. As the crowd size or complexity of the task increased, the participants, understandably, relied more and more on the algorithm to count the people. After all, computers are especially good at tedious tasks that humans shy away from, such as counting, yes just ask John Hopkins disciples. "It seems like there's a bias towards leaning more heavily on algorithms as a task gets harder and that effect is stronger than the bias towards relying on advice from other people," says management information systems PhD student Eric Bogert, from the University of Georgia. The researchers concede that, in this particular task at least, there is no ambiguity in terms of the answer, only right or wrong, so the lack of nuance or perspective makes the task ideal for an algorithm as opposed to a human. "This is a task



that people perceive that a computer will be good at, even though it might be more subject to bias than counting objects," says Aaron Schecter, an information systems researcher from the University of Georgia. However, the researchers emphasized that our perception of how accurate an algorithm can be plays an important factor – outsourcing the task to a machine unwittingly affords the opportunity for bias and discrimination to creep in unbeknownst to the human participants. Yet again the human trait of taking the easy path instead of learning stuff themselves rears it's ugly head, and this fact has contributed to the downfall of man on many levels. With smart phones seemingly ubiquitous in the industrialized world, sleep researchers have confirmed what many already suspected – technology is disrupting human sleep in ways we still don't fully understand. Humans, along with plants, fungi, and animals, possess what is known as a circadian rhythm, the internal clock that regulates our sleepwake cycle. As far as scientists can tell, the majority of this rhythm is maintained by the hypothalamus which releases the sleep hormone melatonin, and is highly responsive to changes in ambient light, especially around dawn and dusk. However, artificial light can impact the dynamics of the hypothalamus, and increased exposure to blue light from electronic devices like smart phones, laptops and certain kinds of ereaders is having a gradual impact on modern humans' near 24-hour intrinsic sleep rhythm. "Light is mainly doing two things to the clock, it is setting the time of the clock and it is changing the amplitude or strength of the clock," says professor Jamie Zeitzer from Stanford University. A growing body of research indicates that artificial light can suppress melatonin production in humans, thereby disrupting the natural inclination to sleep at the end of the day, often lengthening the time it takes to drift off to sleep. There is evidence that 1.5 hours (or more) of bright screen use reduces the natural nighttime increase in melatonin, and this effect may compound over multiple nights," says Dr Cele Richardson from Western Australia University. Previous studies have found that pre-sleep activity can impact the length of time required to fall asleep. One 2014 study compared e-book versus printed book readers and found that the latter group fell asleep up to 10 minutes earlier. But from overview this is a massive victory, the fact that some will go on, when we were designated to be exterminated should not be lost on the listener.

GLOBAL FINANCIAL EXPOSE 1: In 1930 Franklin Delano Roosevelt who was the Jewish Elite puppet remember In FRWL Plus Part 7, represents USA Inc at the Geneva Conventions. The G5 nations agree to declare bankruptcy by treaty in International jurisdiction in May of that year, and plans to remove the gold standard are made. In 1933, FDR is declared President of the USA Inc. and promptly pursues USA Inc domestic bankruptcy as well. The banks name their Trustee, The Secretary of the Treasury of Puerto Rico via Federal Title 5. March 6th 1933 the conference of Governors is told that the USA Inc is now declared bankrupt. They immediately pledge the good faith and credit of their states and citizenry thereof in support. This can only refer to the Territorial citizenry, as FDR had already committed the Municipal citizenry in his first inauguration speech. Nobody mentions their states are just franchises of the USA Inc, and that their citizenry amounts to public employees, African Americans and corporations formed under the auspices of the USA Inc. It should be noted the Federation has sovereign immunity and cannot go bankrupt. For those who are new, the term USA Inc. means the US Government stationed in the principality that is not a part of America, called the District of Columbia. The fact is this USA Inc has been acting as our Government since 1871, we have had no real Government since. So, it was their fake corporation acting as Government that went bust, not the country, the states or the people. The way to end this is to stop voting for their fake Government and demand a return to the real one, for and by the people. Roosevelt issues Executive Orders announcing and implementing the domestic bankruptcy, and moves to confiscate privately held American gold assets from the people. In all 20K tons of gold was admitted to be taken, 6K went to the Federal Reserve, the rest went to the IMF, IBRD the International Bank for Reconstruction and Development which was part of the Marshal plan and also the World Bank. properties was set up and Birth Certificates are issued, all to claim Americans as property, this was called Human Resources. Birth certificates are used to register vessels of commerce as property belonging to the USA Inc, that pledged to pay the debts of the already bankrupt governmental services corporation. The people who were left uninformed continued to use their Trade names as always. The perpetrators claim that this establishes an implied contract and implied consent to be considered as citizens of the United States, when in fact there was no disclosure, no apparent offer, and no conscious acceptance of this proposition. This giant fraud continues to this day, your birth certificates are traded on the stock markets and they collect the bounty. Your name in capital letters is not your real name, that is your trade name. The term United States is nothing to do with America, it is a European harvesting based entity formulated in Vienna in 1815. Now you all know the reason for the organization called Human Resources, they are and have been using us all as a resource, the fact they call it Human resource could be suggestive it is being ran by non human entities, does it not?

United States citizens (territorial persons) and the citizens of the United States (municipal persons) serve the Federal Government (parent corporations). They live either in a Territorial democracy or a Municipal Oligarchy (theocracy) and have no constitutional guarantees, and their labor and assets are pledged as collateral backing Government debt. In return, they receive benefits from the Public Charitable Trust, all of which they pay for themselves. They are subject to every whim of Congress until 1968 and then only have equal civil rights, mere privileges to rely upon. If the birthright Americans lose their claim to their Natural and Unalienable rights, there will be nothing left as a standard for civil rights to be equal to, leaving the door open to the total enslavement of the people of this country, and the debasement of our society at the hands of Congress acting as a plenary Oligarchy, which was in Article 1, Section 8, Clause 17. Plenary means absolute, unlimited powers. Our private lawful trade names on the land are arbitrarily redefined to be public Foreign Situs Trusts operating in Admiralty. The Crown is situated in it's own principality and not subject to UK rules or taxes, just like DC. Mentioned earlier "The banks name their Trustee, The Secretary of the Treasury of Puerto Rico" this is connected to the IRS, who are not an American company, they are a Puerto Rican Trust operating on behalf of The Crown. Your income tax taken by the IRS is not income tax at all, it is a tribute to The Crown, nowhere in the IRS manual does it state you must pay taxes on your income, because it is not a tax, it is a tribute, just like the Kosher foods tax is a tribute to the Rabbis, same program and same people is why. It was The Crown agents who wrote the bible known as the King James bible. In 1937, the Legal title was given to the Municipal Government, and the baby is merely recognized as an Authorative Representative, which is an employee of it's own Estate. The Municipal Government doing business as the USA Inc. creates it's own franchise as John Joseph Average (all capital letters) a foreign Puerto Rican Cestue Que Vie trust registered in Washington DC by the Department of Commerce, to manage the legal title. CUSIP bonds based on the estimated value of our lifetime earnings are issued and traded on the stock exchanges. The practice of trading and speculating in the value of human labor, is then used to fund the Government. Federal Revenue sharing and block grants are polite euphemisms for racketeering kickbacks and payments, from selling tranches of human labor bonds and other public assets. This criminal scam based on non disclosure, fraudulent conveyance, unlawful conversion of assets, impersonation, and semantic deceit runs from 1933 to 1999, when the bankruptcy of the USA Inc is finally settled and discharged, but the crime scheme continues. Andy Blumenthal March 14th 2021 This week, Jordan's Crown Prince Hussein cancelled a trip to the Temple Mount in Jerusalem after a disagreement with Israel, over the size of his security detail and the heavy weapons they brought to enter the sovereign State of Israel. In context, this can also be seen as part of a historical conflict over the authority of the holy Temple Mount itself. In Judaism, we yearn and pray daily to "restore G-d's divine presence to Zion" with the rebuilding of the holy Temple in Jerusalem. Generally, Judaism believes that the 3rd Temple will be rebuilt in the time of the Mashiach, so any forward discussion of it before this period of redemption is not typically encouraged, and may even be considered sacrilegious in some ultra-Orthodox circles. G-d and the Messiah is Lucifer. So while even now-a-days, with Jerusalem and the Temple Mount in our hands since the 1967 War, many Jews will not even ascend and pray on the Temple Mount, because apparently it is not yet time for the rebuilding and therefore, we do not even approach the extreme sanctity of where the Holy of Holies once stood. Yes, after 2,000 years, Jerusalem is once again in our hands, and it is "the unified and eternal capital" of Israel, yet the Temple Mount is not under our stewardship, but rather is managed by the Islamic Waqf and under Jordanian custodianship. For over 1,300 years, the Temple Mount has been divorced from having been the site of two holy Jewish Temples, and instead made to be seen much more narrowly as Islam's 3rd holiest site, with the al-Agsa Mosque and the Dome of the Rock, where Mohammed is said to have ascended to heaven. In essence, the Jewish Temples have been not only physically buried over, but also the site has been historically Islamicized despite the Temple Mount's intrinsic holiness to all three major religions (Christianity, Islam, and Judaism). Those three religions all stem from one program, Hebrew Annunaki, the prominent one is Judaism, Christianity is a fake copy of Judaism, and Islam derived from a Christian sect,

Now, the Jewish people have survived through the destruction of both our first and second Temples in 586 BCE and in 70 CE, as well as our long exile from our homeland until the founding of the Modern State of Israel in 1948. Yet, even with our miraculous redemption from the Holocaust and the return of our people to the land of our forefathers, the Promised Land of Israel, we are still not able to see the rebuilding of our holy Temple in Jerusalem. While of course, it is a great honor to even be able to go and pray at the Kotel (the Western Wall) of what was once our beloved Temple, we are still at arms-length from the actual rebuilding itself and the subsequent ability to once again fulfill all the mitzvot associated with it. While I understand that we, as Jews, must merit the arrival of Mashiach and the rebuilding of the Temple, and we must do everything we can in terms of following the Torah and tikkun olam to hasten the arrival, still it painful to see only the Mosque and the Dome of the Rock perched atop Judaism's holiest site, where literally Heaven and Earth are said to meet since creation of the world itself, and where the sacred binding by Abraham of his beloved son, Isaac, took place in a supreme test of his faith in Hashem. Further, it is even more awful when some Muslim leaders deny the very existence of our having had a holy Temple to begin with, and resorting to violence and terror during the Intifada and other Arab riots, hurling rocks from the Temple Mount unto the heads of the Jews praying below. Not only is it a grave physical danger to the people worshipping at the Kotel, but also it is a vile desecration to our freedom of religion to be under attack in our most holy place. What a load of pro pagan da that is. But what can we do even as Israel is surrounded and vastly outnumbered by enemies in terms of our geographic and political reality, yet are we not entitled to have our people and their religious rights respected and no longer vilified and defiled? What will be special about the 3rd Temple is that it will not only be for the Jewish people, but for all the world's people to come together harmoniously to recognize and worship the one true and faithful G-d of us all. Is there circumstantial evidence to support this? Time to look at the maps. On the peninsula that includes Saudi Arabia, remember the House of Saud are all the Jewish elites, and so that country was long ago annexed before the state of Israel came into existence. War of Independence 1947-1949 they attacked Egypt, Iraq, Transjordan, Syria, Lebanon, Saudi Arabia, Yemen, Holy war Army and the ALA. Sinai War 1956, they attacked Egypt again Six day war, which is a misnomer 1967, they attacked Egypt, Syria, Jordan and Lebanon War of Attrition 1967-70, they attacked Egypt, Soviet Union, PLO and Jordan Yom Kippur War 1973, they attacked Egypt, Syria, Iraq, Jordan, Algeria, Morocco, Saudi Arabia, Cuba and North Korea. Operation Litani 1978, they attacked the PLO First Lebanon War 1982-1985, they attacked PLO, Syria, Jammul and Amal. Security Zone campaign 1985-2000, they attacked Hezbollah, Jammul and Amal. First Intifada 1987-1993, they attacked UNLU and Hamas. Second Intifada 2000-2005, they attacked Palestine and Hamas. Second Lebanon war 2006, the attacked Hezbollah. Operation Cast Lead 2009, they attacked Hamas. Operation Pillar of Defence 2012, they attacked Hamas. Operation Protective edge 2014, they attacked Hamas. If you thought that wasn't enough, add in 86 other military operations carried out, plus dozens of other top secret missions that rarely gets published by the Jewish owned media. So just on that peninsula they attacked every country multiple times, Lebanon, Jordan, Syria, in fact the only countries not attacked yet on that peninsula is the UAE, Qatar and Oman, which the Israelis did deals with recently, which leads to more annexing. The Saudis on behalf of Israel, have been involved in a brutal war with the other remaining country on that peninsula, Yemen. That war has been ongoing since 2014, again Yemen is a coastal country which then closes off the Red Sea to anyone they don't allow to trade, so that all trade is done by the Jewish el-ites. But lets go left as well, as Israel's western border keeps extending further and further into Egypt, who they have attacked several times. The end goal will be the takeover over of the Suez Canal. In Northern Africa they have attacked Egypt, Libya with American assistance,



Algeria and Morocco, essentially all the countries with access to the sea. Like they did with the port city Jaffa, now Tel Aviv a traditionally Arab city until the "settlers" started to move in, and once that starts it never stops, then the el-ites step in and claim it with or without a war. In 1948, under pressure from their World War II allies and to the dismay of the Somalis, the British like they did with Palestine, "returned" the Haud (an important Somali grazing area that was presumably 'protected' by British treaties with the Somalis in 1884 and 1886) and the Ogaden to Ethiopia, based on an 1897 treaty in which the British ceded Somali territory to the Ethiopian Emperor Menelik in exchange for his help against plundering by Somali clans. By British is not meant British people, it was the Jewish led East and West Indies Companies under the guise of the Rothschild's that gave it to Ethiopia. So now you can see the Jewish caliphate creep along the Northern and Eastern parts of Africa, all of which have a key component, access to the sea for these are the original pirates of the sea who came on the land under Admiralty law. Lets now head East from whence they came, and lets start with Kuwait another major port country, that the US and Israel asked Saddam Hussein to invade then double crossed him to then takeover the strategic oil reserves under the pretences of rescuing the country from the regional bully Saddam Hussein. The Kuwait-Najd War of 1919-20 erupted in the aftermath of World War I, The war occurred because Ibn Saud of Najd wanted to annex Kuwait, Ibn Saud part of the House of Saud and Jewish el-ite family. North of Kuwait we come to Iraq, to fight back against Hussein who had been give the go ahead to invade Kuwait, and was heavily funded by the CIA and others in fighting the Kurds, and they funded the Iraq war with Iran. In April 1920 the British Mandate of Mesopotamia was created under the authority of the League of Nations. A British-backed monarchy joining these vilayets into one Kingdom was established in 1921 under Faisal I of Iraq. Yet again the Rothschild's under the banner of a British Mandate is involved in annexing another country. Iraq was invaded by the Mongols just like Iran by Genghis Khan who it is alleged killed 1.7M in a single day. Just 250 years later in 1401, a warlord of Mongol descent, Tamerlane (Timur Lenk), invaded Iraq. After the capture of Baghdad, 20,000 of its citizens were massacred. Timur ordered that every soldier should return with at least two severed human heads to show him (many warriors were so scared they killed prisoners captured earlier in the campaign just to ensure they had heads to present to Timur). Sounds like the same group of psychopath savages to me. North of Iraq is Turkey, a very strategic country as it is the



boundary between the four compass points, and also the gateway to Russia. On the NE side of Turkey in the Caucasian region is Armenia, that country along with many other former Russian states was taken over after WW1. Armenia, Georgia and Azerbaijan were all annexed following the war by the Red Army, and we all now know the Red Army is not Russian. The Armenian citizens were led on a death march out of their country, like in Russia they killed all the intellectuals, and order 800K to 1.2M to march through the desert region in Syria, without food and water and the majority of them died, the rest were slaughtered. When it was all over Armenia lost 90% of it's population. Why were those countries annexed, because they were the region between Russia and Iran. NE of Iran lies Turkmenistan, which means Turk men and so links to Turkey, historically these were Indo-Iranians, which was why after WW1 they formed a coalition to take Russia back. North of that is Kazakhstan which was taken over earlier by Genghis Khan, who went onto ransacking Iraq and Iran. East of that is Tajikistan which is a mixture of Turks and Iranians, again riddled with war and claims of ownership is a part of the life span of this country. This country was also ravaged after WW1 by the Bolsheviks Jews Red Army, mass famine and mass die offs to allow an easier takeover of their country. A number of these istan countries gained Independence in 1991-92 and almost all of them endured civil wars straight after it.
