G7 nations close to historic deal to tax tech giants in plan that would 'change the world', says German finance minister. The plan to reform the taxation of tech firms and bring in a minimum level for business tax rates would "change the world", bringing in billions of pounds in tax revenue which would otherwise have been shifted to low tax countries. The comments came as ministers from the Group of Seven industrialized economies met in London for the first face-to-face summit since the onset of COVID-19. The Governor also directed these agencies to streamline procedures for licensing and transfers, and to address any staffing issues that may arise in expanding capacity. President Biden's open-border policies have paved the way for dangerous gangs and cartels, human traffickers, and deadly drugs like fentanyl to pour into our communities, said Governor Abbott. The notification states that from 6th August 2021 Bank of Ireland are changing the terms and conditions on some personal current accounts and personal deposit accounts, to reflect that they can apply negative interest rates as well as positive and zero interest rates to these accounts. Bank of Ireland go on to say that later this year, they intend to apply negative interest to personal customers with – on average – more than €1 million on deposit across all a customers accounts. Last year, Bank of Ireland announced they were going to apply negative interest rates to some small business accounts. So, what does this mean? with negative interest rates it means they can take extra money out of your account each month. It is rumored to be 0.6% so half a cent, euro or penny for each unit of currency deposited in your account, each month. US President Joe Biden is set to ban Americans from investing in dozens of Chinese tech and defence firms with alleged military ties. The new executive order will come into effect on 2 August, hitting 59 firms including communications giant Huawei. The list of firms will be updated on a rolling basis. The move expands an order previously issued by ex-President Donald Trump. Even before the official announcement, China suggested it would retaliate. Under the new order, US investors will be banned from buying or selling publicly-traded securities for other companies including the China General Nuclear Power Corporation, China Mobile Limited and Costar Group. It expands the previous list from 31 firms to include surveillance companies and is aimed at ensuring "US persons are not financing the military industrial complex of the People's Republic of China," one White House official said. Will he stop Pelosi doing that, or is she not classed as American? What about the agencies investments? What about the fact the USA inc operating as the government is owned by two Chinese tech companies? What about FEMA and Kushner investing in Chinese PPE's and blocking American companies? Between 1943 and 1945, prices rose more than 1,000% per year, weakening the Nationalist government. The inflation helped the Communists eventually come to power in China, and in later years White, Coe, and

Adler were accused of having deliberately fostered inflation by obstructing the stabilization loan. Adler, Epstein and Coe were all born to. Jews were behind the rise to power of Mao Tse Tung, the communist dictator of China, who tortured and murdered tens of millions of Chinese (mostly Christians) during his brutal reign. For Christians read the white race, same program and same people doing it. Sidney Shapiro, who was born in and born to, was in charge of China's propaganda organ. Instead, they place claims of abandonment on our fictional Municipal Estate Trusts, and rename the original Foreign Situs Trust and pretend that now, they are Public Transmitting Utilities. John Joseph Average (all capital letters) British owned and controlled Foreign Situs Trust, now becomes John J. Average, a Public Transmitting Utility, owned as a franchise of a bankrupt Puerto Rican Electrical Utility. United States Inc, State of Wisconsin, John Joseph Average, Foreign Grantor Trust (all in capital letters) is in the meantime seized upon by the creditors of the United States Inc and USA Inc as abandoned Public Trust property.

A private company on Tuesday took over the transmission and distribution operations of Puerto Rico's power authority, which has struggled with blackouts and bankruptcy, corruption and mismanagement. The takeover by Luma Energy under a 15-year contract coincided with the beginning of the Atlantic hurricane season, with many across Puerto Rico worried about the transition and whether the new company can handle a severe storm. The U.S. territory is still struggling to recover from Hurricane Maria, which destroyed most of the power grid in September 2017. "It is extraordinarily fragile and in very poor condition," warned Wayne Stensby, CEO of Luma, a consortium made up of Calgary, Alberta-based Atco and Quanta Services Inc. of Houston. However, Stensby said the company, which will serve all of the island's roughly 1.5 million clients, has enough resources to handle a Category 2 hurricane and can bring in more equipment and workers if a stronger storm hits. The agreement approved by the territory's government and a federal control board calls for Luma to spend billions of dollars in upgrading the battered system, with most of that money coming from the U.S. Federal Emergency

Management Agency, while receiving hundreds of millions of dollars for managing the system. Officials are betting the private operator can do better than the island's Electric Power Authority, which has struggled to restore the storm-battered electrical grid and keep power flowing while trying to cope with \$9 billion in debt, more than that of any other government agency in Puerto Rico. Even with privatization, most analysts expect the government and control board will be forced to agree to an eventual power rate increase to meet the demands of bondholders. Meanwhile, the new company will inherit unresolved blackouts, with more than 30,000 customers left without power in recent weeks. But critics have called on the government to cancel the deal. A Texas-based nonprofit, the Institute for Energy Economics and Financial Analysis, complained that Luma would not be penalized for failing to save money or meet renewable energy goals. USA Inc merry go round tactics or another hostile cor pirate takeover?

The rapid U.S. military withdrawal from Afghanistan is creating intense pressure on the C.I.A. to find new ways to gather intelligence and carry out counterterrorism strikes in the country, but the agency has few good options. The C.I.A., which has been at the heart of the 20-year American presence in Afghanistan, will soon lose bases in the country from where it has run combat missions and drone strikes while closely monitoring the Taliban and other groups such as Al Qaeda and the Islamic State. The agency's analysts are warning of the ever-growing risks of a Taliban takeover. One focus has been Pakistan. The C.I.A. used a base there for years to launch drone strikes against militants in the country's western mountains, but was kicked out of the facility in 2011, when U.S. relations with Pakistan unraveled. Not a surprise to our listeners, but here are some common sense questions: why is an intelligence agency acting like the Military? Why wherever there is war and fighting is the dark shadow presence of the CIA always in attendance? The great question is, are they the real terrorists in every country? What is the Government and Congress going to do about it?

Javaid Akhter, 71, has lived all his life in his 100-year-old ancestral house built by his grandfather. The house is located just a few metres away from a famous Hindu temple in northern India's Uttar Pradesh state. Akhter, says Gorakhpur district officials, including the police, visited his house recently and took measurements of the surrounding land. The next day, he was asked to sign a "consent letter", which said the residents living on the southeastern side of the Gorakhnath temple, had given their consent to transfer or hand over their lands and houses to the government for the safety of the temple premises. We have no issues and as of our consent, we have our signatures as followed, reads the letter, with the names and signatures of residents concerned. Nearly a dozen families, all from the minority Muslim community living in the vicinity of the temple, were asked to sign the consent letter, with the signatories alleging they have been asked to vacate their houses. Akhter said that he saw a few families had already signed the letter. The officials told us that if we do not sign the letter, they have other ways to get our signatures as well,

The latest escalation of fighting in Palestine/Israel highlighted the Israeli government's backing of extremist Israeli settler groups, but new information now reveals that US charities are also funding them. US President Joe Biden provided constant diplomatic backing for Netanyahu's government, throughout its 11-day military operation against Gaza. During this period, not a single word was uttered against the Jewish extremist groups tied to the Israeli government, that antagonized and dragged Israel into its conflict with not only Gaza but the entire Palestinian population. One of the biggest factors which led to what many are calling the 11-day "Gaza war" last month, was the emergence of violent illegal Israeli settler gangs, who paraded through the streets of Jerusalem chanting "death to Arabs" during the holy month of Ramadan. Many of the extremist settlers who participated in attacks on Palestinians in Jerusalem belong to a group known as Lehava (or "flame" in Hebrew), headed up by Bentzi (or Ben-Zion) Gopstein. Gopstein was indicted by an Israeli court in 2019 on charges of incitement to terrorism, violence and racism. He was also a Knesset candidate for the Jewish Power Party, but was disqualified for racist comments he had made. Jewish Power's leader, Itamar Ben-Gvir, was elected in this year's Israeli election, and the party has been an ally of Israeli PM Netanyahu. Ben-Gvir has also been indicted on charges of racism and inciting violence and was recently present in the neighbourhood of Sheikh Jarrah, in East Jerusalem, alongside his close ally Gopstein. The purpose of the two figures presence in the disputed neighborhood was to agitate demonstrators, calling for a halt to the targeted ethnic displacement of Palestinians from the area. Netanyahu failed to take any measures to prevent his ally Ben-Gvir from exacerbating the situation, which was slowly reaching boiling point. The Lehava group follows the ideology of the deceased terrorist ideologue Meir Kahane. Kahane founded the infamous Kach Party, which, despite making its way into the Israeli Knesset, was eventually banned and labelled a terrorist organization in both the US and Israel. New information revealed by 'HaBloc', an Israeli anti-democratic activity-monitoring organization, has revealed that a complex web of nonprofit organisations in the US, as well as Israel, are linked to the funding of Kahanist groups. According to the group's research, US money is being used to fund groups of Jewish extremists. Lehava is not a charitable organisation and is not open to direct contributions. Therefore, according to HaBloc, money is funneled to it through the Israeli nonprofit, The Foundation for the Salvation of the People of Israel, and previously an Israeli fund called Chemla was linked to it until 2014. HaBloc also claims that instead of directly funding Lehava, US money is funding a network around it, fueling its activities. The two US tax-exempt charities, the Charity of Light and the American Friends of Yeshivat HaRa'ayon HaYehudi, fund Kahanist groups in Israel. A common theme that, Americans funding death and destruction around the world, if it is not the Government and agencies, it is the people via their taxes and donations. It was Americans who funded the IRA in Ireland, that led to

many deaths in Britain due to their bombing campaign against the British, when a simple check of history reveals it was the Rothschild's House of Orange that did the damage to Ireland, allied with the Catholic church. Here are the results: All: Hamas: 60% Israel: 40%, 18-34: Israel: 60% Hamas: 40%, 35-49: Israel: 51% Hamas: 49%, 50-64: Hamas: 72% Israel: 28%, 65+: Hamas: 76% Israel: 24%. However, if your child under 16 is judged competent and agrees to treatment, this cannot be overruled by someone with Parental responsibility.

In a statement on its website, the Presidium of the Russian Academy of Sciences says despite jabs being available to the public for months the rate of vaccination remains low. So far, only 11% of residents have received the first dose of the vaccine, 8% have completed vaccination, it says. Polls have shown muted enthusiasm for jabs among Russians. Only 30% said in February they were willing to receive the country's Sputnik V vaccine, according to polls, while a survey this month by SuperJob found 42% of those still unvaccinated did not want a Covid-19 jab under any circumstance. Nice to see the Rus are not buying their shit.

In India Ivermectin continues to make wonders from a high of 414,433 (May 6,2021) down to 101,242(June 6,2021), a huge reduction of almost 75%. In the state of Delhi, daily new cases reported only 231 on June 7,2021 a profound reduction from a highest surge last April 30,2021 with 27,047 cases, an impressive 99.15% reduction in just over month on Ivermectin. In Uttar Pradesh, India daily new cases had declined 98.2% to only 694 on June 7,2021 from 37,944 last April 24,2021 whereas in Tamil Nadu the state who publicly denounced the use of IVM, they are using Remdesivir continues to make blunders as daily new cases are hovering between 36,000 to 23,000, until lately. So there is your real Indian variant, a large variant between the figures.

The Occupational Safety and Health Administration has relaxed its rules for reporting work-related adverse events involving the COVID-19 vaccine, releasing employers from an earlier requirement that they report any incidents suffered by their employees due to a mandated vaccine. In April, OSHA said on its website that any businesses that require the COVID-19 vaccine as a condition of employment, are required to report adverse reactions that arise from an employee's taking the vaccine. If you require your employees to be vaccinated as a condition of employment, then any adverse reaction to the COVID-19 vaccine is work-related, whilst directing employers to follow standard reporting protocol in such cases. Yet by this month, OSHA had reversed that determination, updating the guidance on its website to clarify that employers no longer have to make an entry in the business's OSHA recordkeeping log, if an employee experiences a medical event due to the vaccine. Have we ever witnessed so much backtracking and flipping of narrative, than in the past 13 months? All the so called experts and alt media experts have been riddled with it, why? because they are losing the narrative and the ouro borus programs are creating and deleting at an increased pace. Hiding the figures for adverse reactions oh my, that is out and out lying to the public. The Department of Labor and OSHA, as well as other federal agencies, are working diligently to encourage COVID-19 vaccinations. A Houston hospital has suspended 178 staff members who have refused to abide by its mandate that employees be fully vaccinated by Monday. Nearly 25,000 of Houston Methodist's staff members have been fully inoculated against Covid-19 as part of a vaccination requirement announced in April, Houston Methodist's president, Dr. Marc Boom. But 178 unvaccinated employees who did not get religious or medical exemptions were suspended without pay, including 27 who are only partly vaccinated. The stereotype is a Chinese mother who relentlessly drives her child to study hard, without regard for the child's social and emotional development. The tiger parent is analogous to other parenting stereotypes such as the American stage mother who demands her child achieve career success in Hollywood, or the Japanese kyōiku mama who expends enormous effort directing the development of her children's educational and intellectual achievement, all to the detriment of the child's self-esteem. Take note of the Chinese and Japanese aspect of this, as later stories of Asia, Mongolia plus Japan, perhaps it becomes indicative of a hive minded race? Parents who set up rules that overstep conventional parental boundaries, are regarded as either tiger mothers or (less commonly) tiger fathers. Tiger parents prioritize schoolwork above all else, and only allow children to participate in activities in order to potentially win awards, which they believe will increase the chance of the child's acceptance to the elite universities. Tiger parents constantly propel their children towards their commitment towards excellence. In a similar way, Chinese tiger parents pay more attention to students' core academic subjects such as math, science, and language arts and often ignore other non-academic activities such as art and sports in order to ensure their children's superior performance in their core academic subjects. Tiger parents try to reinforce higher levels of psychological and behavioral control over their children than other parents. Tempering a child's self-esteem may be part of this strategy. Psychological control comes in many forms, but is rooted when parents work to constrain children's autonomy through psychologically manipulative tactics, such as the withdrawal of love or induction of guilt. While behavioral control is focused on setting limits on children's activities, often referring to academics and limiting behavioral problems. The term tiger parents was coined by Amy Chua, who has recently been barred by Yale from mentoring first-year students, over allegations she had continued hosting alcohol-fueled dinner parties at her home, in violation of a prior agreement with the school. Chua is not averse to publicity after she wrote an op-ed piece against Brett Kavanaugh, and his propensity to engage good looking clerks, of which Chua's daughter was one of them. Last year, Chua's husband, fellow Yale Law professor Jed Rubenfeld, who is born to, was suspended for two years from teaching over allegations of sexual harassment, including unwanted touching and attempted kissing, involving multiple students. He has denied the claims. Tiger parenting is as damaging as another big cat role of Lionizing, which we will connect dots to later as well.

EXPOSES: On April 6, 1984, a group of men dressed in police uniforms arrived at the home of Milcíades Contento in the town of Viotá, Colombia. Contento was a peasant, communist and member of the Patriotic Union (UP), a newly-formed experimental

political party born out of the 1985 peace negotiations between the conservative President Belansio Betancourt and the guerrillas of the Revolutionary Armed Forces of Colombia, or FARC. The men seized Contento, tied him up and dragged him away, the next day, his corpse was found in a nearby village. The murder of Milcíades Contento marked the beginning of a nearly two-decade extermination campaign. From 1984-2002, at least 4,153 UP members including two presidential candidates, 14 parliamentarians, 15 mayors, nine mayoral candidates, three members of the House of Representatives and three senators were murdered or disappeared, in what a Colombian court deemed was a political genocide. According to data presented to the Inter-American Commission on Human Rights, the purge claimed more than 6,000 victims through murders, disappearances, torture, forced displacement and other human rights violations. From May 1984 to December 2002, not a month passed without a murder or disappearance of a UP member. In the 2002 elections that brought Álvaro Uribe to power, the Patriotic Union had been so thoroughly wiped out that it failed to meet the electoral threshold, and the government removed the party's legal status. According to a recent investigation by renowned Colombian journalist Alberto Donadio, the extermination of the Patriotic Union was devised by Betancourt's successor, President Virgilio Barco Vargas, implementing a plan concocted by one of the most decorated spies in Israeli history, Rafael 'Rafi' Eitan. The revelations underscore the pivotal relationship that has developed between Israel and Colombia - the United States' respective top allies in the Middle East and Latin America. With the common theme of the CIA and drugs involvement is why, got zero to do with countries supporting each other in safety, allies in their world means partners in crime. Both countries are testing grounds for military weapons and strategies that have long been exported around the world. Following the success of the U.S. government's Plan Colombia in debilitating the FARC guerrilla movement, it has been hailed as an exportable counterinsurgency model to be applied from Mexico to Afghanistan. Israel, for its part, maintains the world's largest repression and weapons-testing laboratories in the occupied West Bank and Gaza Strip, where it has a captive population of several millions Palestinians, now starting on their own so called people. Through the presence of Rafi Eitan in Colombia, the burgeoning alliance of junior partners of the U.S. empire deepened. Despite a series of scandals, the Israel-Colombia relationship has only grown stronger over the years. Under President Iván Duque, the two countries have renewed ties, and Israeli military personnel have trained their Colombian counterparts in counter-terrorism, which is another euphemism for spying on the people and getting rid of dissenters or groups blocking their criminal paths. Yet the systematic murder of the UP remains one of the most extreme cases of political violence in Latin America. The scale of killing is especially striking because, unlike many of the bloodiest U.S.-backed regimes of the 1980s, Colombia never became a dictatorship. The killing of the UP - known among its perpetrators as El Baile Rojo (The Red Dance) - took place in an ostensible democracy. Yes Social Democracy which is Zionism, the Red Dance means

blood killings, such evilness in our midst only now is fully emerging into the light. All very Operation Condor that, on that occasion the P2 Lodge and the CIA were involved.

So who is Raphael Rafi Eitan? Eitan was involved in Israeli espionage since the establishment of the state, Rafi Eitan is primarily remembered for capturing the Nazi war criminal Adolf Eichmann in Argentina. However, he also played a central role in several of the Mossad's most unsavory operations. Eitan once remarked, all intelligence work is a partnership with crime, morals are put aside, indeed. In 1965, Eitan advised Moroccan King Hassan II on how to abduct and murder the leftist politician Mehdi Ben Barka, maybe explains the Moroccan quarter at the Jerusalem site? all connected in some way. During a 1983 Mossad mission in the United States, he disguised himself as an assistant prosecutor in the Israeli Ministry of Justice and met with the inventor of the PROMIS surveillance software. After a visit to the Department of Justice, Eitan obtained the software and had an Israeli working in Silicon Valley install a backdoor in the program. Where were the CIA, FBI, DHS and NSA when this was all unfolding? it is yet again staggering oversight and rank incompetence at best, or worst, they were in on it. Should the latter be the case, all government funding for those organizations should be suspended and those organizations disbanded, and we start again with three agencies, domestic, international and cyber all operating for and by the people of this country, not some tin pot fake dictatorship state in the Mediterranean. Fellow Mossad agent Robert Maxwell, father of Ghislaine Maxwell, child sex trafficker and partner of Jeffrey Epstein, sold the PROMIS technology to dozens of countries around the world, including Colombia. This gave Israel unfettered access to intelligence the program collected in every country using it, friend and foe alike. Israel has no friends only people and countries they can use and manipulate. In 1985, Eitan initiated a spying operation on Israel's top ally, the United States. Eitan's team recruited Jonathan Pollard, who was born to, was an American Naval Intelligence Service analyst, who went on to deliver 800 classified military intelligence documents relating to military capabilities of Arab states, Pakistan and the Soviet Union. Naval Intelligence Service is likely the SSP, Secret Space Program as they have ran it since Majestic 12 was appointed, and possibly earlier. Seymour Hersh who was also born to, reported that the documents on U.S. intelligence capabilities were passed on to the Soviet Union in exchange for release of Soviet Jewry. Hersh to be fair did report many of the crimes going on, including the My Lai massacre in Vietnam, Clintons bombing of Sudan pharmaceutical plant which supplied over half of the medicines to that country, Iran, Iraq and other outings that led him to be labeled a conspiracy theorist. According to a declassified CIA damage assessment, Eitan urged Pollard to obtain material on, signals intelligence and dirt on Israeli political figures, any information that would identify Israeli officials who were providing information to the United States, and any information on U.S. intelligence operations targeted against Israel. According to a court document, Pollard refused some of Eitan's requests because he suspected that Eitan would use such studies for improper political blackmail. A classic agency tactic that,

political blackmail is their forte. The discovery of the spying operation landed Pollard in prison. U.S. federal prosecutors named Eitan as one of four co-conspirators but declined to file charges, just like Epstein and several others of Jewish connections. With Eitan at the center of a national embarrassment, he returned to Israel, never to set foot again in the U.S. Nevertheless, Eitan's elite status ensured he landed in a comfortable position, in the 1970s, he had served as deputy to Ariel Sharon, then national security advisor to Prime Minister Yitzhak Rabin. Sharon, then a general in the army, arranged for Eitan to be appointed as president of Israel Chemicals, the largest state-owned company in the country. This new position left Eitan with ample free time to leverage his experience in black ops, into a position as a clandestine national security adviser to Colombia's president, Virgilio Barco Vargas. With the Patriotic Union beginning to coalesce into a formidable political party, Barco looked for any way to stop them. Eitan's lifetime of experience waging war against the Palestinian peasant population made him the perfect man for the job. Yet another seedy tale of agency clowns and their heinous deeds, they mentioned the Promis software and here is the story for that.

PROMIS (Prosecutors Management Information System) was a case management software developed by Inslaw (formerly the Institute for Law and Social Research), a non-profit organization established in 1973 by Bill and Nancy Hamilton. Bill formerly worked for the NSA for 6 years. The software program was developed with aid from the Law Enforcement Assistance Administration to aid prosecutors' offices in tracking; in 1982 Inslaw became a for-profit entity, Inslaw received a \$10 million contract by the Justice Department to develop an improved PROMIS application for U.S. attorneys' offices. Having previously developed a 16-bit version of PROMIS, Inslaw developed a 32-bit version, for various operating systems, specifically VAX, UNIX, IBM's AS400, and in the 1990s Windows NT. The Hamilton's and the Justice Department engaged in a bitter contract dispute over the software, and Inslaw entered bankruptcy. The Hamilton's sued the federal government, alleging that the Justice Department had dishonestly conspired to drive Inslaw out of business through trickery, fraud and deceit, by withholding payments to Inslaw and then pirating the software. A bankruptcy court and federal district court agreed with the Hamilton's, although these rulings were later vacated by a court of appeals for jurisdictional reasons. Hamilton and others asserted that the Justice Department had done so in order to modify PROMIS, originally created to manage legal cases, to become a monitoring software for intelligence operations. Affidavits created over the course of the Inslaw affair stated that, PROMIS was then given or sold at a profit to Israel and as many as 80 other countries by Earl W. Brian, a man with close personal and business ties to President Ronald Reagan and Presidential counsel Edwin Meese. In September 1992, a House Judiciary Committee report raised serious concerns that, Justice Department officials had schemed to destroy Inslaw and co-opted the rights to its PROMIS software and had misappropriated the software. The report was the outgrowth of a three-year investigation led by Jack Brooks, the

committee's chairman, who had launched in investigation in 1989. The report faulted the Justice Department for a lack of cooperation in the investigation and found that, there appears to be strong evidence, as indicated by the findings in two Federal Court proceedings as well as by the committee investigation, that the Department of Justice acted willfully and fraudulently, and took, converted and stole, Inslaw's Enhanced PROMIS by trickery fraud and deceit. A book written in 1997 by Fabrizio Calvi and Thierry Pfister claimed that the National Security Agency (NSA) had been seeding computers abroad with PROMIS-embedded SMART (Systems Management Automated Reasoning Tools) chips, code-named Petrie, capable of covertly downloading data and transmitting it, using electrical wiring as an antenna, to U.S. intelligence satellites" as part of an espionage operation. So the smart system are chips embedded to spy on you.

Lets look at the word lionize shall we. lionize (v.) to treat (someone) as a celebrity, 1809, a hybrid from lion + -ize. It preserves lion in the sense of person of note who is much sought-after (1715), a sense said to have been extended from the lions formerly kept in the Tower of London from late 16c., that were objects of general curiosity that every visitor in town was taken to see. A celebrity then is, someone who worships the Lions who are attributed to Ra and Bastet. But, also another hybridized word, and another hybrid per se, the felinoids.

But then we come to another word that has crept into our vocabulary particularly since the documentary movie Terminator series, called cyborg. Description of cyborg? "a man-machine hybrid, a human modified by integrated machinery to have extended powers," 1960, a blend of the first elements of cybernetic and organism. The 1960 part is the key, as yet again this technology is way in the past, not as projected as the future. But here is another word that is hybridized and is a hybrid compared to us, humanoid. Description of the word, 1871, an anthropological hybrid from human (adj.) + -oid. The earlier adjective was humaniform (1540s). As a noun, "humanoid being," from 1925. Earlier (1906) brand name of a type of cow's milk altered to be closer to human milk intended as food for infants. Mong came from the word among which means amidst, rel is a suffix, but we have other similar words that may signal something deeper of being amongst us and hybridized as a humanoid. The word is Mongol, from the country is best known for Ghengis Khan (cohen) who is said to have sired thousands of children and was perhaps not human as we know it. Scientists have

Slave trader and trafficking related to the same word and race, who may well be a hybridized off world race, makes a whole lot of more sense also.

Nikola Tesla revealed that an earthquake which drew police and ambulances to the region of his laboratory at 48 E. Houston St., New York, in 1898, was the result of a little machine he was experimenting with at the time you could put in your overcoat pocket. The bewildered newspapermen pounced upon this as at least one thing they could understand. Nikola Tesla, the father of modern electricity told what had happened as follows: Tesla stated, I was experimenting with vibrations, I had one of my machines going and I wanted to see if I could get it in tune with the vibration of the building. I put it up notch after notch, there was a peculiar cracking sound, I asked my assistants where did the sound come from, they did not know. I put the machine up a few more notches, there was a louder cracking sound. I knew I was approaching the vibration of the steel building, I pushed the machine a little higher, suddenly all the heavy machinery in the place was flying around. I grabbed a hammer and broke the machine, as the building would have been about our ears in another few minutes. So, what he was describing is the ancient technology of when you match the frequency of an object of matter, you have the ability to manipulate it and or destroy it. This taps into the later work of Rife, if you match the frequency of a disease, the disease will disappear. If you match the frequency of a small town, the whole town can disappear and an older version of it will come into view. This is also how they built the giant monuments and building, matching the vibrational frequency of a building block changes the density of the block and you can move it in a much easier way than brute force lifting. Outside in the street there was pandemonium, the police and ambulances arrived, Tesla told his assistants to say nothing. We told the police it must have been an earthquake, that's all they ever knew about it." Some shrewd reporter asked Dr. Tesla at this point what he would need to destroy the Empire State Building and the doctor replied: Vibration will do anything. It would only be necessary to step up the vibrations of the machine to fit the natural vibration of the

building and the building would come crashing down, that's why soldiers break step crossing a bridge. Within a year of that event Tesla was moved probably by the military to Colorado Springs, where in 1899 he was using his Experimental Station and inadvertently contacted several other species across the galaxy. On the occasion of his annual birthday celebration interview by the press on July 10, 1935 in his suite at the Hotel New Yorker, Tesla announced a method of transmitting mechanical energy accurately with minimal loss over any terrestrial distance, including a related new means of communication and a method, he claimed, which would facilitate the unerring location of underground mineral deposits. That machine is ancient technology, as that was described as being used in one of the ancient Sumerian texts, and the story of Marduk, remember he and the Annunaki came to this planet looking for gold. In the texts it spoke of him detecting gold from the sky, which means he was using a frequency detector machine, much like our modern version of LIDAR. At that time, he recalled the earth-trembling "quake" that brought police and ambulances rushing to the scene of his Houston Street laboratory, while an experiment was in progress with one of his mechanical oscillators.

From My Inventions: The Autobiography of Nikola Tesla, Chapter 5—The Influences That Shape Our Destiny As I review the events of my past life I realize how subtle are the influences that shape our destinies. An incident of my youth may serve to illustrate. One winter's day I managed to climb a steep mountain, in company with other boys. The snow was quite deep and a warm southerly wind made it just suitable for our purpose. We amused ourselves by throwing balls which would roll down a certain distance, gathering more or less snow, and we tried to outdo one another in this sport. Suddenly a ball was seen to go beyond the limit, swelling to enormous proportions until it became as big as a house and plunged thundering into the valley below with a force that made the ground tremble. I looked on spellbound incapable of understanding what had happened. For weeks afterward the picture of the avalanche was before my eyes, and I wondered how anything so small could grow to such an immense size. Ever since that time the magnification of feeble actions fascinated me, and when, years later, I took up the experimental study of mechanical and electrical resonance, I was keenly interested from the very start. Nikola Tesla waited 37 years to brag of the earthquake incident in 1898, but the very next year in 1899 he dropped everything and went out west to Colorado Springs. In what was described as a transatlantic race to broadcast and receive radio signals on the world stage, he dropped everything and headed west to Colorado. He wanted to send power not signal and send power he did. This is why Marconi was able to pilfer him of radio in the first place, and why the US Supreme Court which is ran by the Commonwealth and subsequently The Crown, awarded him the patents. Marconi, born of Italian nobility and so likely a Jesuit, married into the Irish whiskey family the Jameson's, and in 1933 he was given a fake badge into The Order of Rising sun, one look at their emblem tells you it is the Black Sun. It is a Japanese title and why that country is called

the Land of the Rising sun, but is it the land of the Black rising Sun? Others who received this award was Richard Armitage, Dick Cheney, Douglas McArthur, John McCain, Nancy Pelosi, Condoleeza Rice, Donald Rumsfeld, and also the Hawaiian queen Lili'oukalani, was lili the operative word? Quite a collection of scumbags that is, but there was other notable but lesser awards of this title given to Clint Eastwood, George Takei of Star Trek fame, Mohammad Hatta, better known as the CIA agent of Indonesia, President Sukarno oops. Sukarno spent his time freeing Indonesia from the Dutch, except it wasn't the Dutch at all, it was the Rothschild's. This then goes some way to proving this is the faction war between the Land of the Black rising Sun and the Rothschild's, now you know more of the players.

But, the US Supreme court reversed the Marconi patents in 1943 right after Tesla had died with a massive coincidence with the U.S. Supreme Court decision numbered 369. The third event was September 9, 1899 September 9th month, the 9th or 9 day, $1800 + 1 + 8 = 9$, and 99 years. Three events three days apart delivering all the numbers as 3, 6 & 9. "If you only knew the magnificence of the three, the six and the nine... then you would have a key to the universe." -Nikola Tesla

Another version of the $12 + 1$ emerged this week with the simple wall clock when combining numbers. Starting with $12 + 1 = 13$, $11 + 2$, $10 + 3$, $9 + 4$, $8 + 5$, $7 + 6$ all equaling 13, or $12 + 1$. By going counterwise clockwise and subtracting the opposite number on the clock also renders one number as well. $12 - 6$, $11 - 5$, $10 - 4$, $9 - 3$, $8 - 2$, $7 - 1$ all equals 6. The 4 quarters of the clock all equal a 3, 6, 9 pattern also, $1/4$ past the hour is 3, $1/2$ past the hour is 6, $3/4$ past the hour is 9 and top of the hour is twelve, $1 + 2 = 3$ also.

With extra memory these are known as born in sin, the god of knowledge is Sin, we are their predecessors as we are the sin eaters. This must not also be mistaken for open relationships either, the term open relationship means one or both partners are seeking external sexual partners, this is not the way for polyamorous relationships. Polyamory is about multiple relationships intertwining based on love and emotional connections, which is no different to our TPC memes, or in overview the interconnectedness of combining our PSI fields.
