As the twenty year anniversary day unfolds this week, a poignant reminder of how things are still having a negative effect on people in NY, still to this day. Nearly three-quarters of New York City's Fire Department workers who worked amongst the smoldering, toxic rubble at Ground Zero in lower Manhattan now have some sort of long-term illness linked to their service, according to a new report from the department's World Trade Center Health Program. Of more than 15,200 firefighters, paramedics and other FDNY workers, more than 11,300 had an illness certified under the guidelines of the federally backed program. Ranging from chronic acid reflux and minor breathing problems on the low end, to a broad spectrum of mental health problems to deadly lung ailments and lethal cancers. As of the end of March this year, 3,097 FDNY health program members had at least one 9/11-linked cancer, and hundreds of those people had multiple cancers. That grim statistic helps account for another one that is not in the report, nearly 250 firefighters have died since 9/11 of related diseases. The most common ailment is gastro-esophageal reflux disease, which nearly a half of firefighters and a quarter of EMTs suffered. That's followed by similar levels of upper and lower respiratory problems. The infamous World Trade Center cough, caused by the caustic dust and smoke from the imploded towers, which plagued more than half the responders in the year after the attacks, is now less than 10%. Similarly, chronic sore throats dropped from nearly two-thirds of the department's members to just under a quarter now. Members of the program who have a mental health problem as well as a physical illness report a poor quality of life. And while mental health has steadily improved since 9/11, more than a fifth of responders who were at Ground Zero on that morning still report depression, and around one in 10 have PTSD. One day the full truth of that day will be revealed, but I suspect the culprits that were involved in that from our own country, will be long dead.

Figures from Just Group show State Pension shortfall day arrived on Monday, as Wales Online reports. This marks the point in the year when the average retired pensioner will have spent the equivalent of their annual State Pension. Official figures show the average annual spending for a single



pensioner is £13,842, and the full State Pension amounts to an income of around £9,340, which represents a shortfall of £4,502. The retirement group warn that without additional sources of income, such as private pension provision, this group would have run out of income by Friday September 3. Speculation has been rife that the government may abandon the State Pension triple lock, the promise to raise the State Pension by the highest of three measures, the rise in Consumer Price Index, the rise in average earnings or 2.5%. However, analysis by Just Group reveals that even if the triple lock was implemented at 8%, pensioners would still face a shortfall of more than £3,500 every year in order for them to reach the average yearly spending in retirement. UK pension was \$80B in the red around 2008 and we reported it on the show, I guess it is now crunch time not only in the UK, but America's Social Security also. Like I warned in Expose 1, now you know why they are killing off the elderly first, the clowns in Government and their string pullers have spent the bulk of the Pension money, and the lockdowns has increased the shortfall.

Ethiopia's 10-month war has come at a huge human cost, with thousands killed, millions displaced and many in desperate need of assistance. But that's not the only damage being done to Africa's second most populous nation, the war has incurred a huge economic cost, too, that could take years to repair. In the capital Addis Ababa, 26-year-old Tigist, who didn't want her full name to be used, says her monthly expenses have doubled for two reasons: the war that broke out in the northern region of Tigray in November and the corona virus pandemic. Before Covid and the conflict, I would pay 1,000 birr, about \$22 or £16] each month for groceries, now I spend 2,000 birr, she says. Things are more expensive now, phones, food and clothes. Exactly, but part of the problem they have is using the word phone as the first issue, a phone is not an essential item, and that is where better thinking is required. Official statistics show the cost of basic consumer goods has indeed gone up in Ethiopia, they were on average around a quarter more expensive in July than a year earlier. Tigist is working as a supermarket cashier to support her family. She's responsible for the food shopping while her brother covers the rent. Also, the dollar exchange has not been good, last year, for \$1 you would pay 35 birr, now you pay 45. Faisal Roble, a US-based analyst who specializes in the Horn of Africa, says that spending on the war effort has really negatively impacted Ethiopia's capacity to access dollars, and has caused the exchange rate to deteriorate. It is not clear how much the war has cost, but Trading Economics forecasts military expenditure will reach \$502m (£365m) by the end of the year, up from \$460m last year. Last week, UN secretary general Antonio Guterres said the conflict had drained over a billion dollars from the country's coffers. Yes, all to benefit the shekel people, and the greed based harvesters. Prior to the global pandemic and the war, Ethiopia's economy was one of the fastest-growing in the region, expanding by an average of 10% a year in the decade to 2019, according to the World Bank. So, the



shekel people stepped in, to lower it and ensures they cream off of the top of it. Countries like Ethiopia are not under developed, they are over looted by greed based psychopaths.

Israeli Prime Minister Naftali Bennett presented President Biden in their meeting last week, with what Israeli officials described as a death by a thousand cuts strategy against Iran. Why it matters: Besides striking up a personal relationship, Bennett's primary goal in his first meeting with Biden was, to express his sense of urgency about the significant progress Iran was making in its nuclear program, and Israel's new government conducted an Iran policy review prior to the visit. Behind the scenes: The strategy Bennett presented to Biden involves countering Iran through a combination of many small actions across several fronts, both military and diplomatic, instead of a single dramatic strike, the Israeli officials said. Bennett compared the standoff between Israel and Iran today to the one between the U.S. and the Soviet Union during the Cold War. Except there was no stand off or Cold War, it was a program to create fear, make shekels and steal resources. The prime minister said Israel is the region's America and Iran is the Soviet Union with its corrupt and decaying regime, the official said. Except it was Israeli El-ites who created the Soviet Union with their puppets like Marx, Stalin, Lenin and Sverdlov, who was also a Jew, and has a descendant in the alt media circle, oh the dot connecting of that. Bennett told Biden the U.S. and Israel need to put Iran's regional aggression back in the box, in addition to its nuclear program. To that end, he asked Biden not to pull U.S. forces out of Iraq and Syria, the Israeli delegation felt optimistic about Biden's attitude on that front. Biden did not seem optimistic about the prospect of Iran returning to compliance with the deal, the officials said. Between the lines: Bennett was very happy with two things Biden said in his statements to the press during their meeting. First, Biden expanded on his previous statements that Iran wouldn't get a nuclear weapon on his watch, and said he was committed to Iran never obtaining a nuclear weapon. Unbeknown to Biden and other clowns masquerading as politicians, Iran already has nuclear weapons, because Israel gave them to them - duh!! Second, Biden said that if diplomacy with Iran fails, he is ready to explore other options, echoing Bennett's calls for a Plan B. What he's saying: Bennett told the Israeli traveling press that his meeting with Biden was "excellent" and that he felt like they had known each other for a long time. Biden to visit Israel once COVID-19 is under control. Teams from both sides will continue the discussions on Iran and other issues in the coming weeks. Israeli Prime Minister Naftali Bennett told President Biden in their meeting on Friday at the White House that although he is against a U.S. return to the 2015 nuclear deal with Iran, he isn't going to publicly campaign against it like his predecessor, Benjamin Netanyahu. Why it matters: Biden and his senior advisers are veterans of the intense confrontations between Netanyahu and former President Obama on Iran. Former U.S. ambassador to Israel Dan Shapiro has joined the State Department's Iran team as a senior adviser, a senior State Department official. Why it matters: Israel is pressing the Biden administration to start discussing a Plan B in case diplomacy with Iran fails. Which is all out war strikes and more costs to America, for no apparent benefit. Shapiro, who has a personal relationship with many Israeli officials, including Prime Minister Naftali Bennett, is equipped to play a key role in any such talks. His portfolio will be the regional aspects of the Iranian issue and coordination with Israel, Shapiro is born to, so no chance of adult level diplomatic discourse with that appointment.

More than 7 million out-of-work people across the United States are set to lose all of their jobless benefits this week as three federal programs expire on Monday, in what several experts described as one of the largest and most abrupt ends to government aid in U.S. history. In addition to the more than 7 million people who will lose all their benefits, nearly 3 million more people will lose a \$300 weekly boost to their state unemployment benefits. The cessation of this jobless aid, first put in place by Congress nearly 18 months ago, could upend the lives of millions of Americans still struggling to find work at a time when, the pandemic's delta variant is wreaking fresh havoc across a number of states. That was a predictable ouroborus response, after their deliberate plan to put people out of work for their control agenda, they now find that many out of work are now waking up due to the extra time allowed to focus on things. So, the big appeal to get back to work is underway, but sadly many Americans don't seem to want to work, given a report recently of 11M job openings. Yes, the majority will not be paying high wages, but it is still a job and better than earning nothing.

The US economy added fewer jobs than expected in August as employment rose by 235,000. The figure was well down on the 1.05 million jobs created in July, adding to fears that the recovery from the pandemic may be running out of steam. Despite the disappointing hiring levels, the unemployment rate fell to 5.2% in August from 5.4% in July. Economists say rising infections caused by the Delta variant have hit spending on travel, tourism and hospitality. They also note that the Labor Department's data was collected in the second week of August, so does not reflect the impact of hurricanes Ida and Henri in the second half of the month. President Joe Biden said he was disappointed but defended his record on the economy, saying it was growing consistently. Actually Mr. Biden like your popularity it is going down, not growing consistently.



A judge ordered the rearrest of Doug Jensen, one of the protesters charged with entering the Capitol on January 6, after pretrial services officers made an unannounced visit to his home in Des Moines, Iowa, and found him watching an online discussion featuring MyPillow CEO Mike Lindell. On July 13, U.S. District Court Judge Timothy Kelly released Jensen, with strict conditions, including the prohibition of using the Internet and his cell phone. A coalition of police and firefighters are suing Gov. Kate Brown over her mandate requiring COVID-19 vaccination for state workers. The lawsuit, filed in Jefferson County Circuit Court, says the plaintiffs are the Oregon Fraternal Order of Police along with troopers from around the state, and firefighters at the Kingsley Field Air National Guard Base in Klamath County. It names the governor and the state of Oregon as defendants. The group is asking a judge to declare Brown's executive order unenforceable, claiming it allegedly works against existing Oregon statutes and would result in wrongful termination of employees. The order, which was announced in August as Brown reinstated an indoor mask mandate amid a surge of COVID-19 cases, requires all executive branch employees with the state of Oregon to be fully vaccinated on or before Oct. 18, or six weeks after a vaccine receives full approval from the U.S. Food and Drug Administration.

While many large companies across the U.S. have announced that COVID-19 vaccines will be required for their employees to return to work in-person, there is one state where such requirements are banned: Montana. Under a new law passed by the state's



Republican-controlled Legislature earlier this year, requiring vaccines as a condition for employment is deemed discrimination and a violation of the state's human rights laws. Montana is the only state in the U.S. with a law like this for private employers, said Hemi Tewarson, executive director of the National Academy for State Health Policy.

80% Of The COVID-19 Deaths In August Were Vaccinated People Confirmed The Public Health Data.

Australia is set to end its covid zero policy after Prime Minister Scott Morrison determined, that the country's approach is not sustainable in the face of the more infectious COVID-19 delta variant. Australia has maintained a strict policy of restrictions and lockdowns to stamp out any outbreak, but the government over the weekend laid out a new plan that marks a sharp change in policy. The government will



drop most restrictions once 80% of adults are vaccinated, which the government believes could happen by the end of the year. That way they can get the bots to attack the self thinkers if the 80% is not achieved, divide and conquer again. Any further action would occur only after hospitals reached a point at which they could no longer cope with new cases, but will otherwise handle what they can.

Israeli data shows Pfizer's COVID-19 vaccine efficacy has dropped from a relative risk reduction of 95% during its early trials to just 39% by the end of July. So instead of revealing the jabs are a waste of time, like anti vaxxers warned from the beginning, now the Israeli government is pressuring citizens to take a third booster dose, saying its vaccine passports will expire after six months, for those who've only had two experimental shots. Israel's Green Pass demonstrating receipt of two doses of Pfizer's vaccine, which allows citizens to participate in ordinary activities including dining out, going to the gym, attending conference and entertainment venues, will now be linked to the timing of their last dose of vaccine or booster shot. We are updating what it means to be vaccinated, Israel's corona virus czar, Salman Zarka said, when something doesn't work just change the script or the name, an all too familiar sight with that group. Anyone ask why they use the term tsar for so called virus experts? Tsar, is a title used to designate East and South Slavic monarchs or supreme rulers of Eastern Europe, what has that got to do with medical clowns? This is simply because, in terms of its effectiveness, the vaccine is valid only for a period of five or six months, funny they didn't say that at the beginning of the trial. After about half a year, you have to get a third dose, otherwise, the vaccine loses its power, Health Minister Nitzan Horowitz said, really? Horowitz also said that his government was considering canceling citizens Green Passes, if they had not received a third dose of vaccine. The Green Pass testifies that a person is safe in a certain way, so that was wrong to give them out then, given the vaccines never worked, otherwise you wouldn't need a third dose. So the moment we know that the vaccine loses its effectiveness after a certain period, there's no justification for giving a Green Pass to someone who hasn't gotten another dose, Horowitz said. All of the notifications include this language: Federal law, Title 21 U.S.C. § 360bbb-3(e)(1)(A)(ii)(I-III) of the Federal Food, Drug, and Cosmetic Act, states the following about products granted emergency authorization usage: Individuals to whom the product is administered are informed— (I) that the Secretary has authorized the emergency use of the product; (II) of the significant known and potential benefits and risks of such use, and of the extent to which such benefits and risks are unknown; and (III) of the option to accept or refuse administration of the product, of the



consequences, if any, of refusing administration of the product, and of the alternatives to the product that are available and of their benefits and risks. Any entity or organization that requires EUA COVID-19 vaccinations, COVID-19 tests or masks are in violation of federal law, and will likely face lawsuits if they don't allow exemptions or alternatives. Submitting the notices prepared by Children's Health Defense is the first step prior to seeking an exemption or taking legal action. Vaccine exemption laws vary by state. This in turn generates the false narrative that Iran's nuclear program could initiate a Middle East nuclear arms race. Beinart laments how US deceptions about Israel's nuclear arsenal, undermine America's self-proclaimed status as a champion of non-proliferation. What Beinart did not appear to know until educated by Twitter users, is what machinery keeps the US in lockstep with Israeli so-called nuclear ambiguity and why it exists. Much has happened in the decades since President Richard Nixon first promised Israeli Prime Minster Golda Meier never to publicly discuss Israel's



nuclear weapons. US Senators Stuart Symington and John Glenn learned that Israel with help from some proxies in the US in the 1960s, diverted enough US weapons grade uranium from the government contractor NUMEC to build a dozen bombs. NUMEC President at the time was Zalman Mordecai Shapiro, Shapiro born to and was a long-time Zionist, and his associate we covered previously Rafi Eitan., Shapiro also attended Johns Hopkins. Later U.S. Department of Energy records show that NUMEC had the largest highly enriched uranium inventory loss of all U.S. commercial sites, with a 269 kilograms (593 lb) inventory loss before 1968, and 76 kilograms (168 lb) thereafter. FBI also investigated and no charges were filed. Outraged that nothing was being done about it, the senators complicated presidential strategic ambiguity by amending US foreign assistance laws, to condition aid to nuclear weapons countries that were not signatories to the treaty on the non-proliferation of nuclear weapons. Israel and its US surrogates responded by lobbying incoming presidencies to ignore the law, and commit in writing to upholding nuclear ambiguity. In 2012 the Obama administration passed a gag regulation, forbidding any US federal agency employee or contractor from discussing Israel's nuclear weapons. The regulation severely restricts agency responses to Freedom of Information Act requests about Israel's nuclear weapons activities. For example, Israeli spymaster Rafel "Rafi" Eitan's covert operations team penetrated the NUMEC facility in 1968, the year of some of its most stunning losses. In closed briefings to top agency officials, CIA has never wavered in its conclusion that Israel, with the help of chemist Zalman Shapiro who ran the plant, diverted material to fuel Israel's nuclear weapons development. After Eitan died in March of 2019, a great deal of formerly classified information about his exploits against America, which included running Jonathan Pollard, should have become available since privacy claims no longer prevailed. However, the CIA's internal profile of Eitan, while mentioning his 1960 operation to kidnap Adolf Eichmann from Argentina and Jonathan Pollard, carefully redacts his NUMEC operation in the 1960s chronology. Why is such information continuing to receive protection? If multiple US government agencies reveal that the US has long known Israel has a nuclear weapons program, it raises uncomfortable questions about amount of foreign aid illegally delivered to Israel. Since Symington and Glenn became law, the US has transferred nearly a quarter of a trillion dollars in publicly known foreign assistance to Israel, and additional billions in covert assistance. One of the principal tasks of Israel's US lobby is delivering enough campaign contributions to US politicians that upholding the law remains unthinkable. This has been a winning strategy but also makes the power of Israel's surrogates in the US increasingly visible and the subject of scorn and derision. Ordinary religious Judaism provides this occult sect with a perfect cover. According to Albert Pike the ithyphallic pillars Jachin and Boaz represent the two solstices of summer and winter, the globes represent the earth and celestial sphere. Jachin and Boaz are symbols of the first sacrifice temple, known as Solomon's. The black and white squares represent ignorance and knowledge, overworld and underworld. Knowledge has long been associated with light, the word knowledge comes from Gnosis. Officially referred to as an Armed Forces Experimental Training Activity under the authority of the Department of Defense. Camp Peary hosts a covert CIA training facility known as The Farm, which is used to train officers of the CIA's Directorate of Operations, as well as those of the DIA's Defense Clandestine Service, among other intelligence entities. Camp Peary has a sister facility, The Point, located in Hertford, North Carolina. Camp Peary is named for Arctic explorer Rear Admiral Robert E. Peary. Porto Bello, the historic hunting lodge of Lord Dunmore, last royal governor of Virginia, is listed on the National Register of Historic Places and is located on the grounds of Camp Peary. Comprising 9,275 acres of land, of which about 8,000 acres are unimproved or only partially improved. The 100 acres Biglers Millpond occupies the site adjacent to the York River, but it has been closed to the public since 1951, and remains highly restricted to this day. The majority of Camp Peary falls within York County, though a small portion of the reservation near Skimino Creek at the western edge is located in James City County. During World War II, beginning in 1942, the United States Navy took over a large area on the north side of the Virginia Peninsula in York County, Virginia which became known as Camp Peary, initially for use as a Seabee training base. The Chesapeake and Ohio Railway (C&O) extended a spur track from its Richmond-Newport News main line tracks to the site from nearby Williamsburg, and established Magruder Station near the former unincorporated town of Magruder. As part of the process of converting the property to a military reservation, all residents of the entire towns of Magruder and Bigler's Mill had to vacate. The town of Magruder was a traditionally African-American community, established for freedmen after the American Civil War, it had been named for Confederate General John B. Magruder. A Civil War field hospital had occupied the site of Bigler's Mill near the York River. Although the graves in the church cemetery were not moved, many of the residents and the local Mount Gilead Baptist Church were relocated to the Grove community, located on U.S. Route 60 in adjacent James City County a few miles away. Where a number of displaced



residents from an area near Lackey known simply as the Reservation, had earlier relocated under similar circumstances during World War I, when what is now the Naval Weapons Station Yorktown was created. At the outset of the War, the preliminary training of the Seabees had been carried out at Naval Training Stations across the country. That lasted a short period until boot training was consolidated at Camp Allen Virginia. Camp Allen was replaced by Camp Bradford which in turn was replaced by Camp Peary, they love their name changes, which means Hebrew Annunaki were involved. The initial Seabee recruits of WWII were men who built Boulder Dam, America's highways and New York City skyscrapers. At Naval Construction Training Center Peary, Seabees were taught basic military order, discipline, weaponry, stevedoring, and construction trades. The Camp opened in November 3rd of 1942 with the 36th CB the first to train there, while the first organized there was the 61st CB. Another 100,000 men would go through the camp before training there ceased in June of 1944. During that period the Seabees established over 60 trade schools on the base. In June of 1943 the dynamite and demolition school opened, some of its first graduates included the first six classes of Seabee volunteers for the Naval Combat Demolition Units. After June 1944 Seabee boot camp was moved to Camp Endicott, Quonset Point, Rhode Island. Base commander Capt. J.G. Ware had the idea to raise hogs on base so the recruits called the place Capt. Wares hog farm. Originally the hog yard was in the center of the camp, but the enlisted complained that the pigs were on high ground while they were in the mud. This got the hogs moved to a more obscure location, but still within the limits of the government reservation. A bulldozer numbered B-16 was used for clearing the feed troughs and transporting slop from the galley to the hog yard. According to an article in the St. Peterburg Times, one morning alone it moved 1,400 pounds of slop. It is from this history that base derives The Farm moniker used today. The farm was ran by pigs that were preceded by pigs, and treated "trainees" like pigs of the guinea variety.

German prisoners-of-war: Camp Peary's mission changed when a new need presented itself to the Navy. A portion of the land became a detention center for German prisoners of war in the United States. Many of them were Kriegsmarine crewmen from captured German U-boats, and from ships the Germans thought lost at sea with crews presumed dead, a bit like the American POW from Vietnam then. It was important to keep the German authorities unaware of their capture, since knowledge that they had survived would mean that secret code books and Enigma machines thought lost at sea, could also have been compromised. Learning that these men were being held as POWs, would almost certainly have caused the Germans to change the secret codes that had been broken by Allied codebreakers, thus, extra secrecy was necessary. Yeah right what utter drivel. Many of the former POWs stayed in Virginia and the United States after the war, and became naturalized as U.S. citizens, that was known as Operation Paperclip.



Post-World War II use: Vacated by the Navy in 1946, Camp Peary became a Virginia state forestry and game reserve for five years. A reservoir that had been built on the upper reaches of Queen's Creek, to supply the substantial fresh water needs of Camp Peary when it was a Seabee base, was divested to the City of Williamsburg. The Waller Mill Reservoir formed the basis for the city's Waller Mill Park, although the park is located north of the city limits in York County. A portion of the abandoned Chesapeake and Ohio Railway spur from the Peninsula Extension main line just east of near Ewell Station, to the base also built during World War II is now a recreational rail trail. Then, in 1951, the U.S. Navy returned to the property, securing the portion north of the highway, which was State Route 168 at the time, and announced it closed to the public, it has been that way ever since. In June 1961, two months after the Bay of Pigs Invasion, the Navy announced it was officially opening a new facility at Harvey Point base, in Hertford, North Carolina. A spokesman said that all four branches of the military would conduct testing and evaluation of various classified materials and equipment at the new site. He added that some of the training now being done at Camp Peary, Va., will be transferred to Harvey Point.

The Farm: Camp Peary is known as The Farm, a training facility run by the Central Intelligence Agency for the purpose of training CIA's clandestine officers, as well as officers of other organizations specializing in clandestine activities, such as the Defense Intelligence Agency. The existence of this facility is widely known but has never been formally acknowledged by the U.S. government. Access to Camp Peary is strictly controlled, and visitors to the installation are escorted at all times. The portion of the original World War II Seabee base north of Interstate 64 has been closed to the public since 1951. However, the roads and many structures of Magruder and Bigler's Mill are still there and many are occupied. An airport with a 5,000-foot runway was added to the facility near the site of Bigler's Mill. Flight records show that at least 11 aircraft that appear to be owned by CIA front companies, and are believed to have been used as rendition aircraft by the CIA under the guise of charter flights, have landed on this runway. Former CIA officer Bill Wagner attended a three-week interrogation course at The Farm in 1970. He claims it was the agency's premier course, and that volunteers played the role of interrogation subjects in order to be guaranteed seats in future classes, yes human guinea pigs on the farm for the cia-kars. Interrogators-in-training practiced techniques such as sleep deprivation, deliberately tainted food, and mock executions. According to Wagner, the course was dropped from the CIA training curriculum after the Watergate scandal, due to increased attention being paid to CIA practices.

We at THI have often focused on things that pertains to us, the I portion of us, that in the past has relied on not taking personal responsibility. It is all so comfortable to point fingers away, but too few pointed back at themselves, and a life of personal choices was cunningly snatched away for the convenience of no blame attached. Because if you don't



take personal responsibility, someone will always do it for you, in particular the Government and EL-ites.
