In Fiscal Year 2021 through August 31, more than 20,950 UC's have been encountered by EPT Border Patrol Agents. This number surpasses the prior record for UC encounters in Fiscal Year 2019 of 16,159. Overall, the United States Border Patrol has encountered 130,710 unaccompanied children across the entire southern border. Many of these children are under the age of 12 and are being smuggled and subsequently abandoned at the border.

Meanwhile the Democratic Del Rio Mayor Bruno Lozano called out his party's top two politicians on Saturday, as his town continued to experience the devastating effects of being overrun by illegal aliens on the border. The town of about 35,000 people has seen an explosion of migrants who have illegally entered the U.S., most of whom are from Haiti, by walking across the Rio Grande River. The numbers surged from several



hundred a week ago to approximately 15,000 by Saturday. Lozano called out Vice President Kamala Harris, who attended a college football game on Saturday where she conducted the opening coin toss. President Biden went for a bike ride at the beach on Sunday amid multiple national crises, and he refused to answer reporters questions as he biked past them. The great question is, do Americans still think that voting is a valid effort, a worthwhile effort and your vote counts? New polling shows that the majority of Americans do not approve of President Joe Biden's new vaccine mandate. Biden announced the mandate last week, which includes requirements that any business with more than 100 employees ensure they are vaccinated or be tested weekly. Biden's announcement included a range of other federal rules that are estimated to affect 100 million Americans. Convention of States Action released new polling Monday that showed 58.6% of those surveyed, do not believe President Biden has the constitutional authority, to force private businesses to require vaccine mandates for employees. In the same poll, 29.7% of voters said Biden does have the authority, and 11.7% are unsure. In addition, 55.5% of voters say the mandate sets a precedent that could be abused by future presidents on other issues. In a common sense survey 100% of respondents said Biden wasn't adequate in the first place, so why did people vote for the jackass?



If ever you doubt that all elections are swindles, the recent California one brings it home, although Canada adds a whole new level to it. The movement to recall Gov. Gavin Newsom, appears to have fizzled in large suburban Southern California regions and other swing counties, giving the incumbent a sizable cushion to defeat the effort to oust him, preliminary data showed. There are many ballots yet to be counted, but out of the more than 9.1 million votes tabulated as of early Wednesday, nearly 64% were in favor of keeping Newsom in office. That overwhelming margin, which could still tighten as more ballots are processed, was fueled by lopsided victories in the San Francisco Bay Area and Los Angeles County, both traditional Democratic strongholds. In L.A. County, roughly 71% of ballots counted as of Wednesday morning were opposed to the recall. In San Francisco, the proportion of voters who favored the status quo was just under 87%, according to early results published by the California secretary of state's office. The term Democratic stronghold or the term traditionally Republican as well, needs closer inspection. Are they saying that only one parties people moves to live in a zone where only their own party exists? How can that statistical anomaly even exist over a prolonged period of time? just how or why is California a Democratic stronghold?

A volcano on the Spanish island of La Palma, in the Canary Islands, has erupted, spewing fountains of lava and ash. It sits in the Cumbre Vieja national park, and had been stable since 1971. The island had been on alert for a possible eruption for the past week - with nearby residents being advised to evacuate. Canary Islands President Angel Victor Torres told TVE that no injuries had been reported so far. Should that landmass slip into the Atlantic ocean, it is said that the whole of the East coast would be flooded 10 miles inland.

House Democrats have introduced a stand-alone bill to provide \$1 billion in funding for Israel's Iron Dome air defense system. This bill comes one day after Democrats stripped Iron Dome funding from a short-term spending bill under pressure from the party's progressive wing. Following backlash to the defunding from moderate Democrats and Republican attacks on the party as anti-Israel, House Appropriations Chairwoman Rosa DeLauro, who is married to a Greenberg introduced the new bill. It's not anti Israel at all, the fact is with mounting debts and many of our own people struggling, we simply can't afford it. Get the Jewish EL-ites to fund it. The United States commitment to the security of our friend and ally Israel is ironclad, DeLauro said in a statement. Replenishing interceptors used to protect Israel from attacks is our legal and moral responsibility. Says who? The U.S. has already provided more than \$1.6 billion for Israel to develop and build the Iron Dome system, according to a Congressional Research Service report last year. House Majority Whip, Steny Hoyer, said he would bring the bill up for a vote later this week. Hoyer born in, has led the AIEF trips to Israel for decades and has been happy to be the group's pro-Israel face. The lawmakers meet with top Israeli officials and tour the country, stopping at the Yad Vashem Holocaust memorial museum and the



congressionally-funded Iron Dome anti-missile batteries. Hoyer is a supporter of Israel, and has often been allied with American Israel Public Affairs Committee (AIPAC). In September 2007, he criticized Rep. Jim Moran for suggesting that AIPAC has pushed the Iraq war from the beginning, calling the comment factually inaccurate. Actually it is not, just like they are pushing the Iran war now, stupid puppets.

An Israeli defense contractor last week unveiled a remote-controlled armed robot it says can patrol battle zones, track infiltrators and open fire. The unmanned vehicle is the latest addition to the world of drone technology, which is rapidly reshaping the modern battlefield. Proponents say such semi-autonomous machines allow armies to protect their soldiers, while critics fear this marks another dangerous step toward robots making lifeor-death decisions. The four-wheel-drive robot presented, was developed by the stateowned Israel Aerospace Industries REX MKII. Rex MK 2 Rex means king, MK could well be ultra mark 2. It is operated by an electronic tablet and can be equipped with two machine guns, cameras and sensors, said Rani Avni, deputy head of the company's autonomous systems division. The robot can gather intelligence for ground troops, carry injured soldiers and supplies in and out of battle, and strike nearby targets. It is the most advanced of more than half a dozen unmanned vehicles developed by Aerospace Industries subsidiary, ELTA Systems, over the past 15 years. The Israeli military is currently using a smaller but similar vehicle called the Jaguar, to patrol the border with the Gaza Strip and help enforce a blockade Israel imposed in 2007, after the tiny territory was seized by the Islamic militant group Hamas. Gaza is home to 2 million Palestinians who have largely been locked in by the blockade, which is also supported to some extent by Egypt. The border area is the site of frequent protests and occasional attempts by Palestinian militants or desperate laborers to infiltrate into Israel. According to the Israeli army's website, the semi-autonomous Jaguar is equipped with a machine gun, and was designed to reduce soldiers exposure to the dangers of patrolling the volatile Gaza-Israel border. It is one of many tools, including drones armed with guided missiles, that have given the Israeli military vast technological superiority over Hamas. Unmanned ground vehicles are being increasingly used by other armies, including those of the United States, Britain and Russia. Their tasks include logistical support, the removal of mines and firing weapons. The tablet can control the vehicle manually. A tablet that is riddled with viruses and back doors, just how safe will that be from hacking, or when it goes wrong by home spun hacking, they will just blame Russia or Iran? But many of its functions, including its movement and surveillance system, can also run autonomously. With every mission, the device collects more data which it then learns from for future missions, said Yonni Gedj, an operational expert in the company's robotics division. Critics have raised concerns that robotic weapons could decide on their own, perhaps erroneously, to shoot targets. The company says such capabilities exist but are not being offered to customers. Avni said.



It is possible to make the weapon itself also autonomous, however, it is a decision of the user today. The maturity of the system or the user is not there yet, indeed. Bonnie Docherty, a senior researcher from the arms division of Human Rights Watch, said such weapons are worrisome because they can't be trusted to distinguish between combatants and civilians, or make proper calls about the harm attacks may do to nearby civilians. Machines cannot understand the value of human life, which in essence undermines human dignity and violates human rights laws, Docherty said. In a 2012 report, Docherty, a lecturer at Harvard Law School, called for fully automated weapons to be banned by international law. The defense magazine Janes said the development of autonomous ground vehicles has lagged behind autonomous aircraft and boats, because moving across land is far more complex than navigating water or air. Unlike the open ocean, vehicles have to deal with holes in the road, and know exactly how much force to apply to overcome a physical obstacle, the report said. The technology in self-driving vehicles also has raised concerns. Electric car manufacturer Tesla, among other companies, has been connected to a series of fatal accidents, including an incident in Arizona in 2018 when a woman was hit by a car driving on autopilot. The Israeli drone vehicle is being showcased at this week's Defense and Security System International arms trade show in London. I guess Clowns in Panic was right again. Again it is funny how a majority of Israelis are living in poverty, yet the country can spend unlimited amounts on weaponry, it's child level financing.

POSITIVE NEWS: Twenty-seven Republican governors or attorneys general have vowed to fight the latest executive order issued by President Joe Biden, mandating that over 80 million private employees receive COVID vaccinations or undergo weekly testing, or their employer will be fined. The executive order directs the U.S. Department of Labor's Office of Safety and Health Administration, to require private businesses with more than 100 employees mandate that, their workers receive both doses of the COVID-19 vaccine or undergo weekly testing. Noncompliance would result in fines of \$14,000 per violation. The governors who've expressed opposition include those from Arizona, Alabama, Alaska, Arkansas, Florida, Georgia, Idaho, Indiana, Iowa, Kansas, Missouri, Mississippi, Montana, Nebraska, New Hampshire, North Dakota, Ohio, Oklahoma, South Carolina, South Dakota, Tennessee, Texas, Utah, West Virginia, and Wyoming. Republican attorneys general from states with Democratic governors who also vowed to fight include Kentucky Attorney General Daniel Cameron and Louisiana AG Jeff Landry. Florida Gov. Ron DeSantis, with whom Biden has sparred over mask mandates and vaccine passports, said Florida would fight back. Nice to see some common sense in political ranks, be interesting to see how many of them disappear.

Wildlife crossings are more than simple road signs as you speed down the highway. Conservationists use all sorts of methods to keep our furry friends safe, from becoming road kill or having their habitats fragmented. Increasingly, animal bridges are being



employed around the globe in order to preserve our ecosystems. In the United States alone, it's estimated that road systems affect the ecology of one-fifth the land area of the country, and that vehicle-animal collisions cost \$8 billion a year. Wildlife overpasses and underpasses help assist animals in safely passing over or under busy roadways, and allows them to continue their path within their habitat, which would otherwise be blocked by asphalt. The first animal bridges sprung up in France in the 1950s, in fact, Europe is a leader in the sector. The Netherlands alone has over 600 wildlife crossings, including overpasses and eco-ducts, that protect its populations of badgers, boars, and deer. They can also boast of having the world's longest wildlife overpass. The massive Natuurbrug Zanderij Crailoo is a half-mile long, crossing a rail line, river, business park, and sports complex. A quarter of the \$8B cost for damages between vehicles and wildlife set aside, would be enough to build 200 animal road crossings per year, and eliminate most of road kills within a generation.

Last Tuesday here 19:00 PM local time in Holland, there was again a press conference by the clowns Mark Rutte and Hugo De Jonge of the government, about the covid bs measures this coming Autumn. From the 25th this month, the Dutch government will implement the mandatory QR-codes, for PCR tests and vaccines for entry in restaurants, hotels, festivals, concert, etc. The situation here is that the techno jabs are not directly mandatory but more indirect. COVID BS: Midazolam, sold under the brand name Versed, among others, is a benzodiazepine medication used for anesthesia, procedural sedation, trouble sleeping, and severe agitation. Midazolam can be given by mouth, intravenously, or injection into a muscle, by spraying into the nose, or through the cheek. When given intravenously, it typically begins working within five minutes, when injected into a muscle, it can take fifteen minutes to begin working, effects last for between one and six hours. Side effects can include a decrease in efforts to breathe, low blood pressure, and sleepiness. Tolerance to its effects and withdrawal syndrome may occur following long-term use. Paradoxical effects, such as increased activity, can occur especially in children and older people. There is evidence of risk when used during pregnancy, but no evidence of harm with a single dose during breastfeeding. It belongs to the benzodiazepine class of drugs, and works by increasing the activity of the GABA neurotransmitter in the brain. Midazolam was patented in 1974 and came into medical use in 1982. It is on the World Health Organization's List of Essential Medicines. Midazolam is available as a generic medication, in many countries, it is a controlled substance. Midazolam, in combination with an antipsychotic drug, is indicated for the acute management of schizophrenia, when it is associated with aggressive or out-of-control behaviour. If that is the case why aren't all leading politicians, Agency goons and Military Generals on it? Additional caution is required in the elderly, as they are more sensitive to the pharmacological effects of benzodiazepines, they metabolise them more slowly, and are more prone to adverse effects, including drowsiness, amnesia, especially anterograde amnesia, ataxia, hangover effects, confusion, and falls. In the final stages of end-of-life care, midazolam is routinely used at low doses via subcutaneous injection to help with agitation, myoclonus, restlessness or anxiety in the last hours or days of life. At higher doses during the last weeks of life, midazolam is considered a first line agent in palliative continuous deep sedation therapy, when it is necessary to alleviate intolerable suffering not responsive to other treatments, but the need for this is rare. Researchers have identified a potential reason why lower numbers of COVID cases have appeared amongst smokers compared to non-smokers, even as other reports suggest smoking increases severity of the disease. The test operates without a battery and uses contactless near-field communication via a smart phone application. batteries and use electricity to charge them. In 5 minutes, the digital test detects viruses' presence without the need for dedicated reading equipment other than a smart phone, or a sting or burn phone. The test result is tamperproof and recorded in a digital tag securing user confidentiality, and constituting a standalone digital pass that does not require data transfer over a network. We are testing this approach with spinach and lettuce and have long-term goals of people growing it in their own gardens, Giraldo adds. Farmers could also eventually grow entire fields of it. The highest variance is observed in African populations, the origin of E3b3 will most probably be among Cushitic/Omotic speaking populations of Southwest and Central Ethiopia. Kush came from SW Asia. It has been said by some scientists that the best possible candidate for E3b Israelite ancestry among Jews is E-M123, which is quite common in many Semitic language communities, including among both Ashkenazi and Sephardic Jews, accounting for over 10% of all male lines. According to Cruciani, E-M123 probably originated in the Middle East, since it is found in a large majority of the populations from that area, and then back migrated to Ethiopia. We proved that Jewish lineage came from the Far East, and only turns up in the Middle East via migration He further notes that this sub-clade may have been spread to Europe during the Neolithic agricultural expansion out of the Middle East. However, because E-M123 is also found in low percentages 1-3% in many southern European and Balkan populations, its origin among Jewish groups remains uncertain. Yet the fact that both Sephardim and Ashkenazim possess this sub-clade in similar high frequency, supports an Israelite/Middle Eastern origin. individuals from Ashkenazi, Sephardic and Samaritan communities having traditions of descending from the tribe of Levi, suggesting that the E1b1b1 Levites may have existed in Israel before the Diaspora of 70 C.E. The Samaritan community is a small, isolated, and highly endogamous group today numbering some 650 members who have maintained extensive genealogical records for the past 13-15 generations. Since the Samaritans maintain extensive and detailed genealogical records, it is possible to construct accurate pedigrees and specific maternal and paternal lineages. The Samaritan community in the Middle East survives as a distinct religious and cultural sect and constitutes one of the oldest and smallest ethnic minorities in the world. Y-Chromosome studies have shown that the majority of Samaritans belong to haplogroups J1 and J2, while the Samaritan Cohanim belong to haplogroup E1b1b1a, formerly E3b1a. The bible says Moses is a Levite, and that he married an Ethiopian. Moses was one of the true founders of this bloodline who had married an Ethiopian Wife. But the new research favors a different interpretation something even weirder. Instead of forming a new grouping, a pair of particles traded identities before flying off. This identity swap is known as a triangle singularity, and this experiment may have unexpectedly delivered the first evidence of that process. I can think of a good triangle singularity were a pair of psychopaths trade identities with each other and then whisk off into oblivion, The Rothschild's and the Black Sun groups.

Estimates of the overall size of the subculture vary greatly, ranging from thousands to hundreds of thousands of members. At least eight mass murders, resulting in a total of 61 deaths, have been committed since 2014 by men who have either self-identified as incels, or who had mentioned incel-related names and writings in their private writings or Internet postings. Incel communities have been criticized by researchers and the media for being misogynistic, encouraging violence, spreading extremist views, and radicalizing their members. Beginning in 2018, the incel ideology has increasingly been described as a terrorism threat, and a February 2020 attack in Toronto, Canada, became the first instance of allegedly incel-related violence to be prosecuted as an act of terrorism. The first online community to use the term incel was founded in 1993, when a Canadian university student known only by her first name, Alana, created a website in order to discuss her sexual inactivity with others. The website, titled Alana's Involuntary Celibacy Project, was used by people of all genders to share their thoughts and experiences. In 1997, she started a mailing list on the topic that used the abbreviation INVCEL, later shortened to incel, for anybody of any gender who was lonely, had never had sex, or who hadn't had a relationship in a long time. During her college years and after, Alana realized she was bisexual and became more comfortable with her identity. She stopped participating in her online project around 2000 and gave the site to a stranger. In 2018, Alana said of her project: it definitely wasn't a bunch of guys blaming women for their problems. That's a pretty sad version of this phenomenon that's happening today. Things have changed in the last 20 years. When she read about the 2014 Isla Vista killings, and that parts of the incel subculture glorified the perpetrator, she wrote, like a scientist who invented something that ended up being a weapon of war, I can't uninvent this word, nor restrict it to the nicer people who need it. She expressed regret at the change in usage from her original intent, of creating an inclusive community for people of all genders, who were sexually deprived due to social awkwardness, marginalization, or mental illness. This was likely down to agency interference within the group, anything that benefits people coming together for a better cause, is ultimately targeted, as we at THI have found out. The message board love-shy.com was founded in 2003, as a place for people who felt perpetually rejected or were extremely shy, with

Over the next decade, the membership of love-shy.com, and online fringe right-wing communities like 4chan increasingly overlapped. EXPOSE 2: Mesirah (or mesira, Hebrew: to turn over) is the action in which one Jew reports the conduct of another Jew to a non-rabbinic authority in a manner and under the circumstances forbidden by rabbinic Law. This may not necessarily apply to reporting legitimate crimes to responsible authority, but does apply to turning over a Jew to an abusive authority, or to a legitimate one who would punish the criminal in ways seen as excessive by Jewish community, though excessive punishment by non-Jews may be permissible, if a precept of the Torah has been violated. The term for an individual who commits mesirah is moser or mossur. A person who repeatedly violates this law by informing on his fellow Jews is considered subject to Din Moser, the law of the informer, which is analogous to Din rodef in that both prescribe death for the offender, and according to some, in some circumstances the offender may be killed without warning. The source of the ban comes from the Bava Kamma section of the Babylonian Talmud. Probably the law was instigated to ease Jewish life under Roman or Persian rule. No it wasn't, it was the plan all the time, it is the law all EL-ite Jews live by, it is their code of law, code being the operative word. Their law is another control system, and this is why many lawyers are Jewish to control the system. According to The Times of Israel and a Channel 4 investigation, the concept of mesirah was used by a Haredi leader to protect community members investigated for child molestation from police investigation. And yet people are concerned about Sharia law, with this level of deceit and deception? The principle of mesirah has also been used to dissuade Jewish auditors from reporting other Jews to the IRS for tax fraud. Rabbinic courts in Israel have issued writs calling for social exclusion of Jews bringing legal issues to Israel's civil courts. Rabbi Chaim Kanievsky, a leading Israeli rabbi and posek in Haredi Jewish society ruled, that reporting instances of sexual child abuse to the police is consistent with Jewish law. Other major Orthodox poskim in America, such as Rabbi Hershel Shachter also concur that abuse cases should be reported in full to the civil authorities. Which proves the great differences between the Jewish peoples. Mesirah has also been cited as one of the main reasons for the gross underreporting in the sexual abuse cases in Brooklyn's Haredi community. In Australia: The mesirah doctrine came under intense public scrutiny in Australia in early 2015, as a result of evidence given to the Royal Commission into Institutional Responses to Child Sexual Abuse relating to an alleged long-running and systematic cover-up of child sexual abuse, and the institutional protection of perpetrators at the exclusive Melbourne boys' school Yeshiva College. On 28 January 2015 Fairfax Media reported secret tape recordings and emails had been disclosed, which revealed that members of Australia's Orthodox Jewish community who assisted police investigations into alleged child sexual abuse, were pressured to remain silent on the matter. Criminal barrister Alex Lewenberg was alleged to have been disappointed, and to have berated a Jew who had been a victim of a Jewish sex offender, and whom he subsequently regarded as a mossur for breaking with mesirah tradition. Lewenberg was subsequently found guilty of professional misconduct. In February 2015 Zephaniah Waks, an adherent of the ultra-Orthodox Hasidic Chabad sect in Melbourne, Australia, testified to the Royal Commission that following his discovery that one of his sons had been sexually abused by Rabbi David Kramer, a teacher at their school, Yeshiva College, he confronted the school's principal, Rabbi Abraham Glick and demanded that Kramer be sacked. Waks told of his shock when he learned a few days later that Kramer was still working at the school, and that he again confronted Rabbi Glick, who then claimed that Kramer had admitted his guilt because he wanted to be caught, but that the school could not dismiss Kramer because, Glick claimed he was at risk of self-harm. Waks also told the Commission that despite his anger, he felt constrained not to go to the authorities because of the doctrine of mesirah. I thought this was absolutely outrageous, however if I reported this to the police I would be in breach of the Jewish principle of mesirah. Waks said the concept of mesirah prevented members of the ultra-Orthodox Chabad sect of Judaism from going to secular authorities. At the very least, the breach of mesirah almost certainly always leads to shunning and intimidation within the Jewish community, and would almost certainly damage marriage prospects of your children. Giving evidence to the



Commission on the day before his father, Menachem Waks, one of three children from the Waks family who were sexually abused by staff at Yeshiva College, testified that after breaking mesirah by going public about his abuse. He and his family had been ostracised by rabbinical leaders, shunned by his community and subjected to a sustained campaign of abuse, intimidation and threats, which eventually forced Waks to leave Australia with his wife and children. He also testified about how members of the exclusive Chabad community had pressured him to abandon his advocacy. I was in fact contacted by several considered community members, and they said to me that the anti-Semites are having a field day with my testimony and my publicity around this issue, and that if I cared about the community, I'd cease doing that straight away. Counsel Assisting the commission then asked Waks how he felt having been accused of being an informer, I am appalled by it obviously, because the concept of Mesirah really, you can become a death target. Taken at its literal meaning, you become potentially a target who is legitimate to be murdered, because you've gone and cooperated with the authorities. Now, I've never felt threatened for my life, but it does highlight the severity in which this concept is held. In December 2017, the Commission's final report included a recommendation to Jewish institutions, all Jewish institutions in Australia should ensure that their complaint handling policies explicitly state, that the halachic concepts of mesirah, moser and loshon horo, do not apply to the communication and reporting of allegations of child sexual abuse to police and other civil authorities. When the labor shortage started in the United States, a lot of people blamed overly generous government handouts, but that doesn't explain why the exact same thing is happening in nation after nation all over the globe. There aren't enough factory workers, there aren't enough truck drivers, there aren't enough port workers, there aren't enough employees to properly staff



our stores, and the shortage of doctors and nurses is becoming a major crisis in some areas. During normal times, we were always told that the global economy was not producing nearly enough jobs for everyone, but now for the very first time we are facing an enormous worldwide labor shortage. It is almost as if millions upon millions of people suddenly disappeared from the system. Earlier today, I was stunned to learn that a new survey has discovered that 69 percent of global companies are having a hard time finding enough people to hire. A survey of nearly 45,000 employers across 43 countries showed 69 percent of employers reported difficulty filling roles, a 15-year high, according to employment-services provider ManpowerGroup Inc. At the same time, 15 countries focused in Europe and North America reported their highest hiring intentions since the survey began in 1962. Just a few years ago, any company that was willing to pay decent wages would be absolutely flooded by job applications. But now everyone can't stop talking about the shortage of workers. So where did all the people go? Normally, global supply chains run as smooth as butter, but now they are in a complete and utter state of chaos, is because there simply is not enough workers for them to operate. On a very basic level, we need people to make stuff, pack stuff, ship stuff, transport stuff, unload stuff and sell stuff. A supply chain crunch that was meant to be temporary now looks like it will last well into next year, as the surging delta variant upends factory production in Asia and disrupts shipping, posing more shocks to the world economy. Manufacturers reeling from shortages of key components and higher raw material and energy costs, are being forced into bidding wars to get space on vessels, pushing freight rates to records and prompting some exporters to raise prices or simply cancel shipments altogether. But if we had enough people to do all the jobs that needed to be done, this crisis could be resolved very rapidly. So where are they? As inventories get tighter and tighter, that is invariably going to drive up prices. Earlier this week, one of my readers emailed me about the shortages and price increases that she is seeing in her local area. I asked her if I could share this with all of you. You can't find frozen turkeys, frozen hens, frozen cornish hens, the supply chain has indeed been cut. There was just one box of oatmeal on the shelves of our local food store, that are normally stocked through the gills with food. Prices are higher tomato sauce in a can, what was \$0.99 cents last year now costs \$1.50. Chicken drumsticks last year were \$0.89/pound now they are \$ 1.39 per pound. We only buy meat that has been reduced a rump roast, for instance, was marked down from \$18 dollars to \$7, that's a huge price cut, so we look for deals like that, but they are hard to find. Everything is higher, packaged in smaller boxes and cups and there is not much of it. We all knew this was coming it's going to get worse, for lots of people who don't know what's happening. We have goats for goat milk and meat if we need, chickens for eggs and we've put back lots of produce we found on sale over the summer, in the freezer to booster our garden. It's shocking how much just is not there the shelves are empty, moved closer together, and bare spots are everywhere in grocery stores these days. I mentioned this in a show when I was still in Florida, so pre August 2018, in particular how many Walmart shelves were empty. Unfortunately, what we have



experienced so far is just the beginning. Global food supplies are going to continue to get tighter, and that is going to continue to drive up food prices. Another sector of the economy where the labor shortage is having a big impact is in the healthcare industry. Lately, I have been coming across lots of stories about people dying because they can't get the care that they need. Just before I started writing this article, I came across a heartbreaking story about a 70-year-old woman in Canada that dropped dead after a six hour wait in a local emergency room, when she died early Wednesday in a Kamloops, B.C., hospital emergency waiting room after a six-hour wait for care. Kamloops is known for genocide of kids in the children's homes, churches and hospitals. Nobody should ever have to die that way, due to a lack of care. But it is going to keep happening, because there is an acute shortage of healthcare workers right now. All over the nation, the shortage of nurses has become a really big deal, and new mandates are just making things even worse. Hospitals are struggling to comply with the state's nurse staffing requirements, as pandemic-induced burnout has exacerbated an already chronic nursing shortage nationwide. But burnout isn't the only thing compounding California's nursing shortage: The state's new vaccine mandate for health care workers, is already causing headaches for understaffed hospitals before it is even implemented. Some traveling nurses who are in high demand nationwide, are turning down California assignments because they don't want to get vaccinated. There is a serious shortage of doctors as well, and this is a phenomenon that we are witnessing all over the globe. For example, over in the UK the NHS may be unable to cope this winter because of a frightening shortfall of more than 50,000 doctors, the head of the British Medical Association has warned. Here in the United States, our healthcare system has never been so close to a state of collapse. In fact, one doctor recently wrote an article in which he claimed that it has already collapsed. As a resident physician who has only trained in an era of Covid, I was asked to consider graduating from school early in April 2020 to help with medical staff shortages. My time as a doctor has been defined by working in a system that has already collapsed. The American health system I work in has featured limited personal protective equipment, oxygen shortages, and the construction of field hospitals in convention centers and parking garages. Last winter, many hospitals across the country instituted crisis standards of care, forced to ration health services based on criteria that few people envisioned would be used outside of a mass casualty event, like a terrorist attack. Today, hospitals are full in much of the country, with patients requiring an ICU being airlifted thousands of miles in search of a staffed bed. These are not features of a health system that is approaching failure. These are features of a health care system that has broken down spectacularly, forcing doctors and patients to climb through the rubble looking for help. But just like every other industry, if we had enough people to do the jobs that needed to be done, we would be fine. In all the years that I have been writing about the economy, finding enough workers has never been a problem. Yet here we are in the middle of 2021, and all of a sudden there are millions and millions and millions of empty jobs all over the globe. Once again, there is a question that I must ask. Where did all the
