The company's actions underscore the risks it faces from ongoing talc litigation, which as of July totaled roughly 34,600 lawsuits linking Johnson's Baby Powder to ovarian cancer, asbestos poisoning and other illnesses. The Bank of Thailand and Thai Bankers' Association issued a joint statement on Sunday, saying banks would accept responsibility for the debts fraudulently accrued by customers. The statement said no commercial banks' systems had been hacked. The irregular transactions were for payment to online shops registered outside Thailand. The money was withdrawn through credit and debit cards. The cardholders did not buy goods online from those shops, and were not alerted to the withdrawals. All withdrawals where the same figure of 34.15 bhat. The number of victims remained unclear but the Facebook sharing experience account had more than 57,000 followers on Monday, with the number increasing. Lloyds Banking Group is to close a further 48 branches, after a decline in visits by customers. The Unite union said the closure of 41 Lloyds Bank and seven Halifax branches, will deny thousands of customers access to vital services and cash, and could lead to 178 job losses. Vim Maru, retail director for Lloyds Banking Group, said: like many other businesses, we've seen people using our branches less frequently in recent years, and this decline is continuing. The associate geophysics professor, Dorian Abbot, said activists and MIT academics were outraged by comments he made in an August Newsweek opinion piece, wherein he criticized current diversity, equity, and inclusion standards in higher education. Oops he spoke truth then, global crime that these days. In the piece, Abbot proposed an alternative framework called Merit, Fairness, and Equality, whereby university applicants are treated as individuals, and evaluated through rigorous and unbiased processes based on merit and qualifications. The professor also characterized the current diversity standards as treating people as members of a group rather than as individuals, repeating the mistake that made possible the atrocities of the 20th century. An MIT spokesperson told The New York Post in a statement that the lecture on climate science and life on other planets, hosted by the Department of Earth, Atmospheric and Planetary Sciences, wasn't being held this year at the discretion of the department. Princeton opted to take the reins and host Abbot's lecture remotely on October 21, the very same day it was scheduled to take place at MIT. A Princeton professor, Robert P. George, said in a Sunday tweet that the Zoom quota for the lecture had already been expanded, to accommodate more attendees after the web conference limit was reached. One University of Chicago student attending the lecture, Audrey Unverferth, said that she was excited to attend the revived lecture, and called the professor extraordinarily brave for leading the charge against the cancel mob. Unverferth is the co-founder and editor-in-chief of the student-run newspaper, The Chicago Thinker, which she says is dedicated to challenging the mob's crusade against free speech. The Santa Fe County Sheriff's Department said Hutchins and the film's director, Joel Souza, were shot when the prop gun was discharged by Baldwin. Hutchins was flown by helicopter to the University of New Mexico Hospital, where she was pronounced dead. Souza was hospitalized in critical condition. An investigation was underway. Grew up on a Soviet Military base and yet worked closely inside the US, in their world should that not be a security issue? Rocking back and forth, Shlomo Ben Yaakov reads from a Torah scroll at a synagogue on the outskirts of Nigeria's capital, Abuja. Rocking back and forth in any other form of life and society would label that person with a mental defect, but not in the conspiratorial world of religion it seems. Perhaps this article will reveal why Africa is always in so much turmoil, and who is involved in it. Intermittently his soft mellow voice rises in Hebrew, and he is joined by the dozens who recite after him. Most do not fully understand the language, but this small Nigerian community claims Jewish ancestry dating back hundreds of years, and they are left frustrated by a lack of recognition by Israel. I consider myself a Jew, says Mr. Yaakov. There are a number of African peoples all claiming the same thing, because they wish to be seen as the in crowd and merge with the faked biblical stories. Mr. Yaakov if you knew the true history, the last thing you may wish to consider yourself as is, a Jew. The point being is why people have to label



themselves with external verbs and nouns to begin with? What is wrong with being the self? a spark of Source creation? is that not enough? Outside the Gihon Hebrew Synagogue in the suburb of Jikwoyi, a table is laid inside a tent built from palm leaves to celebrate Sukkot, a festival that commemorates the years Jews spent in the desert on their way to the Promised Land. Just as we are doing this now, they are doing same in Israel, says Mr Yaakov, as people share traditional cholla bread, baked at the synagogue and wine from small cups being passed around. He is an Igbo, one of Nigeria's three dominant ethnic groups which originates in the south-east of the country. Many Igbos believe they have Jewish heritage as one of the so-called 10 lost tribes of Israel, though most are not practicing Jews like Mr Yaakov, oh dear. They comprise less than 0.1% of the estimated 35 million Igbos. These tribes were said to have disappeared after being taken into captivity, when the northern Israelite kingdom was conquered in the 8th Century BC, and the Ethiopian Jewish community, for example, is recognized as one of them. Igbo customs such as male circumcision, mourning the dead for seven days, celebrating the new moon and conducting wedding ceremonies under a canopy, have reinforced this belief about their Jewish heritage. I think someone needs to tell him that is cult behavior. But Chidi Ugwu, an Igbo who is an anthropologist at the University of Nigeria in Enugu, says this identification with Judaism emerged only after the Biafran civil war. The Igbos had been fighting for secession from Nigeria, but lost what was a brutal conflict between 1967-1970. Some people were looking for some psychological boost to hang on to, so began to make the Jewish connection, he says. They saw themselves as persecuted people, much as Jewish people have been through history, especially during the Holocaust. Erm what about the Polish people, the Slav, the Aryans who died in far greater numbers, why does his story always erase that? It is insulting to call the Igbos the lost tribe of anybody, there is no historical or archaeological evidence to back that up. He argues that as evidence suggests, the Igbos were among those who migrated out of Egypt several thousand years ago, it may be that Jews picked up Igbo customs when they went there. Perhaps they never migrated at all and where thrown out for their practices? Rabbi Eliezer Simcha Weisz, chairman of the foreign affairs department of the Rabbinate Council of Israel, the body that determines claims of Jewish ancestry, is also in no doubt. They claim to be one of the descendants of Gad, one of the sons of our forefather Jacob, but they can't prove their grandparents were Jewish, he said. And the customs they speak of, you can find people all over the world who have Jewish practices. Indeed, that is called indoctrination, and subjugation of the local populace, much like how the more modern day Jewish practice did, called Christianity. He said unless the Nigerian Jews converted to Judaism, a process that entails various rituals and appearing before a Jewish court, which is unavailable in Nigeria, they would not be recognized. Rituals and Cohen courts operating Talmudic law, erm no thanks. Just how arrogant does that statement sound? I thought religion was suppose to be about all encompassing and the divine? what a conspiracy that is, as I see no evidence to support it. Mr. Yaakov regards the idea of having to go through a conversion as an insult, the greater



insult is the self elevation through connecting to something you think is greater than yourself. As a convert we would be seen as second-class citizens, he says. Indeed and so nothing would change, go and teach people real values, not chase fake tribes who are connected to a fake story and history.

Turkey's intelligence agency reportedly cracked a Mossad spy ring in an operation earlier this month, exposing five cells and arresting 15 men suspected of conducting covert activities on foreign students and Palestinians. Beware the false flag backlash, that is how these people work. After tracking the network for over a year, the National Intelligence Organization shared the information with counter-terrorism forces. According to the Sabah daily newspaper, a 200-strong team raided the cells in a secret operation across four provinces on October 7. The Turkish newspaper reported that the arrested men had been instructed to gather information on foreign students, particularly Palestinians, enrolled in Turkish universities, with an eye on those thought to have a future in the defense industry. The spies were also allegedly tasked with looking into a number of other unspecified associations, and organizations that hosted Palestinians in Turkey. The network apparently used this information to put together profiles on individuals, which were then relayed to Mossad officials, through end-to-end encryption programs like ProtonMail and SafeUM, a software that generates fake phone numbers. They also communicated through WhatsApp. As compensation, the suspected agents were transferred payments via Western Union, Moneygram, and even Bitcoin in some cases, the paper said. The network also reportedly developed a courier system to transfer funds, using jewelry stores and markets. Or they could have just tapped mask man Biden and Gina Haspel of the CIA and ask for more American aid.

A huge leak of documents seen by BBC News shows how countries are trying to change a crucial scientific report on how to tackle climate change. The leak reveals Saudi Arabia, Japan and Australia are among countries asking the UN, to play down the need to move rapidly away from fossil fuels. It also shows some wealthy nations are questioning, paying more to poorer states to move to greener technologies. This lobbying raises questions for the COP26 climate summit in November. The leak reveals countries pushing back on UN recommendations for action, and comes just days before they will be asked at the summit to make significant commitments, to slow down climate change and keep global warming to 1.5 degrees. Well it has already gone down 0.7C in the past 5 years. The leaked documents consist of more than 32,000 submissions made by governments, companies and other interested parties to the team of scientists compiling a UN report, designed to bring together the best scientific evidence on how to tackle climate change. These assessment reports are produced every six to seven years by the Intergovernmental Panel on Climate Change, the UN body tasked with evaluating the science of climate change. These reports are used by governments to decide what action is needed to tackle climate change, and the latest will be a crucial input to negotiations at



the Glasgow conference. What a complete pile of shit, the time, effort and expense these people go to, to just talk shit just boggles the mind. Here is a novel idea, do something of value or real for a change.

Weeks after initial reports emerged that China had an interest in using Bagram Airfield in Afghanistan, a new spate of reports have emerged on social media, which means the agencies have been inserting stories again, indicating that activity at the former U.S. base could indicate that China is moving forward with that plan. In early September, U.S. News and World Report said China was interested in using the base, which was abandoned by the U.S. weeks before the military's final departure from Afghanistan. The base had been the largest American-run facility in Afghanistan. Multiple military assets given to Afghanistan by the United States were taken when the Taliban overran the base. The report said China was assessing the feasibility of using the base as a forward outpost, later prompting official denials from the Chinese government. On Sunday journalist Tajuden Soroush of the London-based Iran International, an Iranian opposition outlet, tweeted that activity at the base is giving new life to the idea that China is moving in. Sources in Bagram say they have seen military planes are landing at Bagram airbase. Earlier reported that some Chinese are seen there either but the Taliban denied it. Bagram was the biggest US base in Afghanistan and at least 3 US presidents visited it during the last 20 years. Yun Sun, director of the China Program at the Stimson Center, said official denials aside, occupying the base would be attractive to China, according to the U.K. Daily Mail. Yet more faction games and the request for further Military funds to deal with the "China issue", whilst we push ahead with child like games and threats, they are pushing on taking over everything, like economics, and the jackasses are oblivious or complicit in it.

For children 12 to 15 years of age, the extremely short and small Pfizer Covid-19 vaccine clinical trial found the overall incidence of severe adverse events which left the children unable to perform daily activities, during the two-month observation period to be 10.7%, or 1 in 9, in the vaccinated group and 1.9% in the unvaccinated group. Consequently, children who received the vaccine had nearly six times the risk of a severe adverse event occurring in the two-month observation period, compared to children who did not receive the vaccine. In addition, the incidence of Covid-19 in the unvaccinated group was 1.6%, therefore, there were almost seven times more severe adverse events observed in the vaccinated group, than there were Covid-19 cases in the unvaccinated group. To those of us who are not versed in Johns Hopkins or common core maths, would say that was pretty conclusive evidence of failed vaccines at best, and sinister intentions at worst.

Here is another of their own reports. Covid has severely affected healthcare staff and may have killed between 80,000 and 180,000, the World Health Organization says. Healthcare workers must be prioritized for vaccines, WHO head Tedros Adhanom Ghebreyesus said, and he criticized unfairness in the distribution of jabs. The deaths occurred between January 2020 and May of this year, which was the time the jabs were rolled out. Earlier, another senior WHO official warned a lack of jabs, could see the pandemic continue well into next year. There are an estimated 135 million healthcare workers globally. Data from



119 countries suggest that on average, two in five healthcare workers globally are fully vaccinated, Dr Tedros said. But of course, that average masks huge differences across regions and economic groupings. Fewer than one in 10 healthcare workers were fully vaccinated in Africa, he said, compared with eight in 10 in high-income countries. Africans are less brainwashed by the TV is why. A failure to provide poorer countries with enough vaccines was highlighted earlier by Dr Bruce Aylward, a senior leader at the WHO, who said it meant the Covid crisis could easily drag on deep into 2022. Less than 5% of Africa's population have been vaccinated, compared with 40% on most other continents. The vast majority of Covid vaccines overall have been used in high-income or upper middle-income countries. Africa accounts for just 2.6% of doses administered globally. Mainly because they have learned from the Gates Foundation and others vaccine programs before, that killed, injured or sterilized many of their people.

The great debate of the electric cars v. the oil and gas cars is now building up, but there are issues, cost and time to consider before taking the leap. There are four additional costs to powering EVs beyond electricity. The cost of home charger, commercial charging, the EV tax and "deadhead" miles. Deadhead miles: EV drivers incur costs of driving miles to a commercial charger for the sole purpose of charging, due to the lack of electric charging stations. For the example set in Michigan, the direct monetary costs to drive 100 miles in an ICE vehicle is between \$8 and \$12, and in an EV is between \$12 and \$15. For now, EVs cost more to power than gasoline costs, to fuel an internal combustion car that gets reasonable gas mileage. In Michigan, for example, levies an additional registration cost between \$135 and \$235 for most electric vehicles. How is that encouraging anyone to switch by increasing the registration costs, yet again ass backwards bureaucracy and non thinking. There are significant time costs to finding reliable public chargers, even then a charger could take 30 minutes to go from 20% to an 80% charge. The study found that the average cost of a Level 1 charger is \$600. To install a Level 2 costs \$1,600 because it requires hiring an electrician. An L1 charger uses a 120-volt supply of electricity and can take 20 or more hours to charge, whereas an L2 chargers uses 240 volts and can charge in a few hours. You typically have to go to a commercial charger and commercial charger rates are two, three or four times that of residential charger rates. Again some people have taken advantage at what would be around 15-25c per KWh for home charging, these stations are charging at around 30-43c per KWh's, which can rise with additional charges of time of use, to 33-66c per Kwh. Did any jackass in the Government not plan ahead and make subsidies and regulate the cost of charging, before pushing people into this program? clearly not.

The graphics company Nvidia is building its Omniverse, which it describes as a platform for connecting 3D virtual worlds. Perhaps when you go online shopping, you'll try on digital clothes first, and then order them to arrive in the real world. VR has come a long way in recent years, with high-end headsets which can trick the human eye into seeing in 3D as the player moves around a virtual world. The October 5 panel kicked off with François du Cluzel, a former French military officer who in 2013 helped to create the NATO Innovation Hub, which he has since then managed from its base in Norfolk, Virginia. What a surprise they operate out of Norfolk Virginia, just like the guy who wrote the Open Source Handbook for NATO, Robert David Steele. Although the iHub insists on its website, for legal reasons, that the opinions expressed on this platform don't constitute NATO or any other



organization points of view, the organization is sponsored by the Allied Command Transformation (ACT), described as one of two Strategic Commands at the head of NATO's military command structure. The Innovation Hub, therefore, acts as a kind of inhouse NATO research center or think tank. Just like the CIA with it's in house subsidiary companies and private contractors groups. Its research is not necessarily official NATO policy, but it is directly supported and overseen by NATO. In 2020, NATO's Supreme Allied Commander Transformation (SACT) tasked du Cluzel, as manager of the iHub, to conduct a six-month study on cognitive warfare. I don't know what cognitive warfare, but resembles more of cognitive dissonance to me. The psychological tension that occurs when one holds mutually exclusive beliefs or attitudes, and that often motivates people to modify their thoughts or behaviors in order to reduce the tension. Du Cluzel summarized his research in the panel this October. He initiated his remarks noting that cognitive warfare right now is one of the hottest topics for NATO, and has become a recurring term in military terminology in recent years. Although French, Du Cluzel emphasized that cognitive warfare strategy is being currently developed by my command here in Norfolk, USA. The NATO Innovation Hub manager spoke with a PowerPoint presentation, and opened with a provocative slide that described cognitive warfare as A Battle for the Brain. Cognitive warfare is a new concept that starts in the information sphere, that is a kind of hybrid warfare, du Cluzel said. It starts with hyper-connectivity, everyone has a cell phone, he said. It starts with information because information is, if I may say, the fuel of cognitive warfare. But it goes way beyond solely information, which is a standalone operation, information warfare is a standalone operation. Cognitive warfare overlaps with Big Tech corporations and mass surveillance, because it's all about leveraging the big data, du Cluzel explained. We produce data everywhere we go, every minute, every second we go, we go online, and this is extremely easy to leverage those data in order to better know you and use that knowledge to change the way you think. All about harvesting every facet of life with these people, everything is up for grabs and marketable and manipulable for the vampiric parasites. Naturally, the NATO researcher claimed foreign adversaries are the supposed aggressors employing cognitive warfare. But at the same time, he made it clear that the Western military alliance is developing its own tactics. Du Cluzel defined cognitive warfare as the art of using technologies to alter the cognition of human targets. Yet again there is the propensity in these types of documents to mention the targets as humans, why define it in those terms? is it saying those targeting humans are not human? Those technologies, he noted, incorporate the fields of NBIC nanotechnology, biotechnology, information technology, and cognitive science. All together, it makes a kind of very dangerous cocktail that can further manipulate the brain, he said. Du Cluzel went on to explain that the exotic new method of attack, goes well beyond information warfare or psychological operations known as psyops. Cognitive warfare is not only a fight against what we think, but it's rather a fight against the way we think. He said, if we can change the way people think, it's much more powerful and it goes way beyond the information warfare and psyops. Now you know why we opened up



the first THI show with, you have to THInk and act different, because if we don't, these jackasses will think and act for us. De Cluzel continued: It's crucial to understand that it's a game on our cognition, on the way our brain processes information and turns it into knowledge, rather than solely a game on information or on psychological aspects of our brains. It's not only an action against what we think, but also an action against the way we think, the way we process information and turn it into knowledge. In other words, cognitive warfare is not just another word, another name for information warfare. It is a war on our individual processor, our brain. The NATO researcher stressed that this is extremely important for us in the military, because it has the potential, by developing new weapons and ways of harming the brain, it has the potential to engage neuroscience and technology in many, many different approaches to influence human ecology. Instead of cognitive warfare, perhaps they could try teaching the Military to be cognitive of life and reason? that would be a useful start, because from what I see is, all Military leaders are psychopaths. It's very easy to turn a civilian technology into a military one, he said. As for who the targets of cognitive warfare could be, du Cluzel revealed that anyone and everyone is on the table. Cognitive warfare has universal reach, from starting with the individual to states and multinational organizations, he said. Its field of action is global and aim to seize control of the human being, civilian as well as military. And the private sector has a financial interest in advancing cognitive warfare research, he noted, was wondering when the shekel people would be involved. The massive worldwide investments made in neurosciences, suggests that the cognitive domain will probably one of the battlefields of the future. Remember I mentioned people returning from the past with similar names, like Macron? Françoise de Cluzel is the same name as a Marquis, a title of nobility from the 1700's. A lord who owned castles. One of the great battlefields of the future he said, no the greatest battlefield is in their own heads, and perhaps they should cognitively search for some actual brain cells in their own heads first. This level of thinking is no longer a surprise anymore, and people wonder why other beings think of us in terms of child like. The Soviet Union's secret police, the infamous KGB, praised her savvy and erudition, even as she frustrated their attempts to spy on her in Cold War Ukraine. They tagged her with the code name Frida. But today we know Chrystia Freeland as Canada's Deputy Prime Minister and Minister of Finance. Ms. Freeland's ties to Ukraine are no secret, but materials uncovered from the KGB archives in Kyiv, illuminate her role in the Ukrainian independence movement while on exchange there from Harvard University. In the former Soviet republic, now Moscow's antagonist, access to information on the communist period is guaranteed, both as part of reckoning with Ukraine's past and



explicitly as a rebuke to Russia, which is seeking once again to impose itself on the country. The materials show what drew the Soviet intelligence services' attention to the then-troublesome young Canadian, who was the subject of denouncements in the Soviet press and even warranted a feature in top-secret KGB documents. In articles bearing titles like Abuse of Hospitality, Soviet newspapers publicly lambasted the Canadian visitor, for recklessly meddling in the Soviet Union's affairs with malice aforethought. What business, the Kyiv newspaper Pravda Ukrainy asked, did someone from Edmonton have leading a civic organization for the preservation of the Ukrainian language in Ukraine? Why did someone in Ukraine to study the Ukrainian language spend so little time doing so at the university sponsoring her visit. Why study when, as the televised rallies at which she spoke time and again clearly showed, she spoke the language flawlessly? Even Pravda, the official broadsheet of the Communist Party of the Soviet Union, condemned her by name, and others like her, for their efforts to tear Ukraine away from the USSR. Because she like Hunter Biden and many others in Ukraine are there to spy for NATO, the 5 eyes group and Mossad. Remember I also exposed her sister Elana, who was another agent Randy Maugans brought forward into the community, after he introduced the other two spies Lily Earthling, who was a Ukrainian assassin as well and Cara St. Louis, real name Orendorf who worked for the German spy agency. Elana and Cara St. Louis were both "trainers" at Waldorf. Ms. Freeland, in a written statement to The Globe and Mail, said: I am aware that my work with pro-democracy and environmental activists invoked the ire of the Soviet KGB. I remember being the target of smear campaigns in the Soviet press. Though I was eventually forced to leave the country, I have no regrets about my time in Ukraine during the Soviet period. She left because like all other agents who get exposed, they flee or die, sometimes they flee and die by their own paymasters. But clearly this spy had other values to the clowns and she survived. Out of this experience, what struck me, very powerfully, was how quickly a rotten political system could collapse, and how important the work of brave dissidents could be. Haha surely you jest Ms. Freeland your own political system has collapsed and you are forcing Fascism on your own people. Ms. Freeland was part of a flood of tourists; activists; missionaries; students; and even historians, purporting to work in the archives but suspected by authorities, including the KGB, of having ulterior motives, that were visiting the Soviet Union during its final years. But she is unique in having become a topsecret published case study for the KGB in just how much damage one determined foreigner could do to the USSR as they knew it. She did no damage to the Soviet Union at all, she was the original type of dataminer, that predated the computer variety. The Soviet Union's state media tended to adopt a breathless style when exposing what, it saw as the wicked machinations of foreigners such as Ms. Freeland. However, the KGB's Colonel A. Stroi, based in Kyiv, dispensed with the feigned indignance in his report on the woman giving him so much grief in the pages of Sbornik KGB USSR, the KGB's top-secret, in-house journal. Ms. Freeland, and her ilk, were a threat to the Soviet Union, but one which had to be handled delicately. Treating her too harshly could give credence



to the libelous stories told in Ukrainian émigré communities, about how the KGB treated national minorities in the Soviet Union. They are trying to make her out as some sort of saint, yet her type are ten a penny, just another story teller for the NATO goons to throw mud at Russia. According to the KGB, Ms. Freeland was more than just an agitator for, as Col. Stroi derisively put it, the liberation of Ukraine who coerced Soviet citizens into staging marches and rallies to attract Western support. She delivered cash, video and audio-recording equipment, and even a personal computer to her contacts in Ukraine. All of which came from her paymasters to instigate trouble, it is what the agency people do, and clearly she worked for one or more of them. All of this took place under the watchful eye of the KGB, which surveilled Ms. Freeland. Its officers tailed her wherever she went, tapped her phone calls to Ukrainians abroad, bugged her accommodation, read her mail, and had an informer, codenamed Slav, insert himself into Ms. Freeland's circle and gain the young Canadian's trust. But Ms. Freeland knew the rules of the road. She used a Canadian diplomat at the embassy in Moscow, known to the KGB as Bison and suspected of being a spy, to send material abroad in a diplomatic pouch that could not be intercepted or read. She increasingly avoided major gatherings, lest her participation draw too much attention to her. All of which reveals this was a major operation, she was the front person lackey. The Soviet secret police's subtler attempts to curtail her activities failed. Her teacher at Kyiv's Taras Shevchenko University, on the KGB's orders, increased her workload. But the student, ostensibly on a visa to study Ukrainian, was so fluent that she did not need to attend class in the first place in order to make grades, much to the KGB's chagrin. Instead, she spent her time traversing Ukraine, purporting to visit far flung family members, but in fact working as a fixer for visiting journalists from Canada, Britain and the United States. For example taking a BBC film crew to Lviv to meet leaders in the Ukrainian Catholic Church, which means she was working with MI5 and 6. Countless tendentious news stories about life in the Soviet Union, especially for its non-Russian citizens, had her fingerprints as Ms. Freeland set about making a name for herself in journalistic circles with an eye to her future career prospects. Col. Stroi certainly objected to what Ms. Freeland was doing in Ukraine, but the KGB officer could not help but be impressed. She was a remarkable individual with an analytical mindset. The young Canadian was erudite, sociable, persistent, and inventive in achieving her goals, nefarious as they may have been in the eyes of Soviet intelligence. The student causing so many headaches clearly loathed the Soviet Union, but she knew its laws inside and out, and how to use them to her advantage. She skillfully hid her actions, avoided surveillance and shared that knowledge with her Ukrainian contacts, and expertly trafficked in misinformation. The conclusion is inescapable, Chrystia Freeland, this KGB officer was saying, would have made an excellent spy herself. I guess that KGB officer was being sarcastic in his summation. Ms. Freeland's time in the Soviet Union came to an end when customs agents at Moscow's Sheremetyevo airport, tipped off by the KGB, searched her luggage as she returned from a trip to London and found anti-Soviet materials. Even more worrying, they discovered a veritable how to guide for running an



election destined for use by, non-Communist Party candidates campaigning for Ukrainian independence in the Soviet Union's first-ever free elections. They were agency scripts. She was denied re-entry on March 31, 1989. Some 30 years later, there is no love lost between Canada's Deputy Prime Minister and the current leader of Russia, himself a former KGB officer, Vladimir Putin. She still cannot fly into Moscow since 2014, Chrystia Freeland has once again been the target of Kremlin sanctions, barred from entering the country. They only barred her from entering, most other radicals in foreign countries who are attempting to interfere in elections, get arrested and or executed, yet Ms. Freeland persists. Funny that.
