NEWS: The latest fear and Stazi tactics being unveiled by the increasingly desperate old world control structure. Furniture giant Ikea has slashed sick pay entitlement for some unvaccinated staff forced to self-isolate after close contact with someone infected with Covid. The move means unvaccinated workers, who are required by the Government to isolate for 10 days after close contact, could receive as little as £96.35 a week under Statutory Sick Pay (SSP) obligations, a legal minimum. Perhaps something the Positive Action group can take up, other alternative it is call for a boycott of Ikea on social media until they back down.

Retail liquor and cannabis shops in Canada's Quebec province will require shoppers to show proof of vaccination amid a rising surge of new Covid cases. The new measure goes into effect on Tuesday, 18 January. Health officials say they hope the order will encourage more people to get vaccinated. That is sly and underhanded tactics of seducement to get people to take their poisons. The benefit that could come out of this is, less people buy alcohol and drugs, both of which do more damage than vaccines, I might add. Quebec people should boycott the companies enforcing this tactic.

Here is a letter to California Governor and corrupt psycho Gavin Newsome from the Californian school board. As a result, school board members are accustomed to dealing with sensitive issues and are no strangers to criticism or controversy. Yet, nothing in recent memory could have prepared

trustees for the onslaught they face today as citizens lash out on a variety of topics, most notably opposition to state mandates and local COVID-19 mitigation measures. I've watched in horror as school board members have been accosted, verbally abused, physically assaulted, and subjected to death threats against themselves and their family members. The list of dangerous and outrageous conduct committed against school trustees during their board meetings is far too long to list here. I guess the public have had enough, whilst I will never condone violence or threats, one can understand the frustration of the peoples dealing with such extreme and Fascist measures. These events will escalate this year, and it is costing them a fortune now to keep less than half of the population in line, in most cases. tick tock. The point is to the school boards, if you don't like what is unfolding, stop following banal rules and laws being imposed against the people. Finally the people are now holding these public officials accountable, they clearly don't like it as evidenced by this letter. That tells you it works.

Here comes more land grab under the pretences of conservation and saving the planet. Farmers in England will be given taxpayers' cash to rewild their land, under plans for large-scale nature recovery projects announced by the government. These will lead to vast tracts of land being newly managed to conserve species, provide habitats for wildlife and restore health to rivers and streams. Bids are being invited for 10-15 pilot projects, each covering at least 500 hectares and up to 5,000 hectares, to a total of approximately 10,000 hectares in the first two-year phase, about 10 times the size of Richmond Park in London. These pilots could involve full rewilding or other forms of management that focus on species recovery and wildlife habitats. Did you know that 45-50% of the UK currently before this scheme, is already under protected status? Could it be further evidence of creating food shortages? Solution? lets formulate or kick on our plan to grow our own, and in doing so become self sufficient. Campaign to add it to the school curriculum, via the TPC Communal Gathering.

The issue of farming is echoed within America as well, and has been since WW1 when clowns looted Russia of grain and put many American farmers out of business. Like other ranchers across the country, Rusty Kemp for years grumbled about rock-bottom prices paid for the cattle he raised in central Nebraska, even as the cost of beef at grocery stores kept climbing. They are confronting the 4 powerful corporations who control US beef. He and his neighbors blamed it on consolidation in the beef industry stretching back to the 1970s, that resulted in four companies slaughtering over 80% of the nation's cattle, giving the processors more power to set prices while ranchers struggled to make a living. Federal data show that for every dollar spent on food, the share that went to ranchers and farmers dropped from 35 cents in the 1970s to 14 cents recently. It led Kemp to launch an audacious plan: Raise more than \$300 million from ranchers to build a plant themselves, putting their future in their own hands. We've been complaining about it for 30 years, It's probably time somebody does something about it Kemp said. Echoing the TPC compared to the alt media, it is way past time we did things for ourselves, so kudos to the ranchers. Maybe we can hook up with them for sales at a later date.

Here is something to ponder on. There is never enough money or resources for the police to investigate crimes, yet whenever a protest takes place an unlimited amount of resources, man power and equipment are used, funny that.

The Toronto Star under fire late last year for calling unvaxxed selfish and stating we should not treat unvaxxed patients and should let them die, has done another piece. Despite the board's vote, the final decision would ultimately rest with the chief medical officers of health for Ontario and Toronto Keiran Moore and Eileen DeVilla, respectively and from there require government approval. But many people now have had enough of engineered distraction news, the lies, the bias and a complete lack of anything resembling journalism, as this report shows. Percentage change in news consumption habits, 2020 to 2021. Social media interactions with news articles -65%, Cable news primetime viewers -36% News media app downloads -33%, Unique visits to top 5 news sites -8% Engagement with news content plummeted last year compared to 2020, and given the ongoing decline in interest in news about COVID-19 and politics, it doesn't look like 2022 will be much better. Data shows that the Omicron variant is not jumpstarting Americans' engagement in Covid news like it did at the onset of the pandemic. Primetime news viewership was down 36% across the three major cable networks, Fox News, CNN and MSNBC, with the steepest decline during that time frame happening at CNN. Some parts of CNN is down 73% oops. App downloads for the top 12 mainstream publishers dropped 33%. The full-year drop in news engagement would have been even more dramatic, were it not for the enormous amount of news traffic driven by the Capitol siege in January, which was another engineered distraction piece, or to put it bluntly, more theater. Can you hear the sound of tick tock? the death knell of the conspired, deceitful, corrupt and treasonous media has long past began it's death rattle.

Here is another death rattle as more people are seeing through the illusion game. In the stunning poll, just forty-six percent of likely U.S. voters said they have a favorable impression of the FBI, with just 15 percent claiming to have a very favorable view of the agency. That's down from May 2020, when 60 percent had a favorable impression of the FBI. Forty-seven percent now view the FBI unfavorably, with 26 percent admitting to a very unfavorable impression. In recent months, FBI leadership has even

been called a group of politicized thugs at the top of the FBI who are using the FBI, as Joe Biden's personal Gestapo. Forty-six percent of voters agree with this assessment, including 29 percent who strongly agree. Will the FBI address the concerns of the public? be nice to think so, but I won't be holding my breathe.

NATO Secretary General Jens Stoltenberg on Friday ruled out any halt to the continued expansion of the military organization to address Russian security concerns, rejecting a key part of President Vladimir Putin's demands for easing tensions with Ukraine. We will not compromise on core principles, including the right for every nation to decide its own path, including what kind of security arrangements it wants to be a part of, Stoltenberg told reporters in Brussels after an extraordinary meeting of NATO foreign ministers. Except they are not deciding their own path Mr. Stoltenberg, you are rail roading a swathe of European countries under the delusion of security, whilst creating shekels for a private army with no oversight. That is solely intent of engineering disturbances in Europe, to create boogeymen to fight, take over land, create fear for the people, and loot Governments and Countries. NATO is the modern day version of the American fake Cold War, it is the same practice. Boogeyman Russia, EL-ite Jews involved and generate fear the world is at the point of war. U.S. Secretary of State Antony Blinken and his counterparts held online talks to prepare for the first meeting of the NATO-Russia Council in more than two years. The meeting, set for Wednesday in Brussels, will give NATO ambassadors the chance to discuss Putin's security proposals with Russia's envoy face to face. The documents that Moscow has made public, a draft agreement with NATO countries and the offer of a treaty between Russia and the United States, appears to be a non-starter at the 30-country military organization, despite fears that Putin might order an invasion of Ukraine. So, NATO will block a treaty of peace, just like the Palestine and Israel issue then. NATO would have to agree to halt all membership plans, not just with Ukraine, and to end military exercises close to Russia's borders. In exchange, Russia would respect the international commitments it's signed up to on limiting war games, as well as end aircraft buzzing incidents and other low-level hostilities. Stoltenberg may well be another with Jewish connections, but appears concealed during a research on him. MI5 has issued a rare warning that an alleged Chinese agent has infiltrated Parliament to interfere in UK politics. Gov. Kathy Hochul is considering letting a pandemic-spurred hold on evictions lapse after it expires on Jan. 15, sources in the state legislature told The City. A pause on evictions has been in place by executive order since the early days of the COVID-19 outbreak, then becoming law in June 2020. Hochul extended the stay on evictions during her first days as governor in early September. In recent weeks, she and her advisors have been pushing state lawmakers to let the law lapse next week, making the argument that businesses and schools have reopened and people are returning to work. The evolution among white Christian evangelicals to Trumpism is part of another trend showing a growing racism index among this religious group. Asked whether God intended America to be a new promised land where European Christians could create a society that could be an example to the rest of the world, white evangelical Protestants were the only religious group with a majority (52%) who said they completely or mostly agree. Hispanic Protestants were second (46%), followed by other nonwhite Protestants (38%), white Catholics (37%), Hispanic Catholics (35%) and white mainliners (34%). They trying to make out the white people are all conspiracy theorists, and the problem. The reality is the white people are more aware than other colors, more rebellious and backed by scientific study, more intelligent by and large. Which makes the race a greater threat to the old loop based system.

A former Utah tech executive and prominent GOP donor said Tuesday, that he believed Pope Francis was secretly a Jewish agent, installed to help distribute the COVID-19 vaccine around the world in an effort to create totalitarian rule. The CIA has 89 variants, the US Army is creating vaccines, The Pentagon had a motherload of personal protection kits in December 2019, before the fake epidemic started, the DOD signed off last week on a \$137M deal to build a plant for test kits. In Anniston Regional Medical Center's most recent COVID-19 update, there are now more patients who are vaccinated than patients unvaccinated, leaving some to ask, do the vaccines still work? This method of looking at U.S. federal law changes leading up to COVID-19 to determine whether COVID-19 is some sort of a hoax is, based on a 2004 U.S. federal law governing false information and hoaxes. The federal law is partially provided as follows: § 1038. False information and hoaxes (a) CRIMINAL VIOLATION.— (1) IN GENERAL.—Whoever engages in any conduct with intent to convey false or misleading information under circumstances where, such information may reasonably be believed and where such information indicates that an activity has taken, is taking, or will take place that would constitute a violation of chapter 2, 10, 11B, 39, 40, 44, 111, or 113B of this title, section 236 of the Atomic Energy Act of 1954 (42 U.S.C. 2284), or section 46502, the second sentence of section 46504, section 46505(b)(3) or (c), section 46506 if homicide or attempted homicide is involved, or section 60123(b) of title 49, shall— [be punished, etc.; punishments are omitted for ease of reading] ... (d) ACTIVITIES OF LAW ENFORCEMENT.—This section does not prohibit any lawfully authorized investigative, protective, or intelligence activity of a law enforcement agency of the United States, a State, or political subdivision of a State, or of an intelligence agency of the United States.”. (118 STAT. 3765, 3766; 18 U.S. Code § 1038) The law permits “any lawfully authorized investigative, protective, or intelligence activity of a law enforcement agency of the United States,” which, the law apparently implies, may include law enforcement agencies in the U.S. engaging in “conduct with intent to convey false or misleading information under circumstances where, such information may reasonably be believed and where such information indicates that an activity has taken, is taking, or will take place.” “Investigative, protective, or intelligence activity of a law enforcement agency” is broad language. Although most law enforcement entities attempt to keep their methods and advanced technologies secret, some types of hoaxes which might be used might be predictable based off of previous methods used by entities like the FBI, which were at one time reportedly used against America's enemies but could conceivably be used again. One of the most significant was the U.S. government legalizing national security “exercises” for “emerging” threats in October of 2019. (133 STAT. 1123) The National Exercise Program (NEP) is in part intended to “protect against, mitigate the effects of, respond to, and recover from threats and hazards that pose the greatest risk to the security of the Nation.” (Page 1, emphasis added) It is also used in part to “test and evaluate” U.S. government “plans and strategies.” (Page 2) The NEP includes some exercises which may be classified (page 11), suggesting that there may be occurrences throughout the U.S. which may appear to be real but are actually covert or secret national security “exercises.” The NEP may be conducted by the Department of Homeland Security and other “appropriate Federal agencies” (page 2) which may be law enforcement agencies of the United States. But the above-mentioned U.S. federal

law on “false information and hoaxes” apparently implies lawfully authorized use of false or misleading information by law enforcement agencies. Where any federal laws changed before COVID-19 which appear to attempt to “lawfully authorize” such false representations of information, data, or statistics for “law enforcement” purposes? The answer may be found in a federal law on statistics, data, and information that was enacted on January 14, 2019, entitled the “Foundations for Evidence-Based Policymaking Act of 2018.” The new law made sure it was stated in federal law that U.S. government statistical agencies and other government data and information entities and their strategic plans are required to be “evaluated” by specifically federal activities. (132 STAT. 5530) Prior to the reported outbreak of COVID-19, the most recent National Committee on Vital and Health Statistics Strategic Plan was published in September of 2017. One of the objectives of the Strategic Plan is the following: Identify and define opportunities and threats from emerging trends that will enable or require change to health information and data policies, standards, or regulatory frameworks. The same January 14, 2019 U.S. federal law on statistics, data, and information made a significant legal distinction in terminology. The law distinguishes between data and information that the federal government uses for “statistical purposes” and for “nonstatistical purposes.” Simply look at the way the government defines “nonstatistical purpose” in the 2019 law: NONSTATISTICAL PURPOSE.— The term ‘nonstatistical purpose’— (A) means the use of data in identifiable form for any purpose that is not a statistical purpose, including any administrative, regulatory, law enforcement, adjudicatory, or other purpose that affects the rights, privileges, or benefits of a particular identifiable respondent; and (B) includes the disclosure under section 552 of title 5 of data that are acquired for exclusively statistical purposes under a pledge of confidentiality (132 STAT. 5545, emphasis added) It is important to note that the law does not say “any true representation of information” or any “non-falsified representation” or something similar. Thus, when combined, the definition of “nonstatistical purpose” would apparently include “the use of data” and “any representation of information” “for any purpose” including “any...law enforcement...purpose.” So, there you have it again, they changed the law before the event, which the event was preplanned and premeditated. This is also an example of why it is pointless playing their law game, a plethora of deliberately used broad language, that allows for technicalities and distortion should it ever be challenged, all designed to suit the criminal, not the law itself. But these captures, this endless stream of vignettes, are not real life. Instead, they are the vain mirror of the wished life, the showy artifacts of those endlessly seeking to impress, whether they are actually doing anything eventful or not. And yet I wonder whether if some of them use a mirror for critical analysis? Given the dress code, inappropriate clothes for the size of the body, and the classic trout pout due to botox, who said that looks appealing? frankly it looks ugly and the equivalent of kissing a snakehead fish. Quite what females see in that is beyond me, it completely distorts their face. But this is the world of banal fashion designers, who dictate what is fashion and what is not, all appealing to the I must fit elements of society, or worse, I want to look like a celebrity. Quite frankly, they are the worse role models ever to follow, sold out vacuous cretins, riddled with fake everything. Social media particularly Instagram seems to have been performing an enormously influential social experiment, affecting fashion, personal relations, dating, employment, politics, and how we think of ourselves. The way we view and live life is altered by the prism of reflection: everyone is watching everyone else. However, despite the rise of this publicly sanctioned narcissism, in reality vanity remains a vice, a negative, even dangerous indulgence, both socially and individually. There is no world, online or otherwise, where vanity is not sensibly considered a destructive trait, for it engenders inflated opinion, bragging, jealousy, dishonesty, false representation, and ultimately the unthinking egomania of the tyrannical. While we are all vain to a certain degree, restraint or balance is required in all things, for prosperity, health, and the good life. But today every banal facet of a personal life must now be captured, categorized and glamorized. The obsession leads to fantastic feats of modification, such as the trend in getting veneers, where your real teeth are filed down to weird jagged tombstones so you can have that Hollywood smile. This is often performed by a man in Turkey at an irresistible price, and why not get gastric-sleeve surgery to boot, since you are going abroad? This vanity feeds into the phenomenon of Instagram fashion, based on the premise that every single person is potentially a celebrity, an influencer, therefore every single person must also have designer brands. Where previously designer brands were art houses or fashion think-tanks providing haute couture, now the influencer with the most followers controls what becomes fashionable. The discriminatory standards of cutting-edge aesthetics are traded for a mass-consumerism of real and knock-off labels. Thereby the fashions themselves are largely crass, bawdy, and mostly vehicles to display ever-larger

brand logos as wealth symbols, as with all things related to vanity, superficiality rules. Life is no longer so much lived as recorded, it is not even recorded in its warts-and-all honesty, like a document for posterity, but in social simulation of itself. The individual is a hero playing a part in their own life movie. But even this is not strictly true, as we live in a post-reality-TV world, where we seldom think in a framework of storytelling, or view our lives related to classic narrative, so much as an impression or vignette of everyone's personal life and its social relations. This strange alteration in world view is only increasing in scope with the younger generations. With the apparent loss of parents' ability to allow kids to be bored, many children are no longer growing up with a storytelling or narrative framework. Instead of watching films, they are entertained with tablets providing a limitless supply of YouTube package-opening videos in a kind of monotone brainwash of meaningless sensation. There are kids as young as 10 going into school with fake eyelashes, fake tan, false nails, who can't pose for a photo without doing duck lips. It is so endemic that some schools need to adopt policies in direct prevention. For young adults, there seems to be a mania of make-up tutorial videos, make-up itself having become a science requiring an intense variety of paraphernalia: highlighter, primer, contour sticks, and all manner of related items. Also, it's no longer just for women, the feminization of the Western male is no secret, it is openly lauded as a triumph. The reasons for its victory over many thousands of years of guiding patriarchy have many possible sources, feminist policies, lack of male role models, overuse of plastics, and the lowering of testosterone from overuse of soy in commercial food. But what is perhaps most disturbing about the narcissism trend is just how much these influencers, and worse, the hordes of influencer-wannabes, begin to resemble the sterile beautiful ones from John B. Calhoun's mouse utopia experiment. Calhoun enclosed four pairs of mice in a large pen complete with all imaginable mouse amenities: water dispensers, limitless food bins, nesting boxes, and a total absence of predators. He was quoted as saying of this utopia: "I shall largely speak of mice, but my thoughts are on man." While the mice initially prospered and were fertile, after 600 days, with still enough space to double their numbers, they began to decline, until the entire colony went extinct. It appeared that without predators, or want, or even the need to acquire their own resources, they simply lost the will to carry on. The young mice that were born never learned the skills for survival, and along with that, seemingly forgot how to live. Among the aberrations and breakdowns in social norms that occurred in that process was the phenomenon of "the beautiful ones" who spent all their time grooming and sleeping. They were the ultimate personification of life without hardship or struggle. While being more beautiful than ever, they lost all interest in reproductive sex and died out, not so utopian after all. What is the lesson for us, in this grim and familiar analogy? It is this: when abundant luxury removes challenge and responsibility, self-extinction is not far away. So purse those lips, and get your phone out people are watching. This is what we are reversing with the TPC, no longer should you be a passive observer admiring others who do the work, or in many cases critiquing the few who do the work, we have to all play a role and avoid becoming the mouse utopia. Vanity, narcissism, comparative and competitive over the wrong things in life, must give way to personal improvement on the inside not the external. A desire to then help others without attaching it to your self for external gratification, the desire to be a part of the change by doing, not observing others doing.

The Chinese Communist Party has developed an artificial intelligence prosecutor, that can identify and suggest charges for alleged crimes including dissent and provoking trouble. Built by the Shanghai Pudong People's Procuratorate, the tool can file charges after hearing a verbal description of the case. It runs on a standard desktop computer and presses charges based on 1,000 traits from the human-generated case description text. The prosecutor was programmed with information from 17,000 real-life cases ranging from 2015 to 2020 and can identify and, as a result, can press charges for the eight most common crimes in Shanghai. Among the charges is provoking trouble, a term often weaponised by Beijing to stifle political and social dissent and criticism. Other crimes reportedly recognized by the machine are obstructing official duties, credit card fraud, gambling crimes, dangerous driving, theft, fraud, and intentional injury. Chinese prosecutors, however, have concerns over the machine's purported accuracy. The accuracy of 97% may be high from a technological point of view, but there will always be a chance of a mistake, cautioned a prosecutor from Guangdong Province. Who will take responsibility when it happens? The prosecutor, the machine or the designer of the algorithm, they added. A more advanced version of the prosecutor will eventually be able to eliminate data irrelevant to a case, and will be capable of converting spoken words into a standard format computers can understand and act upon. The Chinese Communist Party has increasingly relied on artificial intelligence to implement its social credit score system, using the COVID-19 pandemic as a pretext to implement vaccine passports. The National Pulse revealed that pharmaceutical giant Pfizer Inc. partnered with AliPay, the regime's premier platform for its social credit scoring system one year ahead of the onset of the pandemic. Proving Covid was the driver of a pre-planned database system, I warned in Clowns in Panic show, perhaps Covid means cover for ID. He was also highly critical of US foreign policy, speaking before the United Nations of the US involvement in the coup d'état in Chile in 1973. Kirk had a reputation as the most formidable debater of his time and once famously said that "there are four things that matter to people: they have to have somewhere to live, they have to have food to eat, they have to have clothing to wear, and they have to have something to hope for. Not the type of leader the control system wanted it seems, a year later he was dead. It was proposed that a Royal Commission should be set up to investigate rumors that he had been killed, perhaps with contact poison, by the CIA, well I never.

Policies: Lying about Mass Surveillance. The 2019 Terrorism Suppression (Control Orders) Bill allowed the NZ government to decide on the balance of probabilities, that someone is a terrorist, without a need to show any evidence. As Suzie Dawson summarised it allows them then to control your work/finances/movements/net access and prevent you telling people its happening.

Water Fluoridation: In 2017 the New Zealand government was aiming to introduce laws to expand Water Fluoridation.

Citizenship: Peter Thiel, the Paypal billionaire, was granted NZ citizenship after making a donation to the Christchurch earthquake appeal, sparking a passport-for-sale row.

Drug adverts: As of December 2017, New Zealand was the only country apart from the United States that allowed prescription drug companies to advertise on television.

Internet Censorship: NZ ramped up Internet Censorship greatly in 2019, and again in 2020, claiming that state agencies had the right to censor or remove any online content that, they deemed extremist, terrorist or otherwise objectionable. Which is what the Terrorism Suppression Act was enacted for.

COVID-19 Public Health Response (Vaccinations) Order 2021: In November 2021, New Zealand passed the COVID-19 Public Health Response (Vaccinations) Order 2021. The legislation takes away all legal rights for an unvaccinated or insufficiently vaccinated persons, allowing for:

1. The lockdown of unvaccinated or insufficiently vaccinated individuals.
2. The ability to restrict travel within the country to unvaccinated or insufficiently vaccinated (e.g. a person who does not want to get a booster shot).
3. Withhold certification from those who do not get required boosters, or subsequent combinations of vaccines as may be ordered at any time.
4. The ability to dictate the type and form of certification required for proof of vaccination status — digital or otherwise.
5. The ability to dictate what other information may be required for the renewal of vaccine certificates, and which information may be contained on such a certificate.
6. The period for which a vaccine certificate is valid can be changed at any time, and who it is that may be entitled or eligible to have these certificates.
7. The specification of mandates for entire job sectors.
8. The ordering of certain jobs to require regular mandatory testing and

medical examination. 9. Enforcement officers to be able to demand certification, pretty much at any time. 10. The appointment of enforcement officers that can be anybody they wish to appoint, and not necessarily police. 11. Enforcement officers to inspect and take copies of certification to be verified at a later date, before immediately returning such documentation. 12. The provision of an assessment tool for employers to use to determine who should be vaccine mandated, however employers can totally disregard the assessment tool and mandate at whim. 13. Legal or other representatives of employees may be refused entry to workplaces. 14. Contact tracing information may be used against a person in order to enforce the Act. 15. Employees who have been dismissed for non-compliance of testing or vaccination, but comply at the last minute, may still be dismissed if the employer deems revoking the dismissal to be disruptive of their business. Amendments to the 1956 Health Act: 2021 amendments to the 1956 Health Act will allow punitive measures under the guise of health directives: 1. Hold unvaccinated in quarantine until such time as they have tested negative to infectious disease, and have undergone preventive treatment (i.e. mandatory inoculation). 2. Declare (without proof or evidence) a dwelling to be unsanitary, and in turn order the destruction of the property and the burning of associated materials 3. Prohibit the keeping of animals and order the killing of animals (i.e. punitive killing of pets and eliminate food sources) 4. Close any business not complying with prescribed infection control measures. 5. Forbid congregation (public or private) Events: Trans-Pacific Strategic Economic Partnership Agreement: New Zealand was a signatory to the Trans-Pacific Strategic Economic Partnership Agreement, a treaty to abrogate state power by elevating the rights of corporations. A poll conducted in December 2012 showed that 64% of New Zealanders thought trade agreements, such as the TPP, which allow corporations to sue governments, should be rejected. Christchurch Mass Shooting: In March 2019, a mass shooting happened in Christchurch which was livestreamed onto the internet. Four people were arrested. The New Zealand establishment deemed that video of the attack was objectionable, and so the New Zealand police warned that anyone sharing it could be liable for up to 10 years in jail. The classic Orwellian, Stazi and National Zionist tactics of shameful control of the people, under the frankly ridiculous guise of, they are improving your health and safety. The whole of New Zealand should have risen up against these complete psychopaths, as only psychopaths and weak, fear laden peoples would come up with these plans. Whilst people are distracted by divide and conquer, vaxxed and unvaxxed, your whole way of living and life is being stripped away from you. This was never about being vaxxed, wearing masks and social distancing for your health, it is all about them a creating a dystopian world for those who are left, all under their control. We the people have an obligation to stop that, and create a better world for us all.

It is life, social, political, economic and psychological changes of the most profound nature witnessed here for a very long time. Put your external egos aside, put what you think you know about life and all it's fake machinations, and relearn the truth and then go onto developing solutions that fixes this planet once and for all. The salvation of this human world lies nowhere else

than in the human heart, in the human power to reflect, in human meekness and human responsibility. Keep the company of those who seek the truth, run from those who haven't found it. I feel that the dormant goodwill in people needs to be stirred. People need to hear that it makes sense to behave decently or to help others, to place common interests above their own, to respect the elementary rules of human coexistence. You do not become a "dissident" just because you decide one day to take up this most unusual career. Isn't it the moment of most profound doubt that gives birth to new certainties?
