

THI-SHOW TRANSCRIPT 2022-02-17

I attended further calls this week on the FRWL book, the website upgrades, the PA action group and some other projects this week. Of course we had another extra show on Tuesday, that connected much more in the way of dots, more will come from that show at a later date. Lots of good suggestions being made and promoted of how we expand this coming year. We will be expanding and we want more to come in and help your own people, to get this running more and take the strain away from the few who are doing. Here is a suggestion that all members can do. Lots of people do posts on mewe or FB pages, and at some point it was a valid exercise and still is to a minor point today of highlighting certain issues. But, what if your posts were tailored to be of assistance to the Positive Action group? Instead of just posting, think of ways the posts can be of benefit for the Positive Actions group in terms of using the material to formulate letters of response, and or potential groups for our attention. And no, lets not go after Biden or some other supposed figure of importance, A: they are not important and B: we have no Government and C: it is clickbait and a waste of energy. It is a better use of your energy than just posting and waiting for people to make sarcastic, witty or abusive comments, plus a stream of emojis. The BBC went on to listing 5 ways of preventing war. I have one more simple solution that includes another 5, stop reading and writing scripts prepared by the 5 Eyes groups. War talk is over then.

Washington is bracing itself for an exodus of refugees fleeing Ukraine in the event of a Russian incursion, the White House has announced. Why are they concerned? how about focusing on the influx of refugees on our own borders? Many of said refugees are bringing violence, gangland antics, death and involved in heinous programs. Why not focus on that?

More alarming fear based headlines to deflect from the failing Covid narrative. More than a dozen countries have urged their citizens to leave Ukraine amid warnings from Western powers that an invasion by Russia could be imminent. The US, UK and Germany are among those who told their nationals to leave. In a phone call, US President Joe Biden again warned Russian leader Vladimir Putin of the costs of any invasion. For his part, Ukrainian President Volodymyr Zelensky said invasion warnings could stoke panic, which he called the best friend of our enemies. The White House has warned that an invasion could happen at any time, and could begin with bombing from the air. Russia characterized such allegations as provocative speculation. Here is a great question that should be answered, will all the Governments, Media and Agency clowns apologize for their faulty narrative, should the Russians not invade by the end of the year? Remember the stupid Americans have been saying the Russian's are coming for the past 65 years, they didn't.

Here is another example of interfering where they don't belong. Joe Biden signed an executive order releasing \$7bn in frozen Afghan reserves, to be split between humanitarian efforts for the Afghan people and American victims of terrorism, including relatives of 9/11. But Afghanistan had nothing to do with 9/11, so why are they being made to pay? That is sickly sugar coated politics of the worst order. In a highly unusual



move, the convoluted plan is designed to tackle a myriad of legal bottlenecks, stemming from the 2001 terrorist attacks and the chaotic end of the 20-year war in Afghanistan, which ignited a humanitarian and political crisis. But critics warned that it could tip Afghanistan's already-strained banking system over the edge into systemic failure, and deepen a humanitarian crisis that has left millions facing starvation, and almost the entire country 98% are short of food. You're talking about moving toward a total collapse of the banking system, I think it's a shortsighted view, Dr Shah Mohammad Mehrabi, a longtime member of the bank's board and economics professor at Montgomery College in Maryland. Cash shortages have already led to strict weekly limits on how much of their savings people can withdraw, deepening the economic crisis as inflation soars. In August the Taliban seized control and the former government collapsed, leaving behind just over \$7bn in central bank assets deposited in the US Federal Reserve bank in New York. Why is every countries funds deposited in a New York bank, or the Bank of England? As Afghanistan's top officials, including the president and central bank governor, fled the country, the Fed froze the account as, it was unclear who was legally authorized to access the funds. The Taliban took over the central bank the Da Afghanistan Bank and immediately claimed a right to the money, but under longstanding counter-terrorism sanctions it is illegal to engage in financial transactions with the organization. But, whether we like it or not, they are the recognized Government, even if they are the CIA. Furthermore, the US does not recognize the Taliban as the legitimate government of Afghanistan. But China does, Russia does, most importantly the people of Afghanistan do, and so it is really no one else's business.

US President Joe Biden has mixed up the countries of Afghanistan and Ukraine, despite them being more than 3,000km apart, in what was the second major geography gaffe by a senior American official in just one day. There is no way we were ever going to unite Ukraine, I mean, Iraq. Afghanistan! Biden said in an interview. This is not the first gaffe and won't be the last either, he was not the first either as Bush Jr. couldn't pinpoint on a map a country his Military where attacking. The mental competency levels are beyond low it seems, and is a national disgrace and why we are ridiculed around the world. But, there is another side to this as well, it is beyond disgraceful for people to put in place a male or female in charge of a super charged job, aged 78. The man should be retired, like everyone else and it to me is shameful he is even put in this position on a humanitarian level.

The Biden Department of Justice was recently caught opening Rep. Louie Gohmert's House mail before it reached his office. One letter was from a Christian missionary, one letter was from a constituent in Texas. No doubt will go unpunished, but for anyone else interfering with other peoples mail is a felony. 18 U.S. Code § 1701 - Obstruction of mails generally. Whoever knowingly and willfully obstructs or retards the passage of the



mail, or any carrier or conveyance carrying the mail, shall be fined under this title or imprisoned not more than six months, or both.

Black voters are fleeing President Biden in droves, and it's hard to see a scenario under which they come back anytime soon. President Biden's poll numbers have been stunningly bad lately, the most recent CNN poll has him at 58 percent disapproval, 41 percent approval. In December, Biden was at 49 percent approval in the same poll. Among those who disapprove of his performance, 56 percent say the president didn't accomplish anything in his first year of which they approve. Meanwhile, a majority of Democrats don't even want Joe Biden to run again in 2024, with just 48 percent supporting the idea, this is unheard of after just one year. Two more big numbers to consider: only 69% of Black voters support the 46th president, this is significant, because it was 92% who voted for him in 2020. That's what happens when you vote for the opposition leader after the treasonous media promoted the opposition as a white supremacy candidate. And so the stupid sheep voted against that, all thinking the new leader will be different, they never are and never will. The key is, just when will the people work that out?

Remember in early December when Biden was pressed on fuel prices? He said they would go down below \$3 a gallon, and in some cases have. Well 2 months on, they are now higher again and at which point will people call him out? Fuel prices is another tax on the people, that impacts more business, creates food poverty, damage the economy, the transportation costs and the vacation industry. And yet what are the Government doing to stop these oil barons charging whatever they like? What is the Trustee doing to lower gas prices as she promised? Oil is now heading towards or over \$100 a barrel, that is pure theft as it costs around \$5-7 a barrel to produce. It is another of their fake values again, another of their milking the people again, as if the stealth tax called inflation wasn't enough. How and why could Venezuela charged their people 10c a gallon, until the Bush and CIA junta interfered, when ours is \$3.60 a gallon plus?

The Fed is about to conduct its annual stress test on the largest US banks, measuring their ability to manage events like a drop in real estate, and other asset prices coupled with a surge in unemployment, while still paying their shareholders dividends for four successive quarters. This year's stress test will feature a six-point surge in unemployment to 10%, paired with a 40% collapse in commercial real-estate and other asset prices, along with growing corporate bond spreads. Banks will be graded based on their ability to weather the simulated recession, while still making four quarters of planned shareholder dividends. The last line says it all, whilst still paying the shekel based shareholders their dividends. All banks are bankrupt, so why even bother with these fake tests? It's all an illusion game at this point, is the 40% real estate drop a warning?



Two US senators have raised concerns that the CIA is again spying upon unwitting Americans. The agency has secretly conducted warrantless surveillance through a newly disclosed programme, Senators Ron Wyden and Martin Heinrich alleged. In a letter to intelligence officials, the two Democrats called for declassifying details of the programme. Government data collection has been the subject of much controversy in the US. Officially, the CIA and NSA have a foreign surveillance mission, and domestic spying is prohibited by the CIA's 1947 charter. The foreign surveillance is in relation to the 5 eyes group, they all spy for each other and share the data, which then gets around their countries laws. But in 2013, a programme of data collection using extensive internet and phone surveillance by American intelligence was disclosed to the public by Edward Snowden, a CIA contractor-turned whistle-blower. A Washington Post analysis of the Snowden leak found some 90% of those being monitored were ordinary Americans, caught in a net the NSA had cast for somebody else. Top officials had until then denied and even lied under oath to Congress, that they were knowingly collecting such data. The programme, known as Prism, was later ruled unlawful by a US court. The CIA released a declassified report on one of the programmes on Thursday, but declined to declassify the other, citing the need to protect sensitive tradecraft methods and operational sources. But Mr Wyden, of Oregon, and Mr Heinrich, of New Mexico, said by failing to do so the agency was undermining democratic oversight, and posing risks to the long-term credibility of the Intelligence Community. The usual bs from them, the National Security cover up Act rules again.

Bahrain confirmed on Saturday that an Israeli officer will be posted to the country in the coming weeks, the first time that an Israeli officer has ever been stationed in an Arab country with that country's support. The officer will reportedly serve as a liaison to the US Navy. The appointment of an Israeli officer comes within the framework of arrangements related to an international coalition, comprising more than thirty-four countries, Bahrain's Ministry of Foreign Affairs stated. The coalition secures freedom of navigation in the territorial waters of the region and protects International trade, while also confronting acts of piracy and terrorism in the region, he said. Utterly delusional, those 34 coalition countries, particularly including the US and Israel, are about as safe and secure as being with NATO. Hey, Bahrain, have you told your peoples you have sold your country out? because now there is one cockroach in your midst, others will certainly follow.

Finally some are cottoning onto the problem, maybe our FRWL Plus 3 show the Dutch Connection made some take notice? The administrations of about a dozen Dutch universities, have reportedly demanded their staff hand over information on their relationships over the past 10 years with a long list of Jewish and Israeli institutions, following a request by a Netherlands-based NGO, the Rights Forum. The news was reported by the Dutch-Jewish media outlet NIW on Thursday, I guess the Dutch like



every other nation is not allowed their own media. The request obtained and cited by the paper, asks the academic institutions whether they would share documents and information about their dealings with various Jewish entities, including Israeli universities, institutions, and companies, as well as contacts with organizations promoting support for the State of Israel, NIW reported. The Rights Forum appeared to be particularly interested in student exchanges the Dutch universities had with Israeli educational institutions, but the list of Jewish organizations of concern did not stop at that. It also included the US-based Anti-Defamation League, the International Holocaust Remembrance Alliance, the Simon Wiesenthal Center, and even the Dutch government's office of the National Coordinator for Fighting Anti-Semitism. The request sparked an uproar from various Jewish associations in the Netherlands and beyond. Dutch Chief Rabbi Binyomin Jacobs said, this reeks of anti-Semitism, but it comes as no surprise to me given this group's reputation. How is asking for data of links between several groups now deemed anti Semitic? another excuse to wheel out the guilt and shame program again it seems.

This story didn't get as much coverage as the Charleston event 2 years ago, I wonder why? The suspect arrested over the car-ramming attack against the Freedom Convoy protesters in Winnipeg, Canada is an Antifa member, with a long history of far-left militantism in Manitoba. David Alexander Zegarac, allegedly sped off to try and escape after the attack on Feb. 4, 2022, which injured four people. He ran multiple lights and resisted arrest when he was finally caught around 40 minutes later. Zegarac was the frontman of the antifa punk band Brat Attack until the record label dropped the group because of multiple accusations of sexual assault against Zegarac in 2015. One of the accusers said she was only 13 when he groomed her and raped her. Same story as Charleston but only one story brings mass publication and attention. The question is, who put this guy up to it? Was he another of the CIA payback for your crimes by doing acting work for us? an MK Ultra victim? A multitude of questions too few ask. It will be interesting if he is even jailed, because that was attempted murder.

Prime Minister Justin Trudeau has invoked the Emergencies Act for the very first time in Canadian history, citing the threat to the safety, order and the economy allegedly posed by Freedom Convoy truckers and their sympathizers, protesting his Covid-19 restrictions. What is the Emergencies Act? Adopted in 1988, the Emergencies Act authorizes the federal government in Ottawa to temporarily claim extraordinary powers in response to an emergency, that seriously endangers the lives, health or safety of Canadians and is of such proportions or nature as to exceed the capacity or authority of a province to deal with it. Has it been used before? The Emergencies Act had never been invoked before. The Canadian state broadcaster CBC called its invocation on Monday unprecedented. Its previous version, the War Measures Act of 1914, had been used three times previously, in response to the First World War, the Second World War, and the October Crisis of 1970, when French-speaking separatists in the province of Quebec abducted a member of parliament. The PM who invoked it at that point was Pierre Elliott Trudeau, the current PM's father. Like father like son then, and his story repeats itself again. Is this martial law? Technically no, Trudeau himself pointed out there will be no troops in the streets. However, the emergency powers vastly increase the power of the Royal Canadian Mounted Police (RCMP) to act against what the PM called, illegal blockades and occupations in specifically designated locations. I will tell you what is illegal Trudeau, costing people their businesses, livelihoods and homes. Jabbing people against their will and subjecting children to physical and mental abuse. It also grants the government's financial intelligence agency FinTrac additional authority over banking, online fundraising, and crypto-currency transactions. Which measures will be taken? According to Trudeau, local police will have more tools to restore order in places where public assemblies have been declared illegal and dangerous, such as outside the



parliament in Ottawa and at US-Canada border crossings. The RCMP will also be able to enforce provincial and municipal laws where required. Gestapo and Stazi tactics then, aligned with Fascist rhetoric of illegal and dangerous, no your policies are illegal and dangerous Mr. Trudeau. Denying the public the right to free speech, because your lot are too weak to listen to anything resembling the truth. Border crossings and airports have been designated critical areas and will be kept clear of demonstrators. That reveals the influence of the greed based money makers. The government is also empowered to commandeer the services of towing companies to remove the big rigs used by protesters. Commandeer? what if towing companies don't wish to do it? will you shut them down as well? The government has told banks to review their relationships with anyone involved with the protests and freeze their assets without a court order. Full on Fascist Zionism measure that, but perhaps will show the public of how they wish to act with their One World Government and digital only currency, agree with us or we suspend or delete your account. FinTrac's authority over crypto-currency translations, crowd funding platforms and payment service providers has been expanded under laws against money-laundering and terrorist financing. Oh good will they go after the Soros Foundation then? all major banks as all are money laundering? How long will it last? The emergency went into effect on Monday afternoon and is initially supposed to be in effect for 30 days, though it could be extended. Under the law, the parliament must approve the declaration of emergency within seven days, it would be revoked if either house votes against it. Just as I predicted.

MEDICAL RELATED NEWS: A mixture of good news and outright Zionism in today's reports. Good news on restrictions in other places now unfolding. Manitoba in Canada has announced they will end all restrictions, including Covid passports and face masks on the 15th of March.

German officials are set to end the majority of remaining government Covid restrictions in March, amid decreasing corona virus infections, according to a draft plan on Monday. Broad restrictions of social, cultural, and economic life should be gradually lifted by the start of spring on March 20, 2022, the draft document reportedly suggests. It is set to be formally approved by federal and state leaders on Wednesday. Austria as well added to the mix.

A massive chain of vehicles has jammed up traffic in Jerusalem as thousands of Israelis took to the streets to protest the country's corona virus restrictions, following the Freedom Convoy in Canada's capital over ongoing vaccine requirements there. Long lines of cars could be seen heading for Jerusalem on Monday, reportedly from cities across Israel, in footage circulating on social media. 30,000 vehicles and 40 convoys from 40 cities across Israel converge into one united Israeli Freedom Convoy in Jerusalem to protest the undemocratic Covid restrictions. No chance of the general media posting that, too many restrictions.



Authorities in New Zealand have been playing Barry Manilow's greatest hits in an attempt to dislodge protesters camped outside the parliament building. Songs by the US singer are being played on a 15-minute loop, along with the Spanish dance tune, Macarena. The demonstrators, who are angry at Covid-19 vaccine mandates, responded by playing songs such as Twisted Sister's We're Not Gonna Take It. MK Ultra tactics? is that what they are reduced to now?

Police have intercepted hundreds of vehicles trying to enter Paris as part of a protest against France's corona virus regulations. Tear gas was fired in the city as demonstrators defied an order banning the Freedom Convoy. Interior Minister Gérald Darmanin said more than 300 tickets had been handed out and 54 people arrested. Austria and Belgium have banned such convoys from entering their capitals, with similar demonstrations also emerging in Australia, New Zealand and the Netherlands. Banning free speech, oh my, the weak ones are struggling aren't they. It has been a long time coming, but we now have them where we want them. Exposing them into the light, and using vast resources and energy to keep hold of their failing lie.

China has a population of 1.45 billion people, and as of last August, China has administered 2 billion Covid vaccine shots in the country. But did you know not a single person in China was given a mRNA Covid vaccine. In July 2021 China announced it may be time to work on a mRNA vaccine. But as of December 2021 there was still no word on when China would start administering their own mRNA vaccines.

French President Emmanuel Macron refused a Russian Covid test ahead of his meeting with Russia's Vladimir Putin, the Kremlin has confirmed. The test required a health protocol that was unacceptable and did not fit with the French leader's schedule, a French source told the BBC. It follows reports that Mr Macron refused the PCR test over fears the Russians would get hold of his DNA. The leaders subsequently held a socially-distanced meeting on Monday. So, everyone else has to take the test apart from those who make these rules up? He refused in case the Russian's get hold of his DNA? oh my the implications of that terminology. Are they saying those PCR tests where all DNA testing kits?

Democratic California officials have introduced a bill which would force businesses to require their employees to be fully vaccinated against Covid-19 or face fines and other penalties. California State Assemblywoman Buffy Wicks introduced the bill on Thursday alongside fellow Democratic assembly members Cecilia Aguiar-Curry, Evan Low, and Akilah Weber. This bill would require an employer to require each person who is an employee or independent contractor, and who is eligible to receive the Covid-19 vaccine, to show proof to the employer, or an authorized agent thereof, that the person has been



vaccinated against Covid-19, the bill proposed. Exempting only those with a medical condition or sincerely held religious belief, that would prevent them from getting vaccinated. How is it when many other places this scamdemic is being closed down, but New York and California are ramping it up? Something the people of both States need to seriously ask the question, and demand answers.

The Hershey company is firing all its unvaccinated employees, confirming that it is an evil corporation that denies faith-based exemptions from deadly vaccines. Kim Durham, a payment analyst and sourcing buyer said, I really thought I'd be ok, I thought, you cannot question my faith, nobody can question that. Perhaps she should question her faith and her participation in it herself, because it doesn't work. Durham asked for a religious exemption in August and assumed she would get it. I thought this was behind me until September when I met with an HR representative. It was an interrogation on your religious beliefs, they twisted your words and tried to put words in your mouth. It was terrible, I was asked such personal questions that had nothing to do with religion. She was shocked when, in November, she received word that her request for religious exemption had been denied. Everyone interviewed mentioned being troubled by similar questions during the meetings, usually held with an immediate supervisor and someone from HR, such as: Have you ever been vaccinated? Are your children vaccinated? How do you protect yourself when you leave your home? How often do you go to church? Do you take Tylenol, Ibuprofen, Tums, or Midol? So the Hershey company, which sells lowgrade processed, sugar-filled candy bars that promote diabetes and obesity, is interrogating employees over whether they take Tums? And if they take Tums, they're not allowed to object to spike protein mRNA injections? Quite why people buy their shit is beyond me, their chocolate tastes like soap and smells like vomit. Time to boycott them.

In Ireland, more than 500,000 Covid-19 vaccines expired between Christmas and the end of January, with health officials expecting tens of thousands more to go out of date this month. This reveals just how wrong their forecasts were, and not just the quantity of vaccines needed, but the threat that the relatively harmless corona virus itself posed. There has also been a lower uptake among younger people, because Omicron has proven to be a less severe strain of the virus. The Cabinet was told last month that demand for booster vaccines had dropped among younger age groups, with between 40pc and 66pc uptake of the booster among those aged 18 to 49. Health Minister Stephen Donnelly the suggested they would make them available to developing countries, just like the pharma giants repackaging out of date drugs, and selling them as new to largely African countries. Who will be held accountable for the gross over spend, all of which the Irish people will have to fund?

Around half-way through the article, the discerning reader might notice that only half of those exposed to one nasal droplet actually became infected. The article is about an interesting human challenge study conducted in the UK on 36 young, healthy volunteers between the ages of 18 and 29, none of whom had evidence of prior Covid infection or vaccination. They all submitted to having wild-type SARS-CoV-2 intranasally inoculated and were then placed in quarantine, with constant medical monitoring including regular PCR and lateral flow testing. After excluding two trial participants who became seropositive after screening, the results were that 18 volunteers (53 percent) became infected, and 16 did not. The viral load in those who became infected rose steeply, peaking at around five days post-inoculation. Viable virus was recoverable from the nose up to 10 days post-inoculation, however, meaning that the volunteers could still transmit the virus to others until that point. Not one of the 34 who completed the trial became seriously ill, nor were any adverse events recorded. 12 people developed issues with taste and smell. In a little-known story that garnered almost no attention in the corporate media, Dutch insurer Aegon revealed its third quarter, 2021 life insurance payouts skyrocketed 258% compared to third quarter, 2020 payouts. Continuing with our lightening theme of recent months, here is another supporting story, but also ends with people doing something to fix things themselves. 2,500 Indians who lose their lives to lightning every year, lightning strikes have killed more than 100,000 people in the country between 1967 and 2019, according to official data. This is more than a third of fatalities caused by natural hazards during this period. Survivors might have to live with symptoms such as weakness, dizziness and memory loss, but the number of strikes have also risen sharply. India recorded more than 18 million lightning strikes between April 2020 and March 2021, according to a study by Climate Resilient Observing Systems Promotion Council. This was a 34% rise over a similar period during the previous year. Satellite data gathered by the Indian Institute of Tropical Meteorology also shows strikes had increased rapidly between 1995 and 2014. Although half-a-dozen states recorded a bulk of the strikes, three states Odisha, Jharkhand and West Bengal accounted for 70% of the deaths. Men working in farms are most vulnerable, tribes people who farm, fish and forage for a living are especially vulnerable. But the villagers themselves fought back and decided to make conductors themselves out of the sparse materials available to them. To make these conductors, villagers use second-hand bicycle wheel rims, bamboo and metallic wires. The rim is fixed on the top of a bamboo pole, sometimes up to 30ft high, which is then strapped to buildings, mainly community centres and local schools. The conductor makes sure that the electricity generated will pass to the earth without causing any harm. A Lightning Resilient India Campaign, the campaign has cut lightning deaths by 60% in some states. EXPOSE: Prince Andrew and Virginia Giuffre, who accused the royal of sexual abuse, have reached an out of court settlement. According to court documents filed Tuesday, Andrew will donate funds to Giuffre's charity in support of victims of sexual assault. The amount was not disclosed. Prince Andrew has never intended to malign Ms. Giuffre's character, and he accepts that she has suffered both as an established victim of abuse and as a result of unfair public attacks, a filing reads. The documents also say Prince Andrew regrets his friendship with Jeffery Epstein, who introduced him to Giuffre. Documents obtained under Freedom of Information laws by RT investigative unit The Detail include startling records revealing how, the US Bureau of Prisons moved to shut down any and all public debate about the cause of Jeffrey Epstein's death. Along the way, evidence was distorted, material facts ignored, and key anomalies unexplored and unpublicized. After being found dead in his cell at the Metropolitan Correctional Center on August 10, 2019, the records show that the Bureau issued statements to journalists and



Epstein's family categorically stating he'd committed suicide. The result was international news outlets universally and unquestioningly reporting that Epstein had taken his own life from the word go, despite the Chief Medical Examiner Barbara Sampson having reached no conclusion at that time, and making clear in a statement the next day that the investigation was open and ongoing. Classic media tactics, get the statement out and repeat it, ignoring any sort of journalistic questioning and the bot people have their story to repeat. It was not until August 16 that Sampson publicly declared Epstein's death had been a suicide. The ruling was contested by leading forensic pathologist Dr. Michael Baden, who'd been hired by the billionaire's brother to monitor the autopsy process. Speaking to the Miami Herald two months later, he charged that the autopsy did not support suicide, and that the pathologist who conducted it had recorded this. Then Dr. Sampson changed it a week later, the manner of death to suicide. His brother has been trying to find out why that changed. What was the evidence? Since when have the authorities or treasonous media ever concerned themselves with evidence to back their claims? Clearly the Israeli junta and the DNC criminals leaned heavily on Dr. Sampson to change his report. No clarity on these questions has been forthcoming in the years since, although one rationale for the apparent volte-face may have been a shock Washington Post report a day prior to Sampson's announcement. Sources familiar with the autopsy told the paper that the process had revealed several bones in Epstein's neck, including the hyoid, were broken, and such breakages are more common in victims of homicide by strangulation than hanging. Another explanation may be the then-ongoing psychological reconstruction of Epstein's death compiled by Robert Nagle, the BOP national suicide prevention coordinator. Files released to The Detail by the Bureau record how Nagle, whose name is redacted in the files arrived at the Metropolitan Correctional Center on the morning of August 13 to commence his investigation. In his resultant report, Nagle noted that a video of an unspecified nature related to the significant incident, was confiscated by the FBI prior to the review being initiated. He also said he'd been unable to conduct formal interviews with prison staff, to avoid interference with pending investigations by the Justice Department, and that much of the information typically gathered in psychological reconstructions was not available. So, the FBI and Justice Department where involved in the cover up as well it seems. These constraints severely limited the ability to establish accurate timelines, confirm subjective reports, establish converging and diverging lines of facts, or discover new areas of inquiry, Nagle wrote. For example, he was quite amazingly unable to piece together a detailed description of what the officers found when they discovered Epstein, as they did not write memorandums and could not be interviewed. Furthermore, as no pre-sentence report on Epstein had been completed prior to his death, numerous sections of the reconstruction, such as a review of the inmate's social history, were avowedly incomplete in their appraisal. Still, despite this glaring lack of hard evidence, the document ruled conclusively that Epstein had indeed committed suicide. His decision was attributed to being unable to sleep due to an inability to tolerate the noise of prison, plus the recent

unsealing of thousands of records related to his 2008 conviction on child sex offenses, and the prospect of spending the rest of his life in prison. Sound enough reasoning, one might think though in building his case, Nagle drew repeated attention to Epstein declaring himself on several occasions to be a coward, in the weeks prior to his alleged suicide as indicative of suicidal intent. It's certainly true the prisoner was recorded making such statements, but explicitly in the context of denying any intention, or even ability, to kill himself. He said he is not the type who likes pain or would ever attempt to harm himself, one psychological assessment noted, he even does not like when he has to give blood. This can only be considered a staggeringly dishonest inversion of Epstein's comments, although Nagle's manipulations went unremarked upon, in an internal review of the reconstruction by Metropolitan Correctional Center Warden Marti Licon-Vitale. Nonetheless, in a section marked documentation accuracy she took aim at the failure of officials to log an incident report in a timely fashion, and seemingly submitting conflicting reports on the same incident. Professional responsibility requires taking into account multiple descriptions of an incident as noted in your response. However, when discrepancies exist these should be compiled and noted in documentation to decrease the likelihood of conflicting conclusions, she wrote. Preconceived notions challenge the ability to remain open about alternative explanations. Please develop and provide local training for all staff, that at a minimum reviews the timeframe for writing incident reports and offers guidance when there is not clear evidence of an infraction. While the specific episode criticized by Licon-Vitale is entirely redacted, one can infer that this section refers to the bizarre facts documented by The Detail in the first installment of this investigative series. Marti Licon-Vitale, quit the Metropolitan Correctional Center just 4 months after the Epstein event. In brief, the initial incident report on Epstein's alleged suicide on July 23, 2019 referred to hanging/asphyxiation, but another filed a week later was inexplicably amended to include self-mutilation by laceration, leading to him being disciplined for a penal code breach. These grievances aside, Nagle's reconstruction was received with much delight by BOP higher ups. In an internal email dated August 23, the agency's director Hugh Hurwitz effusively praised his outstanding work, remarking it was unbelievable all you report without the benefit of interviews or video. Indeed, all of which reveals it was a prepared script. This email is ironic in the extreme, for it truly is unbelievable that a conclusive ruling of suicide could be reached, without access to basic and vital evidence. Four days earlier, Hurwitz was dismissed from his post by Attorney General William Barr without warning. Could this be attributable to attempting to shape the narrative on Epstein's death, before the Federal Bureau of Investigation or Justice Department Inspector General had completed their respective probes of the case? Whatever the truth of the matter, there is another supremely curious feature of the psychological reconstruction, never hitherto publicized by any official or media outlet. A review of financial transactions associated with Epstein's prison stay revealed, that one of his attorneys was depositing funds into the commissary account of Efrain 'Stone' Reyes, Epstein's final cellmate, for unknown reasons. He was bought off to buy into the story of



suicide is why. This may account for why Reyes became a person of interest in the FBI's investigation and was duly questioned. He reportedly feared that cooperating with the Bureau might affect him negatively, but in return for his help, he was moved to a minimum security correctional center in Queens, New York, which housed high-value cooperating witnesses like rapper Tekashi69. How convenient, or he was let out of jail altogether for cooperating in the conspiracy. Expect Reyes to turn up dead or used as an MK Ultra assassin in a public display. While there, he was reportedly interviewed personally by Attorney General William Barr, as part of the Justice Department's Office of the Inspector General's probe, who thanked him for his input. Strangely, though, the department has refused to confirm or deny the claim, while Kerri Kupec, its former spokesperson, charges that it's 100% false. Almost a year to the day later, it was reported that the Inspector General report on Epstein's death was nearing completion, with a Justice Department investigator suggesting all the team had left to do was dot their I's and cross their T's, and stating they'd be surprised if it's not released in the next 30 days or so. Whether it will shed any light on the countless serious matters raised by the declassified Bureau of Prisons documents is anyone's guess, although in light of the revelation Reves was in receipt of funds from Epstein's lawyers, The Detail has lodged a request with relevant authorities for the seal to be reconsidered. Right on cue, Reves died in September 2020, five months after being released from the prison, due to a facilitywide Covid-19 outbreak, purportedly through complications arising from the virus. Subsequently, his niece told mainstream news outlets her uncle had frequently voiced intense skepticism that the six-foot Epstein, could not have hung himself from the bunk frames in the cell, as they simply weren't tall enough. In January 2021, federal prosecutors ruled that all records related to Reyes would remain sealed, what a surprise that is - not. Despite requests for disclosure from journalists, due to the potential impact on issues allegedly unrelated to Epstein. In dismissing the request, authorities listed information concerning the billionaire included in all files related to Reyes, which ran to two pages, all of it redacted. The dastardly plot thickens, and yet another example of all the authorities working together to cover up criminals acts. 17 separate agencies, when in reality they all work as one corrupt and criminal enterprise, add the FBI, Justice Dept and even the Government via Barr and Trump. Remember Trump had good reason to quieten it down, he like Ivana and Ivanka where in Epstein's book and flight log.

EXPOSE: A US spymaster inadvertently helped the Nazis develop one of the most effective disinformation campaigns of the Second World war, by spreading rumours about Hitler's plans for a Where Eagles Dare-style Alpine redoubt, a historian with access to classified US military records has found. The myth that the Nazis were amassing weapons and crack units of 100,000 fanatical soldiers in the spring of 1945, for a last stand in the Austro-Bavarian Alps was without any basis in fact, but had a powerful hold on the imagination of American and British military leaders, who feared it could prolong



the war for years. Isn't it strange the same figure of 100K troops amassed is now the pretext for another war? it is not a cohencidence. Thomas Boghardt, a German historian at the US Army Center of Military History in Washington DC, argues in a new book that, the myth of an Alpine Nazi fortress was not a crucial factor behind American forces abandoning the race to Berlin, in favor of a southward push but was one that US spycraft had a hand in making. The Nazi leadership first got wind of allied fears of a mountaintop last stand in 1944, after the SS's intelligence service intercepted a cable sent from the US embassy in Berne, Switzerland. Remember the head of the CIA is in Switzerland, whilst this was pre CIA of America, this next passage will confirm their involvement. As Boghardt shows in Covert Legions: US Army Intelligence in Germany 1944-1949, the message had most likely been sent by Allen Dulles, later the head of the CIA during the Bay of Pigs invasion fiasco, but at the time the Berne station chief for the Office of Strategic Services (OSS). British intelligence had discovered that the special cipher used to secure Dulles's communications had been compromised, but the American spymaster continued to ignore their warnings, driving one irate British agent to despair. Dulles, who went on to be the first civilian Director of the CIA, who also it's longest serving director to date, who over saw the Iranian coup of 1953, the Guatemalan coup of 1954, who over saw Project MK Ultra the CIA's mind control program, and who was fired by John F. Kennedy, ostensibly for the Bay of Pigs invasion. Could you report to the fool Dulles who knows his code was compromised, if he has used that code to report meetings with anyone, the Germans probably identified persons concerned and use them for stuffing disinformation, the agent vented to his station chief, he swallows easily, he added. As the British had feared, Goebbels's propaganda ministry would spend the following months, building up the myth of a German defence effort in Austria and Bavaria via disinformation and media reports, hoping a sidetracked US military leadership could be drawn into separate peace talks or even an alliance against the Soviets. Dulles was a very capable case officer who excelled at working with human sources, but when it came to signals intelligence he was indeed highly negligent, Boghardt told the Guardian. As Covert Legions shows, allied forces were extremely susceptible to disinformation campaigns in the final stages of the war, with Field Marshal Montgomery arrested at one point as an impostor by American guards, following a rumor that the Germans were planning to impersonate the British commander. What this shows is, how easily the Americans are duped, because of preconcieved ideas and brainwashing techniques. Too busy running around screaming the Russians are coming, how bad the Russians are, and yet all of it, or certainly most of it was due to a few half wits with badges of dishonor. The American Military and Agency top brass are riddled with fear programs, none of them have took the time to analyze or address. After the end of the war, Nazis setting themselves up on snowy mountaintops became a staple of swashbuckling war movies, such as 1968's Where Eagles Dare, starring Richard Burton and Clint Eastwood. However, while some allied intelligence reports explicitly cited the Alpine redoubt theory, as an argument for an allied push into



southern Germany in 1945. Boghardt rejects the idea that it played a crucial part in shaping the second world war endgame, and setting the ground for cold war tensions with the Soviet Union, as Winston Churchill later claimed. The US decision not to back a British plan for a pencil-like thrust to Berlin, likely owed more to the fact that the Red Army was already within 20 miles of the German capital, while Anglo-American forces were still 300 miles away, he said, and a deal to divide up the city had already been agreed. A deal to divide up the city was agreed during the war? how nice of them. Next step was 1/4M flights between America and Germany to set up a new shop, for Reich 4. My impression is that the US command ultimately didn't really believe in the Alpine redoubt myth, but may have kept it alive to persuade the British of their overriding strategy. Americans in war don't have strategy, it is just shoot or bomb everything that moves, whether hostile or friendly as we have found out. Following birth, cells called melanocytes start to discharge melanin, the earthy colored shade, in the child's irises. This beginnings happening since melanocytes respond to light in time. Green eyes are most common in Northern and Central Europe. They can also be found in Southern Europe, West Asia, Central Asia, and South Asia. In Iceland, 89% of women and 87% of men have either blue or green eye color. A study of Icelandic and Dutch adults found green eyes to be much more prevalent in women than in men. Among European Americans, green eyes are most common among those of recent Celtic and Germanic ancestry, about 16%. Animals typically use the color green as camouflage, blending in with the chlorophyll green of the surrounding environment. Most fish, reptiles, amphibians, and birds appear green because of a reflection of blue light coming through an over-layer of yellow pigment. The perception of color can also be affected by the surrounding environment. In Ancient Egypt, green was the symbol of regeneration and rebirth, and of the crops made possible by the annual flooding of the Nile. For painting on the walls of tombs or on papyrus, Egyptian artists used finely ground malachite, mined in the west Sinai and the eastern desert, a paintbox with



malachite pigment was found inside the tomb of King Tutankhamun. They also used less expensive green earth pigment, or mixed vellow ochre and blue azurite. Azurite, I wonder why they named a color after a higher race of being than themselves? To dye fabrics green, they first colored them yellow with dye made from saffron, and then soaked them in blue dye from the roots of the woad plant. For the ancient Egyptians, green had very positive associations. The hieroglyph for green represented a growing papyrus sprout, showing the close connection between green, vegetation, vigor and growth. But green is an illusion, so why was green all so important to them? In wall paintings, the ruler of the underworld, Osiris, was typically portrayed with a green face, because green was the symbol of good health and rebirth. Palettes of green facial makeup, made with malachite, were found in tombs. It was worn by both the living and the dead, particularly around the eyes, to protect them from evil. Tombs also often contained small green amulets in the shape of scarab beetles made of malachite, which would protect and give vigor to the deceased. Scarab beetles were more of the Egyptian symbolism remember. It also symbolized the sea, which was called the Very Green. Except the sea is not green either. In Ancient Greece, green and blue were sometimes considered the same color, and the same word sometimes described the color of the sea and the color of trees. The philosopher Democritus described two different greens: cloron, or pale green, and prasinon, or leek green. Aristotle considered that green was located midway between black, symbolizing the earth, and white, symbolizing water. He was wrong then, their intentions were black and how is white symbolizing water? However, green was not counted among the four classic colors of Greek painting, red, yellow, black and white and is rarely found in Greek art. Is it a coincidence those 4 colors represented the 4 races here? The Romans had a greater appreciation for the color green, it was the color of Venus, the goddess of gardens, vegetables and vineyards. The Romans made a fine green earth pigment that was widely used in the wall paintings of Pompeii, Herculaneum, Lyon, Vaison-la-Romaine, and other Roman cities. They also used the pigment verdigris, made by soaking copper plates in fermenting wine. By the second century AD, the Romans were using green in paintings, mosaics and glass, and there were ten different words in Latin for varieties of green. In the Middle Ages and Renaissance, the color of clothing showed a person's social rank and profession. Red could only be worn by the nobility, brown and gray by peasants, and green by merchants, bankers and the gentry and their families. The Mona Lisa wears green in her portrait, as does the bride in the Arnolfini portrait by Jan van Eyck. legends, folk tales films, fairies, dragons, monsters, and the devil are often shown as green. In the Middle Ages, the devil was usually shown as either red, black or green. Dragons were usually green, because they had the heads, claws and tails of reptiles. Modern Chinese dragons are also often green, but unlike European dragons, they are benevolent, erm they were not. Chinese dragons traditionally symbolize potent and auspicious powers, particularly control over water, rainfall, hurricane, and floods. Like a latter day HAARP arrangement then. The dragon is also a symbol of power, strength, and good luck. The



Emperor of China usually used the dragon as a symbol of his imperial power and strength. The dragon dance is a popular feature of Chinese festivals. In Irish folklore and English folklore, the color was sometimes was associated with witchcraft, and with faeries and spirits. The type of Irish fairy known as a leprechaun is commonly portrayed wearing a green suit, though before the 20th century he was usually described as wearing a red suit. In theater and film, green was often connected with monsters and the inhuman. The earliest films of Frankenstein were in black and white, but in the poster for the 1935 version The Bride of Frankenstein, the monster had a green face. Actor Bela Lugosi wore green-hued makeup for the role of Dracula in the 1927–1928 Broadway stage production. Like other common colors, green has several completely opposite associations. While it is the color most associated by Europeans and Americans with good health, it is also the color most often associated with toxicity and poison. A classic medical based inversion then, rather than the cure, they create more sickness to add more poisons and collect more shekels. One ponders are shekels green? According to Jewish law, whenever a census of the Jewish people was to be conducted, every person that was counted was required to pay the half-Shekel for his atonement. There was a solid foundation for this association; in the nineteenth century several popular paints and pigments, notably verdigris, vert de Schweinfurt and vert de Paris, were highly toxic, containing copper or arsenic. The intoxicating drink absinthe was known as the green fairy. A green tinge in the skin is sometimes associated with nausea and sickness. The expression green at the gills means appearing sick. The color, when combined with gold, is sometimes seen as representing the fading of youth. In some Far East cultures the color green is used as a symbol of sickness or nausea. Green in Europe and the United States is sometimes associated with status and prosperity. The color of the cloth in royal counting houses from late 14c., later the color of the cloth on gambling tables. The benches in the House of Commons of the United Kingdom, where the landed gentry sat, are colored green. In the United States green was connected with the dollar bill, since 1861, the reverse side of the dollar bill has been green. Green was originally chosen because it deterred counterfeiters, who tried to use early camera equipment to duplicate banknotes. Also, since the banknotes were thin, the green on the back did not show through and muddle the pictures on the front of the banknote. Green continues to be used because the public now associates it with a strong and stable currency. Not anymore it isn't, yet more of the illusion game. Of course the US issued greenback in what turned out to be a demo run for the virtual implementing of a future program. Greenbacks were emergency paper currency issued by the United States during the American Civil War that were printed in green on the back. They were in two forms: Demand Notes, issued in 1861-1862, and United States Notes, issued in 1862-1865. A form of fiat money, the notes were legal tender for most purposes and carried varying promises of eventual payment in coin, but were not backed by existing gold or silver reserves. Green was also considered to be the median color between light and obscurity, just like the



medias use of the green screen then. One of the more notable uses of this meaning is found in The Wizard of Oz. The Emerald City in this story is a place where everyone wears tinted glasses that make everything appear green. According to the populist interpretation of the story, the city's color is used by the author, L. Frank Baum, to illustrate the financial system of America in his day, as he lived in a time when America was debating the use of paper money versus gold. The Emerald city of course brings up the Emerald tablets, which brings in Hermes and Thoth. Green has played a dominant role in religion. Green is the traditional color of Islam. According to tradition, the robe and banner of Muhammad were green, and according to the Koran those fortunate enough to live in paradise wear green silk robes. Muhammad is quoted in a hadith as saying that water, greenery, and a beautiful face were three universally good things. Al-Khidr known as The Green One, was an important Qur'anic figure who was said to have met and traveled with Moses. He was given that name because of his role as a diplomat and negotiator, or perhaps that was the color of his skin? Roman Catholic and more traditional Protestant clergy green vestments at liturgical wear during Ordinary Time. In the Eastern Catholic Church, green is the color of Pentecost. Green is one of the Christmas colors as well, possibly dating back to pre-Christian times, when evergreens were worshiped for their ability to maintain their color through the winter season. Romans used green holly and evergreen as decorations for their winter solstice celebration called Saturnalia, which eventually evolved into a Christmas celebration. In Ireland and Scotland especially, green is used to represent Catholics, while orange is used to represent Protestantism, yes House of Orange. This is shown on the national flag of Ireland. In Paganism, green represents abundance, growth, wealth, renewal, and balance. In magickal practices, green is often used to bring money and luck. One figure who shares parallels with various deities is the Green Man. Having a green thumb (American English) or green fingers (British English), to be passionate about or talented at gardening. The expression was popularized beginning in 1925 by a BBC gardening program. Other green terms brings in, Greenhorn, someone who is inexperienced. Green-eyed monster, refers to jealousy.
