UKRAINE: Another example of revealing the truth can come with a price. Chilean-American blogger Gonzalo Lira, who went missing in the Ukrainian city of Kharkov a week ago, has appeared online on Friday, revealing that he had been held by the Ukrainian Security Service. Lira was referring to his tweet from March 26, in which he listed the names of Ukrainian opposition figures, who are thought to have died or disappeared since the outbreak of the conflict, adding then that if you haven't heard from me in 12 hours or more, put my name on this list. Since the start of the Russian military operation in Ukraine, Lira had been using YouTube, Twitter and Telegram to criticize President Volodymyr Zelensky and Kiev's conduct on the battlefield, while also speaking about far-right tendencies among the Ukrainian military and debunking what he saw as false reports about events on the ground. After the blogger's disappearance, some unconfirmed claims emerged that he could have been kidnapped by nationalists linked to the notorious Azov battalion, and even executed. The US outlet dedicated a large article to the blogger on March 21, slamming him as a Pro-Putin shill in Ukraine. In the piece, Daily Beast journalists said they had contacted Ukrainian authorities to learn about the man's whereabouts and to clarify if he was still in Kharkov in the east of the country. The Daily Beast, another outed as a faction based version of so called news.

Health officials say they have detected more cases of a mysterious liver disease in children that was first identified in Britain, with new infections spreading to Europe and the U.S. Last week, British officials reported 74 cases of hepatitis, or liver inflammation, found in children since January. The usual viruses that cause infectious hepatitis were not seen in the cases, scientists and doctors are considering other possible sources. Additional cases of hepatitis had been identified in Denmark, Ireland, the Netherlands and Spain, the European CDC said in a statement Tuesday without specifying exactly how many cases were found. U.S. officials have spotted nine cases in Alabama in children aged 1 to 6. Mild hepatitis is very common in children following a range of viral infections, but what is being seen at the moment is quite different, said Graham Cooke, a professor of infectious diseases at Imperial College London. Some of the children in the U.K. have required specialist care at liver units and a few have needed a liver transplant. Another effect of the jabs?

Pfizer is voluntarily recalling five lots of Accupril tablets that were distributed across the United States over the presence of an organic compound that could increase the risk of cancer. According to the U.S. Food and Drug Administration, the recall was issued due to the presence of a nitrosamine, known as Nnitroso-quinapril. Recent testing found that the amount of nitrosamines within the Accupril tablets was above the level set for an acceptable daily intake. I don't know how many Pfizer recalls that is in the past year, but quite a number. Quite how the FDA escapes censure for approving these drugs needs to be addressed publicly also.

For the first time, researchers have found a cost-effective and convenient way to apply a silver-based antimicrobial clear coating to new or existing textiles. A range of textile types can be treated by the researchers' method, and items can be washed multiple times without losing the antimicrobial and therefore anti-odor property. It may be winter for half the world right now, but before too long the warm weather will return, bringing with it beach trips, ice cream, insect bites, and of course, sweat. There are many kinds of products that can be worn or applied to the body which aim to reduce body odor, but

these often come with a compromise such as expense, breathability, limited choice, or something else. Some of these make use of silver, which is well known for its antimicrobial properties, but can be difficult to apply to things like clothes in an easy and efficient way. A team led by researchers from the University of Tokyo's Graduate School of Engineering, has pioneered a way to apply an antimicrobial silver coating to textiles that is cost effective, simple and has some useful implications too. They essentially used a compound known as a polyphenol, tannic acid specifically, to bind silver to fabrics. Polyphenols are found in chocolate and red wine amongst other things, and are responsible for their infamous ability to stain clothing and tablecloths. Fortunately, the researchers' coating, called Ag/TA, is completely clear so it doesn't discolor textiles, but best of all, it can survive being washed. Joseph Richardson and Associate Professor Hiroataka Ejima have studied polyphenols for over a decade, but this chocolate incident got me thinking about using tannic acid to bind silver to fabrics. We think we've found two methods to apply our antimicrobial silver coating to textiles, suitable for different use cases. The first method might be useful for commercial clothing or fabric producers. Textiles can simply be bathed in a mixture of the silver compound and the polyphenol binder. Another method, perhaps more suited to small-scale settings, including the home, is to spray items of clothing, first with the silver compound and then with the polyphenol binder. An obvious advantage is that people can add the coating to existing items of clothing. But what's most exciting is not the ease of application, but how effective the coating is, said Richardson. Does this all smack of a smokecreen to you? what is it covering up? perhaps we will find out. We wanted to study the effect of the antimicrobial coating not just on odor-causing bacteria, but also on fungi and pathogens like viruses. hmm With so many variables to control, it was a challenge of time and complexity to test variations of compounds against variations of microorganisms. But through carefully optimizing our testing methods, we found that the coating neutralizes everything we tested it on. So Ag/TA could be useful in hospitals and other ideally sterile environments. The binding power of TA is so strong that coated textiles tested by the researchers like cotton, polyester and even silk, maintain antimicrobial and anti-odor properties for at least 10 washes. This isn't just a hypothetical situation limited to the lab, I've tried it on my own shirts, socks, shoes, even my bathmat, said Richardson. We'd like to see what other useful compounds polyphenols might help bind to fabrics, and Antimicrobial silver might just be the start. Is this an advanced version of the RFID chips in the clothes?

Italy recently re-counted its Covid deaths, dropping the number from 130,000 to 3,900, admitting the previous number was vastly inflated. Three U.S. Navy sailors assigned to the USS George Washington aircraft carrier have died within a week. The U.S. Supreme Court rejected a bid by four Democratic-leaning states, to lift a cap on federal deductions for state and local taxes, put in place as part of a 2017 tax overhaul under Republican former President Donald Trump. The justices turned away an appeal by New York, Connecticut, Maryland and New Jersey after a lower court threw out their lawsuit. The lower court held that the U.S. Congress had broad authority over taxes and

did not violate the U.S. Constitution, by placing a \$10,000 limit on the amount of state and local taxes that individuals may deduct on federal income tax returns. The deduction limit, known as the SALT cap, was part of a federal tax law signed by Trump, that slashed the corporate tax rate and implemented an income tax cut for individuals, which tax policy experts said benefited wealthy Americans the most. Democrats had opposed the law, which was expected to reduce federal revenues by \$1.5 trillion over 10 years. Capping the deduction disproportionately affects high-tax, often Democratic-leaning states, with New York estimating its taxpayers would pay \$121 billion of extra federal taxes from 2018 to 2025. The four states sued Trump's administration in 2018, calling the cap an unconstitutional attempt to interfere with states' taxing power, and coerce Democratic-leaning states to cut taxes and the services they pay for. The Manhattan-based 2nd U.S. Circuit Court of Appeals last year rejected the states' arguments, ruling that they did not show that their injuries were significant enough to give rise to a constitutional violation. Disney employs 38 lobbyists in Florida's capital, and each election cycle, the company gives generous campaign contributions to Florida candidates on both sides of the political aisle. The Florida Senate on Wednesday voted to eliminate the special zone, which is called the Reedy Creek Improvement District. It would take effect in June of next year. The swift effort to dissolve Reedy Creek by Florida Republicans has been widely seen as brazen retaliation after Disney, Florida's largest private employer, paused political donations in the state and condemned a new education law that opponents call Don't Say Gay. Among many things, the law prohibits discussion about sexual orientation and gender identity through the third grade, in Florida classrooms and limits it for older students. Mr. DeSantis, wrote in a fund-raising email, I will not allow a woke corporation based in California to run our state, Disney has gotten away with special deals from the state of Florida for way too long. The Reedy Creek Improvement District, enacted in 1967 to entice Disney to build a theme park 20 miles south of Orlando, saves the company millions of dollars annually in fees and taxes, experts estimate. The number of poor in India has dropped dramatically from 2011 to 2019, according to a new study. This is backed by an earlier story of how much China worked to get its people out of extreme poverty also. Extreme poverty in India, the second-most populous country in the world, is estimated to have declined by 12.3 percentage points between 2011 to 2019, according to a World Bank Policy Research Working Paper. The count dropped from 22.5% in 2011 to 10.2% in 2019 and the decline in rural areas was much higher than in urban areas. The paper reportedly followed two approaches to estimating extreme poverty. Both approaches yield qualitatively similar levels and trends in headcount poverty estimated at the \$1.90 line, Poverty is about 12.3 percentage points lower in 2019 than 2011, it said. The study found that extreme poverty in the country declined to 19.1% from 2011 to 2015. Poverty saw a sharper fall of 9.1 percentage points in the next four years, dropping to 10%. Extreme poverty between 2017 and 2018 saw the fastest drop in over two decades, statistics showed. While rural poverty declined by 4.4



percentage points between 2011 and 2015, it fell more sharply during the following four-year period from 21.9% to 11.6%. Meanwhile, urban poverty saw a sharp decline of 6.6 percentage points, from 12.9% in 2015 to 6.3% in 2019. This is good to hear, but suspect it is the East v. You Tube are another service that started off one way, and now resembles watching tv with advertisements you are forced into watching for every video. First it was one advert, now it is two and then it was another 2 or more embedded in the video you are watching. Of course, they also now want you to subscribe to their services, where does it all end?

This is another country like Africa and the Native Americans that blamed the British or Europeans for introducing violence, when they were slaughtering all and sundry in their own countries, long before the Jewish backed Europeans arrived. India suffered for nearly five centuries at the hands of a murderous tribe of cultists called Thugs (pronounced Tugs), or Thuggee. The Thugs conflated their religion with membership, and the leadership of established Thug clans tended to be hereditary. Members of the Thuggee cult, like other Hindus, worshiped Kali, the goddess of destruction. But the Thugs' Kali was a male-oriented death cult and demanded endless sacrifices to satisfy her hunger. There was a complex system of rituals, it was, however, not a blood ritual. Thugs killed without remorse but with pleasure, mixed with omens before and prayers afterward. Has an iteration of the Thuggee and the Frankist mindset gained dominance in the modern world? When India's British administrators began to rule around 1800, they heard reports of large numbers of travelers disappearing on the country's roads. Discovery of a series of mass graves across India revealed the gravity of the situation. Each site was piled with the bodies of individuals ritually murdered and buried in the same meticulous fashion. These killings were the work of a single organization, the Thuggee. Thugs practiced extreme secrecy which combined with their religion of murder, made them a most deadly secret society. In the early 19th century, they were credited with 40,000 deaths annually, and some estimates put the overall death toll in the several millions going back centuries. Whatever drove the Thugs, probably a mixture of greed, blood lust and corrupted religious fervor, their output and activities were astonishing. One boasted of 931 murders in a 40-year span. Thugs tended to favor targeting travelers and might join a group in small, non-threatening increments. At its root, the word Thuggee means deceivers, a name that describes their modus operandi. The killing place needed to be out of sight and followed the dumping-ground model. Favored places of execution were known as beles. Often the impostors would journey for days and hundreds of miles with their targets. When the time was opportune, a signal would be given, reportedly the phrase bring the tobacco, and the Thugs would attack. Typically, three men would grab and hold a victim down and strangle them with a rumal, a yellow silk handkerchief. Actually, blood-letting was disapproved of, how noble of them!! Thugs of the highest rank performed the actual killings. The cult's power was its pervasiveness within Indian society. In an era where strict caste divisions dominated every aspect of life, Thuggee was unique for transcending all such social barriers. Anyone from a farmer to an aristocrat could be a Thug, however, they were the prototypical in-group, closed to outsiders. And like the Frankists cult there was inbreeding. As a murderous secret society Thugees seemed to enjoy a level of protection similar to modern-day Crime Syndicate types. When Thugs were arrested, they were almost invariably released for lack of evidence. Accordingly, like ISIS, they just seemed to persist, and were never reduced. They clearly had the country living in fear, and a strange ambivalence toward the cult existed, mostly out of fear or superstition of crossing them and the vengeful goddess Kali. The rich and powerful had some vested interest in Thug activity in terms of payoffs from

the looting of victims and bribes. The Crime Syndicate elites also benefited from the psychological fear at loose in the land. For the public, a see-no-evil, hear-no-evil, fear-no-evil cognitive dissonance attitude prevailed, which allowed this death cult to gain a foothold. It was as if the Thugs had managed to keep the country traumatized. When they were executed for crimes, they showed no trace of emotion, often requesting to be allowed to place the noose around his own neck. Finally in 1836, the British passed the Act for the Suppression of Thuggee and Dacoity bandits. Thousands of thugs were imprisoned, executed or expelled from British India. The campaign relied on captured Thugs, who became informants. These informants were offered protection on the condition that they told everything that they knew, they were also baited and ensnared in traps. After a drawn out pursuit, by the 1870s the murderous Thug cult was finally exterminated. Another sorry tale of worshipping and sacrificing ongoing in India, that has cost millions of Indian peoples lives, all to worship fake gods and their off world brethren. The Indian people and indeed all those following the off world cult called religion, all just need to follow this and all will be well in the world.

All of this is on, in or around the infamous 33rd parallel. Also on the 33rd parallel is Japan, Korea, China and Tibet. Remember one of the tunnels out of the Bucegi mountains, run all the way to Tibet. One place not mentioned above is Tunisia, which is also on the 33rd parallel. But, that is the location of Carthage, once home of Hannibal who nearly toppled Rome. Carthage was a major center of human



sacrifice and demon worship, and child sacrifice took place there almost continuously for 600 years. In America it passes through S. Carolina, Georgia, Alabama, Mississippi, it splits the border between Arkansas and Louisiana. Anyone wonder why Arkansas is pronounced differently than Kansas? perhaps there is a spell cast in their somewhere? After Texas we get into the interesting states and the scene of much off world activity, of New Mexico, Arizona and California. It should be noted that, most of those places in America just mentioned, all have death row on that parallel. Indeed every country that goes along the 33rd parallel's has death row executions. Iraq's infamous Abu Ghraib where people were tortured by the US Military. Abu Ghraib is on the list of Black Sites where suspected insurgents and terrorists are tortured and often times killed. The star gate in Iraq is on the 33rd parallel as well. It is a sacrifice parallel it seems, and here is more evidence. The Vatican takeover by Left-Hand Path / Black Magick Adepts was anointed by a Human Sacrifice in South Carolina, on the 33rd Parallel. Charleston, South Carolina is the home of the so-called Mother Lodge of the World. Anyone who has been there will not miss the overly displayed Masonic symbolism, indeed even what is now the market is a representation of Solomon's Temple. According to various sources was used as the site of a human sacrifice ritual to the Devil or Lucifer, to commemorate the takeover by evil forces of the Papacy and the Vatican. This occurred on June 29, 1963 when Pope John Paul VI assumed the papacy. It was stated that Zionism was born on the 33rd parallel. In 1840, an allegation was made that Jews were kidnapping and engaged in the ritual murder of two Christians in Damascus, Syria, right at the heart of the 33rd parallel. Many Jews were rounded up and killed, and this led Jews to work for the creation of an independent Jewish/Hebraic/Zionist nation-state. This led to the belief in the Muslim world, and the mistrust of Jews performing human sacrifices in secret rituals. We all know that number 33 is not just any regular number, numerous authors have pointed out a number of fascinating details about the number 33, particularly the Masonic influences. The circles of latitude are commonly referred as parallels because they are parallel to each other, that is, any two parallels are everywhere the same distance apart. Many argue that the location of buildings on this line has close links with Freemasonry, religious communities and secret societies, but there are various historical facts attributed to enigmatic places like these. The Earth's parallels 33 North and 33 South reveal fascinating details. If we take a look at northern hemisphere, the alleged parallel makes its way through important US cities such as Los Angeles, Phoenix, Dallas, or the town of Roswell, an area which is popular for its history with UFO-related subjects. Curiously, John F. Kennedy was assassinated on parallel 33, in the city of Dallas, and it is believed that this parallel was specifically chosen for the killing of Kennedy. Which reveals it was a ritual killing. Interestingly, his brother Robert was also assassinated on parallel 33, in the Ambassador Hotel in Los Angeles. US President Franklin D. Roosevelt also passed away near parallel 33. The Amon (AMEN) is the numerical equivalent of  $1+13+5+14=33$ . In the Book of Enoch, the place where the Watcher class of fallen angels descended to Earth, Mount Hermon, is also located on Parallel 33. The Phoenix Lights,

witnessed by thousands of people in the skies above the city were one of the most enormous UFO sightings in history. As per the witnesses, two separate UFO's events were reported, all on Parallel 33. In 1942, at Parallel 33 North, the so called battle of L.A took place, where people say that the military fired anti-aircraft rounds at what some believe was a saucer-shaped flying object. Many other mysterious incidents took place around the Parallel 33. In Alamogordo, New Mexico which is on parallel 33, the first ever nuclear explosion occurred. In the town of Casablanca located in Morocco North Africa, has a huge square and hexagonal pyramidal construction is located on the 33rd parallel. It was the 33rd United States President, who targeted two Japanese cities Hiroshima and Nagasaki with nuclear bombs, both these cities straddled the parallel 33. The Persian Gulf has a few fascinating distinctive attributes also. In ancient Mesopotamia, now modern-day Iraq, where the cradle of the Sumerian civilization was, is the place where the 33rd parallel north acts as a junction of two rivers, the Tigris and Euphrates. Another interesting fact is that Baghdad is located at latitude  $33^{\circ} 33'N$  and the palace of Saddam Hussein was built exactly on this position. The ancient city of Damascus, Syria also corresponds to that parallel. All of which sounds like the caliphate line to me. Countries like Iran and Afghanistan are traversed by parallel 33. On the south parallel Cape Town, South Africa and Sydney in Australia also correspond to the mysteries. Coming to Pyramids, there are, if we travel along the 33rd parallel from the Middle East all the way to the Far East, we can actually find the fabulous White Pyramid which is located about 60 miles southwest of X'ian. The Enigmatic Bermuda Triangle also has a strange connection to Parallel 33.

Then we come to America and some of the strange or coincidental people, accidents or events unfolding on or near this same line. Governor George Bush sets record of 152 Executions in 5 years, the most in USA history, whilst his brother Jeb Bush, the Governor of Florida, has been sending persons to their death at the same time. A pair of brothers sent nearly 20% of death row people to their demise in tandem. It is said to be similar or exactly like the Pontius Pilate Paradigm. There is a commonality among 33rd parallel US Governors that needs to mirror the paradigm of the Governor of Palestine making a decision on granting clemency, to then deny it, in order to seek the Presidency. The Ideal Presidential Candidate must be a governor of 33rd parallel jurisdiction as was Pontius, modern day Israel has 33rd parallel run through north. Actually, Bill Rockefeller Clinton was actually born on the 33rd parallel, and we have all heard about the Clinton death trail that followed. The symbol is the Eagle for Romans as for America, a killer, bird of prey. The signing of the death warrant is reminiscent of the signing of the proverbial pact, with a demon in blood. The sale of the soul for temporal power.

Is there evidence of this line being a ritual sacrifice place? George W Bush as well as being the top Executioner in US history, also praised the Iraq currency depicting the inventor of the death penalty for the world, Hammurabi, the King of Babylon. 1. Death

Penalty founder is King Hammurabi: circa 1750 B.C. was found in the Code of Hammurabi. 2. Codified death for 25 different crimes . Ruler of Babylon. 3. President Bush praised his selection as the replacement face on the currency for Iraq replacing Saddam Hussein. 4. Hammurabi is seen by some as a Proto-Antichrist figure that first dreamed of putting Humanity under one government, run by one man. The intellectual architect, so to speak of the New World Order. 5. Hammurabi worshipped Marduk, a god that was the deliverer from the forces of Chaos. His symbol is the serpent or Dragon.

Saddam Hussein built the Osirak Nuclear Reactor on the 33rd parallel, the addition of the longitude and latitude equals 666. The primarily French built Osirak reactor is located at the following coordinates: 33.123 N & 44.3130 E =  $3+3=6$ ,  $1+2+3=6$ ,  $4+4+3+1+3=15$  which =  $1+5=6$ . Israel attacked it in 1981 and partially destroyed it. The word Osirak is a blend of the Egyptian god of the dead Osiris and Iraq. Saddam Hussein once opened a bank account under the pseudonym Satan. It is named after a pagan god of death is located on the 33rd parallel at coordinates that form the numbers 666. The Branson spaceport built in exact alignment with Saddam's nuclear reactor, was named after the father of Horus, the Egyptian god Osiris. Osiris' son Horus, whose symbol is a hawk he had one eye that was white and one Eye that was black. The white eye was said to be the sun, and the black eye was the moon. The combination of the two is an eclipse, which is yin and yang, and so it is representing Rahu and Ketu. One has to wonder why science or astronomers never mention Rahu and Ketu? given they are both inside the distance from us and the moon. What are the odds that a space facility using Horus son-of-Osiris eclipse symbols is being a coincidence? The often targeted Iranian nuclear power center is also on the 33rd parallel. The depiction of the human face or form is forbidden by Islam as it is seen as a form of pagan idol worship. This could not have been done ignorantly, but on purpose. The largest nuclear reactor in the US is in Phoenix and on the 33rd parallel, called Palo Verde. This was a solar deity, and individuals would sacrifice their children to propitiate it to ensure good crops and favors granted. Also, associated with demonic forces in the bible. The current emphasis to remove the Syrians from Lebanon is to control the sacrifice site. At Baalbek, once known as Heliopolis the city of the Sun by the same forces that control Abu Ghraib, to continue the work of extracting energy from the life force for world domination. Heliopolis came up last week in relation to Phoenix, both are on the same parallel, linked with the same off world entities. Given they both house nuclear reactors on the same parallel, the ugly statute in the Vatican called the Resurrection, that states it is Jesus rising from the ashes of nuclear war perhaps has more meaning? The resurrection of Set? the great reSET? The energy of human ritual killing is very powerful and it lingers, like a ghost at a haunted mansion, forever unless banished. When the current forces took over Abu Ghraib, they did not destroy it they continued using it as before. During the war in Iraq that began in March 2003, personnel of the United States Army and the Central Intelligence Agency under the command of George Bush again, committed a series of human rights violations against detainees in the Abu Ghraib prison in Iraq. These violations included physical and sexual abuse, torture, rape, sodomy, and murder. The universe runs on an energy said the Aztecs, and the gods thirst for it was perpetual and insatiable.

Also on the mainly 33rd parallel, it should be noted that the majority of ritual killings of blacks in the former Confederate States, did not occur through the use of the death penalty but rather through unofficially sanctioned mob lynching. Much of this activity yet again was directed by a secret society, the KKK / Ku Klux Klan, with the same grades of initiation which is prevalent in freemasonry, which was heavily prevalent in the confederate States. Notice the 3 K's again we referenced in FHSTOS? Ku Klux are both said to derive from Asian regions, both also maybe later adopted by Greek, meaning the circle. Which brings up many connotations, the binding, Le Circle the criminal secret society group, witchcraft relies on circles, then you have the Council of or circle of nine who do ritual killings of children. The US Senate was unable, despite 200 bills being proposed to ever outlaw lynching by making it a federal offense, and even to this day is still not a Federal offense, now why is that? Most lynching went unreported and the true number may never be known. Estimates in the south since the end of the US civil war typically run from 10,000 to 30,000, needless to say no one was arrested or certainly convicted of any of these crimes. The KKK used and uses as is widely known, the symbol of the burning cross. The Burning cross is the symbol of the Babylonian sun-god Tammuz, the cross forms the letter T. Thus, the burning cross is a symbol of a sacrifice, which is human sacrifice to the Babylonian solar deity. Most of the lynchings took place in 33rd parallel States by a secret society using the Symbol of a pagan Babylonian solar deity, to ritually and publicly torture human beings and kill them to maintain control over them by a so-called master race. Except as we have found out, the master race was

formulated light years from here involving off world species, and was not started in Germany in the 1940's. Taken from Part 1 of the Cosmic Genetics show, the Anunnaki legions and races to begin forming the master race, to make the Adam-Kadmon race, that would take over this planet. Almost all official Klan organizations at present are based in 33rd parallel states. The usual method for putting crucified prisoners out of their misery was, to break their thigh bones to prevent them from breathing and allowing them to quickly suffocate rather than live longer in agony. All of which brings in another group, which has thigh bones in it's symbol.

The Skull and bones: Thus the secret society which both presidential candidates in 2002 were members of, not only collects skulls and items associated with death, but is most known for collecting the remains or belongings of demon possessed persons. Known as the Brotherhood of Death or the Order of 322, which maybe related to a pagan festival on March 20-21. A Sumerian Festival, celebrating the return of Dumuzi (God of Life and Death) from the Underworld to be with Inanna. Remains from burial sites at Machu Picchu were taken to Yale early in the last century by Yale graduate, Freemason and possible skull and bones member Hiram Bingham. 3,000 Years of Jewish History including items related to Magic and the Occult were sent from Saddam's Intel HQ to Texas by Achmed Chalabi. Saddam Hussein envisioned himself as a modern day Nebuchadnezzar, the Babylonian Ruler that destroyed Israel and brought many leaders of the Jewish community as captives to modern day Iraq. The Jewish presence in Iraq lasted until the rise of Saddam Hussein, nearly 3000 Thousand years. The Jews were influenced by the magical practices of Babylon and vice versa. Saddam collected every item associated with Jewish history he could and kept everything stored in a basement of the Mukhabarat Headquarters in Baghdad. After the War, the items were retrieved by Chalabi with the help of US special forces, and sent to an unknown storage location in Texas. Both Texas and Iraq are on the 33rd. Also on the 33rd parallel is China and Chairman Mao who is said to have slaughtered 70M Chinese, Mao was a disciple of Yale, and subsequently the Skull and Bones. It is all about the sacrifices to the "gods".

Also on the parallel of death and ritual is India, and a quote from Krishna the Hindu god said, I am become death, destroyer of worlds. Hari Krishna may have whole new meaning as well now, the word Hara is used as a synonym for Shiva and the word Hari is used as a synonym for Vishnu. Both Hara and Hari mean one who takes away from us. But the Hindu meaning for Hari is, the green one. Hare Krishna was made famous by the Tavistock creation again, The Beatles, what most don't know is, Hare Krishna is a mantra and so a mind control piece.

The longitude and latitude lines for the center of Jerusalem add up to the biblical Number of the beast 666. The Israeli Supreme Court building in Jerusalem has a pyramid with the all-seeing eye. The buildings cost was donated by the Illuminati/New World Order linked

to the Rothschild Clan or bloodline. Israeli Supreme Court Building linked by Ley Lines to downtown 666 Jerusalem. The Rothschild 666 pyramid in Jerusalem is linked with the Chicago Sears Tower, in the aptly numbered zip code 60606. Louis Rothschild is said to have been a 32nd degree mason in Chicago. Dorothy Rothschild is listed as a donor to the Bush Cheney campaign, and is listed as a contributor to the building of the Pyramid. The list of tenants in the Seer's Tower includes Deutsche Bourse Systems, which is also the oldest stock exchange in Germany, going back nearly 500 years. The power behind the throne of the company are Jacob and Nathaniel Rothschild.

The Freemason motto is Ordo Ab Chao, Order from Chaos. The CIA was heavily infiltrated with fascists and Nazis, that essentially formed it's backbone on the German General Gehlen Nazi espionage web in occupied Europe, towards the end of the second world war. The so-called Ratline that brought them to the USA and elsewhere did not simply bring, scientists, spies and operatives over, it brought Black Magicians or Left-Hand Path occultists prevalent in the upper hierarchy of the SS and other organizations. They knew about the need to create nuclear facilities on the 33rd parallel and its anointing with human blood / life force. The Nazi movement was essentially an evil magical / occult group masquerading as a political party, that took power in Germany and now America. The first atomic bomb was exploded in the desert of New Mexico, the nearest town was Alamogordo, New Mexico. Latitude 33.899 N. The project was called Trinity, and many wrongly link it to the Holy Trinity of Christian or Catholic belief. It is another Trinity, the Hindu one, which includes the Deity, Shiva, the destroyer, when he opens his third eye, the universe is destroyed to born anew or Anu, a New World Order, so to speak. The freemason symbol of an eye as capstone. Oppenheimer, the father of the bomb quoted the Bhagavad Gita of the Hindus when the fireball was rising, I am become Death, the Destroyer of Worlds citing Krishna another Hindu Deity. Shiva and his or her egregores was placed at the entrance to the particle facility, CERN. FDR was replaced with 33rd Freemason Harry Truman who dropped Two atomic bombs on Hiroshima and Nagasaki, two Japanese cities very near the 33rd parallel. The Enola Gay bomber that was used flew on its 33rd mission to drop the first bomb. The 33rd parallel north and south brings up the number 66 on both sides, and when combined brings us the 6-6-6-6 Victim/Victimizer mind technology we referenced in the Cosmic Genetics series. Just like with the sacrificial cult, there is a victim, us, and they are the victimizers. With the rising of the people, their ability to victimize is much reduced, a rising of more people with higher frequency and intention erodes their dark magick ability further. So the solution is simple, raise the frequency.

ENDING PIECE: Many of us grew up with difficult and hurtful parents who spoke critically, with the intent to demean. Controlling and putting you down, was the modus operandi, but not all children are the same, and so all cannot be shoehorned into the perfect child created by the establishment and cultural rules. Each word of sarcasm, each

thinly veiled joke or put-down undercut your self-esteem. Each knocked us down a rung in life and kept us from our potential. Comparisons made to other children succeeding academically, sportingly or other modes, attacks of mediocre performance at school, and harsh language were many parents weapons of choice. When someone attacks your self-esteem repeatedly, you feel beat down. It feels like you were meant to fly, but your own family is making you drown. Then, your natural tendency might be to do to others what someone has done to you. The classic victim/victimizer program. Tendencies were to judge and compare others in your mind, to taunt and verbally attack them. Some got into the habits of sabotaging and hurting others, without thinking much about it. People assumed that because parents had talked to us harshly and treated us badly, we had the license to do the same to others. Others could handle the pain because we had, others could endure a verbal lashing because we had, others could handle emotional abuse because we had. You, too, might have grown up in a household that wounded you deeply. You might have never been able to leave the shadow of the pain and suffering you experienced, and you might have learned to treat people as others once treated you. But just because others hurt us, that doesn't mean we have to continue the cycle of abuse. You can jump off the hamster wheel and looping sorrow and self pity, and stop playing pass the parcel of your own suffering onto others. You don't have to fall into your natural, default behaviors, because you can change. You can choose different actions and make different decisions, you can break the cycle of negativity, criticism, and abuse. So, what are the solutions? think and act different is the main course of ending the victim/victimizer cycle. 1. Work on forgiving those who hurt you. This may be much more easily said than done, but forgiveness is the key to healing. If you can't forgive today, at least set the intention to forgive. It doesn't matter how tragic or traumatic your past was, you must forgive for yourself. You'll feel like a heavy weight has been lifted from your shoulders, you will be able to breathe much more easily. It helps to put your abuser's behavior in perspective so you can see their actions in a different light. Try to understand what influenced their behaviors and characteristics, where your parents raised in a similar way? Their intentions may have been ultimately good, but the way they went about parenting was misguided. Look at them through a lens of gratefulness. What could you appreciate about them, in spite of the pain they caused? Is there anything you can appreciate about the pain? The people who hurt us in essence were hurting themselves, and if you apply yourself in the right way, you end up with more skill sets than a child who was pampered. 2. Work on your own healing. Instead of burning in anger and hatred, focus on what you need for your emotional and mental health. Assess the damage they've caused, look at the impact their behavior has had on your life, and determine what you must heal. Find inner coping mechanisms, write about your hurt, process and heal it and burn the writings in a symbolic letting go. Open yourself to a spiritual practice, seek the tools and people that can help you heal your emotional wounds. Cultivate love for yourself, speak to yourself gently, praise your progress. Let go of your high demands and expectations of yourself, or the low demands and low expectations also. Notice if how

you treat yourself is similar to how the people who hurt you in the past treated you, if you do, just quit it, it serves no one well. 3. Look for alternative role models. Watch your behavior and notice what you do when others hurt or anger you. How do you react when others push your buttons? If you don't know how to respond or react differently from the people who raised you, look for alternative role models. Seek people with positive and emotionally healthy ways of responding to personal situations. Study them, take notes, notice how they handle trying circumstances, and model their behavior in your own interpersonal relationships, until you fully accept your own new model. 4. Learn positive and empowering behavior. If you were taught destructive and dysfunctional ways of being and speaking, opt for alternative ways. Hold back on hurtful words, convey your needs with softer language, and respect other people's boundaries. Practice listening intently instead of responding rashly to what others say to you. Avoid arguing, making a scene, or verbally attacking someone, agree to disagree and move on, not allow situations to fester. 5. Focus on your reactions instead of the behavior of others. You can't control others' reactions, but you can learn to notice, change, and improve your own. Look for triggers and other behavior that provokes you. Notice your immediate reaction when people treat you badly, disrespect you, or lash out against you. Instead of immediately engaging with this behavior, withdraw, reflect, analyze, and take a thoughtful next step. Most interactions of this type require them harvesting your energy, protect it and don't engage. 6. Spread your light. Remind yourself that even if you grew up with challenging people and the darkness of human behavior, you get to choose how you treat others and show up in the world. You can operate by the default of hurting others, or worse, seek revenge. Which then mimics the harmful and negative habits you witnessed growing up, or you can actively take different steps and make different choices. You can bring yourself out of the darkness of bad behavior, cruelty, abuse, and negligent child rearing. You can go out in the world choosing love and spreading your light of compassion and understanding. You can be the conduit who transforms pain into healing, not only for yourself but for everyone around you. You can show others who are hurting that forgiveness, understanding, love, and compassion are possible even after you've been hurt. And in doing so, you can help make the world a less hurtful place. There will always be harmful, hurtful, bitter and twisted people, but the key to it is, how you react to it. If you stand in the truth, you have no need to engage, those who tend to talk too much ultimately to re-affirm the lie. In the end, time always tells, that time used to be longer in between, these days it is much closer in "time". Standing in truth, means you stand in patience, comfortable in your own skin and field, which means you didn't become the victim. Whilst the liar and victimizer suffers each day until the lie is burst. Then it is a matter of how they react to the truth bursting forth.
