

## THI-SHOW TRANSCRIPT 2022-08-25

THI & TPC NEWS: In November this year our members in the UK have arranged a meeting together in London. This is fantastic and I hope you all get out of that trip as much as the Americans have on their gatherings. We will need to come together more than ever in the future with like-minded people, as their world and it's people will not go too well. THI members getting together builds stronger bonds, and you should perhaps see it as a sanctuary for members where you can be yourself. Which will be very important for the future. The village now has 4 houses with residents and a 5<sup>th</sup> expected within a week. Much progress in terms of personal development is ongoing within the community, and a multitude of ideas is in the development stage as well. Request for the media teams in the Communal Gatherings, please seek out potential alt media shows for me to go on. If you can get me slots and a week's notice I would appreciate it. This is for two reasons, our receding period from the alt media to rebuild is now complete, and it is time to get our message out on a few fronts. The first reason is for the book promotion, but that is not the primary reason, as I wish to discuss what we at THI and TPC are undertaking, particularly in relation to the New Blueprint. There is an undercurrent of discontent bubbling outside of our community, indeed there is some inside as well and I want people to channel that energy into something of value, instead of anger, rage and violence, which will at some point inevitably will explode in the masses. NEWS: As the big 5 American news channels scramble for dwindling figures, less than 10M Americans are watching it now. CNN is in crisis mode and firing people and trying to get back to in their words, to more journalism. (M) Did the CIA approve of that? The horse has bolted for all the news networks, I imagine when people get over their Trump savior program the lead network Fox, will collapse also.

Since President Joe Biden took office, 257,110 migrant children have been encountered at the nation's borders, according to data from U.S. Customs and Border Protection. Children are apprehended by Border Patrol and swiftly released to sponsors across the country, not returned to their home countries. The word sponsors should bring a clue and alarm to what has been going on. The number of children who have come to the U.S. alone during Biden's tenure is far beyond anything seen before, including the migration surges of children during the Obama and Trump administrations. Border and refugee agencies have struggled to keep up with the constant arrivals of children, with thousands coming per week. But the biggest impact of this influx may not be felt until years from now, when these children become adults and face potential deportation. That is

assuming they make adults, depending on who the “sponsors” are. While 800,000 illegal immigrants who were brought to the U.S. as children, have been protected under the Obama-era Deferred Action for Childhood Arrivals program from deportation, new children arriving are ineligible, cueing the need for a new DACA. DACA was rolled out by Obama-era Homeland Security Secretary Janet Napolitano in 2012. Congress is the only government entity legally allowed to set immigration levels, but after years of failed attempts to give legal status to immigrants who illegally entered the country, President Barack Obama acted. Does anyone outside of THI ask just what does Congress actually do anymore? Not involved in decisions to go to war, not involved in immigration and not involved in any Government oversight either. What do they actually do apart from being dancing Israeli puppets and accepting illicit funds or positions to collect shekels? DACA allowed noncitizens who were then under the age of 31, and had entered America before turning 16 years old, and before 2007 to request that the government not deport them. DACA recipients also received documents to legally work in the U.S. The protections were good for two years at a time and then would require applying for renewal. Three reasons for this, A: Cover up those going missing within the country, B: to keep some sort of monetary flow and C: using children for nefarious means. Or does it have another higher purpose meaning? More on that later.

The slimy shekel people are at it again, people need to move away from there and let it rot. New York City is using a rule from more than a 100 years ago to deny property damage claims from victims of Hurricane Ida. A total of 4,703 claims related to the deadly storm have been filed, and everyone has been denied by the city’s comptroller Brad Lander. Comptroller Lander’s office confirmed to The Hill that all 4,703 claims were denied. For over a century, courts have held that municipalities across the state of New York, including the City of New York, are not liable for damage from extraordinary and excessive rainfalls. Where damage is caused by negligent action or omission on the part of the City of New York, the City may be liable; however, that was not the case here, the letter states. As a result, the City of New York is not responsible for losses arising from Hurricane Ida, and your claim must be denied. Move out or set up a public cooperative Insurance and let their Insurance companies ironically go under water themselves, are the solutions.

The human rights abuses in Saudi Arabia continues to cause consternation by people around the world, yet curiously not Governments. A Saudi court has sentenced a doctoral student to 34 years in prison for spreading rumors and retweeting dissidents, according to court documents obtained Thursday, a decision that has drawn growing global condemnation. Al-Shehab told judges she had been held for over 285 days in solitary confinement before her case was even referred to court, the legal documents obtained by The Associated Press show. The Freedom Initiative describes al-Shehab as a member of Saudi Arabia's Shiite Muslim minority, which has long complained of systematic discrimination in the Sunni-ruled kingdom.

Saudi Arabia and the executives or executives being the operative word, continue with their killing spree, and their eye for an eye program that is selective in the extreme. The kingdom killed 120 detainees in the first half of the year, returning to the pre-Covid levels of executions. During the first half of 2022, Saudi Arabia executed 120 people, a number higher than that of 2020 and 2021 combined, as the kingdom is on its way to surpass the record of 186 executions set in 2019. According to a report released by the European Saudi Organization for Human Rights last month, 101 of the individuals executed this year were Saudi nationals, 9 were Yemeni, while the rest were citizens from Egypt, Indonesia, Ethiopia, Myanmar, Jordan, Palestine, and Syria. Note there is none from Israel despite various atrocities, same country, same people is why. House of Saud was a recreation of the House of Israel. According to the report: If Saudi Arabia continues to execute people at the same pace during the second half of 2022, they will reach an unprecedented number of executions, exceeding the record high of 186 executions in 2019.

Most of the executions carried out this year took place on 12 March, when Saudi officials killed 81 detainees on charges of terrorism-related activities. 5 days before the slaughter fest known as the Purim, as we revealed in a recent show. Take the term terrorist with a bucket of salt, remember the system of which the Saudis are a part of, declared Americans in the Alt Media as domestic terrorists, and then called anti-vaxxers the same. Rights groups later revealed that 41 of those executed that day came from Qatif, a region populated by the kingdom's Shia Muslim minority. At least 58 of the victims were executed for nonlethal offenses, and 41 were executed for participation in anti-government protests. None of the bodies were returned to the families. No doubt used for other nefarious practices, as we covered in Tuesday's show. At the time, Riyadh claimed the executions were carried out on convicts who held deviant beliefs, pledging allegiance to foreign organizations. I guess free speech is not allowed in that Fascist state. Shia Muslims living in the kingdom are largely seen as heretics by the ruling Sunni Muslim class. The religious minority often denounces marginalization, as they are accused of being sympathizers of Iran. Which confirms Saudis a proxy state and the financial arm of Israel. They are also targeted by arrest campaigns without prior notice or warrants. International NGOs such as Human Rights Watch have criticized the Saudi judicial system for its injustice and lack of due process. Critique is one thing, taking action is another, and all of these so called Human Rights groups have failed us.

The Holocaust committee were out in full force this past week, because A: only they are allowed to suffer and B: the holocaust only applies to them. Questioning or referencing it these days becomes a global event, as the masses of Jewish media report it in almost every developed country around the world. Following last week's IRS announcement of more agents and fire power, here comes the spin as the people regaled against it. The Internal Revenue Service is launching the first internal security review since the Oklahoma City bombing in response to a rise in violent threats, yeah right. The IRS was targeted with renewed fury after the massive new Manchin-Schumer law gave it \$80 billion in funding over 10 years, which is expected to result in the hiring of 87,000 new agents. Outrage on the internet from the Right has turned extreme in a few cases, leading to threats that some believe could be acted on. What has right or left bird politics got to do with it? people are complaining outside of their media boxes. With the country and the people in complete disarray and many struggling with monetary problems, this is the Governments answer? A particular source of online outrage was a job posting for an IRS criminal investigator, that specified that the hiree must carry a firearm and be willing to use deadly force, if necessary. That description, though, only applies to about 3,000 of the IRS's current 78,000 employees, according to the Washington Post. A gun and deadly force just to collect taxes? Seriously? Have these people lost their minds? Commissioner Charles Rettig announced to employees, that the agency would be conducting a security review of all 600 of its facilities. We see what's out there in terms of social media, our workforce is concerned about their safety, Rettig said. The comments being made are extremely disrespectful to the agency, to the employees and to the country. That works both ways Mr. Rettig, the unfair targeting of lower income people whilst the wealthy get off scot free, the intimidation and harassment tactics used, and as for reference to the respect of the country, the IRS is not part of this country. Rettig also complained about what he thought was an unfair treatment of the IRS in the media, and said this country would not function without a functioning Internal Revenue Service. Erm Mr. Rettig, it has done since the 1930's when the Federal Reserve deleted the Tax and Revenue department, and implemented a Crown tribute organization.

#### POSITIVE NEWS:

A YouTube channel that connects Indians and Pakistanis who were separated by the 1947 partition, has gained hundreds of thousands of followers from both countries.

Nasir Dhillon, 38, started Punjabi Lehar in 2016 with a friend, since then, he says the channel has helped hundreds of people reunite with their loved ones, often virtually, across the border.

When the British left India in 1947, they divided the territory into two independent countries, India and Pakistan. Sound familiar? As the next year the Bnai Brithish did the same to Palestine, divide and conquer. The partition was a deeply traumatic event that set off a wave of religious violence. About 12 million people became refugees and between 500,000 and a million people were killed.

The neighboring countries share a tense relationship, which makes it difficult for Indians and Pakistanis to travel across the border. The channel now has more than 600,000 subscribers, and Mr Dhillon says they are flooded with requests from people in India and Pakistan to find lost family members.

People also approach us to find their ancestral houses or gurdwaras, the Sikh place of worship, he says.

Punjabi Lehar doesn't have a team, but Mr. Dhillon and Mr. Lovely have now built up a network of contacts and activists in both countries, which helps them track people.

While virtual reunions are still easier, they have been able to organize more physical meetings after the Kartarpur Sahib corridor was inaugurated on both sides of the border in 2019. Great stuff, and time the Pakistanis and Indians demanded they tear down their fake borders, and all come together. You have all been duped by a weak and pathetic control group, end their occupation games and work together in peace and harmony.

That was nearly 2 years ago. It is not known how many digital first responders have been recruited up to this point. All that investment and it didn't work, oops.

The proof of absence of any possible ability for the mind to first evaluate and express its' decision on one or more acts, regarding certain Property or Rights using cognition, perception, identification, sensation, comprehension, volition and communication means no consent exists.

No consent exists if fraud, deception, threat, fear or duress can be proven, there can be no consent under duress.

If an accusation or claim is made and is not rebutted, consent is presumed; hence, silence is consent. This gets into the realms of, implied consent, funny word implied and so I delved into it.

Implied means intended but not expressed, it also means to enfold, enwrap and entangle, all of which is binding terms. To hint at is another, which means implied consent is to hint at the con that was sent. But perhaps another definition bears greater clarity, when you split the word up. Imp and lied. The current meaning of imp is little devil and attested from 1580s, from common pejorative phrases such as the imp of Satan. The extension from this from the 1640s is to mischievous or pert child.

The imp lied? And hinted at the con that was sent, can be the overriding message from those two words. Consensus exists when consent has been given by all parties involved in an issue.

We need to be very aware of the engineering approach used in mind control practices, that purposely manipulate people out of their informed consent.

Like the methods used in media based psychological operations, and the related propaganda that is used to get the uninformed public, to support ideas and agendas that explicitly benefit the controllers.

It is all about them getting control of your mind, the mind can be manipulated, and that is where they can get in and wreak havoc with people. A better understanding of ourselves can alter that concept.

In order to effectively take back control over our own mind, body and spiritual consciousness, we will explore the meaning of consent, and the types of consent that are common in human language, as well as how consent is manufactured through deceptive forms of mass manipulation. Consent has direct applicability to the power of Universal Laws, and it is cleverly mimicked when used in legal contexts or in the shaping of cultural influences, which often differ greatly to obscure the everyday meaning. Now and ongoing, it is of critical importance that we pay attention and are consciously aware of what we are in consent with. When we better understand what we are truly participating with, an informed and aware decision can be made. The global control agenda is designed to usurp the informed consent of the human public. This psychological operation is escalating in more aggressive ways, so that people will be compromised to easily give away their consent. When people easily give away their personal consent to a structure, belief or another person, it is easy to compromise and interfere with, the intrinsic relationship that person has to their own inner soul and spirit. When we give up our rights to have informed consent in what we interact with, we lose our autonomy and even lose rights to own our body.

Thus, it is up to us to place emphasis on accepting responsibility in our choices and actions, so that we never give up our personal consent, to something outside of our own inner spiritual self's direct connection to the Godhead or Source. In this way, we can interact with many different structures in this world, collaborate with other people and in communities, but external things are never given authority over the direction of the higher self and relationship with Source. This is what it means

to be in this world, but not of this world. Our multidimensional consciousness exists outside of time and when we are reconnected, we are able to hold witnessing way beyond the control matrix. The relationship with the inner core self and the highest expression of self as connected to the Source, must be the highest priority in order to retain power over personal consent. This action unleashes the power of consent in Universal Law, preserving the rights for claiming Self-Sovereignty and assigning higher authority to the body, while being bombarded with 3D mind control tactics designed to manipulate consent away from all people.

### What is Consent?

Consent is an act of the power of the mind to think and understand, to reason and perform careful consideration of participation with something, and to reflect or ponder on the consequences of that participation. The proper meaning of consent is a person who exercises sufficient mental capacity, to make an intelligent decision that is demonstrated through the genuine willingness of an action, as the result of reaching an agreement in mutual or shared interests, or performing an action that is proposed by another. Ponder means to weigh the gravity of the importance of the material, an offer is made and you must judge the importance or relevance of it. Consent is not real consent any longer when tactics of terror, intimidation, deception and fear are used as an explicit tool to manufacture consent in a person, in order to get them to go along with performing an action. Obviously, this is coercion administered under threat of personal harm. Thus, we can be made aware that many people's consent is stolen, manipulated and manufactured, through the specific psychological targeting of the masses with intimidation, bullying, terrorism and victimization fears. This is a mass media psychological operation used to traumatize the world citizens, distracting them from comprehending the power of consent.

Additionally, consent occurs when one person voluntarily agrees to the proposal, goals or desires of another person. This also applies to participating with any kind of organization and other types of corporate structures. When we are in consent with something no matter what it is, a person or inanimate thing, it is important to set your intention, purpose and goals in why you are consciously participating with them. This is called setting the terms of a mission statement, which correlates to the Law of Intent. All individuals should have a mission statement that reflects their intentions and self-goals, no matter how basic it is to outline their purpose and direction. People need to be self-aware to the point that they can define what purpose they want to serve in life. This is also called setting your boundaries, boundaries in terms of your psi field, brain and heart, it is the most common thing that is overlooked by so many people. That has, can and will have devastating effects to an individual. It brings in other people's emotions, intentions and also victim/victimhood programs, so that when you engage with those people, you become a harvested entity. Never let anyone in your field and never put anyone above your own heart. A personal Mission Statement can be as simple as; I choose to be in the highest expression of my divinity and in accordance with Source in reaching my highest potential. Furthermore, all organizations and systems of energy should also have a mission statement, that clearly reflects the declaration of intent and the purpose

of the organizational structure. Mission statements set the intention of the organizational field in the systems of energy being co-created, which will allow you over time, to self-assess and monitor if your mission statement and the mission statement and intent of another, are congruent or dissonant. As a conscious awake and informed person, this step is very important in managing the energies generated between all of your personal associations, projects and the intentions behind them. With this clarity of purpose, this allows you to check in for personal resonance quickly when things between people and organizations evolve over time, to better monitor if you need to make changes in the intent or consent, that you have made in the relationships that you have created.

There are differing types of consent and we will go more into them next week, but added the first of them into this show as it has deep connections to our show on Tuesday, called What in the name of Science's portion is this? Informed Consent: Informed Consent is a legal term and ethical principle that describes biological ethics, which was introduced after World War II. It replaced the earlier medical attitudes that were founded on having implicit trust in a doctor's decisions, and put patients in charge of their own care. Informed Consent is the process for getting permission before involving that person in some kind of situation that impacts bodily health or wellbeing, usually related to medical research or clinical experiments, such as being informed of the potential risks of a therapy or drug, and giving informed consent before being provided with it. Informed consent can be said to be given, when a person has been educated to understand the facts, and considers the implication and possible consequences of an action, which will impact them. Therefore, the term informed consent is an ethical and legal principle in which a person exercises their right, to gather more data for analysis and perform their own due diligence, to better understand the facts and consequences of making a choice that impacts them. Informed consent is directly related to preserving a human right to self-ownership, autonomy and the prevention of abusive conduct. Inform means to train or instruct in some specific subject, it originally meant current in information, but it later could also mean unformed or formless. Form means to shape, but it was their shape they were intending, and so they in-formed us of their opinion or belief. In means within or inside, so on the inside they are forming or shaping us with their in-formation. Which brings in the meaning behind let's make man in our image, by going within us and forming us. All of which means we don't have to accept it.

EXPOSE: An all too familiar story and all too familiar names, that crops up with such alarming regularity and yet is seen by so few. That inability to recognize patterns, names, cultures and religions involved in crimes against humanity, has been a very costly one to society. A New York adoption agency deliberately split up infant twins in the 1960s as part of a controversial study. It is not controversial it is barbaric and plainly wrong. This BBC expose tracks down some of those involved to find out why they are still searching for answers about this intrusive experiment. Twins were used in experiments prior by NASA, CIA and Majestic agents, to try and get twins to operate the bio-engineered ET crafts that had crashed, killing many of them. A heartbreaking story that had a happy ending, in what is a chance encounter on the surface, but a frequency based connection to the unknown. Kathy Seckler was 16 years old when she made an unexpected discovery that

changed her life completely, she had an identical twin sister. It was 4 September 1977 she recalls with utmost clarity, her voice wobbling only slightly when a friend told her that she resembled a girl she knew called Lori Pritzl, and asked if she was adopted. Seckler's birthday was the same date as Pritzl's and the two girls looked exactly the same. Seckler had known she was adopted since a young age, enjoying a happy and loved upbringing, but she then learned that Pritzl had also been adopted from the same agency as her. The girls immediately spoke on the phone and realized their friend's suspicions must have been true, that they were twins. Seckler recalls breaking down in tears when she met her twin sister for the first time. I saw Lori crossing the street with a big smile on her face, then we hugged. It was quite an experience, I felt less alone. Being an adopted child, I always felt different, but then I felt like, wow, I have a comrade there. They were both smokers, had similar artistic interests like dancing and drawing, and both liked music. It was surreal, I felt like I was staring at myself in the mirror says Pritzl. They could have found out earlier due to their similarity to each other, that had been pointed out previously by acquaintances who knew both families. Pritzl had shrugged it off, doesn't everyone occasionally hear that they look like someone else? However, the girls lived about 15 miles from each other and they had family friends in common. Unbeknownst to both girls, their parents had known about the other twin for about a decade, but had been told to keep it a secret. What emerged a few years later was that Seckler and Pritzl were part of a controversial study. In the 1960s, a then well-respected adoption agency Louise Wise Services in New York, had to be New York didn't it? It doesn't end there though yet again sadly, as Louise Wise Services was founded by the wife of a Jewish Rabbi. It deliberately split up at least 10 sets of infant twins or triplets and placed them in separate families. Seckler and Pritzl were among six sets of newborn identical multiples separated between 1960 and 1969, including one set of triplets. The agency had partnered with a group of psychiatrists and psychologists, in an attempt to tease out what makes us who we are. They wanted to know how much of our identities are defined by our nature, and our nurture, but at what cost? Following a documentary about the study, a researcher spoke with both identical and fraternal twin participants, as well as one of the original researchers involved, to explore why the twins today are still seeking answers about their unwitting involvement in this intrusive experiment. We were really deprived of being sisters, let alone twins, and I think it was just horrible what they did, Seckler said in an interview for the film. It was challenging enough being an adopted child, to deprive me of being a twin and having a sister and twin ship was just horrible. Any Louise Wise adoptee from the 60s has every right to think that perhaps they have a twin, says Nancy Segal, a geneticist, twin expert and author of *Deliberately Divided*. She has spent several years tracking down many of the original subjects involved in New York's Child Development Center Twin Study, as well as anyone she could find who was involved with the study. The story of the twins and one set of triplets deliberately split up, first came to light publicly in 1980 when three young men discovered by chance at the age of 19, that they were identical triplets. Their reunion made headlines around the world. Soon after, it became clear there were other multiples who had also been split up, both identical and fraternal twins. Stories of twins have long captured the human imagination. Strangers stop twins in the street and regularly ask questions about that special bond they are reported to have, questions Seckler still gets asked today if she mentions that she has a twin. For researchers,

twins provide a unique insight into the complex interplay between our genetics and the environments we live in. That doesn't mean they should be split up, abused and mentally tortured, it appears like the Tuesday show, science has no boundaries where ethics and morality are concerned, or what levels of evil they will go to under the name of science. Identical twins who grow up apart in different families share only their genes, not their environment. Any commonalities discovered can therefore be largely attributed to their genes, although in recent years the relationship between nature and nurture, has been found to be a great deal more complicated than this. Traits like intelligence, height and weight, for instance, have all been found to have important genetic influences. Findings like these come from years of data collected from retrospective studies of twins raised apart. What we are finding is that many more behaviors than we ever would have thought, do have a genetic component to them. Genetics is not everything, but it does explain a great deal of why we differ one person to another. Actually, that statement is not true, it has everything to do with Genetics, something science is badly amiss on, as our Cosmic Genetics' series revealed. Though it rarely occurs, identical twins that have been raised apart usually only discover this years later. Any insights are therefore gained retrospectively. Because of their rarity, there are limited cases for scientists to study. But what is the actual purpose of studying them? Are they saying they are some sort of freaks? Just because the fake biblical story talks about animals going in the Ark two by two, does not mean that we have to turn twins into some sort of human zoo to look at and study. The researchers working with the Louise Wise Services agency believed they had found a way around that. They realized that they could study identical multiples from birth, capturing their development in real time, which is exactly what they set out to do. The psychiatric advisor to the adoption agency, Viola Bernard, who was born in New York and born to Jewish parents. She justified splitting up twins as she proposed that it would help them develop their own identity, rather than competing with each other in the same household for their parents' affection. She claimed that this was backed by scientific studies of the time. I can tell you honestly, there is no such child development literature in existence, they never named studies, says Segal. Never before in documented history had twins been separated as part of policy. Bernard worked with a researcher called Peter Neubauer, then at the Child Development Center at the Jewish Board of Guardians in New York, who had long sought to study twins raised apart. Neubauer born to Jewish parents, immigrated to New York. The adoptive parents were not informed that their child had a twin or triplet, only that they were taking part in a child development study. And it was very obvious that if they did not accept the study and having the researchers come to their home periodically, they probably would not get this child, says Segal. The twins were given numerous tests, looking at a range of traits related to intelligence and personality. They were also filmed and photographed. Seckler recalls how she felt self-conscious when the researchers came to the house. My mother, she agreed because she was a psyche major and knew the importance of child development studies, she says. But the fact that it was a twin study, they weren't told the truth. From the outset, the experiment had problems. We reached out to Lawrence Perlman, who was also born to, one of the few researchers who has spoken about his brief involvement in the study when he was a postgraduate student. In his role, he would visit the twins, test them and film them. He remembers being surprised at just how similar the estranged twins

were, not just the physical appearance, but their whole personalities. It was quite clear to me that the genetic influences were very strong, he says. One young twin pair, for instance, both loved ketchup, to the delight of one adoptive mother and the frustration of the other, notes Perlman. The twins were placed with carefully selected families based on several key factors, such as their parents' ages, socioeconomic status, education, religion, and their other children. They all had an older sibling who had been adopted from Louise Wise, and that was kind of the hook that they had in terms of getting parents to agree, says Perlman. And according to Segal, it was also a way to create constant conditions across families. The study soon ran into issues and funding ran out and there were ethical concerns in the 1970s, regarding informed consent. Parents were retrospectively asked to sign consent forms, but some refused. Which fits in nicely with the last piece our team did on consent, and why it is important for everyone to grasp it. I spoke with Arthur Caplan, a professor at New York University and a medical ethics expert, who told me that the study took place during a time when, ethical violations in scientific research were all too common and he described this study as a clear case. You could really cause severe harm, marital disruption, battles down the road between children and their parents, says Caplan. The potential for harm is real, the potential for violation of basic rights, absolutely present. The distance between the twins was also ill-thought-through, as was the likelihood of their meeting later in life. The children were all placed with families living in the New York metropolitan area, at a time when communities were far closer knit than they are today. Seckler and her sister had been adopted by families living in similar social circles. In fact, their parents had known about the other twins' existence for over a decade before they met, but were asked to keep the news a secret for the good of the girls. Viola Bernard specifically advised both sets of parents not to tell their daughters, suggesting it might be too damaging, but offered little else by way of explanation. If only the too damaging comment was a consideration before engaging in devious and frankly evil practices. Other twins who were split up also met by chance, often through mutual acquaintances, as was the case for the identical triplets who met aged 19. Scientifically, the research itself was fundamentally flawed. Perlman, looking back, says that the data they collected on the children was a mess, and that the study was not well organized, and no scientific papers were ever published by Neubauer and his team. They didn't really seem to have an understanding of the proper way to handle it from a scientific viewpoint, says Perlman. They were threatened with lawsuits and nothing was published. All of which reveals the reasoning behind it was underhanded. The study did not include fraternal twins, which would have been a natural control group. Fraternal twins are composed of 2 separate eggs and sperms, while identical twins come from the same egg and sperm. Comparing identical twins to fraternal twins can help tease out the role of genetics versus environment. Even so, fraternal twins were also placed in separate families by the adoption agency. We spoke with Allison Kanter who was separated from her fraternal twin. Kanter was also a Louise Wise adoptee, but only discovered her twin recently after she watched a documentary featuring the story of the identical triplets, and curiosity led her to take a genetics ancestry test. I remember getting a shiver all over my body thinking: wow, what if this was real? There was a match with someone called Michelle Mordkoff, they met as soon as they could. Though brief, their relationship was deep, it was like a piece of me that was always missing that I never knew, says Kanter. The more we got to know each other, the



more that we realized we were similar, you know, emotionally and how we looked at life and how we lived our life. Only a few years later, Mordkoff died of pancreatic cancer, meaning that the twins had less than three years together. I think being fraternal twins, we felt we were collateral damage in this whole Louise Wise scheme. They just kind of tossed us aside, Kanter said. Was it, as Kanter questioned, all for nothing? What did happen to the data that was collected? and why are the other unwitting participants still looking for real answers about their involvement in this ill-fated study? In the name of scientific research, they essentially exploited these families without ever using the data said Lawrence Perlman. Perlman only worked on the project for 10 months, before his discomfort with the study led him to take a job elsewhere. But in the years that followed, he had wondered what happened, as only a few highly repetitive case reports containing scant details ever appeared. Eventually, in 2004, Segal and Perlman met after corresponding with each other as each of them searched for answers. Together they went to meet a 91-year-old Neubauer at his Maddison Avenue apartment in New York City. Even then Neubauer did not express any regrets, he defended the practice saying that it was Viola Bernard's idea. He was not going to acknowledge any responsibility for having done anything wrong. In the name of scientific research, they essentially exploited these families without ever using the data. An all too familiar theme, and the great question is, if it was all genuine research why isn't the data made available? the secrecy confirms there was evil intent behind the scheme. Louise Wise Services shut down in 2004, passing on its adoption and research records to another agency called Spence-Chapin. Another theme, get exposed and shift it to another front group. But even that was not the real front as this section reveals. Control of the records relating to the study, however, belongs to The Jewish Board of Family and Children's Services. In a comment to us the Jewish Board strongly denied any responsibility for the Neubauer study. A spokesperson said that, because of confidentiality laws, and out of consideration for the extremely private and personal nature of the information contained in these study records, we have limited access to the records to the study subjects themselves. They added that all of the living study subjects are now aware of their involvement. Question arise from the captain obvious involvement of Israelis in illicit practices. 1. Why is a foreign nation group allowed to experiment on other countries people? 2. Who in the Government allowed this? 3. Where was the oversight committee? 4. Was the plethora of other so-called Government Agencies involved in this as well? Given the so called experiments stated to have only been done on Jews in the camps, why would Israel be involved in this? Or is it the case as our shows have shown, they were involved in these practices in Russia during WW1 and also the camps in WW2. And to these entities they care not who are their subjects, even Jews are cannon fodder to be used and abused by these people who call themselves Jews, but they are not. The researcher requested access to footage filmed of them as young children, but was told that the twins would have to request it themselves. They were then informed that should they get access, they could not share the files with anyone else, as they may contain sensitive information about people other than the study subjects themselves. Due to the emotional toll of revisiting their past, the twins did not wish to pursue it any further. As it stands, the data collected in the study remains sealed at Yale University and cannot be opened until 2065. Neubauer arranged for the records to be locked at Yale in 1990, claiming he did this to protect the twins. Yeah right pull the other one

it's got balls on. Caplan wonders if the reason was simply to hide incompetence? why keep the records of the research under seal? I think that the only explanation I can come up with is embarrassment. I think that is an understatement and down playing to be honest, the details are clearly with malintent, and that is what they are covering up. But even if that data exists in any meaningful way, due to the ethical concerns and the flawed nature of the study, it is questionable whether it should ever be used. Segal for instance, stresses that this is a study that should never have been done in the first place. There really are no insights and we don't know a great deal about what's in there. And if we were to get access to it and publish it, what kind of message does that send to future researchers? For the families, questions persist without answers, and the experiment has cast a long shadow. No living individual has ever been held accountable. One unintended legacy of the experiment is that it provides an example of how science should not be done, and how important ethics considerations are at every stage. And for Seckler, on a personal front, she hopes that by telling her story it will make the painful twists and turns of her discovery easier to bear. Until recently, when people learned she was a twin, it would lead to inevitable questions such as: oh, that must have been so much fun growing up together, did you dress the same, look the same? Seckler says it was often easier not to revisit the emotional turmoil of the story. I would lie and say, oh yes, we dressed differently, I had to continue the legacy of this secret sister, it's been difficult. So, I'm sort of glad, that hopefully people will see this and get the story out there. While the study may have been trying to unravel the role of genes and environment on their identities, it instead exerted a toll on their lives, and that of their families that is hard to imagine. Finding their secret identical siblings changed their lives forever. The triplets involved in the study struggled with mental health problems for years after their discovery, although they also had psychiatric problems as teenagers and one of them committed suicide. It is believed their biological mother had a history of mental ill-health. Another woman from a twin pair, who was separated but not studied, is also thought to have committed suicide, her biological family also had a history of depression. It's worth noting that while stressful experiences do not necessarily cause mental ill-health, severe stress can exacerbate previous mental health issues, especially for with those who have a genetic predisposition to it. Others have experienced anger, sadness and regret at their involvement in the experiment. For some, it affected their relationships with their adoptive parents, and most of all it affected their relationship with their twin. We could never go back because we were twins but we weren't sisters, we didn't grow up together and even to this day that has been a very difficult part of our relationship. Most of all it has left those involved asking a deep question about the very topic of the intended research: how much their nature was impacted by those who split them up? A sad and sorry tale yet again of zero compassion for the people, and yet again the same ugly faces involved in the denigration of human kind. Yet again science is involved, and remember science has been controlled by the Cat-Holic church for the past 600 years. The whole of science needs a complete overhaul, of what is of value? How much harm is it causing? Are their alternative methods? What are the side effects and down sides to the research? Is it beneficial? The great question of course is, is science being ran by off world entities and or programs?

OTHER PIECES: I was curious about the acronym of DACA mentioned earlier in the show, given how I know they like to play on and with words, and put it in the public's face for their amusement. I found Dhaka which is Muslim and has obvious connections to Obama. The origin of the word Dhaka is mixed, in one case it could mean a type of tree native to the area, but another more leading meaning is, watchtower. Remember the Watchtower property on Pine Island Florida in the Cosmic Genetic shows? Which was sold by Ashayne in 2009, which curiously seemed to lead to a falloff in her demeanor and actions. The watchtower she said was linked with the Shield of Solomon, which gave me a big concern as to where that information was leading to. Obama announced the program DACA in June 2012, was he proclaiming control of the Watchtower? The Enochian Watchtowers metaphysical cults, remember the book called The Watchtower? Written by the Jehovahians. Connected to the Freemasons, OTO and other Lodges. Watchtowers are very important to the very highest Freemasons. Interesting side piece I thought, but whether Solomon's Shield or Seal was rendered mute at a future date and so negated.

This has all the echoes of the Clowns in Panic show, again using technology against we the people. This time it is to influence you to buy certain products, but if that works, what happens next? So, who has implemented this? Walgreens have started it, and so now you'll have cameras and sensors watching you and targeting you with specific ads, catered just for your estimated age and gender. The tech can also track your iris, the all seeing eye on what your eyes are looking at to determine what you're interested in, what you've picked up, if their advertising techniques/promotions are working, etc. Yet more datamining it seems with an even more negative twist. In a venture teamed up with Microsoft, a startup company called Cooler Screens have been installing their digitized cooler screens, which will no doubt eventually lead to even more tech installed on other shelves in stores across thousands of Walgreens stores. One highlight of it, according to Brooke Roller of MillerCoors: the Cooler Screens technology gives us the ability to dynamically influence the shopper at the point of purchase and get them to add beer to the basket. Because, you know, it's for the benefit of the customer, of course, but definitely not for the companies trying to sell their products. These are real endeavors by the technocratic globalists that want to keep a constant surveillance over the whole population. With efforts to tag, track and I.D. everyone, using vaccines and the Covid health passport as the reason. Many places already attempting to ostracize those who do not have proof of the vaccine, refusing them entry to their stores, restaurants, concerts, etc., They are all ourorobos people with zero future thinking, what happens when the customers don't return? Eventually all their companies who have abused and spied on us will go away, this leaves a void for the likes of us and others to fill in the gap.
