NEWS: Asking all the Communal Gatherings to get their reports in by this Sunday please for next week's show, thanks. This coming Tuesday will be the next in our Tiny show series, so look forward to that. The great irony after a judge sentences Steve Bannon for the January 6th Pelosi event, for being in contempt of Congress. Ironic since the actual Congress in America has been in contempt at best for over 100 years, and downright criminal at worst for their inability to do anything beneficial for the people.

Who is it that American people dislike the most? Yes, you guessed it: It's the establishment media. I guess people are catching on finally and turning off their utter drivel, lies and agendas. A Gallup poll released Monday found that just 34% of people believe establishment media report the news fully, accurately and fairly. That is just 2 points higher than the record low, which came during the 2016 election cycle. In total, 66% of people have little or no trust in newspapers, television, and radio news. More trouble in the so-called Holy land, as the UN tells Israel again to quit expanding settlements. Jewish West Bank settlers stormed through a Palestinian town in the occupied West Bank, the Israeli military said Thursday, throwing stones at Palestinian cars and using pepper spray on Israeli troops who were trying to disperse the settlers. The settler rampage late Wednesday comes days after a similar incident in the same area, and as Israeli-Palestinian tensions are surging over Israeli raids in the West Bank and an uptick in shooting attacks by Palestinians. Also Thursday, Palestinian health officials said a 16-year-old Palestinian died after being wounded in clashes with Israeli troops late last month. The Palestinians called a general strike throughout the West Bank in response to the spiraling violence. The rampage took place near Huwara, a Palestinian town in the northern West Bank near the city of Nablus, where a group of disaffected youth has taken up arms against Israel, and in frustration with the Palestinian leadership's close security ties to it. Oops the youth have worked out that perhaps the Palestinian leadership are also part of the problem, many of them bought off or coerced by the Mossad group. Palestinian militants in the area have carried out several roadside shootings in recent weeks. The area is home to a number of hardline settlements, whose residents often intimidate Palestinians and vandalize their property. Critics accuse Israel of turning a blind eye to settler violence against Palestinians and treating them with impunity, while being heavy-handed with Palestinian assailants or protesters. Settler violence has in the past also led to confrontations with soldiers which often sparks condemnations from politicians, but rarely leads to a solution to the problem. Politicians are part of the problem, as often they too are coerced by Israeli intelligence. The military said dozens of settlers ran through the town, throwing rocks at Palestinian cars. The settlers used pepper spray on the battalion commander as well as another soldier. The settlers sprayed another two soldiers at a nearby checkpoint, the military said. Notice again it is the youth who have had enough, if only their elders showed the same fight and spirit to fix things. Although I would never advocate violence, but they have to live with atrocities committed against them day after day, whilst the world sit their like lemmings.

But the violence didn't end there. The racist, genocidal apartheid fake state is doing what it does best, killing and destroying again it has been revealed. At least three Palestinian civilians have been killed and 19 others wounded early Tuesday morning, as a result of the use of live bullets by the Israeli army in an operation in Nablus, in the northern West Bank. Red Crescent emergency director in Nablus, Ahmed Jibril, said that medical teams have treated 22 people, of whom three have died and 19 are wounded. The wounded have been transferred to several hospitals. Three of the victims are in serious condition, according to the Palestinian news agency Wafa. The agency said that the Israel Defense Forces (IDF) had stormed several neighborhoods in the old city after it was shelled. Gunfire and explosions were reportedly heard. According to Wafa, the Israeli soldiers had received military reinforcements and were supported by drones. Drones are cowardly fighting in my opinion, and is indicative. In addition, the soldiers allegedly deliberately opened fire on members of the Palestinian security forces and prevented emergency teams from passing through to transport the wounded. For their part, the IDF announced in a statement issued at midnight tonight that they are

carrying out an operation in Nablus, without giving further details at the moment. These operations by Israel come after the Palestinian armed group known as the Lion's Den, a relatively new organization operating mainly in the West Bank, allegedly carried out a series of attacks against Israeli military and civilians. A Palestinian group called the Lion's den? Who are unknown? Lion of Judah ring a ba'al? The great question is; was it done by Israeli agitators? The armed group claimed Sunday that one of its top leaders, Tamer Kilani, was killed in an Israeli operation when a limpet bomb on a motorcycle exploded. Palestine has warned early Tuesday of new crimes by Israeli soldiers, while calling for a halt to attacks on civilians. The Council of Ministers has called on the United Nations and international human rights organizations to intervene urgently, to stop the aggression in which the occupation forces are using anti-armor missiles and drones to target civilians from their homes, the Cabinet said in a statement carried by Wafa. The recent attacks against the besieged town of Nablus has resulted in the death of three people and several wounded for the time being, the missive continued. Likewise, the spokesman of the presidency, Nabil Abu Rudeina, has affirmed that from the presidential office they are making urgent contacts to stop the aggression. Abu Rudeina described the attack on Nablus as a war crime and blamed the Jerusalem government for the repercussions of this aggression. In this regard, Palestinian President Mahmoud Abbas stressed that the current situation is an apartheid state, and criticized the international community, led by the US administration for practicing double standards. It must intervene immediately to stop the aggression and put an end to this occupation before things become much more dangerous than Israel and the United States imagine, Abbas warned, according to his spokesman. A simple solution to this I came up with 30-40 years ago. Assemble a UN based military not affiliated to pre-dominant countries, a true independent army. Move Israel back to 1947 borders and police it. Any violence on either side, they lose territory as a punishment. It seems that the EU opposition is growing against NATO and their patsy-based countries. As former Italian Prime Minister Silvio Berlusconi claimed that Kiev triggered a conflict with Russia by renegeing on a peace plan for eastern Ukraine, a tape provided to the media suggests. In an apparent response to the leak, Giorgia Meloni, who has been tasked with forming a new Italian government, stated that people who do not share a pro-NATO stance would have no place in her coalition. SOCIETY AND OP-ED NEWS: Dozens of New York Astoria residents took to the steps of City Hall urging rejection of the sweeping Innovation QNS project, saying the development would drive up rents in the neighborhood and force them from their homes. If approved by the City Council next month, the \$2 billion rezoning would make way for a dozen new residential and commercial towers in Astoria, with nearly 3,000 apartments, two acres of green space, restaurants, stores and a movie theater. Farihah Akhtar, a lead organizer with the activist group CAAAV, said

that the prospect of the project being approved is leading landlords in the area to begin pushing out long-standing tenants, in an attempt to raise rents and further gentrify the neighborhood. This is about who gets to live in Queens, who gets to live in New York City and nobody is safe from displacement, she said. Small businesses that we work with have already had their rents jacked up, even though the rezoning proposal hasn't even been approved. Yes, New York, California and other rich areas are moving and, in some cases, forcing people out of their money zones. If people have the courage, then best thing to do is leave and watch it sink. People with lots of money don't understand finances and its implications too well. Who will work or provide for them with no lower end pay scale people left?

As Los Angeles rages over racist comments and has tried to play them down, because it didn't paint whites in bad light, which is a media agenda. Officials in Los Angeles are struggling to contain the fallout, stemming from the leaked audio of racist comments made by former City Council President Nury Martinez that forced her to resign. On Tuesday and Wednesday, the council held virtual meetings to try to move forward from the Martinez scandal, after angry protesters disrupted in-person meetings at City Hall last week. But the topic, nearly all the callers wanted to discuss during the public comments portion of both meetings was the leaked audio involving Martinez, a Hispanic who hurled crude and racist comments against Blacks and Americans of Oaxacan descent during a private meeting held in October 2021. Much of the anger was directed at council members Gil Cedillo and Kevin de León, both of who did not attend either meeting, for their involvement in the Martinez scandal, with several callers demanding their resignations. So far, the two men have refused to step down. Both chaired high-profile committees that dealt with housing and homelessness before being stripped of their duties this week. During Wednesday's meeting, a representative from the L.A. County Business Federation, an alliance of 220 organizations representing over 410,000 employers in the city delivered a stark message to Cedillo and de León. Your residents and our own colleagues have spoken, she said. It's time for you to step down so that our city can move forward, and begin to heal and finish tackling the many important issues that have been placed on hold, because of your refusal to do the right thing for the city. You're proving yourself completely unfit for office, and we're calling on you to step down now. Christian Green, a sociology and African American History professor at Cal State University, Dominguez Hills, said during the meeting that the past week was a total disgrace and disheartening, adding it was mind-boggling to see Cedillo and de León maintain their seats on the council. We deserve more than an apology, Green said. We keep talking about the word healing, but we cannot heal without facing the truth. What these elected officials did was revolting, repelling, repulsive, sickening, uninviting, and unsavory. Khansa Jones-Muhammad, a Black commissioner on L.A.'s reparations task force, called into the meeting in her capacity as a regular citizen, decrying out the institutional racism that still exists. Racism from the city's leadership will, in no way, be tolerated by Black Angelenos, she said. Until we accept all people are being played, blamed, shamed and guilted by this program, then institutional racism in all colors will prevail. Personally I don't think it is anything to do with racism, and more to do with geneticism and latent DNA memory. It makes no overall sense how people of all colors have a dislike of other colors, unless there is something

A refreshing change to see, and when you throw in the youth in the slightly older bracket, who are also dumping Facebook and others, also not tolerating poor working conditions and pay, and again they are not participating in religion. This augurs well for the future, that some of the youth will not play their trap game. Next stop I would wish to see is, the drastic reduction of the video games and all the mind control that brings.

Here is a piece written by John Whitehead of the Rutherford Institute that spells it all out very similar to THI. As scientists at Boston University claim to have created a new variant of Covid-19 with an 80% mortality rate, by combining the highly-transmissible Omicron variant of the coronavirus with the original Wuhan strain. The research, which echoes experiments thought to have created the virus in the first place, has caused outrage. Why? just why would you do that? Who approved it? And where is the oversight on these types of entities? In a research paper published last week, the scientists explained that they isolated the spike protein of the Omicron variant and combined it with the backbone of the original strain that circulated in early 2020. This created a virus that robustly escapes vaccine-induced immunity and inflicts serious disease on laboratory mice, 80% of whom died during testing, the paper stated. While the team admitted that their mutant strain would likely be less deadly in humans than mice, they found that it produced five times as many virus particles in lab-grown human lung cells when compared to the Omicron variant. The paper has yet to be peer reviewed. News of the research caused outrage online, as it is widely believed that similar gain-of-function research, a term describing the alteration of a pathogen to enhance its potency at the Wuhan Institute of Virology in China led to the global Covid-19 pandemic. The US funded such research at the Wuhan Institute, although it is still unclear whether the specific coronavirus that caused the pandemic originated in the lab. This should be totally forbidden, it's playing with fire, said former Israel Institute for Biological Research head Shmuel Shapira said of the Boston experiments. How many times did virologists say they were not making chimeric SARS viruses more deadly? How many? reporter Paul Thaker tweeted. The Boston team aren't the only scientists returning to potentially dangerous research in the aftermath of the pandemic. EcoHealth Alliance, the private company responsible for much of the Wuhan Institute's pre-2020 gain-of-function research, was awarded a \$650,000 grant by the US last month to study the potential for future bat coronavirus emergence in Myanmar, Laos and Vietnam. EcoHealth Alliance also came up in the Expose series that was all related to Covid. It was nice to hear an Israeli argue against it, more so given the fascist way their rulers implemented dangerous jabs on their people. As for the scientists, someone needs to rein those complete psychopaths in, once and for all.

Here are why those psychopaths need reigning in. The latest figures published by the USA's CDC reveal nearly 58,000 children have been injured due to Covid-19 vaccination across the USA, and sadly 1,201 of these children either suffered a life-threatening event or a permanent disability. While tragically a further 163 children have sadly lost their lives as of September 29th, 2022. The CDC's latest report reveals that at least 57,622 children (Aged 0 to 17) have suffered an injury due to Covid-19 vaccination as of September 29th 2022. The Janssen vaccine is responsible for 1,358 of these injuries, the Moderna vaccine for 10,751 and the Pfizer vaccine for 45,425. The CDC also reveals that 14,728 children have either visited a hospital or been hospitalized due to an injury caused by Covid-19 vaccination. The Pfizer vaccine has caused 13,636 children to be hospitalized,

the Moderna vaccine 1,001 and the Janssen vaccine 62. Of the 1,201 children that have suffered a life-threatening event or been left permanently disabled due to Covid-19 vaccination. The Pfizer jab has nearly killed or permanently disabled 1,073 children, the Moderna jab 119 children and the Janssen jab 4 children. With at least 163 children have lost their lives due to Covid-19 vaccination. The Pfizer vaccine has killed 143 children, whilst the Moderna vaccine has killed 20 children. In all categories Pfizer is the worst. What's even more unfortunate is that these figures do not illustrate the true consequences of Covid-19 vaccination among children. This is because the CDC estimates just 1 to 10% of adverse events are actually reported to VAERS. Again not enough outrage over this, as people would sooner just hide from the truth, rather than admit they were wrong. As adults, it is their own faults, but the damage to their children is also their responsibility. And whilst it won't bring back those lost or permanent disabled, your voice can stop that happening to other children.

An Israeli Report: The mRNA experimental vaccine from Pfizer killed about 40 times more elderly people than the disease itself would have killed during a recent five-week vaccination period, it has been revealed. World Health Organization European Advisory Group of Experts in Immunization former Vice President Professor Christian Perronne this week said that, all vaccinated people must quarantine over the winter months or risk serious illness. Perronne specializes in tropical pathologies and emerging infectious diseases. He was Chairman of the Specialized Committee on Communicable Diseases of the High Council of Public Health. A major Indian vaccine manufacturer was forced to toss out 100 million expired booster doses of its Covid-19 shots due to unexpectedly low jab uptake. Serum Institute of India, the world's largest vaccine producer, has been making India's version of AstraZeneca's mRNA Covid shot. While roughly 298 million doses of the booster shots have been administered in India since the initial rollout, another 100 million doses in stock expired in September and had to be destroyed. The Indian government had attempted to offload the shots in July, by launching a marketing campaign to provide free booster shots to adults for 75 days to mark India's 75 years of independence. However, the effort failed to generate sufficient uptake. How desperate and embarrassing is that? Using a celebration event to market death jabs. On Thursday, SII CEO Adar Poonwalla said, his company had stopped making Covid-19 shots in December of last year due to a major shortfall in public interest. So, they knew it was not going well and stopped making them. Though India has administered two billion total doses of the shots, according to Poonwalla, there is no demand for the company's booster shots as people now seem fed up with Covid. Not fed up Mr. Poonwalla, they are knowledge based, they know it was all based on a lie and a shekel making exercise, aligned with interfering with their DNA. All of which will have permanent and lasting implications.

More good news on the vaccine front. As Michigan Democratic Gov. Gretchen Whitmer signaled opposition to mandating coronavirus vaccines for children to attend school during Michigan's final gubernatorial debate before Election Day. Whitmer was asked during Tuesday's debate about new guidelines by the Centers for Disease Control and Prevention (CDC) urging children to be vaccinated against the coronavirus. I do not support requiring the COVID vaccine for children, said Whitmer. The flip-flopping nature of elected officials knows no bounds it seems, one would almost think there must be an election coming up with the flip-flopping. Oh wait! There is, classic politician stance. But also reveals they are playing to their audience, who no longer want jobs.

EXPOSE: Often things that appear to be new events have turned out via our shows to be anything but new. Indeed these events are far from new and far from one off events either. History to our story is riddled with such repeat events, throughout many epochs of time, and not just our lifetime either. We touched on this piece in Expose Part 5 briefly, but this widens it out and asks more questions. So this piece will come as to no surprise by our regular listeners, but raise eyebrows to those tuning in as new listeners. This has all the hallmarks of between March 2020 and right up to today. We go back 121 years, when in 1901 a deadly smallpox epidemic tore through the Northeast, prompting the Boston and Cambridge boards of health to order the vaccination of all residents. But some refused to get the shot, claiming the vaccine order violated their personal liberties under the Constitution. One of those holdouts, a Swedish-born pastor named Henning Jacobson, took his anti-vaccine crusade all the way to the U.S. Supreme Court. The nation's top justices issued a landmark 1905 ruling, that legitimized the authority of states to reasonably infringe upon personal freedoms during a public health crisis, by issuing a fine to those who refused vaccination. Notice it took them a 4 year loop to make a decision, by which the alleged virus has likely disappeared. Be interesting to note members reaction to this question; how many people realized vaccines went that far back? In 1901, the city of Boston registered 1,596 confirmed cases of smallpox, a highly contagious, fever-inducing illness infamous for causing a severe rash on the face and arms, that often left survivors scarred for life. In Boston alone, 270 people died from smallpox during the extended 1901 to 1903 outbreak. That's why public health officials in Boston and neighboring Cambridge issued their compulsory vaccination orders, hoping to reach the 90 percent vaccination rate required for herd immunity. Herd immunity? Why has no one challenged that terminology? We are not sheep or cattle and so the herd does not apply to us. Nobody says, oh look there is a herd of humans in the shop or restaurant, so just why is that used in that way? Jacobson, who served as the pastor of a Swedish Lutheran church in Cambridge, had been vaccinated against smallpox in Sweden when he was 6 years old, an experience that he later said caused him great and extreme suffering. So when Dr. E. Edwin Spencer, chairman of the Cambridge Board of Health, knocked on the Jacobsons' door on March 15, 1902, the pastor refused vaccination for himself and his son. A few months later, Cambridge was in a full-fledged smallpox panic with the city ordering the closure of all schools, public libraries and churches to stem the spread of the disease. Police officers accompanied health officials like Spencer, who went door to door vaccinating as many as 100 people a day. One wonders did Dr. Spencer turn up in an avian

mask and suit, or looking like the grim reaper! But while the Cambridge vaccine order was compulsory, it wasn't a forced vaccination. People like Jacobson who refused to get vaccinated faced a \$5 fine, the equivalent of nearly \$150 today. On July 17, 1902, Dr. Spencer issued a criminal complaint against Jacobson and other anti-vaccine activists to collect that \$5 fine. The broader battle over the validity of vaccination science reached a fever pitch during the smallpox outbreak. Anti-vaccination groups, citing alleged cases of death and deformity from bad reactions to smallpox vaccine, called compulsory vaccination the greatest crime of the age, claiming that it slaughter[s] tens of thousands of innocent children. In response, newspaper editorials characterized the smallpox vaccination controversy as a conflict between intelligence and ignorance, civilization and barbarism. The New York Times dismissed anti-vaccine activists as a familiar species of cranks, who were deficient in the power to judge science. We are about 1/3 of the way through this piece lets count up the parallels shall we. 1. Mysterious disease 2. Panicked authorities 3. Authorities exhibiting their power 4. Herding 5. Compulsory although not 6. Media bias and calling people names for not going along with their script 7. Justice depts supporting it and 8. The name Cambridge, whether analytical or not. What a nice mobius loop of repeated traits that is, yet 119 years apart. It was against this heated backdrop that Jacobson fought his \$5 fine, first in a state trial court and then by appeal in the Massachusetts Supreme Judicial Court. Jacobson wanted to present evidence that vaccines themselves were dangerous and ineffective, but the judges wouldn't hear it. Instead, Jacobson's chief argument became, compulsion to introduce disease into a healthy system is a violation of liberty, specifically the personal liberty he believed was guaranteed by the U.S. and Massachusetts constitutions. The highest court in Massachusetts also rejected Jacobson's claims, siding instead with the authority of public health officials to determine the best methods for fighting an epidemic. Not ready to give up, Jacobson appealed his case to the U.S. Supreme Court in 1905, where he was accompanied by officers of the Massachusetts Anti-Compulsory Vaccination Association. In the case known as *Jacobson v. Massachusetts*, Jacobson's lawyers argued that the Cambridge vaccination order was a violation of their client's 14th Amendment rights, which forbade the state from depriving any person of life, liberty, or property, without due process of law. I remember some stating the 14th Amendment in parts didn't exist, yet it was here being used in 1905. At question, then, was whether the right to refuse vaccination was among those protected personal liberties. The Supreme Court rejected Jacobson's argument and dealt the anti-vaccination movement a stinging loss. Writing for the majority, Justice John Marshall Harlan acknowledged the fundamental importance of personal freedom, but also recognized that; the rights of the individual in respect of his liberty may at times, under the pressure of great dangers, be subjected to such restraint, to be enforced by reasonable regulations, as the safety of the general public may demand. This decision established what became known as the reasonableness test. Haha the reasonable test being enforced by people who are unreasonable. No common sense, no logic and definitely no reasoning. The government had the authority to then pass laws that restricted individual liberty, if those restrictions, including the punishment for violating them were found by the Court to be a reasonable means for achieving a public good. Bottom line, there had to be some kind of real and substantial connection between the law itself and a legitimate purpose, which was the public's health, safety and welfare, says Anthony Sanders at the Institute for Justice.

Another example of using a pandemic, false flag event to bend rules against we the people. The Jacobson decision provided a powerful and controversial precedent for the extent of government authority in the early 20th century. In 1922, the Supreme Court heard another vaccination case, this time concerning a Texas student named Rosalyn Zucht who was barred from attending public school, because her parents refused to have her vaccinated. Another such incident happened in Feb 2022 at another hospital in Texas, where a teenager was denied surgery, and almost denied even basic appointments and lab work, due to his being unvaccinated. Another coincidence it seems. Zucht's lawyers argued that the school district's ordinance requiring proof of vaccination, denied Rosalyn equal protection of the laws as guaranteed by the 14th Amendment. The Supreme Court disagreed. Justice Louis Brandeis wrote in the unanimous decision: Long before this suit was instituted, *Jacobson v. Massachusetts* had settled that, it is within the police power of a state to provide for compulsory vaccination. Within the police power of a state? This is another example of words not being looked at closely and being by-passed. The police are the power of the state? Said whom? Police have the authority to force vaccinate people against their will? All very Fascist forms of governance that is. These ordinances confer not arbitrary power, but only that broad discretion required for the protection of the public health. If they were interested in the public's health, they would have addressed the 3rd leading cause of death, medical malpractice, injuries, harm and death of drugs and vaccines, the criminal overcharging of medical insurance which costs people their health or the toxic substances they are putting in our bodies as well. They have done none of those, and so proves they are not interested in our health. In a far darker chapter, the Jacobson decision also provided judicial cover for a Virginia law that, authorized the involuntary sterilization of feeble-minded individuals in state mental institutions. In the 1920s, eugenics enjoyed wide support in scientific and medical circles, and the Supreme Court justices were not immune. In the infamous 1927 case *Buck v. Bell*, the Supreme Court accepted the questionable facts presented in the lower court cases, that a young Virginia woman named Carrie Bell hailed from a long line of mental defectives whose offspring were a burden on public welfare. If only that was applied to bloodline families, the Jewish EL-ites, Royalty and other nobility lines. The principle that sustains compulsory vaccination is broad enough to cover cutting the fallopian tubes *Jacobson v Massachusetts*, 197 US 11. Three generations of imbeciles are enough, wrote Justice Oliver Wendell Holmes in a chilling opinion. All judges and lawyers are imbeciles, they operate under legalese, which is the language of babble or baby talk, and so are deemed mentally incompetent to operate any official positions. The Buck decision opened the floodgates and by 1930, a total of 24 states had passed involuntary sterilization laws and around 60,000 women were ultimately sterilized under these statutes. Land of the brave or is it slave? Home of the free? You surely jest with that statement, all of it is more theater-based illusionism. *Buck v. Bell* is the most extreme and barbaric example of the Supreme Court justifying a law in the name of public health, says Sanders. A lot changed since 1905, including the ways in which the Supreme Court decides if certain laws and statutes violate an individual's constitutional rights. Starting in the second half of the 20th century, the Court began to recognize certain constitutional rights as fundamental, including the freedoms of speech and religion, and personal decisions about marriage, contraception and procreation. Near the beginning of the Covid-19 pandemic, as states

issued lockdown orders that closed businesses and prohibited large gatherings, several judges justified those restrictions by citing *Jacobson v. Massachusetts*, since it was the most recent Supreme Court ruling explicitly addressing state powers during a disease epidemic, even if it was 115 years old. But in a reversal, the Supreme Court ruled in 2020 against broadly applying the logic of *Jacobson* to all Covid-19 lockdown restrictions. In *Roman Catholic Diocese Of Brooklyn, New York v. Andrew M. Cuomo*, the Court decided that the State of New York violated the constitutional rights of citizens, wanting to safely gather in churches and synagogues during the pandemic. The reasoning was that the lockdown laws barred religious gatherings altogether, while still allowing secular business to operate at limited capacity. *Jacobson* hardly supports cutting the Constitution loose during a pandemic, wrote Justice Neil Gorsuch for the 5-4 majority. That decision involved an entirely different mode of analysis, an entirely different right and an entirely different kind of restriction. As vaccines against Covid-19 became readily available across the United States in 2021, employers, including government agencies, hospitals and health care systems and private corporations, started to mandate the shots among its employees. This followed a joint statement from major medical groups encouraging the policy. On July 26, 2021 the U.S. Department of Veterans Affairs announced it would require its frontline health care workers to get inoculated, making it the first federal agency to mandate that employees be vaccinated against the coronavirus. All of which reveals the VA is not what you think it is. It appears to me to be a government control group and another patsy organization to keep the lid on things. Three days later, on July 29, 2021, President Biden announced all federal workers and contractors must be vaccinated, or else face weekly testing and other mandates. In November, Biden added another mandate that required employers with 100 or more employees to ensure that, each of their workers is fully vaccinated or tests negative for Covid-19 at least once a week. All of the vaccine mandates affecting the private sector were put on hold, as legal challenges made their way through the courts. The problem is people largely ignored the events in 1901 and 1922, and so it is burdening future generations with the same levels of tyranny. That is what this medical imposition on peoples live is, tyranny and Zionist Fascism. No government or the police should ever have the power to impose sanctions, fines, mandates or compulsory orders or restrictions on people exercising their free will right to their own body. That in overview is playing god with the people, and that is not and should never be the remit of any form of government.

EXPOSE: The modern day thinking of the term biological weapons is often thought of in more recent time spans than in the past. Yet, we have detailed the use of them in America with the 1919 Spanish flu created epidemic by the US Military on the soldiers and the populace. We have also documented during WW2 the biological atrocities done by the Japanese on mainly the Chinese, only to get a free pass on it due to American military and or agencies acquiring the knowledge of such weapons, and indeed the use of torture. But we are about to highlight something that took place 74 and 75 years ago at was the prelude for further atrocities in the region, that is still being felt globally today. That state is now known as Israel, but this started before the fake state was declared by Britain, Rothschild's and other prominent Jewish El-ites. The details of Israel's secret use of biological weapons and poison against Palestinians during the 1947/48 ethnic cleansing

campaign, has been revealed in a recent article by historians Benny Morris and Benjamin Kedar. The 84-year-old Kedar is professor emeritus at the Hebrew University of Jerusalem and the more well-known Morris is famed for his work as one of Israel's New Historians. This group of Israeli scholars, including Professors Ilan Pappé and Avi Shlaim, dismantled the occupation state's official narrative about its creation in 1948 and the birth of the Palestinian refugee crisis. One must commend these people highly, for having the balls to go against the official narrative, along with the threats, harassment and denigration that generally follows going against any story or script Israel puts out. However, unlike his fellow historians, Morris went on to become a rather controversial figure for adopting morally questionable positions in defense of Israel's ethnic cleansing of Palestine. I find myself as convinced as ever that the Israelis played a major role in ridding the country of tens of thousands of Arabs during the 1948 war, said Morris in an article in the Los Angeles Times about the controversy surrounding his book, *The Birth of the Palestinian Refugee Problem, 1947-1949*. I guess Morris was got at, and I fail to see how he can be allowed to write or say such obvious terrorism and not be pulled up for it? "Ridding the country of tens of thousands of Arabs," that was justifying genocide! and it was their country let's not forget. For unearthing that dark side of 1948, Morris said that he was vilified by the Zionist establishment. He was accused of shattering the founding myths of the Israeli state and lending moral weight to the Palestinian cause. Morris rejected the claim as untrue and explained that he was simply a historian seeking to describe what happened. Shattering the myths of the Israel state? Affirming his commitment to Zionism, however, Morris went on to defend Israel's ethnic cleansing, before giving his justification for why Israel had to expel three quarters of the indigenous non-Jewish, Muslim and Christian Palestinians. I also believe the Israeli actions were inevitable and made sense. Had the belligerent Arab population inhabiting the areas destined for Jewish statehood not been uprooted, no Jewish state would have arisen. The sheer irony of calling someone else belligerent, me doth thinks they protest too much by their own belligerence and distorted his story. Had we not done that, it would have emerged so demographically and politically hobbled that it could not have survived. It was an ugly business, such is history. The flippant way that was described says it all really, these power hungry parasitic harvesters trample over anything and everyone it seems, with impunity from the rest of the world. Morris's argument is typical of many Israelis who find themselves trapped between, the truths about Israel's creation and remaining committed to the Zionist cause. Some abandon the ideology which preserves a Jewish ethno-nationalist state in historic Palestine because of the moral dilemma it presents. Others continue to insist that the Zionist cause supersedes all moral and ethical considerations, even if that means justifying ethnic cleansing, racism and the crime of apartheid. Therein lies the problem and the proof of their win at all costs policies. In light of his background, Morris's take on Israel's use of biological weapons and poison is all the more interesting. His article with Kedar - *Cast Thy Bread: Israeli Biological Warfare during the 1948 War* was published by *Middle Eastern Studies*. According to *Haaretz*, the article is a rarity because it was researched and published against the wishes of the Israeli security establishment, which has tried for years to block any embarrassing historical documents that expose war crimes against Arabs, such as murdering prisoners, ethnic

cleansing and destroying villages. They get away with it because by and large the rest of the world ignores it, or waits until it happens in their country, hello Britain and hello America. Moreover, the article is based on original documents stored in the Israel State Archive as well as other archives. The article provides details of how scientists from the Scientific Corps, together with battlefield units, who were involved in a systematic campaign to poison water wells and spread typhoid bacteria in Arab villages and cities, as well as among the invading armies of Egypt and Jordan. The objective was to frighten the Arab-Palestinian population, to force them to leave and to weaken the Arab armies. It is claimed that the use of biological warfare was approved by the founder of the Israeli state and its first Prime Minister, David Ben-Gurion. Among the examples of the use of poison discussed in the article is the deployment of typhoid germs sent in bottles to the southern front. Morris and Kedar shed light on the Israeli soldiers sent with the poison to Acre and the Galilee village of Ilabun. According to British, Arab and Red Cross documents, dozens of local residents of Acre were poisoned and became severely ill. An unknown number of them died. The same method is also said to have been used in Gaza in May 1948, a week after Israel proclaimed its independence. Proclaimed its independence? Or in truth terms arranged a hostile theft and takeover of other people's lands. Apparently two Jewish soldiers from a Special Forces unit posed as Arabs and infiltrated Gaza with tubes containing the typhoid germs. Their mission was to poison the local water supply to stop the advance of the Egyptian army. However, they were arrested and tortured, and then sentenced to death by an Egyptian military court in August 1948. The use of biological weapons has been illegal for nearly a century, since the 1925 Geneva Protocol. This prohibits the use of chemical and biological weapons in international armed conflicts. Although Israel, Egypt, Somalia, Eritrea and Comoros have refused to commit to the protocol, 183 other states have done so. Yet the other 183 states all ignored the use of the said weapons? all based on some myth surrounding WW2 and some fake his story book written by Jewish priests and later by Crown agents in Britain. While Israel has never publicly admitted to the use of chemical weapons it has been caught red-handed on several occasions. One such was the botched attempt to assassinate Palestinian political leader Khaled Meshaal in Amman, on 25 September, 1997. The brazen attempt on the life of the then 41-year-old head of the Hamas Political Bureau sparked a diplomatic row, which threatened to wreck the peace deal between Jordan and Israel. The crisis ended with Israeli Prime Minister Benjamin Netanyahu making a number of humiliating concessions. A six-member Mossad team arrived in Amman a week before the assassination using false Canadian passports. The plan was clear: kill the exiled Hamas leader using a lethal toxin without leaving any trace of the killers. The idea was that after the toxin had been administered covertly, Meshaal would go about the rest of his day as normal and then, when tiredness overcame him, he would take a nap and never to wake up again; he was expected to die within 48 hours. Two of the Mossad agents delivered the toxin as planned but were captured by Meshaal's bodyguard while trying to flee from the scene. Hours after the arrest of the agents, the Israelis hatched a plan to diffuse the situation. With the diplomatic consequence of his actions dawning on him, Israeli Prime Minister Benjamin Netanyahu attempted to conceal the botched assassination attempt from the rest of the world. He dispatched Mossad head Danni Yatom to plead with King Hussain of Jordan for the agents' release. He failed to diffuse the situation and instead

sparked a diplomatic crisis with the Hashemite Kingdom, which had normalized relations with the Zionist state three years earlier. More fool them, any state or kingdom normalizing anything with that state, has just signed a death warrant for their state and their peoples. The King had gone out on a limb to sign a peace treaty with Israel against the wishes of his people. Following pressure from the US and under the threat to the peace treaty, the Israelis delivered the antidote. Meshaal was saved with just hours to spare. Remember they did the same to Yasser Arafat in 2004, as people still insist he was murdered by poisoning by Israeli elements. OTHER PIECES: Prehistoric stone tools found in a cave in Poland 50 years ago, have just been identified as some of the oldest ever discovered in the region. The tools from the Tunel Wielki cave in Małopolska are between 450,000 and 550,000 years old. This dating may allow scientists to learn more about the humans who made them, and their migration and habitation in Central Europe across prehistory. I thought the Roman cult church said life started 6K years ago? (M) I guess they have never heard of Gobekli Tepi? For example, the timeframe likely means that the tools were made by extinct human species *Homo heidelbergensis*, usually considered the last common ancestor of Neanderthals and modern humans. It means the region was inhabited by humans at a time that Central Europe's harsh climate would have required significant physical and cultural adjustment. Tunel Wielki cave was excavated in the 1960s, with archaeologists returning again to the site in 2016. Layers of material were dated to the Holocene, dating back to around 11,700 years ago, and the Middle Paleolithic stretching as far as 40,000 years ago. But archaeologist Claudio Berto thought the dating was at odds with what he was observing. Animal bones recovered from the site, he concluded, were almost certainly older than 40,000 years. So, in 2018, Kot and her team returned to the cave. They reopened and extended one of the trenches, carefully examining the different layers of material accumulated over the years and collecting more bone material to analyze. They found that the upper layers did indeed contain the bones of animals that lived in the Late Pleistocene and the Holocene, but the bottom layer was distinctly older. It contained the bones of several species that lived half a million years ago: the European jaguar, *Panthera gombaszoegensis*; the Mosbach wolf, an ancestor to modern gray wolves, *Canis mosbachensis*; and Deninger's bear, *Ursus deningeri*. They confirmed the arrangement of layers described by researchers half a century ago. We also discovered more production waste and animal bones. Previously, she added, there were only two known sites in Poland with tools from around the same time period: Trzebnica and Rusko. But the Tunel Wielki cave artifacts are different. Several archaeological sites in the area show evidence of ancient human habitation, but they are

all open-air sites. To find artifacts dating from that time in a cave is was very unexpected. We were surprised that half a million years ago people in this area stayed in caves, because those were not the best places to camp, she noted. How would they know the conditions of such a time period, when scientist methods on that is speculative at best? We found traces that may indicate that the people who stayed there used fire, which probably helped tame these dark and moist places. Also, of interest was the technique used to knap the flint found in the cave. This technique is the simplest used by ancient humans, and, at the time the tools were created, rarely used as a primary mode; usually, it was only used on poor-quality materials, or when flint was in short supply. Only one other site, Isernia La Pineta in Italy, was using the technique as the primary one. The Tunel Wielki flint was not poor quality, nor was it scarce, being locally obtained. This was also the case for Isernia La Pineta; finding a second site with the same characteristics might help archaeologists work out the reason these ancient humans used that specific technique. Next, the team hopes to return to the cave to try and search for bones of Homo heidelbergensis. Will the paleontology or archeology divisions revise their times, dates, records of man and its existence going back hundreds if not millions of years here? or continue to tow the party line that, all life came from Africa six thousand years ago. What did come out of Africa was, the Draconian/Marduk/Anu/Enki and Enlil lineage.

Probably because the story line can only appear in small snippets, as larger ones would perhaps bring more scrutiny. Genesis 6 says the Nephilim were the offspring of the sons of God and daughters of humans, and were basically a new being, some say the sons of God were angels. Who were the actual sons? Does it say? I pondered on the words Nephilim, like Elohim, take the im out, which is probably part of a title, like Tut – ankh – amun, and we are left with Eloh and Nephil. El and Il means god so we are left with Oh and Neph. Neph means the cloud. In ancient Greek mythology Elektra was one of the Okeanides; the water-bearing cloud children of Okeanos (the ocean) and Tethys (a sea goddess daughter of Gaia ie. earth, world). Elektra is the goddess of stormy clouds, which draw their moisture up from the sea. They have also been described as giants in some versions of the Bible. We are left with im and the first documented use of im to become I'm, which is a shortened version of I am, was in 1584, called the Time Traveler. I'm a traveler of time and space ring a ba'al? Moses' wife, Zipporah, is mentioned in the Bible four times. But we don't really know much about who she was, other than she was maybe a Cushite (i.e. an African), which brings in the Kanye West statement again, Cush was a large area in Africa, which included modern-day Sudan and Ethiopia and an interracial marriage would have been quite something back then. But they have deliberately changed the letters again with cush spelt with a c, but these are the nomadic wanderers from the Southern border states of Russia, and in particular around Afghanistan and spelt with a K. Kush with a k is also a slang term for cannabis, and this maybe a stretch on words but you never know with the history revision of these people. Canna means cane or reed, is bis short for Ibis, rendering canna(I)bis the plant of Cain and Thoth? As Thoth is represented by the ibis or bennu bird given their similarities. The Ibis is the enemy of serpents. Ibis is a lesser Stygian god, opposed to Set. The priests of Ibis were driven from Stygia ages ago by the snake-worshippers of Set. Stygia means moth, owl and butterfly, but is also the body of water that ran into the River Styx, the underworld realm of Hades just south of Luxor in Egypt. Josephus states that Moses used the Ibis's ability to repel serpents to triumph against Ethiopia. Cush with a c mentions Ethiopia, where today is a high level presence and prominence of the Jewish, who were said to have brought the Ark there, because that was the site of the 4th Garden of Eden, their Eden not ours. All of which means Moses, which is a title, fought the Ethiopians and imposed not cush with a c rule, but kush with a K. The ibis predominantly symbolizes the human soul. It is connected with the afterlife, with transit between the worlds of the dead and the living and with purity. Which is more fake Egyptian style conspiracy and why going with animal totems is a dangerous practice. The animal totems were either created by or usurped by these fake gods and their emissaries. The mention of it connected to the human soul and the afterlife and transit between worlds, all wrecks to me of host possession again.

Here is this week's pondering and overview, perhaps you should mentally tick all the boxes of whether you see or feel each line or statement is being borne out. Five months ago, this week THI members undertook an epic journey across Arizona for some field work. It was a successful challenge we took on and the preceding 5 months as rendered some interesting results for the people. The overview always brings clarity and the time in between has rendered positive results in so many ways. The old system has now reached a critical point of total collapse. Their public viewing is not rendering the results they wish. Their standing with the public is not garnering the fear and apprehension it once did either. Their truth blocking with factcheckers and social media banning has not worked either. Their governments are falling apart in many countries, not just the more obvious ones.
