A team led by Rice bioengineer Isaac Hilton and graduate student Kaiyuan Wang used deactivated Cas9 (dCas9) proteins to target key segments of the human genome and synthetically trigger the transcription of human genes. By using dCas9 to recruit proteins that can naturally turn genes on, the Rice team was able to reveal important details about human promoters and enhancers, the pieces of our DNA that coordinate when, and to what extent, our genes are turned on, which in turn controls the behaviors of our cells. Which means if they can turn them on, they can also turn them off. Hilton said: We're using these synthetic biology tools to improve the ability to engineer gene expression and program human cells, and consequently to better understand how our genes work naturally. Engineer gene expression means to manipulate them, program human cells is also manipulating them to their taste or liking. What they are revealing here is the permanent altering of our DNA, by inserting a new program like we are a machine. These types of studies are important because in the long run this knowledge and these technical capabilities can enable better gene and cell therapies and biotechnologies. Biotechnologies equals bio-bots. Hilton said the study in Nucleic Acids Research highlights the growing potential of CRISPR-Cas9-based tools for synthetic gene control and cellular engineering. The team's strategy also demonstrates the power of dCas9 to influence and understand the epigenetic factors that animate the human genome. Only around 2% of our genome contains



protein-coding genes, and the remaining 98% is so-called noncoding DNA. What they are saying is, they are terrified of a future event that many of us will begin to turn on our so-called junk DNA. That will trigger a mass awakening and end their rule over us. Enhancers and promoters are key parts of our noncoding genomes and, although the vast majority of these elements do not make conventional genes, there is fascinating genetic variation in noncoding DNA. This variation gives us the magnificent diversity that enables our species to be both amazing and adaptable. Right there reveals their concerns and our potential they are trying to stifle with technology. However, genetic variation in noncoding DNA is also strongly correlated with many diseases, and even subtle differences in these regions can be linked to pathologies. A pressing challenge is that it is often very difficult to pinpoint how these differences influence disease onset and treatments. Not forgetting these same scientists and the medical establishments surrounding them, created many of the diseases to begin with. Backed and supported by off and on world species, who miraculously were immune to widespread contagions, funny that, but also indicative. Our goal and our hope is that technologies and approaches like ours can help researchers get closer to making those important connections, and to ultimately predict and thoughtfully intervene in disease. Intervene in disease, does not necessarily imply they will prevent it does it? Intervene; to come between, intervene; interrupt; stand in the way, oppose, hinder. Or it can mean: interfere, interpose oneself between, act mediatorially. Depends on the definition and purpose does it not? And since when have these Paperclip style scientists ever done anything beneficial for us? By synthetically activating noncoding DNA, the researchers demonstrated how promoters, short DNA sequences that mark the start sites of genes and enhancers can communicate. Enhancers that communicate? Remember the R-6 in the V series of how it can transmit? Transmitting is communicating. Remarkably, enhancers can be thousands of base pairs away from their promoters but can stimulate gene transcription by recruiting activator proteins, and by forming direct physical contacts with associated promoters. Enhancers can also sometimes make mysterious transcripts called enhancer RNAs (eRNAs). Kai showed that CRISPR technologies can be used to turn on these eRNAs, and that in some cases, this fosters a type of genomic tracking, wherein an enhancer can be dragged along DNA to engage with downstream promoters. Tracking, transmitters, to promoters? Who or what are the promoters? It also appears that along the way, vital transcriptional and epigenetic information can be deposited. That is direct data-mining of your DNA, are they trying another round of Cosmic Genetics? It is exciting to speculate that this information could serve as sort of gene expression bookmarking, that reinforces subsequent rounds of transcription in a type of positive epigenetic feedback. Their strategy revealed that enhancers and promoters can have intrinsic reciprocity. But who is the receiver? And what is the real intentions behind it one is entitled to ask. While they knew that signals can be transmitted from an enhancer to a promoter, they learned that this transmission can go the other way as well. We see regulation taking place from a promoter to an upstream enhancer. Mechanistically, that's considered noncanonical and thus rather surprising. They also found that CRISPR activators can increase the frequency of physical contacts between enhancers and promoters, but only when targeted to an enhancer, suggesting a sort of one-way street for increasing physical contacts. We now know that these pieces of DNA can send messages in both directions, but that there appears to be a significant aspect of



directionality for physical contact. Very creepy one has to say, almost on the levels of stalking, There is certainly reciprocity, but it seems that the predominant regulatory mode here, is one in which an enhancer tracks toward a corresponding promoter or promoters. All of which means, the promoters become the new god. The researchers said their study is only possible because of CRISPR-Cas9 advances. Without these genomic targeting tools, we would have to use other more invasive and disruptive synthetic methods, like knocking out or genetically modifying a regulatory element. Targeting and synthetic the keywords in that sentence. Our approaches here make it easier to epigenetically hijack or repurpose native cellular mechanisms to precisely understand and engineer how genes are controlled. Hijack and repurpose are the keywords in that sentence, are you grasping that more now with this piece?

Part 2 DNA can be used to reliably store a vast amount of digital data. However, retrieval or manipulation of specific data encoded in these molecules has hitherto been difficult. Retrieval or manipulation the keywords there. Now, researchers from the CNRS and the University of Tokyo have pioneered the application of a new method that harnesses enzymes, offering initial clues as to how these technical obstacles may be overcome. Their findings are reported in Nature, October 2022. Nature has indisputably invented the best solution for storing a massive amount of data: DNA. This understanding has inspired the use of DNA for the storage of digital data, converting binary (0 or 1) numbers into one of the four different DNA letters (A, T, C, or G). The great question is; why would a biological vessel be converted into a digital one? Funny enough I had the perfect DNA marital family, which I didn't realize until early 2000's. As all four members of my family had names beginning with A, T, C & G. But how does one find a specific datum in the library of information stored as DNA? And how can calculations with DNA-encoded data be performed directly, without first converting them back into electronic data? These are the questions that teams from the LIMMS (CNRS / University of Tokyo) and Gulliver (CNRS / ESPCI) research laboratories have sought to answer. They are testing a new approach using enzymes and applying the solutions of artificial neurons and neural networks for direct operations on DNA data. Artificial neurons and neural networks, all suggestive of digital people, does it not. All ready for their Metaverse world. But, if you remember the last piece from last year, have they not been trying to convince us of a 2D world since birth? Specifically, the researchers have made use of the reactions of three enzymes to design chemical neurons, that reproduce the network architecture and ability for complex calculations exhibited by true neurons. Their chemical neurons can execute calculations with data on DNA strands and express the results as fluorescent signals. For fluorescent signals, read transmitters, just like the jabs. The LIMMS and Gulliver teams have also innovated by assembling two layers of the artificial neurons in order to refine calculations. Precision is further enhanced through microfluidic miniaturization of reactions, allowing tens of thousands to take place. The fruit of a decade of cooperation between French biochemists and Japanese microfluidics engineers, these breakthroughs may eventually permit better screening for certain diseases as well as the manipulation of gigantic DNA-encoded databases. Manipulation of gigantic DNA-encoded databases? Seriously? The obvious conclusions can be derived from that statement alone. Who made them god or Source? we have to ask. When kept away from water, air,



and light, DNA can be preserved for hundreds of thousands of years, without any energy input. And stored in a capsule a few centimeters in diameter, it can hold up to 500 terabytes of digital data. What they are revealing with that is two things; 1. They will use a collective of humans for data storage, instead of expensive servers and 2. This is digital uploaded consciousness technology. By 2025, the total volume of digital data generated by humans is expected to reach 175 zettabytes. Since current storage media are relatively bulky, fragile, and energy-intensive, DNA may provide a viable alternative, able to contain all existing data within the space of a shoebox. Yep, confirmed right there. The problem is, if they decide your shoe doesn't fit into their proverbial shoebox, you get deleted from the mainframe. Which leaves you floating between space and time, a bit like ghosts. Not remembering whether you are real or digital. Facilitating DNA storage will be the PEPR MoleculArxiv goal, a priority research program provided last May by the CNRS. Who are the CNRS? The French National Centre for Scientific Research is the French state research organization and is the largest fundamental science agency in Europe. Let's just see how many clown based operatives this center is connected to. In 2016, it employed 31,637 staff, including 11,137 tenured researchers, 13,415 engineers and technical staff, and 7,085 contractual workers. It is headquartered in Paris and has administrative offices in Brussels, Beijing, Tokyo, Singapore, Washington, D.C., Bonn, Moscow, Tunis, Johannesburg, Santiago de Chile, Israel, and New Delhi. Brussels, DC, Israel and India say much in my opinion, but there is more. From 2009 to 2016, the CNRS was ranked No. 1 worldwide by the SCImago Institutions Rankings (SIR), an international ranking of research-focused institutions, including universities, national research centers and companies such as Facebook and Google. The CNRS ranked No. 2 between 2017 and 2021, then No. 3 in 2022 in the same SIR, after the Chinese Academy of Sciences and before universities such as Harvard University, MIT, or Stanford University. The CNRS was ranked No. 3 in 2015 and No. 4 in 2017 by the Nature Index, which measures the largest contributors to papers published in 82 leading journals. In May 2021, the CNRS ranked No. 2 in the Nature Index, before the Max Planck Society and Harvard University. Quite a list of clown names there. The effectiveness of the recruitment, compensation, career management, and evaluation procedures of CNRS have been under scrutiny. Governmental projects include the transformation of the CNRS into an organization allocating support to research projects on an ad hoc basis and the reallocation of CNRS researchers to universities. Another controversial plan advanced by the government involves breaking up the CNRS into six separate institutes. These modifications, which were again proposed in 2021 by ultraliberal "think tanks" such as the Institut Montaigne, have been massively rejected by French scientists, leading to multiple protests. Think tanks involved as well.

More than a half dozen years ago the largest Swedish daily newspaper the Aftonbladet, reported that Israel engaged in systematic harvesting of organs belonging to Palestinians being killed by the bloodthirsty apartheid government. After the usual anti-Semitic charges from Israel denying such accusations, the Swedish newspaper standing by its original story was then further corroborated by the release of an interview in 2000 with Israel's forensic institute Abu Kabir head Dr. Yehuda Hiss. He stated that in the 1990's the institute harvested skin, corneas, heart valves and bones from deceased Israeli soldiers and civilians, as well as foreign workers and Palestinians without legal consent from their families. Finally, the Israeli Defense Forces admitted the illegal practice but insisted that organ harvesting ceased in 1999, and that family permission is now legally secured prior to any harvested organs for transplants. Just like Bush stating Operation Mockingbird and MK Ultra had ended, they lie through their serpent-based teeth. Meanwhile a number of Palestinian families have registered formal complaints over the years, upon observing the returned bodies of their family members conspicuously missing body parts. A pro-Israeli magazine the Forward confirmed that Israel had been routinely stealing Palestinians' organs for Israeli citizens' spare parts. Isn't highly ironic that they call us all beasts, animals and goyim, yet desperately want our body parts? Finally even the pro-Israeli New York Times has called out the Tel Aviv regime, for its disproportionate role in organ trafficking since 2000. UC Berkeley professor, anthropologist, activist-author and head of the watchdog group Organ Watch Nancy Scheper-Hughes, who released the 2000 Dr. Hiss interview implicated Israel's nefarious organ harvesting and trafficking program said Israel is at the top. It has tentacles reaching out worldwide, Israeli organ traffickers had and still have a pyramid system at work that's awesome, they have brokers everywhere, bank accounts everywhere; they've got recruiters, they've got translators, they've got travel agents who set up the visas. dismantle their bodies. A 2001 BBC report disclosed that Israel per capita stands as the world's largest recipient nation for organ transplants, yet is the country with the fewest organ donors. The problem is additionally compounded by the fact that the Tel Aviv government including the Minister of Defense has historically encouraged the practice, only making organ harvesting and trafficking illegal in 2008. For years, the Israeli healthcare system subsidized transplant holidays up to \$80,000 in reimbursement for organ recipients to travel abroad for transplants. Insurance carriers customarily paid the tab on all remaining costs. Hughes has described Israel's leading role in the international crime syndicate, that is organized through a local business corporation in conjunction with a leading transplant surgeon, operating out of a major medical center not far from Tel Aviv. Additional connections include transplant surgeons in Turkey, Russia, Moldova, Estonia, Georgia, Romania, Brazil and New York City. With Israeli Foreign Minister Avigdor Lieberman originating from the poorest nation in Europe Moldova, it's no accident as Scheper-Hughes says, that hundreds of Israelis have created a production line that starts in the villages of Moldova, where men today are walking around with one kidney. Despite organ trafficking being a flagrant international violation of law, Israeli crime rings are still actively harvesting organs from the world's poorest countries. It's a crime condoned in large part by wealthier nations like Israel and America where the affluent can afford to pay extra costs, to get bumped up on multiple waiting lists for livers, kidneys and corneas. Wealthy nations predatorily feed off poor nations and corruption at the highest deep state levels ensure that the guilty parties are never brought to justice. Frequently the criminal body snatchers end up not even paying poor donors the quoted price promised. It bears resemblance to poachers killing endangered species like African hippos and elephants for their ivory tusks, or cutting off shark fins and then leaving the animals bleeding to death. To the traffickers, internal human organs are just another precious commodity worth far more than any donor's human life. A 1984 law made human organ trafficking illegal in America. But the first case in the US occurred in July 2009 when an Israeli citizen living in New York who paid donors in Israel \$10,000 was arrested, trying to sell them for \$120,000 each to three Americans in need of kidney transplants. Another example of born in and born to. After making millions trafficking in kidneys, he was not deported because his crime was not deemed of moral turpitude, and after the organ peddler served a brief two-and-a-half-year prison sentence, he was released in December 2014. Not deemed moral turpitude? Seriously? Moral turpitude is an act or behavior that gravely violates the sentiment or accepted standard of the community. So, according the fake justice department, selling illegal body parts is not moral turpitude. The convicted Israeli trafficker carried a gun on him and if he encountered misgivings by a potential donor, the kidney smuggler would allegedly point his finger at the donor's head simulating he was pulling the trigger. His illegal racket became the biggest corruption case in New Jersey state history, as it uncovered a money laundering scheme into the millions. A former state assemblyman who was the current NJ Commissioner of Consumer Affairs resigned over his involvement and the supervising FBI agent concluded: New Jersey's corruption problem is one of the worst, if not the worst, in the country. Corruption is a cancer that is destroying the core values of this state and this great nation. That is ironic coming from the FBI, their own corruption has never been addressed in any way shape or form either. Considering how widespread the Israeli

The organ smuggler had made arrangements to tap the large destitute Syrian migrant population in Turkey, to coordinate illegal organ surgeries with local doctors in small private hospitals. He had also placed ads in Russian newspapers in search of potential donors. As is typical, no information or medical follow-up is ever given to donor victims who often suffer complications. For example, one boy in Kosovo was paralyzed after his kidney removal. Consistent with the evil crime cabal forces that operate in coordinated unison, the US-NATO-EU-Israel-Turkey-Saudi-Gulf State axis-of-evil that is overwhelmingly guilty of not-so-covertly financing, training, supplying and supporting global terrorism in the form of the Takfiri Wahhabis' Islamic State terrorists, which is, IS/ISIL/ISIS/Daesh/al Nusrah/al Qaeda. ISIS has set up a medical team with a German doctor said to be in charge that transports fresh organs to the Syrian and Iraq Kurdistan fronts, for transplants into wounded terrorists or sold on the black market. The UN Iraqi ambassador last year made these same accusations, reporting that the terrorists have executed a dozen doctors for refusing to harvest organs. It was confirmed when shallow mass graves of mutilated bodies missing kidneys were discovered outside Mosul. All of which reveals the UN is a part of it, because they have done absolutely nothing to stop this, indeed in some cases are a part of it. As recent as last November the Palestinian ambassador to the UN, once again accused the Israeli regime with harvesting Palestinians' organs killed in clashes with occupying forces. Then as far back as October 2012 reports that the US backed Free Syrian



Army, had been engaging in this same heinous practice of kidnapping-murder of Syrian civilians for organ harvesting. But the day marks the end of Jesus they tell us with a crucifixion, and scholars have done everything to try and prove that narrative. The gist is, the sun spelt SUN not SON died on the cross, behind the sun in the night or day sky on winter solstice through xmas day lies the constellation the Southern Cross. So, the SUN dies on the cross for 3 days, and then rises above the horizon on the 25th, and the SUN ascends into the heavens. Perhaps it was in the word all along? eye of course is Ra, which brings in Rahu. When the word is split up as Ra and Hu, and remember the Sumerian Hu means serpent.
