

THI-SHOW TRANSCRIPT 2024-02-22

I think we have all been thunderstruck with the last few shows, as the veil of secrecy, distortions and lies are coming to the fore. The truth is permeating the planet and the dark forces are on the run and in fear. The planting of many seeds whether from THI or the Blueprint teams are also now bearing fruit. NEWS: This one piece is a news section, society news section and the FHSTOS section as our story reaches a much wider audience. Elon Musk, the South African-born tech billionaire, has once again criticized Julius Malema, the leader of the Economic Freedom Fighters (EFF). Musk was responding to a post by EndWokeness, featuring a compilation of edited clips advocating for violence against white individuals. Julius Malema has repeatedly called for the genocide of the 4 million whites living in South Africa. Malema could very possibly be elected as Prime Minister in a few months. Zero international outrage, EndWokeness posted. Imagine if was said the other way round, the outrage and labels would be enormous. Musk counterattacked by delivering another criticism aimed at Malema. The likely future leader of South Africa calls for genocide of the 4 million whites who live there, he wrote. We have many South Africans tuning into our show, most of them are white and I and we hope they are all safe out there.

Here is another positive piece and shows the power of the people coming together again. This is so refreshing to see now and our message must be rammed home of, we are no longer tolerating your stupidity, control or harvesting. The European Union's executive arm shelved an anti-pesticide proposal Tuesday in yet another concession to farmers, after weeks of protests that blocked many capitals and economic lifelines across the 27-nation bloc. Although the proposal had languished in EU institutions for the past two years, the move by European Commission President Ursula von der Leyen was the latest indication, that the bloc is willing to sacrifice environmental priorities to keep the farming community on its side. Despite concessions, protests continued from the Netherlands to Spain and Bulgaria. Farmers have insisted that measures like the one on pesticides would increase bureaucratic burdens and keep them behind laptops instead of farming, adding to the price gap between their products and cheap imports produced by foreign farmers without similar burdens. Under its much-hyped European Green Deal, the EU has targeted a 50% cut in the overall use of pesticides and other hazardous substances by 2030. The proposal was criticized both by environmentalists who claimed it would be insufficient to reach sustainability targets, and by agriculture groups who insisted it would be unworkable and drive farmers out of business. The decision to shelve the proposal on pesticides was the EU's latest act of political self-retribution, in reaction to protests that have affected the daily lives of tens of millions of EU citizens and cost businesses tens of millions of euros due to transportation delays. Last week, von der Leyen announced plans to shield farmers from cheaper products from wartime Ukraine and to allow farmers to use some land, they had been required to keep fallow for environmental reasons. In France, where the protests gained critical mass, the government promised more than 400 million euros (\$436 million) in additional financial support.

Meanwhile, protests continued in many EU nations. Since early Tuesday, farmers across Spain staged tractor protests, blocking highways and causing traffic jams to demand changes in EU policies and funds and measures to combat production cost increases. The protests came as the Agriculture Ministry announced some 270 million euros (\$290 million) in aid to 140,000 farmers, to address drought conditions and problems caused by Russia's war against Ukraine. Bulgarian farmers added fuel to their protests by moving their heavy farming vehicles from the fields to the main motorways and border crossings, paralyzing traffic and adding to the economic woes of the country. On Monday night, farmers in the Netherlands blocked several roads and highways with their tractors and burned hay bales and tires. Police in the rural province of Gelderland said they took action against farmers blocking roads, but there were no immediate reports of arrests. In recent weeks, farmers have protested in Poland, Greece, Ireland, Germany and Lithuania. They have no option but to concede or make concessions now, as they are being driven into fear by a baying public. They don't have the resources anymore to fight back. But more importantly now it seems, the public is not allowing them to continue their tirade against us.

Here is something that is perhaps signaling a sea of change between government and its people, considered tiny for some can be huge for others. That's the case for some of California's unsheltered homeless community, which hopes to benefit from a promise by state officials nearly a year ago, to provide over a thousand tiny home shelters free of charge. Gov. Gavin Newsom committed \$1 billion in March to address the state's homelessness crisis with tiny homes in Los Angeles, Sacramento, San Diego, and San Jose. California has one of the most severe homeless problems in the country. There are over 180,000 homeless people in the state, according to 2023 data, the latest available. That alarming statistic accounts for 28% of America's total homeless population. The reason being is the greed within certain sections of that state of multimillion-dollar homes, leaves a void at the bottom. Kudos to California for giving something back, but you can buy and install far more than around a thousand tiny homes with \$1B. Be interesting to see who the contract to build the homes is given to and I hope the people there scrutinize that. The mortgage solution in our blueprint will solve all housing issues within this country.

Here is why the people don't have enough money for things like homeless shelters or other services. As the National Science Foundation is allocating over \$900,000 in taxpayer funds to three universities, to conduct a study claiming biology courses inaccurately portray sex and gender as binary, in order to make them more inclusive for transgender and non-binary students. The study aims to explore how sex and gender topics are taught, their impact on transgender student belonging and interest, and ways to create a more inclusive curriculum acknowledging diversity in sexes and the complex relationship between sex and gender. What a complete waste of money and resources, the country is collapsing but can still send monies to Ukraine, Israel and for ridiculous programs like this. Common sense has to prevail in the future for us all to prosper.

He spoke of Zelensky and the Canadian parliament openly applauding an SS

Ukraine belongs to Russia and Ukraine, but Russia was allowing Ukrainian citizens the right to be independent, should they wish, as long as they got rid of Nazism. But the US and their CIA enforcement arm wants to station there, just like they have in many other European countries under the banner of NATO. Are you seeing the real problem now? The entity known as the US or U.S., neither of which are anything to do with America. Because America underwent the same CIA led coup around 80 years ago. Warned humanity has to consider about genetic research and AI issues, again something we covered in the Blueprint. Carlson asked could Evan Gershkovich be released and stated he was not a spy. This is not true, Gershkovich a former New York Times and now Wall Street journalist was obtaining classified documents in Russia and was using the information covertly, that is espionage. Why the furor over Gershkovich? Because he is yet again Jewish. Secretary of state Antony Blinken also Jewish, spoke to his counterpart, Sergey Lavrov, on April 2. and expressed grave concern over Gershkovich's arrest. MEDICAL NEWS: Here is another of the side effects of the experimental vaccines people just sleep walked into, just like the Poles, Hungarians and Jews getting on the concentration camp trains. The Covid-19 vaccines is now being linked to unexplained vaginal bleeding in women without regular periods, according to a study published Tuesday in Science Advances. Kristine Blix, the lead study author from the Norwegian Institute of Public Health in Oslo, Norway, and her co-authors studied 21,000 national survey responses from postmenopausal and perimenopausal women, as well as premenopausal women without regular periods due to hormonal contraceptives. Of the whole group of women surveyed, over 10% experienced some form of unexplained vaginal bleeding, with over half of each group saying that the bleeding started in the four weeks after either dose of the two-dose Covid-19 vaccine. Over 13% of premenopausal women experienced unexplained bleeding during a period of eight to nine months after the vaccine, with the risk of unexplained bleeding being three to five times higher than prior to vaccination. The risks for postmenopausal women increased by threefold. Unexplained bleeding during or after menopause is a possible indicator of endometrial cancer or other serious conditions, such as vaginal or endometrial atrophy.

Our findings of an increased risk across the reproductive stages raise the possibility that, the mechanisms linking Covid-19 vaccination to unexpected vaginal bleeding may be similar across the stages, Blix and her co-authors wrote, acknowledging that the study was unable to determine the causal mechanism of the association. Changes in menstruation due to Covid-19 vaccination and infection have been anecdotally discussed and observed, but few scientific studies have confirmed the connection, with many attributing period changes or unexplained bleeding to stress and anxiety during the early stages of the pandemic. In 2021, reproductive physician Victoria Male published an article in the BMJ calling for further investigation, into the link between both Covid-19 infection or vaccination and changes in menstruation, citing more than 30,000 women in the United Kingdom who reported bleeding changes to their vaccine complications system. Menstrual changes have been reported after both mRNA and adenovirus vectored covid-19 vaccines, suggesting that, if there is a connection, it is likely to be a result of the immune response to vaccination rather than a specific vaccine component, Male said at the time. Male also noted that other vaccines, such as that for the human papillomavirus, can trigger an immune response that has also been associated with menstrual changes.

So, now the birthing issue is coming into question, after our book highlighted this ongoing child birthing reduction program being ran in mainly white countries. The silver lining is, people should learn now that all the organizations of life, are and have been scheming against us. This is an interesting article and will be noted by many members within the group and in particular those connected with the village. At Scientific American, Lydia Denworth brought up an interesting topic earlier this month: The way that brain waves synchronize between two people who are communicating successfully, Neurons in corresponding locations of the different brains fire at the same time, creating matching patterns, like dancers moving together. Auditory and visual areas respond to shape, sound and movement in similar ways, whereas higher-order brain areas seem to behave similarly during more challenging tasks, such as making meaning out of something seen or heard. The experience of being on the same wavelength as another person is real and it is visible in the activity of the brain. For example, she tells us, couples exhibit higher degrees of brain synchrony than nonromantic pairs, as do close friends compared with more distant acquaintances. There's a name for the study of such moments called collective neuroscience. Synchrony is not a brand-new discovery, but methods of tracking it called hyper scanning have become more innovative in the last decade. I disagree, the agencies have been using this for many decades, along with remote viewing techniques. The prospect of using synchrony to better track and understand success or failure in learning environments, is attracting neuroscientists to the field. One study from the Basque research center BCBL using electro-encephalography (EEG) reported that the rhythms of the brainwaves corresponding to the speaker and the listener, adjust according to the physical properties of the sound of the verbal messages expressed in a conversation. This creates a connection between the two brains, which begin to work together towards a common goal: communication. This is telepathy at work and has been demonstrated in the village and even further afield in Europe. Why is it considered only a possibility or another branch of pseudoscience, when in reality many people do it without recognizing it. Just because all can't do it or science tells us it is not possible, does not

mean it is not real, it is. For the purposes of the study, the BCBL researchers used 15 dyads of people of the same sex, complete strangers to each other, separated by a folding screen. This ensured that the connection generated was truly thanks to the communication established. Following a script, the dyads held a general conversation and took turns playing the roles of speaker and listener. There is some evidence that synchrony makes people more willing to help each other. According to a 2017 study of synchrony: People tend to be more prosocial after synchronizing behaviors with others, yet the underlying neural mechanisms are rarely known. How can it be unknown when it is simply related to waves and frequency, which along with energy are the three components of everything? In essence the people are the Wi-Fi, yet another example of an internal technology being replicated with an external, the phone. In this study, participant dyads performed either a coordination task or an independence task, with their brain activations recorded via the functional near-infrared spectroscopy hyper scanning technique. Participant dyads in the coordination group, showed higher synchronized behaviors and greater subsequent inclination to help each other than those in the independence group, indicating the prosocial effect of interpersonal synchrony.

The US has announced sanctions on 25 China-based firms and individuals allegedly involved in the production of chemicals used to make fentanyl. One hopes that is an actual crackdown on the drug and not just some lame attempt to protect the market of it for the agencies here at home. Fentanyl, a potent opioid used as a painkiller or sedative, plays a major role in the US drug crisis. Attorney General Merrick Garland said the drug's supply chain often starts with chemical companies in China. Which will be the case, but what about the chemical companies here or the military chemical warfare factories here as well? Like Fort Detrick and many others. China criticized the imposition of sanctions, saying the fentanyl crisis was rooted in the United States itself. We firmly oppose the United States' sanction and prosecution against Chinese entities and individuals, and the severe infringement of the lawful rights and interests of the relevant enterprises and persons, the Chinese foreign ministry. The Chinese government has been strictly cracking down on drug crimes and we deploy the harshest control on precursor chemicals. Imposing pressure and sanctions cannot solve the United States' own problems. It will only create obstacles in the China-US co-operation on drug control, it said. In April, a spokesperson for the Chinese foreign ministry said there was no such thing as illegal trafficking of fentanyl between China and Mexico. This came after Mexican President Andrés Manuel López Obrador called on the Chinese government to help stop the alleged flow of fentanyl and its precursors into his country. The US authorities blame Mexican drug gangs for supplying fentanyl to users across the US. But the gangs in Mexico were supplied and funded by the CIA, where is the crackdown on them? Fentanyl can be legally prescribed by doctors, but a dramatic increase in opioid addiction in the US in recent decades, has led to a rise in illegal production and overdoses. In 2022, the drug was linked to a record 109,680 deaths. Near 110K deaths due to mind control programs to make the public docile and line the pockets of the shekel makers at the agency based private contractors.

SOCIETY NEWS: Another example of our warnings that countries are finished was posted in the Telegraph recently and said this. Britain's decline over the past 25 years has been staggeringly rapid. Britain's residual virtues, our individualism, independence of mind, tolerance and openness, uniquely appealing features of our national character, are fading. Like a frog in boiling water, few saw the full scale of the decline coming until it was too late, and those who did were ridiculed by the bien-pensant. None more so than the media itself, perpetuating lies of how great the economy is, ignoring social issues and pandering to rampant criminals, masquerading as the ruling class. Yet even in 2024, when millions now realize that Britain is on the wrong track, there is no hope of meaningful improvement. We at THI disagree, the Blueprint provides all the improvements. stating the captain obvious. Why? Because that is a truth too far currently, even Putin and MacGregor danced around the “Jewish” issue. They have to be diplomatic of course at this time, but eventually the band-aid has to come off. But predictably the report then went onto the Jewish pity party and how only they are in fear, all of which is another sign of their desperation to keep the public in check. Guess what? It’s not working and won’t be ever again.

This time it was the turn of a women’s basketball match in Latvia. Like so many other sports teams in Ireland, and like other apolitical targets of the sinister Boycott, Divestment, Sanctions movement, the basketball team had come under heavy pressure from Irish Sport for Palestine to boycott fixtures against Israel. But for the Irish team this was a vital EuroBasket qualifier. Had they boycotted it, they’d have been effectively banned from competition for the next five years. Some players chose not to travel. Then a member of the Israeli team said in an interview that the Irish side were quite anti-Semitic and it’s no secret. Cue absolute outrage from Irish commentators and the Irish team deciding not to partake in pre-match arrangements, like exchanging gifts and formal handshakes. The game was played behind closed doors. It’s a telling incident. The Emerald Isle has built its tourism industry on visions of friendly, welcoming citizens, the reality is a country that is becoming increasingly nasty. The author said I disagree with my countrymen on many issues, because many are congenital virtue-signalers who love to support the popular, easy side of any controversy. I disagree with her, as what about the support for the IRA? Wasn’t that a truly nasty example of virtue-signaling? What about the virtue-signaling in support of the Catholic church, despite them committing many heinous acts against children? Another sordid and horrible tale the media of most nations are covering up, which indicates who runs them. Every newsreader is soaked in the blood, fear, death, harvesting and traumas of these children in not just Ukraine, but globally, by their refusal to speak the truth. The author said when I began investigating the kidnapping of children in Artiomovsk by Ukraine, I had no idea of the extent to which I would uncover trafficking on an international scale and the sordid methods used to supply children to pedophile networks and organ traffickers. Flashback. In April 2023, I interviewed a refugee from Artiomovsk called Yulia, who told me that as well as having mined and blown up their building, Ukrainian units called "Phoenix" and "White Angels" were kidnapping children in the town. Phoenix of course brings in Project Phoenix a dastardly CIA program of torture and abuse. The white angels is a

new term, but again has CIA memes running through it, as the former names White Hats and Helmets has their blood-soaked fingers written all over it. White “angels” can also be seen as the royal Draco as well, hence the term CIAkars. Notice they use the term white a lot and yet operate in an evil manner? Which runs alongside how the media portrays the whites as well, why? CIA runs the American media as well. This information immediately caught my attention, and I decided to investigate further to find out why Kiev was taking children away from their parents in this way. On the very day I was conducting this interview, Russian colleagues were interviewing a little girl from Artiomovsk, whom the White Angels had tried to kidnap from her grandparents, claiming that her mother was dead and that they were to take her to Germany. It was clear to me that these children kidnapped by Ukraine in Donbass were then sent abroad for all sorts of sordid trafficking, from organ trafficking to pedophile rings. Because the inhabitants of Donbass have never been able to assert their rights in the face of the war crimes, committed against them by Ukraine since 2014 within the international justice bodies. Kiev enjoys total immunity at the ICC and the ECHR with regard to the crimes it may commit against the children of the region. A few days later, other refugees from Artiomovsk confirmed the child abductions and I discovered that the same methods were being used in other towns such as Avdeyevka, now similar information is coming in from Kupiansk. The last refugee from Artiomovsk we interviewed, Katia, confirmed the abduction of children by the White Angels, then explained that when the parents of abducted children called them to find out where they were, they claimed not to know anything about it. Katia also told us that before the battle of Artiomovsk, they had never seen organizations like the White Angels in the town. These child abduction units only appeared once the fighting had started. In other words, once the city was in a state of general chaos and the inhabitants could no longer turn to the courts to assert their parental rights. Another example of their order out of the chaos. An ideal situation for traffickers of all kinds.

Their modus operandi was revealed at the 27 July 2023 conference on Ukraine's crimes against the children of Donbass, held in the DPR or the Donetsk People's Republic. A woman, Liliya and her daughter, Kira, gave evidence of how at the start of the special military operation, around ten children were taken from a school in Chtchastye. Which was then under Ukrainian control in the LPR or Lugansk People's Republic over to western Ukraine by the headmistress of the school upon orders from Kiev, without informing their parents. The children were even forbidden to call their parents to tell them where they were. Something that has been replicated in schools in America about the Covid jabs and also their pro pagan da and woke programs. See how it all unfolds? Do you now see why the whole schools system needs to be temporarily closed and a whole new curriculum put in place to eliminate these agents against we the people. I have outed many professions involved in operating against we the people, this adds teachers into the mix as well, whether knowingly or not. All too often people do what they are told, despite knowing it was wrong, well enough of that shit! But Kira knew her mother's telephone number by heart and managed to call her to let her know that they were in Lvov and then Khoust. Thanks to Liliya's determination to find her daughter after she went to look for her in western Ukraine, we discovered how Kiev exports the children it abducts.

The children taken from the school in Chtchastye had been taken away without any identity documents, they were not yet old enough to have passports and their birth certificates were with their parents. When she got her daughter back, Liliya discovered that they had produced a new original birth certificate for Kira, who had been declared an orphan, even though her mother is alive and well. According to Kira, the group of children with the

new documents were to be sent to Poland. Poland is rapidly becoming a den of iniquity and is destabilizing the whole of Europe, with their alignments with the old order groups and organizations. Yet didn't Putin warn and inform us of Poland chicanery that led to the start of WW2, so perhaps we should not be surprised. Without the perseverance of Kira and her mother, no one would have known where and how the children had been taken. This is how Ukraine makes the children it abducts disappear, preventing anyone from finding out what happens to them. The parents are not informed of anything, the children are forbidden to contact them and they are given false papers. That's the best way to describe it, given that it's impossible for the authorities to produce an original birth certificate, when it's in the hands of the parents and declared to be orphans, before being sent abroad. This is what happens in England with secret children courts, where no legal representation takes place and parents who had their children taken cannot attend the court either. The organizations involved in that scam and theft of children in the UK are: the police, social services, child protection, lawyers and judges. These sectors along with teachers, politicians, news media and medical people will never be trusted again, once all the truth emerges. It is and it will and also why we need a 180 of every organization and group.

This is surely what happened to the children of Nikolayevka, who were taken to a holiday camp to shelter them, but whose parents now have no news of them. Why use such illegal methods if the real aim is simply to shelter these children from the war? Well, because there is nothing legal about the real aim. At the conference, Vassily Prozorov, a former employee of the SBU the Ukrainian intelligence services, explained that one of his investigations, had revealed that some of the children abducted by Ukraine are sent to pedophile networks in Great Britain, via a whole network of Ukrainian and British officials or former officials who work together. At the heart of it all is one man, Sergei Borissov, a former SBU agent who was arrested in 2020 for kidnapping entrepreneurs for ransom. Strangely enough, he and his entire gang were released on bail in 2021, and here he is again, trafficking Ukrainian children to the UK! On the British side, members of MI6 and the Foreign Office are involved. So why was Borissov allowed bail to continue? Because he is leveraged and so now he has no option but to dance for the dark forces. Intelligence agencies have a lot to answer for in the near future, and I suspect like other organizations it will be deemed as a pariah going forward that no one will trust.

That is why it has to be stripped and started again with better people. This is hardly surprising when you remember that in recent years, there have been several scandals involving networks exploiting children in Great Britain, plus the pedophiles in the British establishment, such as Sir Jimmy Savile, whose crimes were covered up for years. Saville and many other so-called entertainers in the BBC were investigated by Scotland Yard late 80's early 90's. The investigation stopped because it reached into Buckingham Palace and the royals and was subsequently shut down. People in Scotland Yard have the fear, trauma and death of the children abused after that, on their hands. The future has to entail the Golden Rule and RITA law, so that no one is ever above the law again and all are equal within it. In 2021, the UK's National Crime Agency (the NCA) stated that there would be between 550,000 and 850,000 pedophiles in Britain alone. Many of them are leveraged I would say, where curiosity was taken over by dark forces or maybe I am wrong and there are that many pedophiles, a sad statistic. In other words, there's no shortage of customers, including very high-ranking people, for the pedophile rings that kidnap children in Ukraine. Another investigation carried out by Vassily Prozorov revealed that several organizations registered in EU countries, are also involved in exporting children from Ukraine, under the pretext of providing them with shelter. These organizations take unaccompanied Ukrainian children out of

Ukraine, what happens to them afterwards is unknown. However, as early as 2022, several Western media, including Deutsche Welle and The Guardian, reported that Ukrainian children evacuated abroad had disappeared. It is not only in the UK that Ukrainian children are at risk of falling into the hands of pedophile rings. In May 2023, a 52-year-old Ukrainian refugee was arrested in Poznan, Poland, for renting out children in her care to pedophiles. She adopted 10 children aged between 4 and 16. The adoption agencies all need to be heavily investigated globally, as this is not just a Ukraine problem. Investigators discovered that the woman rented out the children to pedophiles in Ukraine and Poland. Worse still, while the clients were abusing the children, she stood next to them to make sure they kept to the time limit as the sessions lasted 20 minutes. The Daily Mail report revealed that she tortured and sexually abused the children herself. In April 2022, a group of around thirty Ukrainian children disappeared in Spain on their way to the Canary Islands. That same month, an investigation was opened in Lithuania into potential child trafficking at a private Ukrainian orphanage, Perlinka, from which 43 children had been evacuated to the Baltic country. Several of the children, including girls, had complained of threats to send them to work in brothels, or that there were plans to send them to other countries, including the United States. When Ukraine demanded the return of these children, several sought asylum in Lithuania for fear of reprisals or being sent to who knows where. Pedophile networks are not the only threat hanging over Ukrainian children. In June 2023, a man was arrested in Transcarpathia while trying to take a baby to Slovakia. The man had bought the baby from its mother and was planning to sell it to organ traffickers. He had already sold and transported at least three other children in this way. Babies for shekels? Seriously is nothing sacred anymore? For those who think this is Russian disinformation, think again, even the Ukrainian press and the UK Daily Mail have reported on this affair. As a further confirm of the veracity of these claims, this article was also shared by the Russian Embassy in London.

The disappearances of Ukrainian children used for their organs are nothing new. In 2005, a journalist from The Globe and Mail wrote an article condemning the discovery in Kharkov, of a mass grave containing the bodies of babies and fetuses without their vital organs. Mothers complained that hospital staff had taken their babies at the moment of birth and then returned later to tell them that, they had supposedly been stillborn. A very practical method of fueling child trafficking. But hospitals would never do that would cry the masses, wrong thinking. Since December 2021, organ trafficking in Ukraine has been facilitated by the passing of a law that abolished the obligation to have the organ removal authorization signed by the donor, his parents or his legal representative authenticated by a notary. Wow and no one thought to question that or asked as to why that law was needed? The pattern then becomes very clear: children are abducted, provided with new original documents and declared orphans, so that they can be placed under State guardianship or adopted by who knows who. These new guardians can then sign an organ harvesting authorization, which no longer needs to be authenticated by a notary and the deal is done. In the light of all this information, it is high time that international organizations for the protection of human rights and especially children's rights, seriously investigated the abduction of children in Ukraine, plus the sordid trafficking, organ trafficking or pedophile networks of which they are the victims. It's also time for people in the West to open their eyes to what is happening in Ukraine, with the active complicity of the country's authorities, in terms of child trafficking. Officials in Ukraine are making money by selling children to Western pedophile networks and organ traffickers, thanks to the ongoing conflict. This is how Ukraine repays its debt to the Western countries that supply it with arms and funding: by selling the children it steals from the Donbass and other regions, where fighting is taking place, for their organs or to

The house of horrors was revealed after the doctor was called to treat one of the children suffering from stomach problems. The doctor said: that night she began to talk about the violence that Svetlana used. I have never seen such a child, eyes fixed on one point, tears dripping down her face and she talked and talked. She was pouring out information, she finished one topic and started another. The next day, more children started talking. Plyushko, who faces up to 15 years in jail if found guilty, said that before Russia's invasion she had been running a foster home in Ukraine for 15 years. She faces just 'up to' 15 years in jail, where is the rest of the sentence? As these children face a lifetime sentence of being haunted by those events. She added that there had never been any complaints before. Denying all charges, she told the court: Maybe I hurt them because I didn't surround them with love and care. Or maybe you are just an evil psychopath, trading a child's innocence for shekels. A harrowing story that makes all western media complicit in it. But the people's reluctance to take any notice of events outside of their own bubble also must be brought into question. Looked at and fixed. One source said that at least nine apparent non-human craft have been recovered by the US government, some wrecked from a crash and two completely intact. Three sources briefed on those alleged top secret operations said that the Office of Global Access (OGA), a wing of the CIA's Science and Technology Directorate, has played a central role since 2003 in orchestrating the collection of what could be alien spacecraft. They lie, they were involved from their inception since 1947 as our shows called The Events that changed the world Parts 1-3 revealed. The three sources, who spoke on condition of anonymity to avoid reprisals, have all been briefed by individuals involved in those alleged UFO retrieval missions. Though the shocking claims sound like they come from a science fiction novel, they are part of a growing body of evidence suggesting the US government, could indeed be hiding advanced

vehicles that were not made by humans. The Office of Global Access, a wing of the CIA has played a central role in collecting alien spacecraft since 2003, Former top intelligence officer David Grusch told Congress as much in an explosive public hearing in July. The same month, Senate Majority Leader Chuck Schumer sponsored an extraordinary bill to allow disclosure of recovered technologies of unknown origin and biological evidence of non-human intelligence, which has now passed in the Senate. Sources who spoke to shed light on how the CIA has allegedly coordinated the secret recovery and storage of these alleged crashed or landed UFOs. There's at least nine vehicles, there were different circumstances for different ones, it has to do with the physical condition they're in. If it crashes, there's a lot of damage done, others, two of them though are completely intact. The source said the CIA has a system in place that can discern UFOs while they're still cloaked, and that if the non-human craft land, crash or are brought down to earth, special military units are sent to try to salvage the wreckage. Another source with knowledge of the OGA's role said, that they specialize in allowing the US military to secretly access areas around the world where they would usually be denied, for example behind enemy lines. They are basically a facilitator for people to get in and out of countries, the source said. They are very clever at being able to get anywhere in the world they want to. Who wrote this contract agreement up and why has every government agreed to it? If only the military were just a proficient in delivering humanitarian aid, as our Blueprint tasks them to do. Most of OGA's operations involve more conventional retrieval missions, such as stray nuclear weapons, downed satellites or adversaries' technology. But they claimed some missions coordinated by the OGA have involved retrieval of UFOs. The task at hand is simply to get it into custody and protect the secrecy of it, one source said. Again one must ask as to why that is the case? Why do they feel the need to cover it up? The two great questions are, Are the actual craft theirs? Is the US Military and the CIA run by the owners of these crafts? The actual physical retrieval is by the military, but it's not kept under military control, because they have to keep too many records. So they start moving it out fairly quickly into private hands. Who are these private hands and why do they have the ultimate in cloaking themselves? Is private hands the private contractors of the CIA? If yes, who are these people? Are they people as we know it, at all? Documents published by the National Archives and Records Administration (NARA) in December 2016 showed that the OGA was one of 56 offices in the CIA, with its chief and deputy making up two of a total 286 director-level officials in the spy agency. What a waste of public money that is, they all must go with Agency revamp. An unclassified organizational chart published by the CIA in October 2015 lists the OGA among nine offices in the Science and Technology wing of the agency. And you all thought they were a spying agency and protecting your country, turn it in, they are a secret organization that wields and receives way too much power for clandestine operations with zero oversight. The late CIA expert Jeffrey Richelson wrote in a 2016 book on the agency that the OGA was established in 2003, and cited a CIA description that it integrates analysis, technology and tradecraft to attack the most difficult targets and to provide worldwide collection capability. MYSTERY SECTION 2: This piece is an addition to the thoughts of being paid within the Blueprint work. I spoke about how we are all being paid by unseen methods, a gift of life force from the Cosmos. The problem is, people have danced in the external for too long and have forgotten the internal effects. But the act of giving is receiving as well in overview, but again in unseen effects as they are internal. To give is a soul level thing, it is

caring, sharing and compassionate. But society has created a system whereby if we give, we have to receive something back from the receiver. This is wrong thinking on our part as that is a two way payback system. Paying it forward though can create a multi exchange system, which ultimately has a clockwise flow and so all are touched by it. The current money system is a pay back with interest scheme, which is harvesting and anti-clockwise and so it doesn't touch us all. So as you give, you also receive in non-physical terms, not necessarily the physical terms or ways. All about the overview and perspective again.

Here is a deeper pondering that will no doubt raise furrowed foreheads lol. So many of our THI members on zooms are moving their hands and fingers to smooth out their foreheads these days, I see you! Lots of omg I do that all the time you cry, maybe now you know why, I guess I'll get the blame for that as well. Self-sacrifice and service to others question came up recently on a zoom. I have covered in recent shows why we all need to become service to others and not selfish and just serving the self. It is ironic, in overview how a discipline within that is beneficial to the self, is largely ignored by many people. Shadow and inner work is an individual pursuit that gets people to help them on a wider scale. Yet the pursuit of a better world and service to others, generates the opposite and is only more service to self. What if the atrocities ongoing now, including the Covid sham, has created a unique situation and opportunity? The great question is, are people self-sacrificing themselves for the greater good to allow the people to finally see through the illusion? What if the Gazans are self-sacrificing to expose the Israeli problem? What is the Ukrainian's and Russians are self-sacrificing to also expose the Jewish EL-ite problem? What if the masses are staying asleep, so the rest of us can see the difference and elevate ourselves? What if masses have already ascended and they are avatars in this world to help us? What if the dark souls are self-sacrificing themselves for the light to ascend? What if the religious constructs and people within are self-sacrificing themselves, to get people to become adults and not remain the child tied to the church cult? Why do people do that is another great question, that should be assigned to the lunatic asylum piece. What is wrong with people being happy for source sakes? Why does life and people always have to be about misery, struggle and strife? Too often people and life lets you down, yet do we realize yet, that this is a harvesting center of epic proportions? People sucking the life out of each other, total energy vampires, spreading their own special brand of

unhappiness and misery. We have all come across these people, yet rarely is it addressed or even looked at. Why is that? Why would we allow our own happiness to be destroyed or ruined by these people. These people in overview are djinns, consuming the life force energy of others for sustenance. But the djinns have an excuse, they are non-corporeal and have no option but to consume energy that way. The people have zero excuse. The bizarre thing is most don't even know they are doing it, living life totally unaware of everything about or around them. Friends, lovers, work colleagues and even within your own families, energy vampires who suck the enjoyment out of everything. It is one thing them not realizing they are doing it, in essence they are an expanding sub-culture on this planet, but it is another for you to allow it. What this means is, A: you don't value yourself enough B: you tolerate too much shit and the worst C: you are not protecting your own PSI field. Other people and life itself will always let you down, it's what they do, the key is to not let yourself down. Don't become the deflated balloon, devoid of life and energy, looking sad and withered. Don't become a copy of the energy vampires and retain the essence you at all costs, ultimately if you stand your ground and retain your sovereignty over your field, eventually those people drift away. You never needed those types of people in your life, you just always went along with it and them. Mainly because they were too familiar to you, too family to you as well. The sad balloons people in life are because they allowed others to dictate and influence their lives, and so they become the copy and victims of the energy vampires. People will always attempt to let down your balloon, it is what they do. The key is you not allowing it. Why do people do it? They don't understand life, can't comprehend happiness, can't live comfortably in their own skin, so destroy others due to their own failures and misguided lives. ENDING PIECE: Tuesday's show brought another swinging healthy dose of reality to the light for purview. A harsh reality check of all the races, how things where so much better long in the past, but never in this lifetime. The problem yet again highlighted who were the main protagonists, that many doubted in the beginning of the

FHSTOS series, but now after 35 episodes, there is no longer any doubt. Controversial subjects like the mixing of the races, often danced in the realms of racism in the past and outside of THI, now brought to light in full clarity. People beginning to understand the importance of it, beginning to understand it is not racist to not mix, it is a genetic reality that needs to be addressed to the all. It shouldn't stop people wanting to mix, as that is a free will choice and should not be denigrated, but all should be aware of the consequences of such. Dancing in the dark and denied so much knowledge has been and led to our downfall. The key to the future is teaching, an enormous undertaking of epic proportions, as everyone has to unlearn the lies and distortions and then learn the new way and adapt to it. But as all people must be taught the new ways, all people must learn to take personal responsibility for their lives and their choices. We are only 7 shows into this year and yet somehow there seems to have been a year's full. Everything has happening and unfolding so quickly now, that many of you are struggling to keep on top of it and yourselves. Miscommunications arising, because many are in a fog currently due to the onslaught of what is unfolding around you. People being uncertain of themselves, people not thinking straight, people being irritable are all symptoms of integrating the external turmoil into the internal part of you. You were all told to observe it not absorb it, learn to take a little time of each day to clear the thoughts and interactions of others with you from your field and just be at one with you, then go again. We must address things a lot sooner also, no longer is time allowing the stretching out of issues external or internal. But everything is sped up, issues arise quicker and we must learn to overcome them quicker as well. Take the 5 minutes of your day to clear it all out and that way things will begin to flow within you and also flow around you. The old way of ignoring does not apply anymore, the out of sight out of mind generally means ignoring it, but it really means you have no eyes or brain. No eyes or brain means you are blind and stupid, is that how we all wish be seen as? This is something said by Sir Anthony Hopkins that applies to this piece. My philosophy is: What people say about me is none of my business. I am who I am and do what I do. I expect nothing and accept everything and that makes life easier. We live in a world where funerals are more important than the deceased, marriage is more important than love, looks are more important than the soul. We live in a packaging culture that despises content. All of what he said was about people being external and not internal. Stop stepping outside of yourselves and learn to be you, love you, trust you and internalize you. Because then the sad balloon inflates and begins to rise vertically on towards the Golden Path, where eventually you are back to walking amongst the gods.
