Here we go with yet more bombshell reports, exposures and break down of the former control system and their lackeys. Two expose and a whole heap of mystery section tonight. A show that continues to give hints and warnings, that has been the theme of the last number of shows, but did you heed them?

NEWS:

Here is exactly what the Government, Pentagon and top brass US military thinks of the value of their soldiers. The Biden administration strongly opposes a proposal to raise the pay of junior enlisted service members in the military, even after nearly spending seven times the proposed amount on Ukraine and the broader region's security. The House Armed Services Committee's (HASC) draft of the 2025 National Defense Authorization Act (NDAA) would give all junior troops a pay raise, representing a rough total of \$24.4 billion over five years, according to the Congressional Budget Office. The Biden administration said in a statement, that it does not support the proposed significant, permanent pay hike until it has had a chance to conduct a compensation review. The Biden administration has spent over \$175 billion on aid to Ukraine and European security since 2022, roughly one-seventh of the proposed pay hike for the junior troops, according to the Committee for a Responsible Federal Budget. The \$175 billion amount is broken into several packages over the course of two years, including the most recent aid package of \$61 billion in April. No pay rise because we have to spend all our money pacifying the Israel war machine and the Jewish coup in Ukraine. I would love to see all military staff walk away from the Military and let them sink. It would not take much to tip the US Military over these days, since they have little to no defense and also a rapidly dwindling force and Americans now refusing to join the Military altogether. In FHSTOS we covered the atrocities committed by the US Military at the request of the bankers in Tulsa, Oklahoma. Survivors of one of the biggest race massacres in US history have lost their historic legal bid for reparations over the attack. The Oklahoma Supreme Court dismissed the suit, filed in 2020 by a trio of survivors, on Wednesday. An estimated 300 black Americans were killed when a white mob razed the Greenwood neighborhood of Tulsa, Oklahoma, in 1921. Only two known survivors - Viola Fletcher, 110, and Lessie Benningfield Randle, 109 - remain. The third, Hughes Van Ellis, died last year at 102. The people of Tulsa, Oklahoma need to listen to the official story on that brought forward by Dane Calloway. No it was not a white mob at all, it was the US military and Federal agents who slaughtered the people there.



India returning to their roots again with Draconian policies and being frightened of the truth? This is beyond ridiculous and about as ridiculous as locking up that 95 year old woman in Germany, for talking the truth about WW2. Will one of India's most celebrated writers really face prosecution for things she said more than a decade ago? Last week, 14 years after the original complaint, Delhi's most senior official granted permission for the Booker Prize-winning author Arundhati Roy to be prosecuted under India's stringent anti-terror laws. The Unlawful Activities Prevention Act (UAPA) is notorious for making it exceptionally challenging to get bail, often resulting in years of detention until the completion of trial. The Modi government has been accused of using the law to silence critics, including activists, journalists and civil society members. Ms. Roy, 62, an outspoken writer and activist, is in the dock for comments on Kashmir, a perennial lightning rod in India. So, people telling the truth now are classed as terrorists? What type of society supports that? A corrupt and anti-human one only. Only people with something to hide create laws to stifle people's opinions and truth. Like the Holocaust law, like the Antisemitic law, like the National Security Act law and finally the Patriot Act law. All of which are covers for lies and distortion of facts. So what did Ms. Roy say that was so terrorist like? She said: Kashmir has never been an integral part of India. It is a historical fact. Even the Indian government has accepted this, at a stormy, day-long conference in Delhi, organized by the Committee for the Release of Political Prisoners, in October 2010. At the time, Indian-administered Kashmir was in turmoil, with locals describing it as a fierce uprising against India. Ms. Roy's remarks had followed the deaths of dozens of protesters since fresh pro-freedom demonstrations broke out earlier that year. Summing up, India is stealing land like their sub gray brethren the Jews in the Middle East.

This piece is extraordinary and supports what THI stated 4 years ago, of exactly who was responsible for the so-called January 6th Capitol Building riot. Former Speaker of the House Nancy Pelosi admitted that she was responsible for the National Guard not being ready to deal with the January 6 Capitol riot. According to findings from the now defunct January 6 select committee, Pelosi, Sens. Chuck Schumer, D-N.Y., and Mitch McConnell, R-Ky., and other lawmakers were all shepherded by security personnel to Fort McNair in southwest Washington, D.C., as the protest raged on. Pelosi's J6 Select Committee spent taxpayer's money chasing false political narratives and using Hollywood producers for their investigation, said the subcommittee's chairman Rep. Barry Loudermilk, R-Ga. Her admission of responsibility directly contradicts their own narrative.



Here is another of the top officials lies exposed and also it implicates the media in the cover up. The 51 former US intelligence officials who smeared The Post's bombshell reports on Hunter Biden's laptop as Russian disinformation in a 2020 letter, are standing by their decision with some referring to the move as patriotic, even after the FBI and Justice Department have confirmed the device's authenticity, according to a new report. Former Director of National Intelligence James Clapper, former Defense Secretary Leon Panetta, ex-intelligence heads of the CIA and other analysts and officers have all said they had no regrets about their involvement in the Spies Who Lie missive. The report comes as special counsel David Weiss' prosecution of Hunter Biden for alleged gun and tax crimes continues recently, after both the FBI and Department of Justice confirmed in court filings and proceedings this year, that the laptop's contents were authentic. That letter has other connotations and is even worse than the lying agents. The letter was organized nearly four years ago by former CIA acting director Michael Morell, he said, he wrote it after being triggered to do so, triggered? Interesting terminology I have to say. So, who did the triggering? Well he was triggered following a phone call with then-senior Biden campaign official Antony Blinken, now the secretary of state. Anthony fucking Blinken again, every week that clown appears on our show for being involved in skullduggery against this country and its people. Here is another poor example of the operations of the US Military and why it has to be disbanded from the top down and replaced with non-corrupt and non-psychopathic organic HU-mans. At the height of the Covid-19 pandemic, the U.S. military launched a secret campaign to counter what it perceived as China's growing influence in the Philippines, a nation hit especially hard by the deadly virus. The clandestine operation has not been previously reported. It aimed to sow doubt about the safety and efficacy of vaccines and other life-saving aid that was being supplied by China, a Reuters investigation found. Through phony internet accounts meant to impersonate Filipinos, the military's propaganda efforts morphed into an antivax campaign. Following on from the bot campaign of the Israelis on the internet recently, just how much of the internet is corrupted by bots and military and agency goons? Social media posts decried the quality of face masks, test kits and the first vaccine that would become available in the Philippines, China's Sinovac inoculation. Reuters identified at least 300 accounts on Twitter, that matched descriptions shared by former U.S. military officials familiar with the Philippines operation. Almost all were created in the summer of 2020 and centered on the slogan #Chinaangvirus – Tagalog for China is the virus. Covid came from China and the vaccine also came from China, don't trust China! one typical tweet from July 2020 read in Tagalog. The words were next to a photo of a syringe beside a Chinese flag and a soaring chart of infections. Another post read: From China – PPE, Face Mask, Vaccine: FAKE. But the Coronavirus is real. After Reuters asked X about the accounts, the social media company removed the profiles, determining they were part of a coordinated bot campaign based on activity patterns and internal data. The U.S. military's anti-vax effort began in the spring of 2020 and expanded beyond Southeast Asia before it was terminated in mid-2021. Tailoring the propaganda campaign to local audiences across Central Asia and the Middle East, the Pentagon used a combination of fake social media accounts on multiple platforms to



spread fear of China's vaccines among Muslims, at a time when the virus was killing tens of thousands of people each day. A key part of the strategy: amplify the disputed contention that, because vaccines sometimes contain pork gelatin, China's shots could be considered forbidden under Islamic law. The military program started under former President Donald Trump and continued months into Joe Biden's presidency, even after alarmed social media executives warned the new administration that the Pentagon had been trafficking in Covid misinformation.

A number of points come from this:

- 1. The very US Military where involved in the creation of the virus along with the CIA, in conjunction with the CDC, NIH and other fake government departments.
- 2. Dr. Fauci and his other clowns like Wellensky, another Jew in a prominent position at the CDC, did gain of function with Chinese medical labs.
- 3. The NIH sent funding to China for Dr. Fauci's plan.
- 4. The Pentagon had thousands of PPE kits delivered before the outbreak in 2019, as reported by THI.
- 5. The masks and other equipment from China was brought in an a secret deal by Jared Kushner.

He did a deal with China and India for PPE's, and then had people threaten American companies to not produce any American PPE's. Speaking of the snake in a skin suit, Jared Kushner is now being investigated 3-4 years after we at THI exposed this on our show. Senate Democrats are launching a new investigation into the foreign payments made to Jared Kushner's investment firm. Senate Finance Committee Chair Ron Wyden announced the probe, saying that the panel would investigate the billions of dollars that Affinity Partners manages from foreign sources. Kushner started Affinity in July 2021, less than six months after leaving the White House as a senior adviser to former President Donald Trump. It was going on prior to leaving the White House, where he operated a puppet called Donald Trump. The firm quickly attracted big-time investors from the Middle East and within weeks, landed \$2 billion from the Saudi public investment fund. Affinity continues to overwhelmingly derive the majority of its funds from the Saudi Arabian government. It is deeply concerning that several Middle Eastern governments are using funds managed by Affinity, as a means to



pay tens of millions of dollars in fees every year to former President Trump's son-in-law, Jared Kushner, creating significant conflicts of interest and potential counterintelligence risks, Wyden wrote to Affinity Partners Chief Financial Officer Lauren Key on Wednesday. Affinity has disclosed to regulators that 99 percent of the \$3 billion of assets that the firm manages come from non-U.S. persons. The \$1 billion not funded by Saudi Arabia is reportedly split between sovereign wealth funds owned by the governments of the United Arab Emirates and Qatar, Taiwanese billionaire and politician Terry Gou, and another investor whose identity has not yet been publicized. Terry Gou in 2012, a controversy arose after Gou compared his Foxconn's workforce to animals during a board meeting. The Xinhua News Agency reported that while speaking on the challenges of presiding over a workforce with over one million employees, Gou stated that as human beings are also animals, to manage one million animals gives me a headache. All sounding very Jewish to me. On Wednesday, Wyden raised concern that Kushner and others were using Affinity's foreignfunded private investment funds as a loophole, exploiting those accounts to avoid federal laws that require Americans to disclose payments from foreign governments. He estimated that Affinity receives at least \$60 million in management fees annually from its exclusively foreign investor base and that from 2022 to 2023, the Saudi PIF alone paid the firm at least \$80 million in management fees. As the founder and sole owner of Affinity, Kushner is the biggest beneficiary of the fees paid to Affinity by the Saudi PIF and other Gulf state clients, Wyden wrote. During his time at the White House, Kushner advised his father-in-law on foreign affairs, advocating for the Trump administration to embrace Saudi Arabia. Kushner never advised Trump, he told him what to do, Trump is another Israeli puppet. Remember the Hannukah party inside the White House? Would Israel celebrate an American holiday in their Knesset? Kushner, a staunch defender of Crown Prince Mohammed bin Salman, remained close with the royal even after U.S. officials found that he orchestrated the assassination of Jamal Khashoggi. The Saudi PIF's decision to invest \$2 billion in Affinity so soon after Kushner's departure from the Trump White House, raises concerns that the investment was a reward for official actions Kushner took to benefit the Saudi government, including preventing accountability for the Saudi government ordering the brutal murder of journalist and American citizen Jamal Khashoggi, Wyden said. He continued, moreover, in the final two weeks of the Trump Administration, Mr. Kushner traveled to Saudi Arabia purportedly on official business, even though any reasonable window for meaningful foreign policy achievements would have closed with an upcoming inauguration of a new President. Wyden expressed concern that Kushner's limited track record as an investor, including his nonexistent experience in private equity or hedge funds, raise questions regarding the investment strategy behind the seeding investments and lucrative compensation that Affinity received from the Saudi PIF and other sovereign wealth funds. The Oregon Democrat asked Affinity to turn over records and information pertaining to the tens of millions in payments that the firm receives from foreign sources every year. He asked that the firm provide answers no later than June 26. I am glad that Kushner is finally being questioned, but I wish to know why no one questioned him in 2016 like THI did?

Another politician is now having the courage to expose the mess that Israel and its vast tentacles of minions impose upon countries. As British former politician Alan Duncan, who was Conservative MP for



Rutland and Melton, says the time has come to flush out the extremists in the UK government, who are subservient to Israel. We blame you for the senseless deaths of soldiers. We blame you for the numerous injuries to our children, both physically and mentally. A new poll by the Jewish People Policy Institute released on Monday finds that some 60 per cent want the country to accept the hostage-forceasefire deal and almost three quarters expressed a very low or fairly low level of trust in the government. More and more people now are having a fairly low trust of their government, not just Israelis. That augurs well for true change. Israel's colorful and raucous demonstrations are generally peaceful affairs, although there have been violent clashes with the police on the fringes. While the large crowds may not directly trigger the downfall of the government, one of their causes the fate of a draft bill to address exemptions from mandatory military service for ultra-Orthodox, or Haredi, young men, has the potential to break Mr. Netanyahu's coalition apart. I think people would prefer to break Netanyahu apart, not just the coalition. The man is a genocidal war criminal and it beggars belief he is allowed to govern anything. He is a total psychopath and a blight on humanity.

MEDICAL SECTION:

Here is more incriminating exposures of the Covid scam. Japanese researchers warn of the risks of using blood from mRNA Covid vaccine recipients, highlighting potential deadly effects and the need for urgent action to secure the global blood supply. Blood contaminated with prion-like structures from the spike protein, raises the risk of inducing fatal neurodegenerative diseases in recipients. The potential transmission of harmful proteins through exosomes via shedding and the risk of autoimmune diseases due to the vaccines' mechanism and components like lipid nanoparticles (LNPs) are other major concerns. Proposals for managing blood collection include rigorous donor interviews, deferral periods and a suite of tests to ensure the safety of blood products. The researchers advocate for comprehensive testing of both jabbed and unjabbed individuals to assess the safety of blood products and suggest discarding blood products contaminated with spike proteins, or modified mRNA until effective removal methods have been developed. They call for suspending all gene-based vaccines and conducting a rigorous harm-benefit assessment in light of the serious health injuries reported. All of which sounds like our Covid and Medical Blueprint solutions, the full testing part. They also urge countries and organizations to take concrete steps to address and mitigate the already identified risks. More and more coming out now, shame more didn't heed our warning in the Expose series, around 9 of which were done before the Trump and Trustee vaccines came out.



More medical skullduggery and yet again involving New York, quite why people would live there is beyond me. The widespread but controversial drug-testing of mothers and newborns in hospitals is now under greater scrutiny in New York, with accusations of unfairness surfacing in multiple lawsuits and state Attorney General Letitia James investigating. Positive tests that lead to CPS calls have the potential to separate families during infants' earliest stage of life, a practice parents, legal advocates and activists say punishes women and children and drags too many people of color unfairly into the foster care system. In an ongoing upstate lawsuit, Laura Kuzdale of Dunkirk said all she did to incur the intrusion of child protective services was eat Everything Bagel Bites with poppy seeds before giving birth in 2020. Food Nazis as well. Unbeknownst to Kuzdale, staff at Oishei Children's Hospital later tested her for drugs, which came up positive for opiates. The mother of two said that's when the nightmare began: Child welfare workers barred her from critical bonding time and interrupted a smooth return home with her newest family member. Non-consensual medical testing is illegal and billing the patient for tests they weren't aware of is unethical, Kuzdale stated. Taking a newborn from a parent is immoral is inhuman. I agree, but living in New York certainly doesn't help that factor does it, it is a floating landmass of iniquity. In a lawsuit filed in Erie and Chautauqua counties, Kuzdale accuses the hospital's former president Allegra Jaros and its parent company, Kaleida Health, of allowing staff to conduct a toxicology test without her consent, and later reporting a false-positive result to the Statewide Central Registry for Child Abuse and Maltreatment. In court filings, lawyers for the \$1.5 billion Kaleida Health stated that at the time of Kuzdale's hospital stay, staff did not need informed consent before conducting drug tests. Why didn't staff need informed consent? they are invading people's privacy. They also stated that the monitoring for opiate exposure did not result in any medical harm and there was no undisclosed risk of such harm. In reporting the test results to CPS, the defendants stated, they were just following legal standards. The law requires reporting and other protective action when there is reasonable cause to suspect maltreatment, and encourages mandated reporters to err on the side of reporting and protective action, court documents read. Whose law? The pedophiles and traffickers law? More on hospitals later.

SOCIETY SECTION:

As the cost of a home escalates to accommodate the greedy people amongst us and with rents skyrocketing, the fall out is taking hold. On top of that, there has been a massive increase in the US of underwater homes this year. Expect an almighty crash soon. More than 18 million Americans are living in homes that stretch their budgets far beyond what's considered financially healthy. That's the biggest takeaway from a LendingTree study released this week, that found that 18.3 million homeowners are what the housing industry calls cost-burdened, or house poor. That refers to homeowners who pay more than 30% of their monthly income on housing, including the mortgage, utilities and other costs. Anyone who spends more than half of their monthly income on housing is considered severely cost-burdened. All to keep up with the Jones' again! The high cost-of-living states California, Hawaii and New York have the largest share of house poor residents, while West Virginia, Indiana and Arkansas have the fewest,



LendingTree said. No surprise California and New York are leading the way, they are both harvesting centers. California 2.2 million house poor and 1 million severely housing cost-burdened – that 3.2 million people struggling. Hawaii 88,000 house poor and 39,000 severely housing cost-burdened. New York 1.1 million house poor and 550,000 severely housing cost-burdened. The solution is The Blueprint again and people being taught finances in a proper way to avoid debt. This program must end, to then replace it with something better for the all.

Adding to the previous piece and the struggles of Californian's. During a press conference, California Governor Gavin Newsom faced scrutiny regarding the state's expenditure of \$24 billion to address homelessness. Newsom, in a conference, disclosed that California is facing a budget deficit of at least \$45 billion and proposed various cuts to state worker jobs, education programs and healthcare services. As part of the proposed measures, Newsom suggested reducing funding for homelessness and housing initiatives by almost \$1.2 billion, with \$474 million being taken from an anti-foreclosure program aimed at preserving affordable housing. Despite the significant budget announcements and austerity measures, a reporter at the conference pressed the governor on the issue of homelessness in the state. An audit released in early April highlighted that California had allocated \$24 billion towards combating homelessness in the past five years. However, the audit revealed a lack of consistent tracking of how this substantial sum of money contributed to alleviating the homeless crisis. It didn't, as it was not meant for that. Clown money laundering again, maybe California officials are using that money to pay immigrants to come across the border? \$24B would buy 100K modular homes at \$200K each and potentially remove 1/2M who are on the streets or people struggling to keep a home due to rising costs. Or we can implement the Blueprint solution and fix all the housing issues in one sweep.

This is a prime example of it is not just the super-rich who are frivolous with money, but even those amongst us with in my opinion too much money, yet still can't make ends meet. It is bizarre and embarrassing and also a slap in the face for the many who have very little. While you might expect wealthy Americans to weather the cost of living crisis better than most, data shows a staggering 36% of American consumers earning \$200,000 per year or more say they're living paycheck to paycheck. Nearly half (48%) of those making over \$100,000 a year are in the same boat. Around 22% of high-income earners reported family expenses as the main reason they live paycheck to paycheck, while 15% cite nonessential spending as their primary pain point. That tells me they are incapable of budgeting and or you live in a house that is over pricing your budget. They call that living beyond your means. \$200K a year not enough, seriously! These people need to give their heads a wobble. Try not living to the standard of the super-rich for a start, buy a house that is manageable, keep a car longer than a year and why do you have to buy new? It's not rocket science. But those types of communities operate only to outdo each other, only serving to put each other into debt, sheer lunacy strikes again. The PYMNTS report also finds high earners' budgets can be as inflexible as low earners, simply because the former group tends to have more fixed expenses. There are about 7B people around the world who would love to have \$200K+ a year



problem. Having lots of money seems to make people lose their brain cells and out of touch with reality. It is not that \$200K is not enough, it is because you have a spending problem.

ABC(IA) News did a hilarious opinion piece recently to cover Robert Kennedy and discredit his statements as conspiracy theories. One such statement was that the CIA runs the media, seems fairly straight forward to me, but not to the cover up news channels. They wrote approximately 2000 words on why that statement is wrong. Dismissed Project Mockingbird as an isolated incident and completely left out any mention of the Church committee meetings that revealed the news media had 400 CIA agents involved back in the 1960's. This means they also own a major chunk of The Federal Reserve, the privately owned US central bank created through a coup in Congress on December 23, 1913, when the majority of congressmen and senators had already left for their Christmas holiday. To a great extent, therefore, Rockefeller interests control global finance, such as interest rates, and the printing of fiat dollars, which is counterfeit money on a massive scale. The Federal Reserve therefore has the power to cause stock market booms and busts, as well as financial crises leading to recessions and depressions at will. They have used that power several times.

The Rockefeller social engineering project was first documented in 1910 with the Flexner Report, 3 years before the creation of the Rockefeller Foundation. It was about reforming and controlling medical education in the US and Canada. Realizing that their plan would need support from public opinion to become successful, they began to focus on influencing and shaping the thoughts and opinions of the general population. On the one hand they targeted the educational system in general, from kindergarten



and all the way through the Universities. This meant getting children into the hands of specially trained nurses and pre-school teachers, who would make sure all children were properly indoctrinated, practically from birth. Children would be properly indoctrinated, yet we as parents never worked it all out until the 2000's? The social engineering program has been far too successful, due to our own stupidity and laziness in my opinion. So, in order to shape children's minds as early as possible into accepting Rockefeller's industrial world model, and help create an expanded source of both workers and customers for the new industries of the wealthy elite, it was necessary from the Rockefeller point of view, to make women want to compete with men in the workplace and earn as much money as men. That's why they launched the Feminist movement. That program has been the most damaging of them all. In general, women have become like men and men like women, which is bad enough, but the damage that movement and new working lifestyles have done to the children, is far worse. The means to achieve this was to take control of news media, and also to use entertainment and games, including Hollywood movies, to reshape people's perception of what is important in life. As scientists have made a breakthrough in robotics: a shapeshifting robot that can switch between liquid and metal states to navigate tricky environments without compromising on strength. It is not a breakthrough, it is just introduce at key moments in time. Because they can be both soft and hard, the small, sea cucumber-inspired robots can overcome the limitations of robots that are only one or the other, and thus have the potential to provide greater utility in areas such as electronics assembly and even medical applications. Robot medical applications? Sounds like a lizard symbiote to me. Researchers made the robots navigate obstacle courses, remove or deliver objects to a model of the human stomach, and even liquefy to escape a cage before reforming back into its original humanoid shape. Before reforming back into its humanoid shape, hmm, why would it be shaped humanoid? Giving robots the ability to switch between liquid and solid states endows them with more functionality, says engineer Chengfeng Pan of The Chinese University of Hong Kong in China. There are many potential uses for small robots that can get around places too small or convoluted for humans to manage with typical tools, from finicky repair work to targeted drug delivery. The, we are doing it for humanity line again and it will help us save time, save time for what? But hard materials aren't the best for navigating confined spaces or tight angles, while soft, more flexible robots tend to be weak and more difficult to control. To find a compromise, a team of researchers led by Pan and his colleague, Qingyuan Wang of Sun Yat-sen University in China, turned to nature as a source of inspiration. Animals such as sea cucumbers can alter the stiffness of their tissues to improve load capacity and limit physical damage, while octopuses can alter the rigidity of their arms for camouflage, object manipulation and locomotion.

To design a robot that can do something similar, the researchers needed a non-toxic material that can easily shift between soft and rigid states in ambient temperature. They turned to gallium, a soft metal that has a melting point of 29.76 degrees Celsius (85.57 degrees Fahrenheit) at standard pressure - just a few degrees below the average human body temperature. You can melt gallium just by holding it in your hand. You can melt clowns also by the hand, just by recognizing the power is in our hands. The researchers embedded a gallium matrix with magnetic particles, creating what they call a magnetoactive solid-liquid phase transitional machine. The magnetic particles here have two roles, says mechanical engineer Carmel Majidi of Carnegie Mellon University, one of the senior authors on the team's paper. Carnegie and Mellon



families now, someone needs to Chase them away from humanity interference. One is, that they make the material responsive to an alternating magnetic field, so you can, through induction, heat up the material and cause the phase change. But the magnetic particles also give the robots mobility and the ability to move in response to the magnetic field. Ah the magnetic field trick again, just like the veil. We have our own special field, we don't need their type of magnetism. Does anyone ask, what is the magnetic field attracting? Or repulsing? Why are you not repulsed by magnets? After testing to see whether the transition from solid to liquid was reversible, it was, the researchers ran their little robots through a gamut of tests. The robots could leap over small moats, climb over obstacles, and even split up to perform cooperative tasks moving objects around before recombining and resolidifying. Just like the replicator entities and people in the Alt Media were screaming for replicators a decade and a half back. Do you really think they would build anything for our benefit? They even had a little humanoid version shaped like a Lego figure, to melt to escape a little prison cell, seeping through the bars and re-forming on the other side in homage to a scene from the movie Terminator 2. Same as the biblical people wanting Armageddon or Rapture, go and find a tiny island and destroy each other, then you can have your own Armageddon without bothering us with your lunacy. Next, the team investigated practical applications. They created a model of a human stomach and had the robot engulf and remove a small object contained within it. A useful way, one imagines, to extract swallowed batteries, for example and then perform the reverse operation, delivering an object the way the team hopes it might deliver drugs. What a load of nonsense, notice how they always state it is for medical advancement purposes, when in reality it is all for weaponizing purpose. How many kids swallow batteries each year? That it would require this level of investment and time? Why don't they fix something more common like flu, cancer, heart disease, no it is to prevent some kids swallowing batteries. Apparently 70K kids per year swallow batteries, the greater question is what where the 70K parents doing, whilst kids popped batteries like they are cheerios? For circuit repair, the robots could navigate to and melt onto circuits to act as a conductor and a solder; and even act as a fastener, oozing into threaded screw sockets and solidifying, performing the function of a screw without someone needing to fix it in place. For real-world applications, the phase-transitional machine would need some tweaking. For example, because the human body is higher than the melting point of pure gallium, a robot designed for biomedical purposes could have a gallium-based alloy matrix, that would raise the melting point while maintaining functionality. Future work should further explore how these robots could be used within a biomedical context, Majidi says. Biomedical or bio-bot? What we're showing are just one-off demonstrations, proofs of concept, but much more study will be required to delve into how this could actually be used for drug delivery or for removing foreign objects. What if the foreign objects were us?

We must not forget that they are a minority, the Collective West, their worldview is not shared by anyone but them, citing memoranda adopted by multinational blocs such as the Russia-led BRICS group, the Shanghai Cooperation Organization, the African Union and others, in which member states commit to forming a multipolar world order. The SCO covers 3 billion people or half of humanity. Is that revealing that 2 billion people have vanished? Because 3 is half of 6, unless you went to common core lessons or Johns Hopkins school of non-math. BRICS covers more than 30% of the Earth's land mass, 45% of the world's population and 33% of global GDP which 3% more than the GDP of the G7. Zakharova noted that even in the West, some analysts argue that the U.S. has not been world hegemony for a long time. That is correct, the illusion of a world super power is a created myth, it was just designated to play a dirty role by banksters and EL-ites, but in the 1980's into the 1990's the energy was being withdrawn, it was never returned. In preparation for the end of the Federal Reserve western based harvesting to the Eastern based version of harvesting called BRICS. But then in 2007-08 Marduk pulled the plug on them all, ultimately doing us all a favor.
