

THI-SHOW TRANSCRIPT 2024-07-04

The Blueprint Episode 25 Teams Report week ending 30th June 2024.

The Agenda:

This week's agenda followed a more loose and less structured flow, it gave the teams a chance to just converse on a more intimate level and chat about their own journey on navigating through these uncharted times. We often forget that behind each team is someone's personal life and personal challenges, we are all learning that being mindful of each other during this time of great change is as equally important as planting the blueprint seeds. Providing a safe space to discuss whatever needs to be said encourages growth and inhibits the old environment we all worked in, where profits mattered more than people. Finding our voices is part of the journey, opening the throat chakra is key to being more authentic and creates a confidence within the person and then the group. An agenda is merely a tool for conversation, and sometimes the best and most fruitful outcomes emerge when we learn to open up, without being concerned it might offend or upset anyone. Working through the heart opens us all up to showing our vulnerable sides, for isn't that where the heart of the matter lies. We are a work of art in progress, and just like the blueprint it can only flower in the right environment. It is up to us to provide that environment, and if we apply as within and so without, we have set a new frequency as our baseline which then permeates outward. We all want results with the blueprint, but we must never forget the most important result we can have, is our own inner growth. This champions the way to becoming true guardians that will emerge on this planet. We cannot create the change, without becoming the change. We do this one step at a time by uniting and overcoming together.

Book Team:

The Romanian version of the Consent booklet is now on thinkdifferent.thepeoplesclub.org, alongside the Sacred Divine Masculine and Sacred Divine Feminine booklet previously added to our collection of free publications. The Romanian translation of From His Story to Our Story Volume 1 is completed and now in the formatting stage, with digital, PDF, and print versions being prepared, and the Romanian translator is ready to begin Volume 2.

Research Team:

Belated Happy Anniversary to the Research Team! We formed fourteen months ago in April 2023 with seven members. Our first summary report on April 27th, 2023, stated we were off to a great start and

waiting for Thomas to give the signal to send out/deliver copies. Our reports were much shorter back in those early days. 45.33 seconds is all it took for the June 8th, 2023, progress report. We noted that a signal had arrived: A focused and unified launch process is planned by the Book Team for all distribution of the book. That gave us more valuable research time. A full year ago, it took 1 minute 45.7 seconds for the June 15th report. In it we proudly announced Mission One of reviewing the 14-months of THI Shows was finished with three more missions to go. Our success was having found 335 influencer names in the shows, gathered fifty more from the Mewe chat members to bring the total to 385 names. By June 29th of 2023 we had reduced the report time to 50.57 seconds. We had encountered the first roadblock on our Plan A path. Plan B was in action. We detoured around the problematic Google cloud data entry and moved the goal post to Monday, July 3rd for the Excel spreadsheet to be fully phased into use. By Sept 7th, 2023, we had the top twenty-five mailing addresses for the first books to be mailed and at last had roller skates on the turtle. As of June 23rd, 2024, we have made successful contact with 411 influencers and have 281 in our name bank being prepared for outreach. The most current additions of 200 were names and email addresses provided by our Australian member of the Forbes Top 200 Billionaires for 2024. We are greatly appreciative of his diligent research efforts. We will provide an update of the full spectrum of statistics in the next show.

We had a skeleton crew of three attending the Father's Day meeting, partly due to the holiday and partly due to the continued absence of the database manager and our team secretary. We gladly welcomed a new member to increase to a crew of four worker bees and dealt with the grass catching of old business matters to keep the meeting short. Once again, the advance preparation served the team well, as we had already made successful outreach to the twenty influencers listed in today's report with the pdf and/or the link to the website. Likewise, we had all their biographical information at hand. We did review a list of names in our saved bank for future shows. Regular business matters included the team revisiting the Help Wanted ad. It was posted in the THI section of the Be Forum and the THI Mewe main chat several times. Two people joined the team because of it. We will ask the ad creator to continue posting it weekly for another month, then reconsider the next step. We have asked the advertising specialist member to create a second ad of: Help wanted for contacting US Senators in their home states. Or Calling American members in AL, HI, KY, VT, and WV. We are planning to send the Blueprint to five senators in these states. We are facing a stumbling block to reach them. Their website allows voters within their constituency exclusively to send a message. Will you help us by filling in their website contact form using your address? Please contact <blueprintfeedback@thenewblueprintforhumanity.org> we will provide further details.

When we have a few more members we can add a 5 x 5 expansion effort of commenting on YouTube podcasters shows that have already received an email or PDF, even the book, to ask them why they have not mentioned anything about the book or asked Thomas onto their shows yet. There were some questions

from the BP Action Group about t-shirt designs, order forms, turnaround times and the payment process tabled to research for answers when the full research team is back. There had been some research done on the large building banners cost and some car bumper or notebook stickers. Many variables need further clarification before price quotes or free samples can be requested. In conclusion, we return to the first research team April 2023 assignment sheet where our volunteers were encouraged to: Do the work with love in our hearts, knowing we shine and whatever we send out has a positive impact. The whole universe is waiting for us to give them the answers. We at THI and of the action groups can be congratulated on doing that very job of sharing the Blueprint solutions far and wide.

Jane Ruby: Is a licensed medical professional in internal medicine, with a subspecialty in cardiology and host of the Dr Jane Ruby show. She exposes the truth in breaking medical news to help listeners make the most educated health choices.

Jason Shurka: Is an author, producer, truth-seeker and founder of the UNIFYD World organization. He is dedicated to uniting humanity through awareness, compassion and Love. He uses the laws of the universe and breaks down complex principles into digestible and tangible bites of knowledge, that can be applied to every area of our lives. Jason is now a world-renowned author of five books, a film and TV producer, entrepreneur, visionary, leader, truth-seeker and the founder of UNIFYD TV and UNIFYD Healing. He organized UNIFYD World Inc. to help wake up millions around the world to their true power through conscious media and leading-edge technologies that promote health and wellness. In 2023 he was an executive, writer, and producer of the movie Sound of Freedom. According to Box Office Mojo, it has grossed over \$250 million worldwide since its release on July 4, 2023. It is based on the real story of Tim Ballard, a former U.S. Department for Homeland Security agent who conducts sting operations to rescue a young brother and sister from human trafficking in Colombia. The movie was criticized as being associated with right-wing conspiracy theories and accused of being sensationalists by portraying human trafficking in shipping containers. His other movie collaborations were The Nazca Alien Autopsies and The Marfa Lights – A UFO Disclosure with Serena DC.

Esai Morales: Is an Award-winning actor and devoted truth seeker. He has described himself as an actor/vist, primarily as one of the founders of the National Hispanic Foundation for the Arts. He takes inspiration from his mother, who was an organizer for the International Ladies' Garment Workers' Union. He is also interested in environmental issues and was a founding board member of E.C.O. (Earth Communications Office).

Erin Elizabeth: Is a longtime activist with a passion for the healing arts, working in that arena for a quarter century. She is an author, public speaker and has recently done some TV and film programs for some of her original work, which have attracted international media coverage. Erin was the recipient for the Doctors Who Rock Truth in Journalism award for 2021.

Over the years, she has lent her expertise to national organizations and boards combating human trafficking and abuse of women and children. She is a partner with the National Center on Sexual Exploitation and a member of The Coalition to End Sexual Exploitation.

Mel K: Is a sleuth Hollywood journalist, producer, whistleblower, who hosts the Mel K Show. Her show seeks to provide the most fact-based crucial information on events, both geopolitically and here at home. She wants to empower people to empower themselves with the knowledge to be active participants in the future of our republic. She strives to return power to the people where it belongs!

Mark Prody: Is a Republican senator in the State of Tennessee. He supports small business to create jobs and opposes the public school system from assuming child rearing responsibility from parents and improvements to transportation infrastructure.

Faisal M. Al Jazzaf: Is a Major General for Kuwait. He is the Secretary General for the World Veterans Federation (WVF). It is an international non-profit, non-governmental umbrella veteran organization. Susan Schnall: Is currently President of Veterans for Peace.org It is a group who has been exposing the true costs of war and militarism since 1985. To this end we will work, with others both nationally and internationally, to increase public awareness of the causes and costs of war. We will work to restrain our governments from intervening, overtly and covertly, in the internal affairs of other nations and to resist racism and repression in our home communities. As a note of special interest is Susan's personal claim to fame. She is a former U.S. Navy Lieutenant, JG nurse who was court-martialed and found guilty in 1969 for anti-Vietnam War activity and since spent many years campaigning for Vietnam Agent Orange Relief and Responsibility. Among the thirty Advisory Board Members of the organization are Cornell West, musician Jackson Browne, Phil Donahue and Jane Fonda.

Veterans of Foreign Wars: Is a non-profit veteran's service organization comprised of eligible veterans and military service members from the active, guard and reserve forces. Their Mission is to foster camaraderie among United States veterans of overseas conflicts. They serve our veterans, the military and our communities. They advocate on behalf of all veterans. Their vision is to ensure that veterans are respected for their service, always receive their earned entitlements, and are recognized for the sacrifices they and their loved ones have made on behalf of this great country.

Sheriff Calvin Hayden: Began his career in law enforcement when he joined the Summit County Sheriff's Office in the state of Colorado. His public service included selection and service as a foreign policy advisor to several Republican U.S. presidential candidates (2016) and subsequent appointment and service as the National Security Advisor to the 45th President of the United States of America. General Flynn is a national bestselling author, holds three master's degrees and is the recipient of numerous military, intelligence and law enforcement awards.

Robert A. Manning: Is another excellent candidate to receive the Blueprint for his wide range of international policy expertise and connections. He is a former senior fellow with the Scowcroft Center for Strategy and Security at the Atlantic Council. Previously, he served as a senior strategist at the National Counterproliferation Center in the Office of the Director of National Intelligence (ODNI) from 2010 to 2012, and as the director of long-range energy and regional/global affairs at the US National Intelligence Council's Strategic Futures Group from 2008 to 2010. From 2005 to 2008, Manning served as a member of the US Secretary of State's Policy Planning Staff, and from 2001 to 2005, he was senior counsellor for energy, technology, and science policy at the US Department of State. There he advised the Under Secretary of State for Global Affairs and a senior fellow at the Council on Foreign Relations (CFR). He has published widely in Foreign Affairs, Foreign Policy, the National Interest, the New York Times, the Washington Post, the Los Angeles Times, Chosun Ilbo, and other publications.

Hannah Rothschild: Is the eldest child of Jacob Rothschild, British writer, documentary filmmaker, businesswoman and philanthropist. She said in an interview, I was brought up in a secular household and so felt almost as if something had been foisted on me, if that doesn't sound too awful. Nevertheless, there was a creeping sense of pride because I also understood quite early on about the part my family had played in the creation of the State of Israel. Then, as I got older, and I learned more about the country, that pride grew.

Cheryl Hersha Beck: Cheryl was born into an occult family who traded her and her sister into government and CIA programs, in exchange for her parents to have judicial immunity for any crimes that may be committed against them. Cheryl was a bright and precious child who began speaking in full sentences at just 9 months old, but was deemed a throwaway child by her family. Media Team:

The media team have been having issues with some of the accounts, especially TikTok in the last few weeks, as it keeps crashing after an upload. Was it a coincidence that it only happened after the preface to the Blueprint video was uploaded? TikTok decided the music was against their standards and gave an option to choose another song, but even after this, we still found it went against regulations. They muted the whole video or was it Thomas's voice that triggered them and stunted our reach? They then decided that the link to the blueprint website also goes against community standards, their message read as follows: Link not allowed – It looks like your profile contains a link that is not allowed. We restrict certain content and actions to protect our community. You can change this link or remove it. This means that they are scared of us, imagine that the tables are turning and it cannot be stopped. Twitter is also playing games with one person's account that was getting a lot of traction and is now heavily monitored. Either way we call this a win and will keep finding other ways to push out the blueprint message further. We are concentrating our efforts on seeking out potential podcasters that align with the Blueprint ethos and will request that they invite Thomas onto their show to discuss the Blueprint and the depths of why this is needed at this critical point in our story. There is so much now dominating the news in every country on topics that Thomas warned us about back in 2019 and 2020, it seems like the old shows have become mainstream news. With this in mind, we will now focus on making some memes that state predicted in 2019, or whatever the relevant year is, for as we know in THI, we have been warned for a long time about what is coming. We also have two European members that are looking to open a personal account to spread the Blueprint message in their own countries, as we have many translated memes for this purpose. As personal accounts are targeted less in general and have fewer issues with shadow banning. Our aim is to shine and remain the beacon for others, which is most needed right now and moving forward. If we continue to intend great things and come alive to collaborate on live events/chats and the 5x5 strategy, we will see that larger audience embrace our mission.

Canadian Blueprint team

The Canadian Blueprint has been sent to a wider Canadian group for comments, suggestions, and/or approval.

Law Team:

Work continues on editing the transcripts from the Intro to Law Series. The Fundamentals of Law and Trusts and Rights units are complete, with work progressing on Estates, Rolls and Registers then Corporations, Funds and Property, then on to Documents and Securities then Money, Capital and Markets. Just as it is important to understand why the knowledge of what a Trust is, what are Rights and how do we claim them? Understanding what is an Estate and how does this affect us, is critical to knowing how our natural rights have been usurped and used to force us into debt slavery. An Estate is formed when a valid record, known as a Roll, is issued by some ecclesiastical, sovereign body or body politic, denoting assumed or actual beneficial rights or privileges and obligations of one or more persons of the same condition or circumstance. An Estate Roll creates a unique legal entity having certain limits of legal capacity, standing or status within the jurisdiction of the body and control of the body that created it. An Estate is the equivalent to the concept of a unique legal person. The limits of legal capacity or standing or status determined by the valid record in the Estate Roll, owned by the authorized body that created it,

therefore, defines to what extent other property may (or may not) be held and used as privileges and liberties by the beneficiary claiming use of the legal person. An Estate is equivalent to the primary legal title and legal capacity and legal standing of a particular class of persons. Subject to such limits of legal capacity and legal standing, an Estate may then hold one or more beneficial rights of use, or property as privileges and liberties within one or more temporary beneficial trusts associated with the Estate (i.e., “real estate” and “personal estate”). An Estate is equivalent to the aggregate property of immovable, movable, corporeal and incorporeal things associated with these temporary trusts (i.e., “the whole of the estate”). To properly administer the affairs of the Estate, the beneficial rights, also known as property, may then be pledged, promised, assigned, granted, or delegated as security to form one or more assets. The value of such assets may then be monetized or securitized through various funds, agreements, licenses, accounts and certificates. An Estate is equivalent to the aggregate monetary value of the net assets of the estate after all debts have been discharged. The concept of Estate is so powerful within the Western-Roman Model, because it deprives most people of ever really controlling or owning any form of rights or property. It means virtually anything can be taken away from you, with such action considered lawful under the Western-Roman Model of Estates. It also answers the paradox of real property and personal property once and for all; and explains why, in modern societies, virtually all our privileges are nothing more than personal property of things.

All Rights associated with an Estate are always Rights of Use, known as Property. Property is not the primary Right of Ownership, only Right of Use. The Rights of Use in an Estate come from the named and conveyed Rights in an existing Trust created by a Trustor, who has the claim of legal right of ownership. A person is an Estate. A person is a unique identity, a fictional form enclosing attributes such as the identity of a man or woman, a body politic, assembly or a thing. An individual’s access to Rights is through a particular person. The person is connected to the rights, not the physical you. The physical you is connected to one or more persons by virtue of the attributes and likeness of the person and ultimately by agreement and implied consent. Persons you may be connected to are federal citizen, licensed driver, employee or registered taxpayer. Each unique person is the property of the government agency, department or corporation that formed it, and each unique person will have a different set of privileges, obligations, and standing depending on the statutes that enclose the rights and limits for the person. It is a mistake to think we are connected to one person, when we are connected to multiple persons. Perhaps we can now see how powerful the concept of Estate is and how it has been used to enclose our natural rights through the creation of a fictional thing, a person, but how could our Natural Rights be frozen in Trust as the property of someone else? The absurd and immoral concept of Original Sin was created in the 17th Century and is one of the most important concepts for control of the world. It is a unique, fictional concept within the fictional concept of morality. Due to inheriting the sin of Adam and Eve, as all people are claimed to be descended from them, it implies that all are born bankrupt and in debt (sin). Bankruptcy implies the

spiritual, mental and physical insolvency of people, the deliberate cheating, deception and theft of Rights and Property against the Rule of Law. As all are born bankrupt and in debt, they are lawfully slaves until the debt is settled. Formed as an essential commercial element of the control of the Vatican it includes the opposite concepts of Grace and Salvation, essential to justify the need to salvage souls. Once salvaged, the Vatican can then freeze Natural Rights in Trust, and monetize them as debts in the form of money. Individuals are then freed from debt and granted minimal rights as fictional persons under the control of the Vatican. Unlike general offences, the offence of sin is claimed to be inheritable. This claim is absurd and contrary to thousands of years of Rule of Law.

An ancient Maxim of Law states that no one is punished for the transgression of an ancestor or another. This is just a brief summary of the depth of information within the Intro Series. Whilst editing the transcripts, the Law Team contacted the author of the Ucadia material to keep him informed of our use of his material. His response was encouraging. He appreciated the fact that we reached out, and the integrity, courage and efforts of our group and the work we are doing. He offered to look through and review our work before we start using it on a wider scale. We shared the first few transcripts. In his response after reviewing our work, he said that this Intro Series is over 15 years old now; hence, our edits contain some errors. He has been updating the material and producing new slides. He will be publishing new material that is better and stronger in the near future and suggested we wait for him to release the updates. He is also updating and publishing the 22 Maxims of Law, which can be purchased on Amazon. We will continue to evolve the Intro Series as there is much value in learning the fundamentals. We will pause on uploading this series onto the law website, as we prefer to wait to view the updated material so we can edit and ensure that we and our audience have access to the strongest information available.

In Overview:

We are now in the final battle, and with that in mind maybe it is a good time to think about the art of war and just what will it take to win this war of all wars. One of the most famous books written on the subject of war is called the Art of War, written by a Chinese author in the 5th century known as Sun Tzu, it went on to become one of the best-known military strategies for war. In effect it teaches you to know thy enemy, this book I am sure has had its avid readers and was used in many military manoeuvres. On closer inspection a few quotes though from this book, makes the reader ponder on who and what is the enemy? if you know your enemy and know yourself, you need not fear the results of a hundred battles. Quote 2: Thus, the expert in battle moves the enemy and is not moved by him. The third quote reads: The wise warrior avoids the battle. So, is it teaching the reader the art of war or self-mastery? All very THI to me and led me to ponder further on our own journey of self-discovery and self-mastery. We have all been taught who and what our real enemy is here in the safe environment of THI. We have been handheld and

guided through the gut-wrenching truths, triggers and the shadow work that tends to follow an expose or a medical piece. As we all have been wounded by millennia of skullduggery and heinous crimes that have been perpetrated upon us. Oddly enough there also seems to be some kind of war going on about the origins of some of the text for this book and has been adapted throughout the years with additions etc. I guess someone else always wants the glory, I digress.

The key to all self-mastery, is the realisation that the enemy you are always battling is yourself. There have also been many books written on the art of love as it seems we also need great direction on how to do this also. Our most basic function that is present from birth, the beautiful heart opening between a mother and her child the connection of the divine essence present at birth, has become overshadowed with medical intervention. Is it the first real separation of the family unit? Nowadays it seems we need books to tell us how to love better, to parent better and be better lovers. Our own precious flower of life connections to ourselves our heart, in the most basic and primal form have been smothered with the fruit of the poisonous tree. Instead of creating and growing our own tree of life, we have literally grafted their branches upon ourselves and now doubt our ability to love first ourselves and then others. Another book called The Art of love, written by a man called Ovid, an ancient Roman poet that wrote several popular books in 2ad, was at the time known for its most famous groundbreaking epic poem Metamorphoses, but came under severe criticism for and I quote: it playfully instructed women in the art of seduction and men in the skills essential for mastering the art of romantic conquest. The age-old program of seduction one of the biggest hooks that creates division, separation and confusion, turning love into a battlefield, all overlaid to distract us from our true Rus line heritage and teachings. Indeed, I am no literary scholar, but these are just two examples of War and Love which were written a long time ago. The U.S. military veteran and researcher known as WarClandestine on X posted a segment of the Kirillov statement, explaining the new report alleges the Pentagon relocated its secretive Ukrainian biolab operation to Africa. Kirillov alleges that Biden-owned Metabiota, and other intermediary NGOs, are running for cover. — Clandestine (@WarClandestine) June 26, 2024

The Russian military general specifically said U.S. biolab activities are taking place in the Democratic Republic of the Congo (DRC), where a new variant of monkeypox that reportedly causes miscarriage and has a fatality rate of 10 percent is currently spreading. Kirillov also explained how the U.S. government is using third-party companies such as the Hunter Biden-linked groups Metabiota and EcoHealth Alliance, as well as a company called Quicksilver and over twenty others. These corporations are essentially used as buffers, so the government doesn't get into legal trouble by creating bioweapons against global agreements. Clandestine wrote on his X post, Also keep in mind, the founder of Biden-owned Metabiota is Ghislaine Maxwell and Clinton affiliate, Virologist Nathan Wolfe. To conceal the purposes of the research, Washington uses third parties. These are contracting and intermediary organizations (Metabiota, QuickSilver, Eco-Health-Alliance, more than 20 companies in total), as well as enterprises of the so-called Big Pharma, he stated. Continuing, Kirillov pointed out Metabiota work in Africa has been discontinued after national governments started questioning its connections with the U.S. government. In 2014, samples of the Ebola virus were illegally exported by company representatives and transferred to the US Army Research Institute of Infectious Diseases, he said. I would like to once again recall Washington's opaque methods of work and warn our African partners against cooperation with the United States in the military-biological sphere. As practice shows, such interaction results in a loss of national sovereignty in the field of biosafety and a worsening of the morbidity situation, Kirillov added. The Russian official alleged a 2013 yellow fever outbreak in Cairo, Egypt, that killed 60,000 people was connected to a U.S. military biolaboratory. Kirillov also suggested the US could intentionally spread a disease via migratory birds, which could be part of a plan to release another pandemic ahead of the 2024 election. Migratory birds or migratory people? He stated, Let me remind you that the main goal of Washington is the removal of strains of dangerous pathogens and biomaterials from the territory of Ukraine, as well as the implementation of a

number of very specific programs codenamed U-Pi and TAP. For example, U-Pi-4: Studying the possibility of the spread of particularly dangerous pathogens through migratory birds. U-Pi-10: Study of the spread of African swine fever in Ukraine in the wild and through trade routes. Concluding his message, the Russian MOD spokesperson pointed out the U.S. is increasingly trying to control the UN Secretary-General's mechanism to investigate alleged use of chemical and biological weapons. According to Russia, this move is aimed at creating its own tool under its control, for investigating outbreaks of infectious diseases and other bio incidents. Hence the role of the WHO taking over countries policies, that is what that is for. The dominant role of the United States in the activities of the Secretary-General's mechanism will allow Western countries to assign blame at their discretion, as happened in the Organization for the Prohibition of Chemical Weapons, Kirillov explained. So, the Deep State operatives running America may be ready to unleash a second pandemic to disrupt the 2024 election and blame the pathogen release on Russia or another adversary. In 2016 Trump was running for election and the Russia gate unfolded. In 2020 Trump was running for election and Covid gate unfolded. In 2024 Trump is running for election, what will unfold this time?

Meanwhile, Israel's Supreme Court heard arguments Tuesday about a law granting far-right National Security Minister Itamar Ben-Gvir sweeping power over the police. Ben-Gvir was convicted eight times for offenses that include racism and supporting a Jewish terrorist organization. As national security minister, he has encouraged police to take a tough line against anti-government protesters and has actively supported officers accused of using excessive force against Palestinians.

Here is another exposure of criminality. House Judiciary and Oversight Committee chairmen Rep. Jim Jordan (R-OH) and Rep. James Comer (R-KY) sent a letter to Central Intelligence Agency Director William Burns calling for a briefing over allegations, that the CIA interfered in federal investigations related to Hunter and Joe Biden. As part of their impeachment inquiry proceedings, on March 21, 2024, the House Oversight and Judiciary Committee Republicans requested documents from the CIA, concerning its purported meddling into the Internal Revenue Service's and the Department of Justice's investigation into Hunter Biden. On behalf of Burns, James Catella, the director of the CIA's Office of Congressional Affairs, said the allegations proposed by the House Judiciary and Oversight committees were false. However, according to Jordan and Comer, information and documents provided in an affidavit by an IRS official, reveal that Catella may have been misled and given false information to Congress members. So, what happens next? The National Security Act will be wheeled out again. It is high time the National Security Act, the Patriot Act and all other acts that combine to cover up rogue operations and criminality amongst all the fake government departments.

A British bank that escaped prosecution for money laundering carried out billions of dollars of transactions for funders of terrorist groups, US court papers allege. Standard Chartered, one of the UK's largest banks, avoided prosecution by the US Department of Justice after Lord Cameron's government intervened on its behalf in 2012. New documents filed to a New York court claim thousands of transactions worth more than \$100bn were carried out by the bank from 2008 to 2013 in breach of sanctions against Iran. An independent expert has identified \$9.6bn of foreign exchange transactions with individuals and companies designated by the US government as funding terror groups, including Hezbollah, Hamas, al-Qaeda and the Taliban. Sanctions breached: Standard Chartered was publicly accused of falsifying transaction data on Swift, an international payment system used by thousands of financial institutions to move billions of dollars through its New York branch on behalf of sanctioned entities such as the Central Bank of Iran. But in September 2012, George Osborne, then chancellor in Lord Cameron's government, secretly intervened on the bank's behalf. Three months later, the US Department of Justice decided not to prosecute the bank. He says SCB processed transactions for a bank fronting for the Central Bank of Iran after it claimed to have stopped its Iranian operations in 2007. That happened at the same time it was borrowing an average of \$2bn a day from the Term Auction Facility, an emergency program set up by the US government to support banks through the global financial crisis of 2007-2009. Why would the US Government have a fund to prop up a UK bank? The transactions include those of a Pakistani fertilizer company, Fatima Fertilizer, known for selling explosive materials that were used by the Taliban in roadside bombs, that killed or maimed thousands of UK and US military personnel in Afghanistan. It also facilitated 73 transactions for a Gambian front company owned by a key Hezbollah financier, Mohammad Ibrahim Bazzi, the documents allege. Standard Charter in Asia were previously charged with laundering money for child traffickers. SCB, the shirt sponsor for Liverpool FC, well I never, perhaps now to be renamed as Liverpool Terrorists and Trafficking FC.

Here is another report highlighting the dangers of AI, bots and chat bots, these reports are also increasing and pleasing to see. We have a solution for that in the Blueprint as well. The article states: As much as I love using ChatGPT, a few troubling developments from the company recently have made me question my trust in OpenAI. Ilya Sutskever's departure is one of them and probably the most important. The OpenAI co-founder was seen as the main person keeping AI in check at OpenAI. But it's not just Sutskever who left the super alignment team, making us wonder who is overseeing AI safety at the company? Plenty of top engineers departed OpenAI. Then, CEO Sam Altman reorganized the team into a safety and security committee that answers to him. Sam Altman born in Chicago and born to Jewish parents, yet again a Jewish person at the head of a rogue organization or department. Add the public fight with Scarlett Johansson over GPT-4o's voice that sounded eerily similar to one of the actress's AI-related roles, and you realize that OpenAI might be breaking too many eggs for its own good. Fast-forward to this week, we have an open letter out in the wild from a group of AI engineers that includes current and former OpenAI

employees. They're asking for better oversight of AI companies. This would include a system that encourages whistleblowers to come forward, when they feel something isn't right without risking backlash from the company they work for. Considering the fast pace in the AI industry, whistleblowers might be the best thing that happens to ChatGPT and other AI products, especially if companies like OpenAI don't fully understand how their AIs work. It turns out that's also what's happening with current AI chatbots. The company doesn't know how their products work? Are you kidding me? Then who implemented them? is the great question. The open letter is available on a Right to Warn website for anyone to read. It's signed by former OpenAI, Google DeepMind and Anthropic employees who were unafraid to put their names under the letter. But it also has anonymous signatures from former and current OpenAI employees who fear retaliation from the company. Indeed, reports a few days ago said that OpenAI's non-disclosure agreements might prevent former employees from publicly criticizing the company. The signatories say they believe in the potential of AI technology to deliver unprecedented benefits to humanity. AI does not offer unprecedented benefits to humanity at all, as it is being created by psychopaths for psychopaths. The same psychopaths that want to eliminate humanity down to 500M. But they also understand the serious risks posed by these technologies. These risks range from the further entrenchment of existing inequalities, to manipulation and misinformation, to the loss of control of autonomous AI systems potentially resulting in human extinction. AI companies themselves have acknowledged these risks, as have governments across the world and other AI experts. The scientists say that guidance from the community, policymakers and the public can mitigate the risks. But there's not enough oversight in the nascent AI industry. The interfering with children and collecting their voice data tells you that. Companies have too much control over what they know and don't know about AI. There are no laws in place that would protect AI whistleblowers. The Blueprint has a whistleblower law that would protect them. Work has been taking place in the background to eliminate the AI threat issue and in the words of Simple Minds Ghostdancing song: Cities, buildings falling down Satellites come crashing down I see them falling out the skies like eagles Mirrored glass and shattered egos.

Small update on something related to the Blueprint. We sent the Blueprint out to 20 of the top news media outlets in America and in the preface letter we warned about them losing a large following, then asked them what happens next? The lawsuit filed on Monday comes on the heels of the April 20 test flight of SpaceX's next-generation Starship rocket, which ended with the space vehicle exploding over the Gulf of Mexico. This follows on from the oil lawsuit we mentioned recently. It is a case of turning the tables back on them.

Here is a classic bot level headline that defies belief and yet so many Milgram experiment people buy into it. It said: Climate change causes home values to fall off a cliff. Now as forecasted the Israeli junta are turning on their own people. The Israeli Knesset has voted to revive a bill that would end exemption on military conscription for some ultra-Orthodox religious students. The 63-57 vote in the parliament late on Monday means that the legislation will now head to committee review. The return of the bill from the previous parliament has provoked anger from opponents, as well as those that say it does not extend conscription sufficiently. As Israel conducts the war in Gaza and deals with expanding conflict with Lebanon's Hezbollah and other Iran-linked forces across the region. The legislation aims to slowly ramp up conscription among the ultra-Orthodox, whose members have for decades enjoyed exemptions to study the Torah. However, it would also lower the age of exemption from mandatory military service for ultra-Orthodox Jews from 26 to 21, thereby limiting the numbers that could be called up to serve. That saw far-right and religious factions support the vote, alongside Prime Minister Benjamin Netanyahu, while it was opposed by more moderate and military-linked factions, who say it does not do enough to ensure conscription at a time when the country increasingly needs soldiers. Defense Minister Yoav Gallant voted against the bill, saying it signals an engagement in petty politics at the expense of the Israeli military. This reveals Israel are losing far too many soldiers as mentioned in a previous show and that they will use their own so-called people to act as cannon fodder for the pandering EL-ites.

One of the benefits of living in Farmington New Mexico is it has the cleanest air in the country, but another hidden benefit is no Israeli smart meters. That maybe about to change although heavy opposition has gone against it. New Mexico, one of the few states without smart meters, is on the brink of introducing the invasive technology across the state.
