THI-SHOW TRANSCRIPT 2024-09-12

The Blueprint Episode 30 Teams Report week ending 8th September 2024.

The Agenda:

The action team discussed a variety of ongoing projects in different stages this week, and the tenor of the meeting was increasing interdependence, self-reliance and confidence within and amongst teams. The What Is? Series production is down to image selection to represent the life topics within the series, and several members have provided ample inventory to choose from. Selections will be made and implemented soon. We have also viewed a draft landing page design for each individual "What Is? Series Ponderable" that includes the audio file of the original reading out of the pieces, and the media team will be able to draw from those mp4 files to create a series of short clips for the social media platforms once they have access. These will increase the current inventory of videos. We welcome new people willing to join us and explore their creativity by making media clips. These short clips are instrumental to building our wider audience and pool of people ready to come forward and help, in a form that most directly touches people's hearts in these uncertain times. We are at the point where a shaking of the head and commenting how crazy it is, appears inadequate to the self and those around us, and people are truly searching for the words to describe the magnitude of events unfolding before our eyes. The research, media, and 5x5 teams are engaged in developing plans to counter a number of Milgram-experiment, Deep State initiatives and are preparing tools to cordially but firmly address tiers of institutional figures attempting to roll out initiatives rife with human rights violations this autumn. Everything else carried on as usual, we were busy handpicking suitable influencers and researching their profiles for the report, and updating the database to generate a tailored report for the 5x5 team to select the next batch of influencers for their weekly engagements.

Reason Foundation: Is a think tank based in Los Angeles, California with a 2nd office in Washington, D.C to advance a free society by developing, applying, and promoting libertarian principles, including individual liberty, free markets, and the rule of law. They use journalism and public policy research to influence the frameworks and actions of policymakers, journalists, and opinion leaders by way of their Reason Magazine and Reason TV.

Caroline Vonhoff: With others in Holland created "I, the Citizen" as a completely independent initiative of citizens that provides "the neglected citizen" with the necessary muscle power from their field of expertise and encourages them to take their own initiative.

Brian Eno: Cofounded Earth Percent with the mission to use music to help the planet by providing ways for artists, music organizations, and fans to donate a small percentage of their income to environmental and climate justice organizations.

The Peoples Voice: Is an American news publication committed to covering the headlines mainstream outlets shy away from. They have a team of writers from around the world, who deliver original reporting, political commentary, and entertainment to American and Western audiences.

Mary Jane Wilmoth: Is a trustee at the National Whistleblower Center Legal Defense & Education Fund. She is a member of the Board of Directors of the National Whistleblower Center, where she serves as the corporate secretary and treasurer. She is also the Editor of the Whistleblower Network News blog. In her efforts to uphold such safeguards in the American workplace, she has helped to strengthen whistleblower rights in licensing and enforcement proceedings with the Nuclear Regulatory Commission. She has also defended whistleblowers at the Environmental Protection Agency in actions before the Department of Labor.

Abi Roberts: Is a British stand-up comedian, writer and commentator. She has appeared as a guest comedian on BBC Radio 4's Midweek, Saturday Live and BBC Radio Scotland's The Janice Forsyth Show, and ITV's Good Morning Britain, debating mandatory vaccine passports opposite Edwina Currie. As a writer, Abi has written for several publications including Spiked and The Times. She is a regular commentator on GB News,

Tonight Live with Dan Wootton and Mark Dolan, appears regularly on Andrew Doyle's Free Speech Nation and on Nana Akua's weekend Debate show on GB News every Friday from 4-6pm.

Professor Dr. Paul Frijters: Is of Nova Academia, Belgium. We need to stop being victims admiring our enemies and become actors in our own future. We need to develop our own plans. The problem we face is far, far deeper than a few thousand rotten eggs. Tinkering around the edges of the existing system, to somehow 'fix' it by disinfecting it of the villains, will be nothing like enough to get us back on track. Rather, large chunks of the system itself must be dismantled altogether and replaced with something that is genuinely revolutionary. Opposing the agenda of the globalist elite is but a tiny sliver of what needs to happen to get to a better place. A real solution must start with realistic ideas about what to set up in place of current structures, and how to get to such a change, even if only in our own country and painfully slowly.

Professor Jolle Demmers: Is a professor in Conflict Studies at the History of International Relations section of the Department of History and Art History. Professor Jongyoon Han: Is the principal investigator of Micro/Nanofluidic BioMEMS Group in the Research Laboratory of Electronics at MIT. The lab is developing novel methods for small-scale seawater desalination. Using the ion concentration polarization, the Han group has developed an energy efficient but scalable seawater desalination and water purification system. The lab is interested in biomolecule separation using nanofluidic molecular sieve. Currently, most biomolecule purification and separation use random nanoporous materials as molecular sieving matrix. Unlike polymeric gels or nanoporous molecular filters, nanofluidic molecular sieves and filters could be engineered to have precise physical and chemical characteristics, therefore can have higher separation efficiency and selectivity.

Steven Jackson: Became an FBI whistleblower in 2022 after making protected disclosures to Congress about the FBI's questionable and manipulative investigations of January 6th protestors. He joined Steve Friend and Garret O'Boyle as they endeavor to keep the spotlight on government corruption. European Blueprint team

We are progressing nicely with editing and writing for the European Blueprint Solutions. The European Governments solution is getting more shape and together with the Banking and Financial Systems solution are next on schedule to be discussed in more detail. One of the members has set up a Google Drive for the documents we are working on, this is very helpful for our work in collaboration. An idea for a solution about decolonization was shared in the meeting. We did some future thinking and are investigating how we can create a list of European influencers.

In Overview:

The letting go: In a world where so much does not work anymore, where greed is the master and battles are a way of life, why does humanity struggle so much to let it all go? Have we become so fearful as a populous that we would rather keep the things that no longer serve us? NEWS:

As America freaks out over who won the debate this week, the answer is neither Trump nor Harris, only the US Inc. clowns. Following last week's reports of the struggles of Go-ogle, here is another hit to the electric grid drainers. As plans for a vast Google data center on the outskirts of Dublin have been blocked, amid fears it would put pressure on the electricity grid and heighten the risk of blackouts. The tech giant's proposals for an expanded data center, measuring nearly 800,000 sq feet, were refused by local officials over concerns they risked further straining the existing insufficient capacity in the electricity network. The country's grid operator, EirGrid, has previously warned of rolling blackouts, if the expansion of foreign tech giants was allowed to continue unchecked. Ireland is home to more than 80 data centers, which account for more than a fifth of the country's electricity consumption, and many US tech giants maintain a sizable presence in the EU member state. Google's European headquarters are located in Dublin. There has been a de facto moratorium on new data facilities in the Dublin area since 2022 to ease pressure on its electricity network. However, Google had put

forward plans for a new facility at Grange Castle, which would have been roughly the size of 10 football pitches. The project was expected to create 800 construction jobs and 50 permanent roles once it was in operation. The world or their world is obsessed with data it seems. Why? The obvious is their pervert voyeur routine of spying, but the hidden hand for the data is for the new AI control system and their plans for a replicator style robot world. In a world where there clowns tell us to conserve energy, whilst they create systems that consume vast quantities of it. 20% of Ireland's electricity is used to spy on people. No doubt at far cheaper rates than the general public.

When crypto came out alt media were telling me that it is a good thing and is going up against the big banks. I dismissed that foolish notion and warned of the dangers of it, it is the precursor to a credit or tokens system and the UBI program. No compliance with all their demands and you lose your tokens, it is the ultimate goal of control freaks. Perhaps this piece might make those who like crypto and the dangerous blockchain technology think. Crypto exchange Binance has seized all funds belonging to Palestinians, acting on a request from the Israeli Defense Forces (IDF). This revelation comes straight from Ray Youssef, who stated that the exchange refuses to return the funds. All appeals have been denied. Palestinians affected by this decision have found their accounts frozen with no way to access their crypto assets. The seizure is reportedly tied to Israeli law, specifically, the Anti-Terrorism Law of 2016. The law gives Israel's Minister of Defense broad powers to confiscate property deemed to be linked to terrorism. A seizure order, labeled T56/23, was signed on November 1, 2023, under this law. Then maybe that is what the rest of the world should do with Jewish ELite accounts, including their politicians, ambassadors and lobbyists group for supporting actual terrorism, not fake terrorism. The claim is that cryptocurrency wallets, including those owned by Palestinians, have received funds from a group designated as a terrorist organization by Israel. This group, the Dubai Exchange Company operating in Gaza, was flagged by Israel in 2022. Ray explained that: According to the anti-terrorism law, cryptographic currencies that have been transferred by a declared terrorist organization constitute property of a declared terrorist organization and cryptocurrency wallets to which it has been transferred. The law provides cover for Binance's move to freeze and hold Palestinian funds, citing reliable intelligence as the reason for targeting specific cryptocurrency wallets. Ray said: I have received this from several sources. All Palestinians are affected and judging by the way things are going all Lebanese and Syrians will get the same treatment. Not your keys, not your coins. We are all Palestinians now. Centralized exchanges like Binance are starting to look more like government snitches than safe places to store your crypto. Starting to look like? It was that from the beginning just as I warned. And it gets worse. Ray claims that Binance has been leaking info on MENA (Middle East and North Africa) users to the IDF without any legal process, no warrant, no subpoena, just handing it over. If that's true, it's a massive betrayal of trust, not just to Palestinian users, but to anyone using the platform. CZ was innocent. He went to jail because he refused to tow this line. Now, Binance is fully compromised, and so is any other centralized exchange. CZ was the founder of Binance a Chinese-Canadian who was arrest by the US for alleged money laundering and jailed for 4 months and a puppet installed at Binance it seems. CZ refused US demands just like Pavel Durov who wouldn't bow to US intelligence demands to add in back doors to the Telegram program and was subsequently arrested. Today it is the Palestinian's, the tomorrow is all of us. It seems all Israel has to do, is declare everyone not Jewish a terrorist and they claim all the funds. Just like the Templar group and the Silk Roads.

Here is more anti-humanity interference and initiating fake laws to threaten people and organizations who dare to question or ignore them and their demands. The top law enforcement officials in 24 states warned Brown University of financial penalties, if the school's trustees vote in favor of a proposal calling for divestment from companies with close ties to Israel. What has law enforcement got to do with, how people exercising their free speech and where they spend their money? Is there any authority group in America ever going to do what is best for the people, or will they always pander to the anti-humanity group? I would love to know the actual figures of time, energy and money the authorities use to appease the terrorist, apartheid and genocide group, it must be staggering. National Security Minister Itamar Ben Gvir calls for the deportation of Eritrean asylum seekers after two men were killed and five others injured in a massive street brawl between pro-regime and anti-regime Eritrean migrants, in south Tel Aviv. According to the minister's office, following a conversation with senior police officials, the National Security Ministry and Israel Police have agreed to demand that the state prosecutor, attorney general and justice and interior ministries act to deport the Eritreans, following the request submitted a year ago and the discussion held with the prime minister. Eritreans like all other African's who stupidly align themselves with Jewish or Israel are labeled as schwartzers, who Israelis think are beneath them. Most simply, the Secure Community Network is the Jewish community's own FBI and Department of Homeland Security. SCN tracked over 5,000 threats last year, sending more than 1,600 tips to law enforcement. Director Michael Masters leads a team of analysts that don't need warrants to follow leads. We can also have tools that are active in our command center to look at the deep and dark web, Masters said. Founded in 2004, SCN took off after the 2018 mass shooting attack at Pittsburgh's Tree of Life synagogue, the deadliest antisemitic attack in U.S. history. They just have to mention the tragedy event don't they? I am not demeaning that event and the fact that people lost their lives, it is just used to install draconian measures, guilt and shame on the rest of us. SCN now hosts active shooter trainings at synagogues and Jewish centers nationwide, and Orsini says threats have skyrocketed since the start of the Israel-Hamas war. In an April report, the Anti-Defamation League recorded 8,873 antisemitic incidents in 2023, which includes harassment, vandalism and assault. That is the highest tally since it began tracking the number in 1979. 8873 events that would not unfold if those at the top of the Israeli plans would stop their genocide. 8873 antisemitic events, 41000 anti-humanity events with 10's of thousands of people disrupted due to anti-humanity events. Big difference. I warned they would place their own people in danger and they have, just like they have always

The problem, industry experts explained, is that energy is bought and sold in a global market, and the only way that gasoline could go from \$3.40 a gallon now down to \$1.70 a gallon is for crude oil prices to fall from \$75 a barrel to between \$20 and \$30 a barrel. And at those lower prices, U.S. oil producers would not be able to break even. That would bankrupt the U.S. industry and the entire U.S. industry would shut down before that happened, said one oil executive. Utter rubbish, they just have to clean up their industry and stop giving rogue elements backhander cuts out of it. A straight trade deal just like our Blueprint solution advocates. A US Navy carrier strike group and a few other warships that spent months battling the Iran-backed Houthi rebels in and around the Red Sea fired \$1.16 billion worth of munitions during active combat operations, a Navy spokesperson said. This previously unreported figure covers the total cost of the 770 munitions that the Dwight D. Eisenhower Carrier Strike Group launched from October 7 to mid-July and underscores the significant financial toll of America's ongoing counter-Houthi mission. US Navy ships have maintained a presence in and near the Red Sea to deter threats and protect shipping since the launch of near-daily attacks by the Iranian-backed Houthis in November 2023, the spokesperson said. New York City Comptroller Brad Lander audited the \$432 million contract between DocGo and the Department of Housing Preservation and Development (HPD). In a scathing announcement on Tuesday, his office announced many problems with the department's oversight of the company, which houses asylum seekers. Aiming to help asylees who needed housing, HPD looped DocGo into the process in May 2023, despite its position as a medical service company. Yet 4 of the top 6 people in the DocGo company are Jewish, hence them being awarded the contract despite not fitting the criteria. And as of June 2024, they'd paid DocGo nearly \$182 million of the \$432 million value

of the contract. Ultimately, Lander's audit argued that the agreement was poorly managed. Its allegations include unlicensed contractors, overpayments and subpar housing. Perhaps most galling of its findings, the audit accused DocGo of charging for and being paid nearly \$1.7 million to rent empty hotel rooms. In one example, DocGo rented nearly five thousand vacant rooms at the Armoni Hotel in Orangetown for 61 nights. This after the town got a restraining order from the Rockland County Supreme Court blocking the hotel's use for asylee housing. Though the hotel charged \$100 per night per room, DocGo got \$170 per room from the city. Pocketing the difference meant DocGo made \$343,140 in profit off of a \$490,200 bill—totaling \$833,340 for empty rooms. According to the comptroller, DocGo also got reimbursed \$21,820 for other services at hotels that had no asylum seekers. A license to print money for the same anti-humanity group. Message to New Yorkers, you are paying for this extortion through increased taxes.

There is a flow to these events that few people understand.

- 1. One or more groups has a financial problem.
- 2. Create a solution so the one or more groups are in place when the event unfolds.
- 3. The event unfolds.

It's always a good idea for passengers to keep medicine in their carry-on bag, but even that doesn't guarantee they'll get to their final destination with all their prescriptions. According to a January survey of 1,245 Americans from BuzzRx, one

in 10 Americans have had their medicine confiscated while traveling, either by the Transportation Security Administration or by border officers abroad. Before traveling, it's imperative to research the destination, especially if traveling internationally, about what their medication requirements are, Ricardo Rodriguez, a member of BuzzRx's data team. Rodriguez explained that some U.S. medications are not approved in other countries, which could make traveling with them complicated. Discussing the issue with your provider will probably be the best thing to do. Medicine is almost equally likely to be confiscated on domestic trips, with 41% of respondents saying it has happened to them, as on international trips, with 44% of respondents saying they'd experienced it. For domestic trips, the TSA recommends keeping your prescriptions in their original, marked containers. TSA regulations allow travelers to bring more than 3.4 ounces, the usual limit for liquids, if their medicine comes in liquid form. Data from BuzzRx shows that one in nine travelers have had to cancel their trip after having medicine confiscated at the airport, and one in six have been able to replace their meds but had to pay full price for the prescription. More than 50% of the respondents to BuzzRx's survey said having their medicine increased their stress and anxiety around a trip, and 18% said it forced them to cancel some trip activities. Anxiety medication was the most common type to be confiscated, followed by sleep aids and over-the-counter remedies. Rodriguez said travelers should reach out to their doctor to see about getting confiscated medicine replaced, or consider seeking help from a consulate or embassy if the issue happens abroad. Like I said we live in a lunatic asylum.

Interesting they used the term Enlightenment hostility. The Enlightenment, also known as the Age of Reason, was a philosophical movement in Europe during the 17th and 18th centuries. It was also attempted in the middle ages and was crushed by a plague. During the Middle Ages, especially Thomas Aquinas, had employed reason as a tool of understanding. People began to question received authority, whether in science or religion. Rulers had long claimed their powers to be given by God. But Enlightenment thinkers questioned the idea, that God had given the monarchs their power. Enlightenment ideas were popular and spread quickly. The Roman Catholic Church and European monarchs tried to censor, or ban, many of the books and other works of Enlightenment thinkers. Something they accused the Germans of 200 years later, no it was not the Germans, it was these same rulers of anti-humanity. The monarchs were right to be alarmed. The Enlightenment led many people to think about their government and to consider ways in which it should be reformed. Just like what is unfolding now. The relationship between the people and the state began to be envisioned as a social contract, rather than one in which an authoritarian leader ruled his subjects without question. This view eventually led to the American and French revolutions, when monarchs

lost their power. Only to be handed over to the Houses and nobility. For example, in Voltaire's A Philosophical Dictionary, he wrote of Jews: In short, we find in them only an ignorant and barbarous people, who have long united the most sordid avarice with the most detestable superstition and the most invincible hatred for every people by whom they are tolerated and enriched. Three hundred years later that same avarice, harvesting, non-caring and hatred still persists, the Jewish people need to discuss amongst themselves as to why? A harsh look in the mirror, because what Voltaire said is the reality, not an illusion. Telushkin states that Voltaire did not limit his attack to aspects of Judaism, that Christianity used as a foundation, repeatedly making it clear that he despised Jews. Judaism, that Christianity used as a foundation? That tells you right there that Christianity is a Jewish creation. In fact in overview, Christianity is Stockholm Syndrome, of following and worshipping your abusers. On the other hand, Peter Gay, a contemporary authority on the Enlightenment, also points to Voltaire's remarks for instance, that the Jews were more tolerant than the Christians in the Traité sur la tolérance and surmises that Voltaire struck at the Jews to strike at Christianity. Yes because Voltaire and others worked out that Christianity was a fake Jewish religious program. Whatever antisemitism Voltaire may have felt, Gay suggests, derived from negative personal experience. Arthur Hertzberg, a Conservative Rabbi, claims that Gay's second suggestion is also untenable, as Voltaire himself denied its validity when he remarked, that he had forgotten about much larger bankruptcies through Christians. However, Bertram Schwarzbach's far more detailed studies of Voltaire's dealings with Jewish people throughout his life concluded that he was anti-biblical, not antisemitic. His remarks on the Jews and their superstitions were essentially no different from his remarks on Christians. Because in overview, both follow the same insidious script, which has been proven to not be beneficial to either group. Voltaire said of the Jews that they have surpassed all nations in impertinent fables, in bad conduct and in barbarism. You deserve to be punished, for this is your destiny. He further said, they are, all of them, born with raging fanaticism in their hearts, just as the Bretons and the Germans are born with blond hair. I would not be in the least bit surprised if these people would not someday become deadly to the human race. What a warning that was and clearly went unheeded, just like the Santies.

Some authors link Voltaire's anti-Judaism to his polygenism. According to Joxe Azurmendi this anti-Judaism has a relative importance in Voltaire's philosophy of history. However, Voltaire's anti-Judaism influenced later authors like Ernest Renan. Voltaire did have a Jewish friend, Daniel de Fonseca, whom he esteemed highly, and proclaimed him as the only philosopher, perhaps, among the Jews of his time. Despite him highlighting the Jews as a problem, he, like myself was a supporter of Jewish people as well. Voltaire had also condemned the persecution of Jews on several occasions including in his work Henriade, and never advocated violence or attacks against them. According to the historian Will Durant, Voltaire had praised the simplicity, sobriety, regularity and industry of Jews, however subsequently, Voltaire became strongly anti-Semitic after some regrettable personal financial transactions and quarrels with Jewish financiers. In his Essai sur les moeurs Voltaire had denounced the ancient Hebrews using strong language; a Catholic priest had protested against this censure. The anti-Semitic passages in Voltaire's Dictionnaire philosophique were criticized by Isaac De Pinto in 1762. Subsequently, Voltaire agreed with the criticism of the anti-Semitic passages and stated that De Pinto's letter convinced him that there are highly intelligent and cultivated people among the Jews, and that he had been wrong to attribute to a whole nation the vices of some individuals. That is a key line in there, did you spot it? "He had been wrong to attribute to a whole nation the vices of some
